

A Futile Mission – Georgia Attempts to Bleed its Way into NATO



Georgia is filling a growing security gap in Afghanistan that is being left by full-fledged and fatigued NATO member states. The strategic purpose of the country's mission is not worth the lives being lost.

As the United States and its NATO allies have been with-drawing their forces from Afghanistan since 2011, albeit slowly, Georgia has been doing just the opposite - increasing

its troop presence in the South Asian country to the point where it is now the largest percapita troop contributor.

Meanwhile, Georgia's new government appears to be following in the previous government's footsteps in placating the U.S. by expressing its commitment to a post 2014 role in Afghanistan when nearly all combat troops are slated to be pulled out and local Afghan security forces are expected to begin fending for themselves.



The timing is uncanny, and for the Georgian government to

be committing itself to a post 2014 role without knowing what the future situation will be in Afghanistan is politically reckless and dangerous for its young men in uniform, as it impacts the integrity of the Georgian armed forces and its moral. Even talk of Georgian troops only serving in a training capacity should be met with caution given the steady rise of "green-on-blue" (insider) attacks by local Afghan forces against their foreign mentors.

Tbilisi has long stated that its contribution to what is now

a 12-year long foreign occupation of Afghanistan is tied to its future - potential membership with the North Atlantic Treaty Organization and thus putting at stake the country's sovereignty and national security. However, as the war winds down (at least in terms of foreign involvement) and official Tbilisi and regular citizens alike come to terms with Russia's position in their country following the 2008 Russian-Georgian war (in which the country's two breakaway regions were recognized by Russia and a handful of other nations as independent states, thereby further crippling Georgia's territorial integrity and chance of joining the alliance as a united state), the more Georgia's increasingly bloody mission in distant war-torn Afghanistan appears ill-conceived and fu-

Georgia cannot help bring an end to the occupation by Russian Federation of what Tbilisi considers its own territory by continuing to occupy another country. Moreover, officials in Tbilisi should think less about the perceived benefits that its contribution to the mission is bringing to Georgia, and more about the impact it is having for the future of Afghanistan and the Afghan people. The longer the Georgian flag, with its five-fold Crusaders cross waves over Afghan soil, the more the fighting capability, brutality and resolve of the Taliban resistance will increase.

It is increasingly clear that the motivation behind the Georgian troop deployments to Afghanistan is nothing short of an attempt to bleed Georgia into NATO. This appears to have been an intentional move by Tbilisi (and those hell-bent on expanding this Cold War leftover into geo-strategically important areas of the former Soviet Union) in light of the fact that Georgia cannot do so by following the same set of rules as other countries, such as the Baltic states, which have been successfully integrated into the alliance.

Russia Cuts Off Georgia from Tskhinvali

Russia has started moving deeper into Georgian territory by installing a barbed-wire fence on the administrative boundary between Georgia and its breakaway South Ossetia region, commonly referred to as Tskhinvali region. Russian border troops' progress, however, didn't become a subject for sharp criticism by Georgia's government. Nevertheless, the country's youth responded to the news in a more aggressive way, organizing a small-scale rally near the former building of Russian Embassy in Tbilisi with a slogan "No to crawling occupation".

On May 27, Russian soldiers started erecting a new fence close to the Georgian village of Ditsi, moving the de facto border 300 meters into Georgian-controlled territory. This is not the first time Georgian territory has been snatched by Russian frontier guards – it occurred on numerous occasions after the Russian-Georgian war in 2008. In 2009 the then de facto President of South Ossetia Eduard Kokoiti demanded to "return" Truso Gorge, which

lies on the Georgian side; later the same year Russian troops moved a few hundred meters into Georgia's territory near the village of Kveshi, though the Kremlin denied this. Similar incidents happened in 2010 in five villages of Gori region.

"There is nothing surprising here. Historically Moscow has been breaking all its agreements. We didn't have great expectations about how the treaty would be implemented when it was signed after the war," Gigi Nasaridze, Founder of the NGO "Georgia Is Not for Sale" and one of the participants of the rally held outside the Russian Embassy told the Georgian Times.

Nasaridze has been protesting against Russia's "annexationist policy" towards Georgia since 2004, but this time "it exceeded all the limits". "This is not the fault of the new government it is no one's fault except Russia's – this is how Russian policy works. The only thing we can accuse our government of doing is not expressing a proper protest against the recent events. Some of the representatives of the authorities assure we shall not protest it at all, others – the presidential candidate of the Georgian Dream coalition, in

particular – do not comment on such important issues. This is a huge problem," Nasaridze added.

Zviad Khorguashvili, the executive director of NGO Club of Liberty that organized the rally on May 28, emphasized their goal is not only protesting against the fence installation but also showing to the international community that Georgia will never accept Russian occupation. "We want to tell our government that we are with them and we demand this issue to be solved once and for all," he told GT.

Some rally participants' speeches were exceptionally emotional. Giorgi Rukhaya was outraged with the small number of protestors and inertness of the Georgian government and society. "Where are those priests with stools who we saw on the demonstration against sexual minorities now?! Isn't Georgia's territorial integrity more important than that?! Or what does the government do regarding this issue? It's a shame!" he cried despite his associates' calls to bar him from making political statements.

The only steps taken by the Georgian government so far were filing a note of protest to the Kremlin and calling on the international community to react appropriately. Inactivity of

the country's authorities, unclear position and playing footsie with the Kremlin was seen as the main reason for illegal actions of Moscow by Russian journalist Oleg Panfilov, who moved to Georgia in the end of 2009 after being threatened in Russia.

"I'm afraid that the change of Saakashvili's stiff policy towards the Kremlin with Ivanishvili's obscure position will result in more provocations by Russia. The government should be as strict as possible with the occupant and aggressor; otherwise the Kremlin considers the authority weak and does whatever it wants. It's impossible to make friendship with a country that captures your territories," he told GT, adding that filing a note of protest is not enough to solve the problem as "it's similar to sending a note to Stalin or Hitler".

Nikolay Silaev, senior researcher at the Center for Caucasian Studies of Moscow State University of International Relations, considers Moscow's decision on moving the border now apolitical. As he said, this is the result of unstopped "bureaucratic inertia". "I think this is a part of South Ossetia's border delimitation programme, which was launched sometime

Jean-Claude Mignon Expresses Concern About Detention of Former Senior Officials

The statement was made after the Jean-Claude Mignon met with Davit Usupashvili, the Parliament Chairman on May 29."We are concerned about the series of detentions carried out in Georgia. Of course, we can't interfere in Georgia's interior political processes, but if there are accusations against these people, we want these processes to be held in a democratic and fair environment," Mignon said. As Mignon stated, there is the presumption of innocence for every person. "Accordingly, we are worried about the detentions of the former senior officials in Georgia; the EU will observe with great attention how the upcoming presidential election will be held," he added. Jean-Claude Mignon has already met with the PM, Parliament Speaker David Usupashvili, Tbilisi Mayor Gigi Ugulava and the member of Parliamentary minority, Chiora TaktakishviliA meeting between Mignon and President Mikheil Saakashvili is also planned.

Levent Murat Burhan: Georgian-Turkish Relationship an Example for Other Countries

The Georgian Times recently interviewed **Turkish Ambassador Levent** Murat Burhan, who discussed Turkey's current relationship with Georgia and future economic projects which will be implemented in the region for mutual benefit.

Mr. Ambassador, please tell us how easy was it for you to adapt to Georgia. What did you know about this country before; what were your expectations and how has your experience been?

I first came to Georgia four years ago. Soon I observed that Georgians have similar attitudes towards national traditions, family values and living. They have the same way of thinking and the same cultural peculiarities as Turkish people. I am from the Black Sea city Trabzon and I can see that Georgian traditions are very similar to the traditions of that region (Karadeniz). By the way, most of the Turkish businessmen who work in Georgia are from Karadeniz and most of them know the Georgian language. It is easy for them to adapt to Georgia. I like Georgian traditions and culture and these are very specific and similar to Turkish. Georgian cuisine is also very similar to Turkish. We have dishes that are similar to Georgian favorites like Khinkali and Khachapuri. The only difference is that we eat lots of fish, and this may be because I am from the Black Sea region where everybody likes fish. But in general, Georgia and Turkey are similar countries, and this is why it was very easy for me to adjust. I can say I feel at home.

Describe relations between Turkey and Georgia, and specifically trade relations?

Turkey has very good relations with Georgia. We have signed a number of very important agreements over the last five years, which includes one agreement allowing Georgian citizens to pass through the Sarpi Border crossing point only with their ID cards; there is no need for a foreign passport. Such an agreement gave an opportunity to more Georgian citizens to easily visit Turkey. In the last year, five million Georgia visitors traveled to Turkey through the Sarpi checkpoint. Moreover, one million cars have passed to Turkey. Consequently relations between the two countries' people are becoming closer and more intensive.

As for trade relations, Turkey is Georgia's number one

trade partner. Last year Turkey had 1.5 billion GEL worth of trade with Georgia. Turkey also has made huge investments in Georgia. One of the largest investments of the last year is TAV which operates the airports in Tbilisi and Batumi. By the way, those citizens of Turkey which want to travel to Hopa, first came to Batumi and from Batumi go to Hopa by bus and by other means of transport. Batumi is fast becoming a common airport for the region, similar to the role that Geneva's airport plays, which is used by both France and Switzerland. This is a very rare example in international practice and it is being replicated here. Turkey has also made big investments in Georgia's tourism sector. For example, Batumi Sheraton Palace was built by a Turkish company and it is controlled by a Turkish company.

Eighty percent of electric energy produced in this station will be sent to Turkey. But for the transmission of this energy, a new electric power transmission line is needed because the existing capacity is inadequate. To address this need, a new high voltage electric line of 500 megawatt voltage is now being constructed near Akhaltsikhe. We think that this project will be completed this summer. But we are not talking only about Paravani; there are 15 other hydroelectric projects and power stations in Adjara region, and located on the Enguri and Rioni rivers which are also being implemented by Turkish companies. Georgia is rich in water supply and has ample conditions for excess hydroelectric capacity. Initially, hydroelectric energy produced in Georgia will be sold to Turkey, but afterwards Georgia can start expanding its export capacities and even sell energy to Europe.

Can you tell us about new developments besides economic and trade relations?

We are going to open additional border crossing points because of the high border crossing rate in Sarpi. For instance, we are going to open two new border crossing points - the Childirak-Kartsakhi checkpoint and the Muratlik-Kirnaki checkpoint. Consequently these border-crossing lines will serve to make the passing of both transport means and people to Turkey easier, and to alleviate the bottleneck at Sarpi border crossing point. In the nearest future the control on customs will become

February Mr. Ivanishvili met with our Prime Minister Erdogan during his visit to Turkey, where they discussed all existing problems. I think that the relationship between Georgia and Turkey are an example for other countries and that these relations will continue to improve. For example, do you know any other neighboring countries whose citizens can visit each other's countries without foreign passports, and instead with just an ID card? This is a sign of mutual trust. We are going to continue to strengthen these already good relations both economically and politically. The Georgian side thinks in the same manner and I am sure that political, economic and cultural, relations between our two countries will develop and improve.

Yes there is. Seven universities of Georgia are teaching Turkish studies and the Turkish language. Great interest in Turkey can be observed by checking the sheer number of people who passed the border last year: 1.5 million. Georgia Considers Decriminalizing Marijuana

The Georgian government is considering the possibility of decriminalizing marijuana. The majority of Georgians believes that the decriminalization of marijuana will increase its consumption and increase the number of other crimes committed by people under the influence of drugs. Numerous pages calling for the legalization or decriminalization of marijuana have recently sprung up on Facebook, with supporters now planning to hold a rally outside the Georgian parliament building to demand decriminalization of cannabis on June 2.

Marijuana users in Georgia face a year in prison and stiff fines if they are caught with more than two grams of the drug. They also could be sentenced to up to three months of community service.

Such strict measures were first put into force in 2006 after President Mikheil Saakashvili came to power and amendments were made to Georgian law. But

Georgia's new ruling Georgian Dream coalition, led by Prime Minister Bidzina Ivanishvili, is considering taking a softer stance on what is often referred to as the "gateway" drug. Draft amendments to the Criminal Code on this issue have already been initiated by the parliament.

According to MP Eka Beselia, the chairperson of the human rights committee at the Georgian Parliament, a discussion on weakening punitive measures and decriminalizing marijuana use is underway which will be joined by relevant experts and lawmakers. "However, it does not mean that the government is encouraging marijuana use," Beselia commented.

"As far as drugs are concerned, ban-related mechanisms very often produce a ricochet effect, which means strengthening, development in other directions. It is a topic that requires a well-thought out strategy, an element of which could be the legalization of marijuana," stated David Sergeenko, Georgia's Minister of Labor, Health and Social Affairs.

Many countries are current-



ly considering the possibility of decriminalizing marijuana, the minister said. Some of them have already passed appropriate laws, Sergeenko continued.

According to international organizations, currently 4% of the world population smoke marijuana, and there are more opponents of legalization and decriminalization. Their arguments are as follows: marijuana use, especially when prolonged,

harms humans' respiratory and nervous systems. Also, prolonged marijuana use can be addictive. It often leads those who are addicted to explore harder drugs. There is also the fear that if legalized, drug dealers will start to "launder" their profits.

"Just because we are discussing this issue today does not mean that we will wake up one day and see marijuana being sold at supermarkets. Certainly, it

will not happen this way. Discussions should continue," Sergeyenko explained.

Likewise, lawmaker Koba Davitashvili, a member of the parliamentary majority, has proposed that prison sentences for marijuana users be replaced with stiff fines.

"If a Georgian citizen tries marijuana, believe me, they will not catastrophically harm him/ herself and society, but the postroyed," she continued.

"For many years the policy in Georgia has been straightforward and unwavering; it has been aimed at repression against people who are involved in the illicit drug trade – buyers and dealers, but also users," noted Davit Otiashvili, a doctor who specializes in the treatment of drug addicts.

The most important thing here is that the decision on boundary delimitation was not taken by Moscow, Tskhinvali did it," Silaev told GT.

He mentioned that on the one hand South Ossetia tries to dilinate its borders as it is part of establishing an independent state; on the other hand holding negotiations with Georgia is impossible as official Tbilisi doesn't recognize the independence of its former breakaway territories; and finally Tskhinvali wants to show that "in spite of Georgian-Russian relations, negotiations over South Ossetia's independence is out of discussion" and "no one cares what they think in Tbilisi". MGIMO's researcher emphasized that Georgia's indignation is understandable, and the process of "state boundary delimitation" at the same place where the administrative border used to be is a painful and difficult process even when it happens on the basis of bilateral agreements. Nevertheless, Silaev considers Georgia has not yet exhausted all of it diplomat-



ic resources that it could use to influence the situation.

Meanwhile, Paata Zakare-ishvili, Georgia's State Minister for Reintegration Issues declared on May 29 that Russia has captured kilometers of Georgian land since August 2008 and now "we are speaking about 200-300 meters". "Do you want us to declare war with Russia over 200-300 meters? They are crossing the

line which they consider territory that they have conquered. They want to involve the Georgian government in negotiations on where the border lies. It is totally unacceptable to us, as there is no border on South Ossetian territory. There are only separating lines, we won't be involved in this game, from which Russia benefits," Zakareishvili said, emphasizing that Georgia will raise this issue on

all international forums, though it has clearly appeared that the world is helpless against Russia's violent forces. "We have no right to wait for Russia's free-will to leave the Caucasus. If we are a state, we have to take care of our citizens," he stressed.

As it turned out the most difficult was ensuring the safety of local dwellers. During the last week three Georgians were arrested for illegal border crossing. Moreover, one of them was detained on Georgian-controlled territory.

On Friday the 34th meeting under the Incident Prevention and Response Mechanism (IPRM) took place in Ergneti, co-facilitated by EUMM Ambassador Andrzej Tyszkiewicz and OSCE Ambassador Andrii Deshchytsia. The Georgian side expressed concern about increasing fencing activities and the high number of detentions in areas adjacent to Tskhinvali region and, in particular, in the village of Ditsi. In response, South Ossetia's representative Khokh Gagloity said they are running delimitation process and earlier they offered Georgians to cooperate in "borderisation", though Georgians didn't respond, so they started the process on their own and they will not stop it.

However, Georgian President Mikheil Saakashvili believes that it was Russia's provocation and it was oriented at probing the ground – authority's steadfastness and inner unity of the country. At the same time he said, he doesn't

blame new government for the progress of Russian soldiers into Georgian territory and hailed its position being prudent and not succumbing to the provocations of the "big northern neighbour". He offered the Cabinet to work as a team in order to solve the problem facing Georgia.

The situation in Ditsi remains the same: Russians continue erecting fences and drawing the lines of separation. "Some of our dwellers remain on the occupants' territory, refusing to leave their homes which now are at the other side of the so-called border," Zakaria Vatitidze, Ditsi's Governor told GT. As he said, part of the pastures and cemetery are also on the Ossetian-controlled territory.

From June 1, representatives of the Center of Public Initiatives' Union launched rallies in all large Georgian cities against the occupation. Young people plan to gather signatures and send the petition to Georgia's Prime Minister and the international community with a demand to solve the problem.

State Oil Company of Azerbaijan Republic, SOCAR became this year's winner of the XIV annual National **Business Award contest,** organized by media holding The Georgian Times and social and marketing research company GORBI. A title-holder of the best image and the best respondent became the company Smart Retail. In total the award ceremony revealed 25 best companies operating in Georgia.

Traditional business award ceremony held on May 30 in the Marriott Courtyard Hotel was hosted by well-known Georgian journalist Inga Grigolia. She compared Georgia's business environment before and after the change of the government in Georgia, saying that previously entrepreneurs were greeting each other by asking "How's your business going?" and getting in response "I have no business, I have only problems".

"Today there's a new form of greeting: were you released or did you return? Perhaps, many of you experienced this pressure yourself. Despite this you showed that you were stronger than that; and I want to wish you the best of luck," Grigolia said.

For the last three years The Georgian Times and GORBI's business rating was not conducted, as Malkhaz Gulashvili, President of the media holding The Georgian Times, was imprisonment by the previous Georgian government.

'When I was in Gldani [prison] I used to meet so many businessmen there that I started thinking of revealing the best businesses among them. But luckily the October 1, 2012 parliamentary elections turned out the way they did and everything has changed since then. Today our business is free and I am grateful to Mr. Bidzina Ivanishvili who exempted Georgia from this great pressure. Business always needs praises and boosts," he stated, expressing hope that Georgian business will become the engine of the country's economy, raising its GDP and will return not only Georgia's market but also developing new markets with its products.

Merab Pachulia, Founder of Georgian Opinion Research Business International "GOR-BI", explained to the guests the rules of hidden voting in choosing the best company of 2012.



According to Pachulia, Georgia's Finance Minister Nodar Khaduri helped GORBI find out upwards of 150 companies that contributed over 1 million GEL to the state budget. A board of 60 professional experts selected 25 best companies, which were listed in the bulletins distributed among the representatives of those companies. Each firm should sign the bulletins and return it to the award organizers - this would make each document unique and exclude any possibility for cheating. Later the ballots would be returned to the participants of the business completion who would number the best companies from 1 to 25.

"While choosing the companies and filling in the documents experts and participants of today's event were complaining that Georgian business was not developing in a competitive environment during the last years, however, we decided to restore the tradition of holding this award. This was the most transparent election ever held in Georgia and I hope the future presidential election will be just as transparent," Pachulia said, adding that his life-long wish is to live in the country where the five first businessmen would be wealthier than the five first politicians. The head of GORBI is sure

Georgia is on the path of economic recovery. As he told GT, for business development four major factors are needed and Georgia slowly moves towards them. "First of all, despite the aggravated situation around Tskhinvali Region [South Ossetia] today there is no talk about war like there used to be for all this time since Georgia

gained independence. Second, during the last 20 years there was much talk about the embezzlement of state funds by high-ranking officials; today this issue is not on the agenda. Third, the last nine years were marked with repressions of employees who were noticed at opposition's rally; now nothing like this happens. Finally, the fourth factor is freedom of speech, which we enjoy today. No surveys are needed to prove these changes as they are apparent," he emphasized.

Organizers' appearances followed by declaring of the first awardees. There were four winners in the banking sector. CEO of TBC Bank Vakhtang Butskhrikidze was granted with a certificate and praise for investment attractiveness, international recognition, effective PR campaign, team-working tradition and international standards. VTB Bank, represented by CEO Archil Kontselidze, was marked for its dynamics and stability, high credit rating. assistance to small and medium enterprises. Constanta Bank and Tamar Lebanidze were awarded for their support in reviving the agricultural sector, stability of effective management and constant progress. Finally Bank of Georgia was also awarded for its cooperate management, transparency, good quality of service and international recognition.

Seven praise-winners were revealed in consumer sector. Geocell and its Director General Pasi Koistinen were awarded for high social responsibility, non-stop service, creative marketing, public image and charity. Nino Shevardnadze's Goodwill was praised for its 24-

hour service, public image and consumer choice. Popularity, immense budget contributions, quality guarantees, high technologies, new working places, charity in education and healthcare – these are the reasons that helped SOCAR Energy Georgia's and its Director General Mahir Mammedov to be awarded. For its reputation and providing pure water was praised Georgian Water and Power company and Besik Vashakashvili. The experts also emphasized FlyGeorgia's reasonable rates, comfortable and safe flights and effective public image management awarding to Bijan Mougouee, Chief Executive Officer. Gas Energy and its Director Giorgi Koiava got the price for business reputation, social responsibility and investment attraction. Wissol Group and Smart Retail widen the list of the best companies of the consumer sector. Among the leaders of Geor-

gian beverages were producers of mineral water, beer and wine. Nabeghlavi met experts' approval for its high economic strategy, standards and public recognition for the revival of the field it works in. Natakhtari, headed by Mehmet Kochak was named the best company for effective advertisement, management, new technologies and for being Georgian customers' choice. Brewery "Zedazeni" (Georgian Beer Company) was recognized as the largest employer company, which was also marked for its significant contribution to Georgia's economy. Sarajishvili company was awarded for its popularity abroad, having old tradition and new technologies, popularizing national brand and

GeoPlant's Gurieli Tea and Agara Sugar won the nominations of "Best National Products" - the first - for being successful exporter, for meeting high ecological standards and rebirth of the sector; and the second – for being the largest taxpayer and providing an ecologically pure product.

Pharmaceutical sector also was presented by two companies: Paata Kurtanidze's "Aversi" and Gocha Gogilashvili's "PSP Group". According to experts choosing the best companies, both enjoy public confidence. The heads of the firms were also awarded by Founder of Georgian Times media holding Malkhaz Gulashvili for Permanent Support. "These people have never left the holding throughout our difficult times. I am grateful for that," he said.

Seven more companies were awarded, including communications network operator "Akhali Kselebi" - Akhteli", building company "Orbi Group", "Integrated Georgian Systems", Georgian Service Group_2007", wine-producing company "Qimerioni", "Petra" and "Caucasus University".

On the Kamara's initiative, a special posthumous praise for the contribution made in setting Georgian business free was handed to Badri Patarkacishvili's mother Natela Patarkatsishvili. "My son was raised from death. He was such a per-

son who deserved this praise. I would like to thank Mr. Malkhaz Gulashvili and Nana Gagua for that," Natela Patarkatsishvili mentioned.

During the awarding ceremony journalists were asked to choose the best respondent among the firms listed in their blanks. The company Smart Retail, a subsidiary of the Wissol Group, gained the victory in the hidden voting. The praise was handed to Levan Pkhakadze, Vice President of "Wissol Group".

After announcing all the awardees of the XIV business rating the long awaited process started: representatives of the 25 companies had to choose the best among themselves. While they were filling in the bulletins the guests' attention was drawn to the stage again but this time for musical performances.

GORBI's specialists didn't take much time to count the voices. The winner was declared but nobody was surprised with the result: the majority agreed with the choice of the businessmen – SOCAR Energy Georgia and its Director General Mahir Mammedov.

"To tell you the truth, while sitting here I had this thought in my head, I waited for the victory. It's very pleasant to us to win this award after six years of operating in Georgia. During this time we were the largest taxpayers in Georgia, but now it is our triumph. This is the mother of all nominations. We are glad to be the best company in Georgia and what is more pleasant is Malkhaz Gulashvili's return," Mammedov told GT.

Georgia Considers Decriminalizing Marijuana

"As a result, drug users have disappeared from the streets. Part of our society has calmed down because of this and they approve of the current situation. On the other hand, the root of the problem hasn't disappeared or even been reduced," declared Otiashvili. "Thousands of people have been locked up in prisons

They've been isolated and those who have not been caught have gone underground," he added.

Meanwhile Bacho Tsomaia, one of the organizers of the June 2 rally asserts that the main goal of the demonstration is to protect individual rights and freedom of choice. "We do not want to promote cannabis, but criminal penalties for marijuana use should be abolished" he explained.

Supporters of this approach also have their arguments. According to them, marijuana is not addictive, as



are other drugs and alcohol too. It doesn't cause death, as alcohol consumption often does. For example, in the U.S. alcoholism results in of 20,000 deaths annually, but not a single death has been attributed to marijuana use. It is largely thought that legalization of marijuana will increase the number of consumers, but this will occur only initially. Moreover, while Marijuana decreases efficiency, this can happen due to many other reasons as

"I think that at some point this process will become the international norm," Otiashvili said, adding that "sooner or later, Georgia will have to comply with this trend."

This isn't the first time that there has been talk of decriminalizing and legalizing marijuana in Georgia. In 2005, the head of the Georgian Council for Drug Policy, Tamara Sirbiladze, called for marijuana legalization, saying it could "reduce the number of drug-related

Draft Changes Prepared in the Constitution **Regarding Dual** Citizenship

Draft changes have been prepared in the Constitution regarding dual citizenship. According to Zviad Dzidziguri, Vice-speaker of Parliament, initiatives regarding the changes will be presented in the nearest future. "There are many problematic issues that were left in the constitution by the former government. One of them is the issue of dual citizenship. I think those are issues requiring attention and timely correction. Initiatives referring to those topics will be presented soon," mentioned Dzidziguri.Based on the current Constitution, the state is liable for setting the limitation on the political activities of foreign citizens or citizens having no citizenship. A citizen obtaining citizenship of another country may not hold the positions of President of Georgia, Prime Minister and Parliamentary Speaker. In addition, last year, after current Prime Minister Bidzina Ivanishvili entered politics in 2012, an unprecedented norm was included in the Constitution of Georgia by the initiative of the Christian Democrats party, which was endorsed by the ruling UNM party at the time. Specifically, supreme law specified that prior to January 1, 2014, Georgian citizens of the required age, who are born and live in Georgia for the last 5 years, and have citizenship of an EU member state, have the right to participate in the parliamentary and presidential elections and the right to vote. In this case the Constitution does not refer to those citizens holding dual citizenship and it limits the right of being a President, Prime Minister and Parliamentary Speaker.
