President Zourabichvili's Remarks on China's Activity in Georgia and the Need for Western Involvement in Infrastructure Projects

During a discussion at Chatham House, the President of Georgia, Salome Zourabichvili, remarked on China's increasing activity in Georgia, expressing uncertainty about the implications of the 'strategic partnership'. She stated, "Now we are in a 'strategic partnership', don't know what that means, don't ask me."

Zourabichvili also noted that China is heavily involved in infrastructural projects. Consequently, Georgia requires increased involvement in largescale infrastructural projects from its western partners.

Salome Zourabichvili also addressed the Anaklia port project, emphasizing its essential significance. She highlighted that the security of the Black Sea impacts everyone globally.

"China is becoming more active in Georgia. This has happened in the last few years, but it has become more and more active. Now we are in a 'strategic partnership'; I don't know what that means, so don't ask me. We also got a visa-free regime with China yesterday.

In addition, China is active in many infrastructure projects in



Georgia because it is cheap, does not respect many laws and labor rights, but this is also because our western partners are less involved. Perhaps we need more in-

volvement from Western partners in large infrastructure projects.

One of them is very important, and it is an issue that I have not yet touched upon - the

port of Anaklia. It is of essential importance since the security of the Black Sea is an issue that will probably concern us all in the future. Georgia's coast on the

Black Sea is of essential importance so that Russia does not have exclusivity on Black Sea cooperation, trade, etc," Zourabichvili stated.

Papuashvili Accuses Opposition Parties of Establishing Scheme with Fake NGOs for Illegal Foreign Donations

The Chairman of the Parlia ment, Shalva Papuashvili, accused opposition parties of receiving illegal donations from abroad, stating that receiving funding from abroad in an election year is equivalent to interfering in the elections.

Papuashvili stated that opposition parties in Georgia have set up a scheme involving fake NGOs to receive illegal donations, with a significant portion of the opposition being directly financed from abroad. He emphasized that foreign interference, whether from Russia, the European Union, or the USA, undermines the election process in Georgia. Papuashvili called on donors involved in hidden schemes, citing the European Endowment for Democracy (EED) as an example, and urged the European Union and the European Commission to intervene to ensure fair elections. He stressed that stopping direct financing of parties from European channels is crucial to prevent election interference.

"Opposition parties have created a scheme through fake NGOs to receive illegal donations. Besides, in addition to these illegal donations, we are talking about financing from abroad. In fact, what we are observing, as it turns out, is that a large part of the opposition is directly financed from abroad. Taking into account that it is an election year, this is equivalent to foreign interference in the elections.

Foreign interference is one of the expected threats in these elections, primarily originating from Russia. However, I want to emphasize that regardless of where the intervention occurs-whether from within Russia, the European Union, or the USA - any interference constitutes meddling in the election process of the Georgian people and mirrors Russian tactics.

Once again, I call on donors who are involved in a hidden
