## State Agency for Religious Issues Condemns Adigeni Incident

On March 8, a religious conflict erupted in Adigeni, Georgia. Dozens of people gathered in Adigen township, preventing Muslims from praying. The Batumelebi publication released a video from the location, showing citizens, including clergymen, gathered near a house. In the video, they verbally abuse the resident and demand that he leave.

The State Agency for Religious Issues issued a statement regarding the developments in Adigeni. In the statement, the Agency condemns the use of religion and belief for narrow interests. It also calls on Muslim and Christian religious leaders not to follow the provocation and to work within their congregations to prevent the tension surrounding the incident from spreading further.

"For the Agency, any deliberate destruction is unacceptable, and it condemns the use of religion and belief for narrow interests. The agency does not welcome violence and hopes that the issue will be resolved as soon as possible. Freedom of religion and belief is protected in Georgia, and this has been repeatedly acknowledged by high-ranking individuals working on religious issues in Georgia's partner countries.

# EU Delegation in Georgia Issues Statement on Brussels Meetings with Zurab Adeishvili

The Delegation of the European Union to Georgia released a statement regarding the meetings held at the European Commission in Brussels with the participation of Zurab Adeishvili, the former Minister of Justice and Prosecutor General of Georgia, and the Prosecutor General of Ukraine, Andriy Kostin. Zurab Adeishvili has been accused of committing multiple crimes and has been found guilty of some of them in Georgia.

The EU Delegation has clarified that Gert Jan Koopman, Deputy Director-General of the Directorate-General for Neighbourhood and Enlargement Negotiations, regularly engages in meetings with representatives from diverse regions, including Ukraine.

The statement highlighted that any misrepresentation of Koopman's recent meeting with the Prosecutor General of Ukraine would be classified as disinformation. Furthermore, the statement emphasized that combating disinformation aimed

On the International Women's Day, we celebrate the accomplishments and contributions of women around the world, including in Georgia. We reaffirm our commitment to achieving gender equality and empowerment of all women and girls.

At a time when the world is facing many crises, achieving gender equality is more vital than ever. Despite progress over the last decades, full equality is clearly off track. Globally, at the current pace of progress, achieving full legal equality may take up to 300 years.<sup>1</sup>

In Georgia, women spend five times more time on unpaid domestic and care work than men.<sup>2</sup> This prevents women from pursuing their own professional success and from participating in political and public life. Women's economic activity rate

(41.5%) lags significantly behind men's (64%).<sup>3</sup> Nearly half of women aged 25-34 are not working. Thousands of women have migrated to support

their families through remittances. Violence against women and girls remains one of the most pervasive human rights violations. Women's voices are often excluded from political participation and decision-making. Despite the implementation of mandatory electoral gender quotas, women in Georgia hold only onefifth of parliamentary seats and one-fourth of local council seats. Fifty-four percent of women candidates in Georgia have experienced physical, psychological, economic, or sexual violence and harassment during their election campaigns or political careers.4

To build stronger, fairer societies, we must ensure that the rights of women are safeguarded and promoted, that women have

an equal seat at the table and an equal voice and agency in economic, political and social life. Public and private investments are needed to drive women's inclusion across all sectors of the economy and to actively address all forms of discrimination and violence against women and girls. Ensuring decent work for all women, including by closing gender employment gaps, ensuring fair wages, and formalizing women's informal work could significantly boost Georgia's economy and lift women and their families from poverty. More support is needed for forcibly displaced women who have shown great resilience and taken on leadership roles in seeking solutions for their communities.

We hope to see strong, meaningful commitment by all political parties to gender equality and women's political and economic empowerment. We especially emphasize the urgent need to take concrete steps to eliminate violence against women in politics and strengthen efforts in combatting sexist hate speech

against women politicians and women election officials. We must also support women's rights organizations fighting against stereotypes and battling to make women's and girls' voices heard.

On this International Women's Day, let us all join forces in building inclusive communities and societies with the full participation of women and girls of all backgrounds.
