Central Election Administration Reports Alleged Pressure on Employees and Illegal Use of Personal Data



The Central Election Administration spoke about alleged pressure on employees and attempts to illegally use their personal data. However, the CEC did not specify the cases under discussion, although it stated that information would be provided to international partners.

"It seems that the targeted discrediting campaign of the election administration of Georgia and its employees is moving to a new stage. Unethical attempts to obtain and use their personal information, allegedly dishonestly, including attempts to intrude into the personal lives of election administration employees and obtain personal information from them, have been recorded," the statement reads.

The CEC noted that such campaigns and efforts aim to "overshadow and depreciate the significant progress" achieved recently. They view this as psychological pressure on election administration employees, hindering their professional activities. It remains unclear which campaigns the election administration is referencing.

"The election administration will use all legal means to prevent violations of its employees' rights, intrusion into their personal lives, and the unlawful dissemination of personal information.



The employees of the administration will continue their activities in accordance with the law and with dignity to ensure the elections are conducted at a highly professional level. The election administration will continue to uphold the legal interests of its employees, and it will take all measures provided by law to address any violations of these interests. This includes

informing all international partners of such violations."

The CEC expressed concern that certain individuals or groups in the country are prioritizing personal or party interests over the broader goal of enhancing the election process. The CEC urged all parties to adhere to ethical and legal standards, emphasizing the importance of conducting the 2024 elections in

line with international standards, as the elections are a matter of collective concern and responsibility.

"Today, with Europe focusing on establishing high standards for the reputation, activity, and image protection of election administration employees, some parties in our country are acting based on narrow personal or partisan interests. This behavior hinders the crucial process of election modernization and damages the electoral environment. We urge everyone to adhere to ethical and legal standards and not obstruct the 2024 elections from proceeding in line with international standards, as these elections are a matter of collective concern," the CEC stated.

DRI Reports Alleged Russian Truck Traffic Crossing Enguri River

The Democracy Research Institute reported, according to their sources, that last week

there was allegedly active truck traffic with Russian license plates observed crossing the Enguri River into Georgia and back, specifically in the Gali re-

gion.

"Some cars were escorted to the Enguri Bridge by vehicles from the State Auto Inspection, also known as GAI, of the de facto



Ministry of Internal Affairs of Abkhazia. Additionally, trucks crossed the 'border' checkpoint after 7:00 PM Moscow time, following a ban on movement imposed by both the Russian and Abkhaz sides, primarily affecting residents of the Gali region.

Abkhazia de facto and Russian security services are searching local residents to confirm that they did not capture the movement of these trucks on photo or video material," DRI statement reads.

Democracy Research Institute stated that the meeting between the first deputy speaker of the Georgian Parliament, Giorgi Volski, a leader of the Georgian Dream, and businessman Davit Khidasheli, who has close ties to the Russian government, as well as the subsequent disclosure of their conversation details in the Georgian media, reignited concerns about why the Georgian

authorities are turning a blind eye to the movement of cargo to and from Russia through the territory of Abkhazia, which is occupied.

"The leaders of the Georgian Dream may present this negative trend as indicative of the rise of the Georgian economy through increased freight turnover with Russia, or perhaps as a policy aimed at integrating Abkhazia into Georgia. However, common sense prompts us to consider how willing Russia, and even more so its satellite Abkhazia's de facto government, would be to prioritize Georgia's interests.

Obviously, the only logical conclusion here is that the political power in Georgia is guided only by its narrow interests when cooperating with Russia. In this context, a rhetorical question arises: how different is the policy of the Georgian government from the de facto government of Abkhazia, which it labels as a proxy regime of Russia?" DRI stated.

She added that in April, once Ukraine fulfils the conditions agreed, the EU will make a second disbursement of the bridge financing of Euro 1.5 billion.

As a next step, the Commission will now swiftly assess the Ukraine Plan and submit a proposal for a Council of the European Union implementing a decision to approve it as conditions to access regular payments.

The Ukraine Facility of up to Euro 50 billion will provide stable and sustainable financing to support Ukraine's recovery, reconstruction, modernisation, including key reforms necessary on its $EU\ ac$ cession track for the period of 2024-2027. This amount is composed of up to Euro 17 billion in grants and up to Euro 33 billion in loans.
