T bilisi Municipal Inspection has started dismantling 12 illegally constructed residential buildings in the Africa settlement in Tbilisi, which has led to a confrontation between the local population and law enforcers.

As a general inspection claims, the reason for the dismantling is building on the state-owned territory without the permission of construction. The people whose building is being dismantled say they have applied to the City Hall for legalization, but the inspection started the dismantling process without any warning

Several days ago, the Human Rights Education and Monitoring Centre called on Tbilisi City Hall not to start the deconstruction of the illegally constructed buildings as the locals living there will be left without shelter.

The situation on the ground became tense several times. Residents of nearby buildings confronted the law enforcers. Police arrested 8 people during the confrontation. According to the Ministry of Internal Affairs, they were arrested on charges of petty hooliganism and disobeying a lawful request of the police.

Residents of Africa have been protesting against the dismantling of the buildings. According to them, most of the buildings' residents are socially vulnerable and their houses have been built without permission, and in some cases, the City Hall has decided to legalize it.

Regarding the Africa settlement, Mayor Kahkha Kaladze announced that no one lives in the houses that were dismantled:

"These are the people who have houses, these are the people who have lands, and so on. This is a deliberate seizure of land. I do not rule out that there may be some forces behind this that are benefiting from an action is carried out anywhere, it should be prevented," Kaladze said at a briefing yesterday.

Hereby, Kaladze emphasized the decision that 350 million will be the 2021 budget precisely in the direction of social and healthcare.

It was also noted that in recent years, citizens who have real estate in the regions, as well as some others in the name of others, have started illegal construction on state lands in Tbilisi.

"We have a reasonable suspicion that we are dealing with a fraudulent scheme backed by certain individuals who are pushing citizens to break the law in or-



"We declare with full responsibility that not a single building that was subject to dismantling was completed and no one lived in it," said Mayor Kaladze. such decisions."

Kaladze assures that as long as he is in charge, he will in no way allow the misappropriation of state property. "And for those who do not have a home, there is a shelter, half of which is empty."

"We provide everything. The second option is that people who have a certain problem, are having their house demolished or so on, the boards will allocate money for them, we can rent these families houses so that they do not stay on the street," he said.

The mayor emphasized that although the municipal inspectorate had warned the offenders several times, both verbally and in writing, unfortunately, there was no response to the warning.

"The principled position of the state is that land grabbing and illegal constructions should not be allowed and if such der to obtain economic benefits," the mayor said.

According to Kaladze, Tbilisi City Hall will provide all the materials to the relevant agency to start the investigation of the case.

Public Defender of Georgia Nino Lomjaria responded to the dismantling of a residential building in the African settlement of Samgori district.

As Lomjaria noted in her Facebook post, the demolition of the house is related to the risks of homelessness, which raises the need for the state to assess the method. If necessary, they should take supportive measures and provide appropriate shelter. She spoke of the challenges that shelters are facing and emphasized that the implementation of dismantling

The UNM head Vashadze leaves the party



"I disagree with the recent tactics or the UNM leaders that have been chosen without consultations with party members, as well as the absence of a party strategy. There are odious figures in and around the party who are the part of the past and will never be able to regain the public truth."

Trigol Vashadze, Chairman **T**of the United National Movement, Georgia's largest opposition party, announced on December 15 about leaving the party as well as stepping down from all held positions.

He wrote in his Facebook post that there are aspects to the party that he would categorically not tolerate. Vashadze said he does not agree with tactics chosen by the majority of the UNM leadership without consulting party members, and that the absence of a future strategy is even more unacceptable to him.

Vashadze expressed concerns over 'the campaign of attacks and insults' against the chiefs of diplomatic missions of strategic partner countries that were launched 'unclear by whom and why'. Vashadze considers such moves as damaging to Georgia's relations with the western partners. According to him, it creates impressions that creators of this campaign have never heard that attacking an ambassador equals attacking a state they represent. "This is the state which has been guarding Georgia state and its territorial integrity since the day it regained Horoby

Vashadze apologized to Georgia's partners.

Before this announcement, Nika Gvaramia, the director of Mtavari Arkhi TV criticized western diplomats, including facilitators of the recent postelection talks between the opposition, that boycott election, and the ruling Georgian Dream party.

On December 15, the night before Vashadze's decision was known, the UNM leader and former Georgian President Mikheil Saakashvili criticized German Ambassador Hubert Knirsch over his opposition-critical remarks, questioning his qualification.

Politicians from both the ruling party and the opposition reacted to Vashadze's decision. members Roman UNMGotziridze and Salome Samadashvili have praised Vashadze's chairmanship of the party, stating that he has made the party stronger in the past 3 years. On the other hand, UNM member Khatia Dekanoidze said that Vashadze's claim on attacks on the diplomatic corps was wrong, as well as his decision to leave the party without consulting with its members first. She criticized the chairman for quitting with a sole statement and

sion proved that "there are differing opinions in the opposition," including varying views over the current opposition tactics.

MP Irakli Kobakhidze, executive secretary of the ruling Georgian Dream party also commented on the announcement, saying that political processes unfold 'in the right direction.' He noted that the "so-called odious figures" are dissolving [United] National Movement and European Georgia.

Parliament Speaker from the ruling Georgian Dream party Archil Talakvadze stated that the 'reasons named by Vashadze behind his resignation are a deadly diagnosis for the UNM.'

MP Mamuka Mdinaradze assessed Vashadze's decision as to the sign for UNM's dissolution:

"When the chairman of the party leaves the party for specific, declared or hidden reasons, it is one of the preconditions for the party's dissolution."

The leader of the Georgian Dream Tea Tsulukiani described Grigol Vashadze as a positive figure after leaving the National Movement and said that he was acting in the interests of the country. According toTsulukiani, she met Vashadze for the first time during the signing of the March 8 agreement with the opposition. According to the leader of the European Georgia, Giga Bokeria, it is noteworthy that Tsulikiani praised Grigol Vashadze. "It seems that a good opposition for her is an opposition member who leaves politics."

The US Ambassador to Georgia Kelly Degnan commented on Vashadze's resignation as well, saying he is an outstanding person with a long and impressive career in the service of his country

The UNM Chairman first confronted his party soon after

the elections, when he called for moving street protests to the negotiations table, implying a possible end of boycott that was announced by all major opposition parties following legitimacy concerns of the parliamentary polls. Other members of the UNM said that "the statement is Vashadze's personal opinion which was not agreed upon with" them. While the members of other opposition parties who took to the street following the October 31 parliamentary elections, said that Vashadze's statement was 'unexpected and confusing.'

Grigol Vashadze, a former Soviet diplomat, served as a Foreign Minister under the UNM government. He was the 2018 Presidential candidate and was elected as the party chairman in March of 2019, replacing Saakashvili. In the October 31 parliamentary elections, Vashadze ran as a majoritarian MP candidate for the Kutaisi constituency. The UNM garnered 27,18% of votes and 36 MP mandates which the party intends to reject.

Team Europe: EIB and Bank of Georgia expand credit line for SMEs and mid-caps with €25 million to aid recovery from COVID-19 pandemic

The EIB will top up its existing credit line at the Bank of Georgia $\pounds 25$ million to a total of $\pounds 75$ million to support the recovery of Georgian SMEs from the pandemic, extending coverage to include mid-caps.

The operation is part of the Team Europe's COVID-19 emergency response to help sustain jobs, maintain liquidity and operations, and fuel the economic recovery of Georgia.

Since 2007, the EU bank has invested close to £2 billion in all key sectors of the Georgian economy, including connectivity, healthcare and SMEs.

Five opposition parties had their party lists annulled by the Central Election Commission today

Following the memorandum and official request of Georgia's five opposition parties, the Central Election Commission (CEC) has annulled their respective party lists. This means that the candidates of European Georgia, United National Movement (UNM), Lelo for Georgia, Strategy Agmashenebeli, and the Labour party will not be able to replace the MPs who refused to claim their mandates after the October 2020 Parliamentary Elections. Opposition parties refuse to recognize the election results on the grounds of alleged falsification and demand for the elections to be repeated.

The memorandum was not signed by Girchi and Alliance of Patriots, which each won a total of 4 seats, as well as Aleko Eliashvili's Citizens (two seats) and the Republican bloc of the UNM. Moreover, 8 out of 14 parties that won at least 1% of the votes during the October Elections, have already requested the annual state funding.

The 10th Parliament Session was held on December 11, and no opposition parties attended. The International Society for Fair Elec-



tions and Democracy (ISFED) has adjusted its parallel vote tabulation (PVT). According to the new figures, the United Opposition bloc received 1% more votes and the ruling Georgian Dream party received 1.8% more votes. The ruling party responded by pointing out another severe mistake in the NGO's data, namely the initially reported imbalance between the number of ballot papers and regis-

The country remains in a de facto one-party state, and the political crisis is yet to be resolved, despite the significant efforts of the diplomatic corps to hold negotiations between the ruling party and the opposition bloc. On top of calling for the new elections, the opposition demands large-scale electoral reform (including the country's Central Election Commission), as well as the immediate release of the political prisoners: Iveri Melashvili, Giorgi Rurua, and Natalia Ilichova.

In turn, the ruling Georgian Dream party stated that they will be willing to repeat the elections if the temporary investigative committee, created by the 10^{th} convocation of the Georgian Parliament finds any evidence of the violation of the proper conduct of the October elections. Georgian Dream's Executive Secretary, Irakli Kobakhidze went as far as to claim that he is so confident that not even 0.1% of the ruling party's votes were rigged, that, if the opposite turns out to be true, he will be willing to quit politics altogether.

The current political crisis is unfolding amidst the second wave of the COVID-19 pandemic, which leaves the country especially vulnerable to both external and internal threats.
