On Saturday, April 18th, the ruling Georgian Dream party agreed to sign the agreement which was first proposed by the EU mediator Christian Danielsson. The newly signed agreement addresses issues such as the large-scale reform of the judicial and electoral systems as well as the amnesty to the individuals whose had cases launched against them in relation to June 2019 protests in Tbilisi – including the opposition leader Nika Melia, who currently remains in detention.

Following the signing of the document, speaker of the Georgian Parliament and member of the ruling Georgian Dream Georgian opposition refuses to sign the EU-proposed agreement despite repeated calls from the country's Western partners. Hartzell renews the document

party Archil Talakvadze stated that by doing that, ruling party showed its high degree of responsibility, and added that it was now the opposition's turn to show that "it can put the interests of the state above their personal interests".

A number of the country's opposition parties have already rejected the possibility of signing the agreement along with the ruling party. Member of the United National Movement party Koba Nakopia stated that while the chairman of the UNM remains in detention following his 'illegal' arrest, "no agreement with the Georgian Dream is possible." Nakopia added that Melia should not only be let free but should also participate in the process of negotiations with the ruling party. As of right now, the opposition Girchi- More Freedom, UNM, Lelo for Georgia, European Georgia and Strategy Agmashenebeli have already refused to sign the agreement proposed by the EU. In response, the chairman of the ruing Georgian Dream party Irakli Kobakhidze told Imedi TV that the opposition's decision is "illogical but expected":

"It's illogical [for them] to refuse [signing the agreement], but it was probably expected, given that, unfortunately, the opposition very often takes illogical steps."

Meanwhile, in order to help bring the ongoing crisis to the conclusion, several

high-ranking Western politicians have already called for all MPs to sign the agreement. The Spokespeople of the High Representative of the European Union and Vice-President of European Commission as well as the United States Department of State, in their statement urge the parties to sign the agreement drafted by the President of European Commission Charles Michel and address the needs of Georgian people:

"After nearly six months of negotiations, the citizens of Georgia have made clear that they want the political stalemate to end, and for all elected Members to work together in Parliament and address the serious challenges facing the country, including the regional challenges, COVID-19, and the economic crisis. With this in mind, we call on all Members of the Parliament of Georgia to sign the agreement that President of the European Council, Charles Michel, will



propose today", the statement reads.

Earlier today, in another attempt to assist Georgia out of the political crisis, the head of the EU delegation to Georgia Carl Hartzell proposed a renewed version of the agreement which accommodates one of the oppositions main demandssnap elections. According to the renewed document and based on the ruling party's previous offer, the early parliamentary elections will be held in 2022 if the ruling Georgian Dream party fails to obtain 43% of votes during the self-government elections of October 2021. With an updated version of the agreement in hand, Carl Hartzell stated that the mediators are now "looking forward to convincing political parties to with the view to finalising this process as a way forward and end Georgia's current political crisis."

The National Center for Dis ease Control and Public Health published a statement regarding vaccination in the country. According to the statement published by NCDC, more than 8,000 people have registered for their second dose of Pfizer.

However, on the first day of registration, a number of people who wanted to register for their second dose of the Pfizer vaccine, weren't able to do so.

According to NCDC, they were not able to register as the system was overbooked. "Some of the technical issues are connected with the pause of vaccination from 30.04 to 3.05 due to the Easter holidays," reads the statement of NCDC.

NCDC also noted that for evervone who has received the first dose of the vaccine, there is a second dose set aside for them.

The director of the National Center for Disease Control and Public Health Amiran Gamkrelidze has recently discussed the vaccination process in the country. He noted that there are talks with several developers, such as Sinopharm, Novavax, and Pfizer. Gamkrelidze noted that the decision was made to open a registration website for the Sinopharm vaccine on April 27 for the vaccination process to start on May 4. According to him, the country has 100,000 doses of the Sinopharm vaccine, which should be enough to vaccinate 50,000 people. Further talks with Sinopharm envisages additional 500.000 doses of the vaccine.

As for Noavavax, the country has a contract with the company for as much as one million doses, which should arrive in the country around July-August. The country is considering buying one million doses of the Pfizer vaccine.

Gamkrelidze noted that all of this is happening behind the Covavax platform, from which, the country should receive 1.4 million doses. From the platform, Georgia has already received 43.000 AstraZeneca doses and 29,000 Pfizer doses. Additional 86 thousand AstraZeneca doses should arrive in the country near the end of April.

Health Minister Ekaterine Tikaradze stated that around 24,000 people have already received the Covid-19 vaccine.

In total, Georgia has reported 295,358 cases of coronavirus, and 3939 have died. On Sunday, 818 new cases were reported.

Person responsible for hostage-taking and attempted robbery of Bank of Georgia to remain in pre-trial detention

he man who, on Friday, April 16, attacked the Bank of Georgia branch near the Avlabari metro was sentenced to remain in pre-trial detention, as per the Tbilisi City Court ruling. The defense of the accused reportedly requested a bail of 30,000 Lari, however, its motion was denied.

On Friday, 28-year old man named Nikoloz Tsurtsumia broke into the Bank of Georgia near Avalabari metro and took seven people hostage. As a result of negotiations carried out by the Ministry of Interior employees, an hour later all hostages were released, and the attacker was arrested.

In its official press release, the Ministry of Interior states that Tsurtsumia will be charged for the possession of the firearm and hostage-taking:

"The Ministry of Internal Affairs detained one person - N.Ts. (DoB 1993) - for attacking one of the branches of the Bank of Georgia located in vicinities of Avlabari metro station, Tbilisi as well as for taking hostages and illegal possession and carrying of a firearm.

The investigation established that the armed offender broke into one of the branches of the Bank of Georgia located on Dusheti Street, Tbilisi and took 7 people as hostages.

Relevant police units were mobilized at the scene and operative-investigative measures have been launched.

As a result of negotiations between the representatives of the Ministry of Internal Affairs and the attacker, the accused person gradually released citizens from illegal captivity, after which the law enforcers arrested N.Ts. at the place of crime. In the course of the incident no one was iniured.

Investigation is in progress on the fact of the attack, hostagetaking and illegal possession carrying of a firearm- crimes envisaged under articles 144, Part II, Subparagraph C and 236, Part III and IV of the Criminal Code of Georgia", read the official statement.
