State Inspector Appeals Law Abolishing State Inspector's Service in Constitutional Court

eorgian State Inspector Londa Toloraia has filed a constitutional complaint with the Constitutional Court appealing the law abolishing the State Inspector's Service and replacing it with two new agencies.

Toloraia said her appeal requested an immediate suspension of the appealed norms before the Constitutional Court makes a final decision on the case, claiming that the enactment of the disputed norms will lead to irreparable conseguences for the State Inspector. According to the legislation, adopted on December 30, 2021, the State Inspector's Service will be abolished from March 2022 and the new agencies will be formed instead.

According to the Georgian Young Lawyers Association (GYLA), Toloraia was appointed State Inspector by the Parliament of Georgia on July 3, 2019, for a term of 6 years, however, under the disputed norm the authority of Toloraia was terminated after 2 years and 8 months. GYLA notes that the new law contravened Article 25 of Georgia's Constitution, according to which "every citizen of Georgia has the right to hold any public position if they meet the requirements established by law."

According to the Constitutional Court of Georgia, to terminate the term of office of state officials, it is necessary to have an increased public interest following the requirements of the Constitution. As Toloraia notes, the lawmakers will have

terest in restricting Article 25 of the Constitution.

to present proof of legitimate public in-

The Parliament of Georgia named the conflict of interests as the basis for the expedited dismissal of the State Inspector. According to Toloraia, the MPs have not also proved that there was indeed a conflict of interest in the State Inspector having assumed both investigative and data privacy protection mandates and even if there was such a legitimate reason, Toloraia believes that she should have been allowed to continue working as head of the Personal Data Protection Service or the Special Investigation Service until her term ends.

The ruling party claims that the replacement of the State Inspector's Service with two new agencies will strengthen the body and add functions to it, noting that the authority of the State Inspector's Service 'has been broadly expanded'. The selection commission for choosing the chairpersons of the newly established bodies has been formed and began working on Monday.

The MIA has arrested 2 police officers involved in a physical assault on the person with disabilities, charging them for the violent attack. Giorgi Gamezardashvili, Deputy Head of the State Inspector's Office, said two officers had been arrested following the prompt investigation announced by the ministry late on Monday after the footage aired on television channels and was posted on social media.

"On January 24, 2022, based on the information spread through media, the State Inspector's Office immediately launched an investigation. Witnesses were questioned, including the victim, who was questioned in the presence of a psychologist," Gamezardashvili said.

The investigators said the disabled minor and his brother had been approached by the police in the Isani subway station on Sunday evening, with the 17-year-old taken to the police staff room at the station, where one of the officers repeatedly punched the minor in the head. The assault continued despite the juvenile indicating he was disabled and could

not understand the officer addressing him throughout the arrest and the subsequent attack. It was noted that the deaf adolescent has received injuries to his head and face as a result of the assault.

The assaulting officer has been charged with 'degrading or inhuman treatment by an official against a minor, through abuse of official authority, with his colleague facing the charge of abuse of official authority after failing to report the assault. The crime, under Article 144.3 (2a, 2b, 2g) of the Criminal Code is punishable by a prison term of 5 to 10 years, and possibly with deprivation of the right to hold any office or carry out activities for up to 5 years and with restriction of the rights to carry weapons.

The offense, under Article 332 (1) of the Criminal Code is punishable by a fine, house arrest for 6 months to 2 years, or by imprisonment for up to 3 years, with deprivation of the right to hold office or to carry out activities for up to 3 years.

Vice President of the Deaf Union Maia Metonidze states that the juvenile beaten by a policeman in the metro is being examined.

Metonidze notes that a sign language translator is involved in the case.

'This is a cause of great outrage in our community with a very great emotional background. We try to provide as much information as possible to these people. As you know, the environment is not fully adapted, ie it is difficult for all members of society to obtain information. In terms of awareness-raising, training has been conducted and important issues have been resolved, but there is a constant need for awareness-raising, as you know that the responsible persons in the public institutions and various institutions are changing accordingly.

A protest action 'No To the Militia' took place yesterday in Ortichala, in front of the building of the Ministry of Internal Affairs, organized by the members of the party 'Droa' and the representatives of the youth organization 'Lelo'. They protesting against the violence in the metro station. According to them, the incident is not a single case and indicates a problem in the system.

The incident also spurred a protest rally outside the ruling Georgian Dream party headquarters and the MIA building on January 24.

The local watchdog, Social Justice Center, stated that the attack 'cannot be an isolated incident,' adding that such practices demonstrate the closed system and the lacking accountability of the Interior Ministry. According to them, the political elite has yet to carry out substantial reforms aimed at preventing police brutality.

International festival Night Serenades founded by world-famous Georgian violinist Liana Issakadze has been awarded at Georgian Brand Day. The awards ceremony was held at the Sheraton Grand Tbilisi Metechi Palace hotel.

Georgian Brand Day is an annual business ceremony that has been reflecting the ongoing processes in the Georgian market for 19 years, representing national brands on every stage of development and boosting their motivation. The winning companies in different nominations were awarded diplomas and medals at the awards ceremony this year.

International festival Night Serenades, organized by the company Art Alliance, won the nomination Successful International Project. The award was received by Nina Tsagareli, the director of the festival and founder of the company Art Alliance. Tsagareli thanked the founder of Georgian Brand Day, Manana Gegidze, stressing that "holding such an event in today's conditions is tantamount to bravery". The director of the festival also
