# PM Marks 8th Anniversary of Signing **Association Agreement with EU**

marked the 8<sup>th</sup> anniversary of the signing of the Association Agreement with the European Union, calling it a 'historic 10 years.'

According to him, a few tangible outcomes have been achieved by the country since. Firstly, he talked about the free trade agreement made with the EU, through which Georgian entrepreneurs are exporting their goods to the EU without any barriers. The second major achievement is visa-free travel, according to PM. All citizens of Georgia travel to EU countries without visas with Georgian passports, which, according to the PM, is also a tangible result. The third achievement is Georgia's European perspective as recently recognized by European leaders.

As Garibashvili noted, by granting Georgia a European perspective, the European leaders pledged that Georgia will become a member of the EU. The head of the Government stressed the ruling Georgian Dream party had obtained these three 'main achievements' in 'just 8-

Garibashvili also underlined that the process of Association Agreement negotiations was delayed under the previous authorities.

According to the Prime Minister, far-reaching human rights, penitentiary, educational, and science reforms have been implemented alongside those in the areas of innovations, agriculture, transport, public service, energy, and regional development.

"believe that we will receive the [EU membership] candidate status very soon and we will continue to advance and develop our country. This is that real thing that the country has been able to do under our governance", he stressed, adding that on the initiative of the ruling party Georgia's foreign policy was defined as Euro-Atlantic on a constitutional level.

dacy during the consultations. The President of the Court of Appeal shall be elected from among the judges of the same Court. He is appointed to the position by the High Council of Only Justice. Mikheil Chinchaladze applied for the post of the Chairman of the Court of Appeals in the High Council of Justice. He has been holding this position since 2017, and his 5vear term expired in May.

NGOs working on the judiciary and the court of justice called on members of the High Council of Justice not to support Chinchaladze's candidacy, calling him a 'clan member' in court and claiming that it will be harder to attain the EU candidacy status with 'Murusidze-Chinchaladze Clan' ruling the judiciary. A few days ago, Elene Khoshtaria, the leader of the Droa party, called on Georgia's international partners to sanction judges, following the businessmen. 9 judges nominated by Khoshtaria included Chinchaladze as well.

he High Council of Justice L has re-elected Mikheil Chinchaladze as the Chairman of the Tbilisi Court of Appeals for a five-year term. Council members unanimously supported Chinchaladze's candidacy.

Prior to the session, Ana Dolidze, a former non-judicial member of the High Council of Justice, said that the obstacles to Georgia's European integration were the fault of the exist-

Representatives of the civil sector criticized the candidacy of Chinchaladze as the Chairman of the Tbilisi Court of Appeal. Among them is Nazi Janezashvili, a former member of the High Council of Justice. Court Watch, the NGO chaired by her, was studying the process of electing the chairman of the Court of Appeal. Janezashvili announced after the trial that 53 judges of the Court of Appeals supported Chinchaladze's candi-

# Ship with Sanctioned Cargo Leaves Batumi Port

The Revenue Service of the ▲ Ministry of Finance of Georgia disseminated information regarding the ship entering the port of Batumi and the sanctioned cargo it was carrying. According to the service, a Turkish-flagged ship entered the port of Batumi on June 26. During the inspection, it was found that neither the ship nor its owner were included in the list of international sanctions, 'therefore, the ship was allowed to enter the port of Georgia, which was clarified by the Maritime Transport Agency'.

As a result of the inspection, it was determined that the goods placed on the ship were cargo to be sent to Turkey, which was also an oil product sent from a company under international sanctions. Hence, the shipowner was refused to unload the cargo and carry out further customs procedures.

"At the moment, the Turkishflagged ship is leaving the port of Batumi with cargo," the Revenue Service of the Ministry of Finance said.

On June 27, the Minister of Economy and Sustainable Development of Georgia Levan Davitashvili confirmed in a comment to the media in the government administration that a ship whose cargo belonged to a sanctioned company entered the port of Batumi, but the Georgian customs authorities did not approve the cargo.

Initially, information about

the entry of a Turkish-flagged ship into the port of Batumi, which was allegedly loaded with 30,000 tons of vacuum gas from the Russian company Rosneft, was released on Sunday, according to its own sources, by the Main Channel TV. The link to the website of the publication 'Ukrainskava Pravda' was shared on his telegram channel by the chairman of the Rada faction 'People's Servant' Davit Arakhamia, according to the Georgian authorities in helping Russia circumvent the sanction.

"When this information became available to the United States, we heard from Georgian officials that this was not true. But, over time, more and more objective information confirming my words emerges. Data on the transfers and accounts of progovernment MPs and ministers from Georgia abroad will soon be available, and, of course, on Mr. Ivanishvili's connections, which are deeply involved in the country sponsoring terrorism to circumvent sanctions. But I want to disappoint those who decided to make money on the deaths of Ukrainians."

In response to a media question, Davitashvili said Arakhamia's accusations were insulting to Georgian citizens, irresponsible, and unfounded. According to him, such accusations have not been substantiated by any facts.

The Main Intelligence Division of the Ministry of Defense of Ukraine has twice reported that Russia is trying to circumvent sanctions through Georgia. On May 1, they announced that Russia was allegedly in talks with Georgia, Armenia, and Azerbaijan to re-export Russian products to the international market. Earlier, Ukrainian intelligence reported that Russian agents were setting up smuggling channels through Georgian territory to circumvent sanctions.

The Ministry of Finance of Georgia called the statements of the Ukrainian authorities on April 4 'a completely unfounded and absurd accusation'. On May 2, Andriy Kasyanov, the Charge d'Affaires of Ukraine, was summoned to the Ministry of Foreign Affairs of Georgia in connection with the above-mentioned information.
