# Parliamentary majority to not participate in special Parliament session convened by President

Y eorgian President Salome ▼Zourabichvili on Friday satisfied the opposition's appeal and signed a decree convening a special session of the Parliament to address the 12-point recommendations outlined by the EU for granting the country the membership candidate status. However, the decision caused controversy among the politicians.

On Monday, the ruling Georgian Dream rebuffed to partake in a "parallel, contrived, sabotaged and unpromising process, planned by the radical opposition." As Givi Mikanadze, an MP for the ruling Georgian Dream party, said, none of the 81 members of the fraction would participate in it. According to him, the aim of this process was not to contribute to fulfilling the conditions of the European Union for granting the country the membership candidate status but to "deepen the polarisation" of the domestic political environment. He also added that the agenda of the domestic opposition did not comply with the requirements of the Parliament's regulations.

We declare once again that we are not going to participate in a parallel, made-up sabotage process planned by the radical opposition with no prospects for the outcome. None of the 81 members of our faction will participate in the special session", Mikanadze said.

Mikanadze noted that since

the Georgian Dream parliamentary faction would not attend the session and the quorum would not be formed, the session could not be opened.

"Salome Zourabichvili said

fulfilling the [EC] recommendations requires to team up. The opposition and the ruling team should cooperate, both in working groups, as well as in plenary sessions and committees," said

the President's Parliamentary Secretary Giorgi Mskhiladze.

The opposition believes the majority's decision to not attend the session would be a "sabotage and boycott of the European integration process." As Strategy Agmashenebeli member Paata Manjgaladze noted, "this will directly illustrate that the Georgian dream does not need and does not want EU integration."

### Soso Gogashvili says weapon was planted on him by Deputy Director of General Inspectorate


Soso Gogashvili, a former State Security Service deputy chief, says he was arrested violently.

"At two o'clock at night, they intruded into our house. They did not follow any rules, they did not warn me. I explained to them that I had little children - a 4-year-old grandson and a 10-year-old son. I told them I would take the children to another room and open the door for them, but they kept breaking the door," Gogashvili said today at the pre-trial hearing.

He said that Giorgi Gambashidze, the General Inspectorate's deputy director, planted placed a weapon on him.

They forced Gogashvili to handle the weapon before putting it in his home, he claimed today during the trial.

"When I felt what they were doing, I tried to free my hands. At that time, I looked at that person and recognized Giorgi Gambashidze, Deputy Director of the General Inspectorate. After I shouted: "What you doing?", he kicked me in the jaw, then I cursed him and another person hit me. I felt a very strong pain," said Gogashvili at the pre-trial hearing.



Republican Party Chair Khatuna Samnidze hopes that "the ruling party would consider the current reality and this historical chance, which we should not miss, and find the political will and strength to hold a session."

### Prosecutor's Office Charges Former Deputy Head of State Security Service, Gogashvili with 3 Articles

The former deputy head of the L State Security Service, Soso Gogashvili, was officially indicted. The Prosecutor's Office charged him with 3 articles exceeding his official authority, illegally obtaining, storing, distributing personal data using his official position, and illegally purchasing and storing fire-

According to the statement of the Prosecutor's Office, as a result of the investigation, it was established that Ioseb Gogashvili had access to information containing state secrets, as well as personal and personal data, given on his official position, while working in various leadership positions in the State Security Service in 2015-2018.

"Gogashvili, exceeding his official authority, took the abovementioned data from work for personal purposes and kept it in his residence, some of which information was disseminated publicly with his participation, which caused a violation of the constitutional right of citizens and significant damage. In addition, there was a danger of disclosure of state secrets."

In the same statement, it is written that Gogashvili purchased 5 firearms and ammunition, 2 of which were unregistered, and three, which were also kept in his home, were signed under the name of a close rela-

Employees of the State Security Service arrested Gogashvili on July 16. He is accused under the 1st part of Article 333 of the Criminal Code of Georgia (exceeding official authority by an official, which caused a substantial violation of the legal interest of the state), under the 4th part of Article 157 (illegally obtaining, storing, distributing personal data, causing significant damage) caused by the use of official position) and was presented under the 3rd part of Article 236 (illegal purchase and storage of firearms and ammunition), which provides for imprisonment for a term of 4 to 7

ready applied to the court with a motion to extend the prison term to the accused as a preventive measure.

"As a result of the search conducted by the court's ruling. marked state secret documents related to the activities of the State Security Service, documents containing personal and personal data, dozens of technical equipment and illegal firearms were removed from the residence of Gogashvili. The investigation of the mentioned criminal case in the State Security Service is continuing."

Soso Gogashvili was arrested in Tbilisi on July 16, at his home. The video footage shot by his wife shows that masked law enforcement officers physically arrest Gogashvili in the first seconds of entering the house. According to the agency, the arrest of the former head 'became inevitable as a result of the search'. His relatives

Gogashvili himself connects his arrest with the statement made by him on the disclosure of information related to election fraud. According to the lawyer,

documents, Gogashvili intended to make public, will probably be published by July 25.

According to Gogashvili's wife, Tea Martkopishvili, law enforcement officers planted a firearm under the bed and another in the closet, as well as a 'flash drive, computer, written documents, and a hard drive' next to the bed. She claimed that law enforcement officers did not allow her to call an ambulance or a lawyer.

Notably, Gogashvili's arrest was preceded by the dissemination of a secret audio recording by TV host and singer Gia Gachechiladze, who has had close ties with the government, of Mtavari Arkhi TV journalists discussing how to cover 'secret files' given to them by Gogashvili. The former deputy head also authored a July 15 Facebook post after the distribution of the secret recording, which exposed authorities' falsification of last year's local elections and claimed that Gogashvili already provided evidence of the 'entire structure' to media and other organizations.
