The opposition is developing draft laws to implement the EU's recommendations

The parliamentary opposition is starting to develop draft laws to implement the recommendations of the European Union. The meeting of the working group was held where they discussed the elimination of corruption and the reform of the judicial system.

The ruling Georgian Dream party did not participate in the meeting.

Opposition member Giorgi Vashadze hopes that the Georgian Dream will be pressured into supporting the laws:

"There were many cases when the ruling party was forced to adopt a law that they did not want to adopt. They voted for the constitution in the first reading and voted for it. They did not want to switch to a fully proportional low-barrier system, but they had to. Therefore, we must create mechanisms that force them to fulfill all 12 recommendations to get candidate status" said the leader of Strategy Aghmashenebeli.

According to Giorgi Botkoveli, a member of the United National Movement, all opposition parties that come up with any initiative will work in a coordinated manner

"Any group that will meet today in the opposition format will not meet under the leadership of anyone. It will be a coordinated group that will work on what the opposition will do additionally and jointly

in order for us to move forward in the process that our country needs most to-day." he said.

The non-governmental sector also participates in the process of developing draft laws for 12 recommendations.

The Georgian Young Lawyers Association say that they will share their vision regarding the constitutional, judicial or anti-corruption direction with any political group.

Georgian Dream is working separately

to complete the recommendations from the European Union. They have already held a meeting regarding the judicial system, however, without inviting non-governmental organizations and the ombudsman.

Gov't to amend the law on diplomatic service

According to the press service of the government administration, the ministers discussed the amendments to the law on the diplomatic service to regulate the rotation cycle in the diplomatic service, as well as "the manner and terms of sending employees to the diplomatic missions of Georgia on long-term business trips".

It is not yet known what changes will be made in the law.

The Government of Georgia has a constitutional dispute with the President of Georgia regarding the appointment of ambassadors.

The constitutional lawsuit "Government of Georgia against the President of Georgia", which evaluates the constitutionality of the president's refusal to appoint ambassadors and diplomats submitted by the government, was accepted by the plenum of the Constitutional Court for consideration on June 25, 2022.

The government requests an explanation regarding the appointment and dismissal of Georgian ambassadors and heads of diplomatic missions, separation of powers between the President of Georgia and the Government of Georgia.

By the way, external and internal surveillance cameras caught how illegal items and documents were brought in, and my family members also saw it, but the cameras have now been damaged and the recordings deleted by the Operational Technical Department, just like during the previous illegal assignments, such as 1) the beating of Gela Khvedelidze because of swearing at Bidzina on the phone, which carried out Partskhaladze's gang and was erased by the Operational Technical Department, and 2) Bidzina's task - the kidnapping of Mukhtarli, which was also erased by the Operational Technical Department," reads the statement.
