# PM Gharibashvili says his statement about Georgian fighters killed in Ukraine was misinterpreted

Prime Minister Irakli Gharibashvili explained his statement regarding Georgian fighters in Ukraine that 'war parties' are urging Georgians to go to war in Ukraine. According to the Prime Minister, his statement was misinterpreted and he respects all people 'in uniform'.

According to the Prime Minister, some of the Georgian fighters are fighting in Ukraine "with their idealistic attitude", but there is also a category that was sent away by the 'United National Movement'.

"I want to say that what I said was misunderstood and it is your fault that you misinterpreted it. As if I called all the people who are fighting in Ukraine today 'members' of the 'National Movement'. This is a big lie, you all have been spreading it.

I have said the following and now I will repeat it so that it is completely clear:

We all know very well, specific surnames have been named by various media outlets, that there are people with specific surnames and names, who are directly connected to the UNM and Saakashvili.

There are people, ex-military, policemen, ordinary citizens, who went to war with their beliefs, their spirit, their idealistic attitude, this is their decision.



Of course, I did not say that all party, the party that lost our these people were taken by the United National Movement and the 'War Party'.

I have said the following and I will say it again that it must be separated. There is a category - a few people, maybe a dozen, who are, yes, Saakashvili's war

territories and handed them over to the Russian occupier and handed over strategic objects after the war, taken and organized by them, there is evidence of this," he said.

According Irakli Gharibashvili the government is doing everything to bury the dead fighters in Ukraine with dignity.

The state is doing everything it can to give these people a dignified rest, and then all these people will be buried with military honors.

In general, I want to ask ev-

eryone, including the most radical, degraded, immoral opposition, that speculating on issues related to the death of a person, especially the death of a person in trial, war, is immoral immorality and hypocrisy," Gharibashvili said.

## Public Defender's Office: Article 18 of the European Convention violated in Nika Gvaramia's case

he Public Defender of Georgia has completed the study of the appeal verdict of Nika Gvaramia, the founder of 'Mtavari Channel'. According to the document, the Public Defender believes that Article 18 of the European Convention on Human Rights (restriction of human rights based on non-conventional/political motives) is violated in the criminal case of Nika Gvaramia.

As stated in the conclusion, this assessment was based not only on the study of court decisions and case materials, but also on the public statements of government officials addressed to Nika Gvaramia (before and after imprisonment), as well as the analysis of the media environment in the country.

According to the Public Defender's assessment, the appeal verdict against Nika Gvaramia is not substantiated, it is a case of imposing criminal liability for corporate actions, and the political motive in the case outweighs the interest of justice.

As stated in the conclusion, regarding the so-called 'episode of advertisements', the Public Defender of Georgia, applied to the Tbilisi City Court in 2019, in which they noted that a business decision similar to Nika Gvaramia's accusation cannot lead to not only criminal, but also corporate liability.

Due to the essential shortcomings of justice, the Public Defender applied to the President of Georgia for the purpose of using the power of pardon.

"First of all, Georgia is a legal state and decisions are made through legal procedures. The court makes a decision and everyone must respect the decision.

This is the minimum elementary principle of the legal state. We have seen attempts to intervene before, and I hope that in this case they will refrain from making unnecessary statements and putting pressure on the court," said Shalva Papuashvili.

According to Shalva Papuashvili, the announcement of rallies demanding the transfer of Mikheil Saakashvili abroad for medical treatment means that the "United National Movement" is completely missing the interest of the Georgian people.
