# Mikheil Sarjveladze Neither Excludes nor Confirms Parliament to Have Candidate for Ombudsman

ikheil Sarjveladze, Chair-Lman of the Human Rights Protection Committee of the Parliament of Georgia, told the media that comparing positions for the best model for electing the Public Defender is still underway. He added that he does not have any information that the consultation for the selection of the Public Defender is currently underway.

According to him, political consultations should be effective. As Sarjveladze said the most important thing for the 'Georgian Dream' now is to be less dependent on the 'conscientiousness' of the opposition.

"We need to focus on the result. Moreover, it is required by the 12 recommendations of the European Commission. Beyond that, it is important for the country that the Public Defender's Institute works properly and that it has a Public Defender elected for six years. Political consultations should be effective and if we entrust this process only to the opposition and their conscientiousness, unfortunately, there was not enough conscientiousness in the votes. Therefore, we will have to conduct the process in a different way. Consultations will show how it will be otherwise. It will be seen what the perspective can be in order to choose a public defender. I do not have any information that the consultation for the selection of the



Public Defender is currently underway.

I can neither exclude nor confirm that we will have a candidate. Positions are being compared, what will be the best model. It is very important not to have any hindering factors, which meant the impossibility of allowing a compromise on the part of the opposition. At some point, an ultimatum was issued. and unfortunately, the party issuing the ultimatum was held hostage. Due to the arguments, the candidates named by them could not be impartial.

The previous attempt was unsuccessful and the opposition will also be cautious in issuing such ultimatums, as it was clearly felt that many opposition members were prevented from making a decision because they had given harsh ultimatums. We cannot invent a new bicycle when selecting a public defender. We need a qualified staff with an orderly system of values. "Impartiality is no less important,

which implies political impartiality," said Sarjveladze.

On December 22, 2022, the Parliament rejected all candidates for the position of Public Defender. The reason was the decision of the ruling team, Georgian Dream, not to support the presented candidates.

## Russia Supports Restoration of Air Traffic Between Russia and Georgia, Does not Rule Out Easing Visa Regulations

The Deputy Chairman of the ▲ Foreign Affairs Committee Novikov told the Russian media. of the Russian Duma, Dmitry Novikov, said that he supports the restoration of air traffic between Russia and Georgia. Novikov did not rule out easing the visa regime for Georgian citizens either

"Despite the difficult period that the Russian Federation has gone through with the Georgian authorities, there are many citizens living in this country who are friendly towards Russia and support friendly relations between our peoples. Therefore, I would certainly support the restoration of aviation communications.

As for visas, I would consider the situation in the same way. Although here in this case it is necessary to study all the pros and cons more carefully. But I

do not rule out that in the near future it will be worth easing the visa regime significantly,

Also, according to Russian media, the Russian Association of Lawyers in the field of human rights appealed to the President of Russia and the Minister of Foreign Affairs to ease the visa regime for Georgian citizens. According to the association, the majority of Georgian citizens are in favor of friendship with Russia, and here "the group of nationalists is only slightly represented."

"The cancellation of the visa regime for Georgian citizens entering Russia, as well as the restoration of direct flights, can be a worthy response to those who do not want stable and peaceful relations between Russia and

microfinance institution (MFI) in Georgia. It is the first certified gender bond issuance in the South Caucasus and in the Georgian Stock Exchange.

The proceeds will finance women-owned micro, small and medium-sized enterprises (WMSMEs). The total bond issuance amounts to GEL 25 million with ADB as the anchor investor and the Bank of Georgia as co-investor with a subscription of GEL 6.25 million. Gender bonds are social bonds issued to enhance gender equality and empowerment. women's Crystal's gender bond framework received a second party opinion to certify its compliance with the Social Bond Principles of the International Capital Market Association.

"Local currency bonds bridge financing gaps that prevent developing countries from achieving sustainable and inclusive growth, and support sound capital management by the private sector," said ADB Private Sector Operations Department Director General Suzanne Gaboury. Women in particular are disproportionately affected due to high collateral requirements and other cultural biases that hamper asset ownership. MFIs play an important role in providing access to finance to low-income borrowers particularly in remote rural areas, which traditional commercial banks are generally reluctant to
