# US Sanctions Four Judges for Damaging Georgian Democracy with Their 'Significant' Corrupt Activity

n April 5, the US made a decision to sanction three current and one former judges of Georgia. The US State Department imposed sanctions on the Chairman of the Tbilisi Court of Appeals, Mikhel Chinchaladze, the member of the Supreme Council of Justice, Levan Murusidze, the Deputy Chairman of the Tbilisi Court of Appeals, Irakli Shengelia, and the former chairman of the Tbilisi Court of Appeals, Valerian Tsertsvadze.

Sanctioned persons are banned from entering the United States and it applies not only to these judges but also to their

family members. They had their valid US visas revoked due to 'significant corrupt activity'.

According to the United States Secretary of State Antony Blinken, sanctioned persons abused their positions and harmed the rule of law and the public's trust in the Georgian judicial system.

"The United States of America continues to support the citizens of Georgia in strengthening democracy and the rule of law, and will continue to ensure the accountability of those who abuse public power for personal gain."

We stand by all judges with the courage and integrity to act impartially and independently," Blinken said.

US Ambassador to Georgia Kelly Degnan also explained the reasons for the decision to sanction Georgian judges. In a video address on the matter, she said that the decision was based on reliable. She agreed information that these judges "abused their public office and engaged in significant corrupt activities.'

"Through their actions, they disregarded the judicial and public process by offering or pressuring judges to make decisions in favor of their political allies and manipulating judicial appointments for personal gain.

With these corrupt actions, they violated the rule of law and the democratic process and weakened the confidence of the Georgian people in the independence of one of the most important institutions among the democratic institutions of Georgia," said Kelly Degnan.

According to Kelly Degnan, under American law, such important information is the basis for sanctioning.

"All citizens of Georgia deserve justice, the rule of law and the right to a fair and independent court, regardless of their property status, family or political ties. These sanctions reflect the importance of the fight against corruption for America. Corruption and interference in justice hinders Georgia's European integration," the US Ambassador to Georgia said.

## Foreign Minister of Georgia Calls on US Department to Review or Present Evidence on Four Sanctioned Judges

L Georgia, Ilia Darchiashvili, wrote a letter to the US Secretary of State, Ansanctions on four judges, and wrote that the Georgian government expresses hope that the decision will be reviewed or evidence presented.

In his letter to Blinken, Darchiashvili noted that if it's not reviewed or proven, sanctioning the judges will be perceived as pressure on the independent court of the sovereign state and gross interference in its activities.

"The decision of the US State Department on sanctioning judges, which was made public without presenting any evidence, is completely incomprehensible and unacceptable.

We hope that the State Department will provide relevant evidence or reconsider its decision. Otherwise, the State of Georgia and the people of Georgia will perceive this as putting pressure on the independent court of the sovereign state

and gross interference in its activities, which will damage the long-standing The Minister of Foreign Affairs of friendly relations between Georgia and the United States," Darchiashvili's letter reads.

> Affairs said that it was after the Georgian Dream came to power that reforms were carried out and the court became

independent.

Darchiashvili said that until 2012, the court was one of the rings of the 'repressive machine', the rate of guilty verdicts exceeded 99 percent, and 300 thousand Convicts were tortured in prisons.

Minister emphasized that after the Georgian Dream came to power, the num-

ber of prisoners in prisons decreased by 2.5 times, and the death rate decreased by 10 times.

Ilia Darchiashvili also talked about the statistics of appeals by Georgian citizens to the Strasbourg Court and wrote that after the changes in the government, the number of appeals has decreased dramatically.

"In 2009-2012, the European Court considered about 4,000 complaints filed against Georgia. According to the data of 2023, only 147 complaints filed against Georgia are considered in the Strasbourg Court, which is the best indicator of Georgia during its membership in the Council of Europe.

It should be noted that during the period of the previous government, the main creators and architects of the court's criminal system - Mikheil Saakashvili and Zurab Adeishvili - were not sanctioned by any country, and moreover, unfortunately, they enjoyed or still enjoy concrete guarantees of inviolability.

"Today's court is much freer and our government has improved the independence of the court,"Talakvadze said.

"It is unfortunate that our friendship has reached the point where we speak to each other in the language of sanctions. I mean Georgia and the USA. Second, you know that the court, like other democratic institutions, is evaluated by objective

Germany has been active in the field of environmental protection and sustainable use of natural resources in the South Caucasus for more than 20 years and is the largest bilateral donor in Georgia.




