# NGOs Appeal to Ruling Party to not 'Sabotage' Georgia's EU Candidacy Status

Non-governmental organizations appeal to the authorities and point out that any legislative initiative or action that would oppose the basic values of the European Union would be a sabotage of the status. More than 140 organizations signed the statement.

"Last month, the citizens of Georgia once again proved that we are loyal to European values and we are not going to deviate from the path leading to the European Union. We showed that the Georgian people deserve the status of a candidate by a wide public consolidation around the idea of joining the European Union as a national idea.

According to various reports, the European Commission may recommend granting Georgia the status of a candidate for EU membership in October 2023, if Georgia continues to work on reforms in the next period and does not worsen the situation of human rights and democracy in the country.

The government is fully re-

sponsible for receiving the candidate status. It is necessary for the government to reconsider and strengthen its efforts to achieve the historic opportunity. Any legislative initiative or action that would oppose the fundamental values of the European Union would be sabotage of the status acceptance and an action contrary to Article 78 of the Con-

stitution," the statement reads.

NGOs indicate that the main goal of their activities as civil society organizations will be to make maximum efforts to obtain candidate status. According to them, at the end of the year, the whole society should proudly announce that Georgia is a candidate country for EU membership.

Mikheil Saakashvili's Lawyers Appeal to **European Court**

The lawyers sent Mikheil Saakashvili's case to the European Court of Human Rights.

As lawyer Shota Tutberidze stated, the complaint talks about the violation of the clauses protected by the European Convention on Human Rights and Fundamental Freedoms.

"The European Court, of course, has a very strict estabman Rights and Fundamental Freedoms," Tutberidze said.

According to the assessment of the defense side, Saakashvili's state of health provides the basis for the court to establish the violation of a number of articles.

The members of Saakashvili's family say that they will not talk about the contents of the case due to their interest in the case.

"I think it would not be appropriate to go into the specific details of the content of the complaint and repeat the government's rhetoric and abuse of the practice of the European Court, so I cannot go into the details," stated Tutberidze.

**Minister of Culture** Thea Tsulukiani **Condemns Imposed Sanctions on Four** Georgian Judges

The Vice Prime Minister, Minister of Culture, Sports and Youth of Georgia, Thea Tsulukiani, said that US State Department's decision to sanction 4 Georgian judges is incomprehensible to her because according to her, the judiciary of the country is on the right path of development and has great success both in terms of impartiality and independence.

Tsulukiani also noted that she considers the US decision on sanctions unacceptable since no evidence has been presented.

"As a former Minister of Justice and a lawyer of the European Court of Human Rights,



which means about 20 years of experience, I want to strongly, loudly condemn this decision of our friend, the USA." It was unacceptable, especially since it had, as it turns out, the form of a surprise.

Partners, friends probably don't behave like that, although in friendship and partnership, it sometimes happens when there is some misunderstanding. This friendship and partnership has such great roots and tradition that such misunderstandings cannot diminish it, however, of course, we, who represent the Georgian nation in the government, are obliged to condemn what is an unacceptable act for the history, sovereignty and independence of our country in the form of sanctions," Tsulukiani said.
