

Georgia Presents Report to European Union on Progress Towards Membership Candidacy Status

The Minister of Foreign Affairs of Georgia, Ilia Darchiashvili, handed over a report prepared for the European Commission to the Ambassador of the European Union in Georgia, Pawel Herczynski.

The report was prepared in accordance with the Copenhagen Criteria as part of

the enlargement package. It consists of 35 chapters that describe the legislative, institutional, and other activities carried out by Georgia over the past year to approach the European Union and the progress achieved in this regard.

According to the Ministry of Foreign Affairs, the report's preparation began at the end of February upon the European Commission's request, and the process was coordinated by the Ministry of Foreign Affairs. All state agencies, legislative bodies, and judicial authorities were involved in the process.

The European Commission will evaluate the report based on the so-called Copenhagen Criteria, which includes political, economic, and sectoral aspects. The evaluation report is expected to be published in the fall of 2023. Based on this report, the European Council will discuss granting Georgia the status of a candidate country by the end of 2023.

The mentioned document is a part of the important work carried out by the Georgian government in the direction of European integration, which will be a very important support mechanism for the European Commission to make a relevant conclusion in October, and the European Council to make a positive decision by the end of the year and grant Georgia the status of a candidate, - the Minister of Foreign Affairs of Georgia said. Ilia Darchiashvili said this after the meeting with the EU ambassador, during which the head of the foreign ministry handed over the first report prepared within the framework of the expansion package to Pawel Herczynski.

According to Darchiashvili, the document reflects the steps taken and reforms carried out by the Georgian authorities since May 2022 and will be an essential part of the discussions within the European Commission.

"I personally presented this document to the EU Ambassador. We had a very interesting meeting during which we discussed all the important steps that Georgia has taken and which are planned in order to fulfill the 12 points of the European Commission within the promised time frame and with the logic included in the recommendations. We also discussed future activities. The most important thing is that the document we shared with the ambassador today and sent to Brussels simultaneously will play a vital role in the decision-making process of the European Commission," said Darchiashvili.

US Ambassador Kelly Degnan Says US 'Convinced' of Sanctioned Judges Corrupt Activities

S Ambassador to Georgia Kelly Degnan stated to reporters that the creation of a temporary investigative commission on the court presents an opportunity for the Georgian authorities to look into long-standing allegations of corruption within the court system. According to Degnan, "protecting four individuals who have credible information about their involvement in corrupt activities is not showing solidarity with the professional judges." "As we have said many times, this is an opportunity for the Georgian authorities to investigate allegations of corruption in the judicial system, which has been widely known for years. I want to make it very clear, since so many people have made statements as if we are not well informed - there is no room for error.

The United States is absolutely convinced that the basis for sanctioning these four individuals is their involvement in corrupt activities. We did a very thorough review, gathering information, much of which is publicly available, before we put it into the system that goes to the Secretary of State. Secretary of State Blinken approved these restrictions because we were absolutely convinced of the basis for it. As I said earlier, this is an opportunity for the Georgian authorities to investigate these allegations themselves in accordance with Georgian law, based on the same publicly available information and other information," said Kelly Degnan. Kelly Degnan highlighted that many Georgian judges have participated in successful exchange programs and expressed her hope that the government will use this chance to investigate the allegations

Against the continuous impediments by the Russian Federation to peaceful conflict resolution, security, and stability in the wider region, the Secretary General welcomed Georgia's continuous efforts and initiatives aimed at promoting dialogue and reconciliation, and their provision of free access to health care, education, and other social benefits for all residents of the Georgian regions of Abkhazia and South Ossetia, as well as their efforts to address the needs of internally displaced persons.

During the period under review, operational activities on **Confidence-Building Measures** were continued. The report, for instance, notes that archive specialists from both sides of the Administrative Boundary Line (ABL) continued to work in online format and met in person, for the first time since the Covid-19 public health crisis. Efforts have been initiated to facilitate dialogue between psychologists specialised in war traumas and on the prevention of genderbased violence on both sides of the ABL. The development of further initiatives continues in close co-ordination with the Office of the State Minister of Georgia for Reconciliation and Civic Equality.

Note for Editors

Consolidated reports on the conflict in Georgia have been prepared by the Secretary General since 2010, following a Committee of Ministers decision. The current report is based, inter alia, on the results of the factfinding visit to Tbilisi on 13-14 February 2023. The delegation also had the possibility to observe the situation at the Adimplementation of the European Court's judgments in the two inter-state cases "Georgia v. Russia (II)", concerning the armed conflict between Georgia and the Russian Federation in 2008 and its consequences, and "Georgia v. Russia" (I)" concerning arrests, detentions and expulsions from the Russian Federation of Georgian nationals in 2006-2007.

On 20 April, the European Court of Human Rights is due to deliver a ruling on the inter-state application "Georgia v. Russia (IV)", lodged by the Government of Georgia in August 2018, which concerns the alleged deterioration of the human rights situation along the administrative boundary lines between Georgian-controlled territory and Abkhazia and South Ossetia.
