NGOs Demand Release of Detained Protestors in Batumi, Georgia, Citing Interference in Freedom of Expression

Non-governmental organizations Transparency International - Georgia (TI) and the International Society for Fair Elections and Democracy (ISFED) are responding to the developments in Batumi.

According to the NGO, it is worrisome that the Ministry of Internal Affairs continues the practice of illegally arresting peaceful protestors, which is a gross interference in the freedom of expression and contradicts both the Georgian Constitution and internationally recognized standards

They call on the agency to stop arresting peaceful protestors, illegal restrictions on freedom of expression, and immediately release all detainees.

"We are responding to the events that took place in Europe Square in Batumi. Yesterday, June 3, the police arrested six people, including 2 minors, for unfurling banners at a peaceful rally in Batumi.

It is worrisome that the Ministry of Internal Affairs still continues the practice of illegally arresting participants of a peaceful protest, which is a gross interference in the freedom of expression and contradicts both the Georgian Constitution and internationally recognized stan-

dards

As it is known, on June 2, in front of the Parliament in Tbilisi, 7 participants of a peaceful assembly were arrested because of banners with similar content, and they were taken to temporary detention centers in Telavi, Gurjaani and Dusheti.

Until now, the Ministry of Internal Affairs has not made any clarification regarding the need to transfer detainees to regional isolation cells. This raises suspicions that the reason for this decision could be the limitation of the right of defense for the detainees and the obstruction of unhindered communication

with the lawyers.

It should also be noted that the detention period of the detainees was extended up to 48 hours without justification.

We consider the tendency of arbitrary and unlawful arrests of peaceful protest participants by the Ministry of Internal Affairs to be worrying.

We call on the Ministry of Internal Affairs to stop arresting the participants of the peaceful protest, illegal restriction of freedom of expression and to immediately release all those arrested," the statement read.

Protesters Arrested at Parliament Rally Granted Release, Trial Delay Expected

Activists Levan Nishnianidze and Lasha Janjghava, who were detained at the June 2 rally, were released from Dusheti pre-trial detention center on the basis of a warrant.

According to the lawyer, the trial, which was expected to take place today, is likely to be postponed.

The rest of the detainees, among whom are human rights defenders Eduard

Marikashvili, Nika Romanadze and Saba Brachveli, remain in Telavi and Gurjaani isolators.

On June 2, at the rally near the Parliament, the police arrested 7 citizens because of the banners. Prime Minister Irakli Gharibashvili was mostly mentioned on these banners, while some citizens stood with empty banners. Those arrested are charged with petty hooliganism and resisting the police.

Lawyer Eka Kobesashvili states that it is not clear to her why the Ministry of Internal Affairs used the extended 48-hour period of detention if it was possible to release the activists based on their signatures.

On June 2, at the rally in front of the parliament, the police arrested citizens because of the banners. Mostly, the banners mentioned Prime Minister Irakli Gharibashvili. As it is known, 7 people are arrested.

The chairman of the Democratic Initiative of Georgia, Eduard Marikashvili, is among those arrested. Eyewitnesses say that he was holding a blank sheet of paper in his hand. According to reports, several people needed medical help due to the confrontation with the police.

On June 3, the action "Protect Freedom of Expression" was held in Batumi in parallel with Tbilisi. In Batumi, the police arrested several people on Europe Square. The police confronted the citizens because of the posters and arrested 4 people, including 2 minors.

Initially, citizens gathered near the parliament in support of Lazare Grigoriadis' father, Beka Grigoriadis, who was arrested on June 1 for trying to set up a tent. The court fined him 2000 GEL



After several days of unsuccessful attempts, Beka Grigoriadis, the father of the detained activist Lazare Grigoriadis, pitched a tent behind the parliament on June $3^{\rm rd}$.

Every day we will be here, my plan is to save my son, my Lazare from the injustice that my child faces. I tried my best to find out everything, I found out and made sure that he is being blamed for something he did not do.

I was there that day when they were arrested, I have not seen anything like that, if I have seen it in Moscow. I think that the policemen are especially doing something to lower the institute on the international arena, to spoil its name. If something was good in Georgia, everything will be ruined, so that the European Union will tell us that you don't deserve anything, stay with Russia.
