# President Zourabichvili Vetoes Changes to Election Process for CEC Chairman and Members

A ccording to reports from the presidential administration, the amendments made to the "Election Code" that modify the process of electing the Chairman and members of the Central Election Commission (CEC) have been vetoed by the President of Georgia.

Salome Zourabichvili expressed concerns that reducing the required number of votes from 100 to 76 for electing the chairman and members of the Central Election Commission (CEC) could undermine the need for consensus-based decisions and potentially lead to increased polarization.

The President has put forward a proposal to the Parliament suggesting that the Chairman and members of the Central Election Commission (CEC) be elected with a minimum requirement of 90 votes.

"According to the current edition, the President of Georgia, an independent and non-partisan official, announces the competition and creates a candidate selection commission. The President will present the selected candidates to the Parliament.

According to the changes, the commission's creation, candidate selection, and presentation will be carried out by the chairman of the parliament, and the election will be decided by a



simple majority of the parliament, which implies a one-party

decision.

Electing the chairman and

members with 76 votes instead

of 100 eliminates the need for consensus-based decisions and increases the risk of polarization.

The veto serves the purpose of maintaining this consensus.

The President proposes to the parliament that the chairman and members of the CEC should be elected with at least 90 votes, as was the case with the public

defender.

This is necessary to uphold and strengthen trust in elections and the administration of elections," the statement reads.

During the discussions surrounding the EU Special Representative for Sanctions, David O'Sullivan's visit to Georgia, the Minister of Economy, Levan Davitashvili, stressed the utmost importance of closely collaborating with strategic partners to ensure effective enforcement of sanctions and prevent any attempts to evade them.

Davitashvili highlighted that Georgia is an exceptionally trustworthy partner when it comes to enforcing sanctions.

"In this regard, Georgia emerges as an exceptionally reliable partner for the European Union, the United States of America, and Britain. We maintain regular communication with our partners at a personal level, including representatives from the customs structure and the Ministry of Finance, among others. The Ministry of Finance and relevant entities have imple-

mented several precautionary measures to counter attempts at circumventing EU sanctions.

We acknowledge that the implementation of sanctions is not an easy process for the countries imposing them. There are inherent risks, including the potential misuse of Georgia as a transit point by these countries. However, Georgia has been proactive in responding and has successfully thwarted dozens of such cases. Additionally, there is a risk of sending sanctioned cargo to a sanctioned country through third countries. In this context, Georgia actively engages in close cooperation with partner countries to facilitate the exchange of relevant information," stated Davitashvili.

As highlighted by Levan Davitashvili, during David O'Sullivan's visit, they will review and summarize the progress made in their collabo-






