# US Ambassador to Georgia Highlights Contrasts Between Kremlin-Inspired Law and American Law on Lobbying Activities

In response to the question about the lobbying activities in the case of Mikheil Saakashvili, the US ambassador to Georgia, Kelly Degnan, highlighted the distinction between the law inspired by the Kremlin and American law, based on documents from the US Department of Justice.

According to Kelly Degnan, the Kremlin-inspired law, which was rejected by Georgia in March, specifically targeted Georgian NGOs and civil society organizations working on behalf of Georgia.

On the other hand, the American law focuses on law firms and lobbyists hired by foreign entities to work in their favor.

Degnan further noted that they have witnessed the outcome of a Russian-style law in Russia, which led to the expulsion or closure of NGOs and civil society groups that were doing beneficial work.



Degnan emphasized that Georgia already possesses great transparency and regulations under its legislation. Therefore, she believes that the matter is not about transparency, as it already exists in Georgia.

"In my opinion, we have witnessed the consequences of a Russian-style law that forced NGOs and civil society organizations engaged in beneficial work in Russia to either close down or relocate. The rejected Georgian law, which was under consideration in March, addressed this matter. I would like to reiterate that Georgia already has robust transparency measures and regulations in place within its legislation. Information about the activities of donors and non-governmental organizations in Georgia is fully accessible to anyone genuinely interested. Therefore, I do not believe that the issue revolves around transparency since it is already well-established in Georgia,' stated Degnan.

## GYLA Calls for Release of Detained Protesters in Batumi Amid Concerns Over Prioritization of Russian Citizens' Safety

expressed apprehensions regarding the recent protests in Batumi linked to the arrival of a Russian cruise ship. GYLA called on

the Ministry of Internal Affairs to release the 23 individuals detained during the demonstrations



GYLA raised concerns about the law enforcement's apparent prioritization of Russian citizens' safety over others, leading to restrictions on protesters' constitutional rights. The organization emphasized the need to safeguard the rights and freedoms of all citizens, without discrimination based on nationality or other factors.

According to the statement, there is information concerning the ship owner and related companies and their sanctions.

The organization has raised concerns about the law enforcement's apparent prioritization of the safety of Russian citizens over other cases, leading to limitations on the constitutional rights of the protesters. GYLA emphasized the significance of safeguarding the rights and freedoms of all citizens, without any form of discrimination based on nationality or any other criteria.

The protest against the 2nd cruise Russian ship started late last night, July 30, and has continued throughout the night, still ongoing. The police mobilized on-site did not allow the participants of the rally to gather

It is alarming that the law enforcement structure, compared to all other cases, is especially concerned about the safety of Russian citizens and, based on this, including using forceful methods, restricts the constitutional rights of demonstrators to peacefully protest against the Russian occupation and Russian influence in Georgia. It should be noted that the Ministry of Internal Affairs organized a sa corridor for Russian citizens to prevent any obstacles for them to get to the city from the cruise. Currently, the police have again fenced off the area around the Batumi harbor with double

The Georgia's Young Lawyers' Association continues to monitor the ongoing protest in Batumi and protect the interests of the illegally detained persons; however, until now, the Ministry of Internal Affairs has not provided information about the location of the detained persons. Lawyers are not given the opportunity to visit their clients in the pre-trial detention center," the statement reads

Furthermore, there were reports suggesting that the 'Astoria Grande' website had removed Batumi port from its list of cruise ship destinations during this period of unrest.

#### **Allegations of Police Assault During Batumi Protest: Public Defender Refers** Incident to **Investigation Service**

As per the information from the public defender, there are allegations of physical assault against one of the detainees during the protest rally in Batumi.

The statement released by the Public Defender mentions that they have referred the incident to the Special Investigation Service

During a meeting with three citizens who were arrested at the protest, one of them, identified as R. M., reported experiencing verbal and physi-

cal abuse by police officers. The Office of the Public Defender immediately informed the Special Investigation Service about the alleged mistreatment of R. M. and expects a prompt and effective response.
