Zourabichvili expressed warm congratulations to everyone gathered for the day, acknowledging the beginning of Hanukkah for those of the Jewish faith and extending early congratulations to the Yazidi community for their upcoming holiday. She then recognized the imminent celebrations of Catholic Christmas and Orthodox Christmas, sending her best wishes to those celebrating it. President Zourabichvili emphasized the significance of living together, not only in mutual respect but also in shared celebrations and moments of mourning. She acknowledged the diversity of holidays celebrated collectively, highlighting the unity that comes with commemorating important

events together.

The Georgian President also acknowledged the difficult day for Armenians due to the Spitak earthquake that occurred 35 years ago, expressing solidarity with Armenian citizens living in Georgia and recognizing the shared remembrance of this tragic event.

U.S. Participation in the 59th Round of Geneva International Discussions on the Conflict in Georgia, December 5-6, 2023

The United States notes the conclusion of the 59th round of the Geneva International Discussions (GID) on the Conflict in Georgia, which took place December 5-6 in Geneva.

The United States delegation, led by Ambassador and Permanent Representative to the U.S. Mission to the OSCE Michael Carpenter, welcomed dialogue with participants to seek a peaceful resolution to the conflict in Georgia. The United States called upon the Russian Federation, as a party to the conflict, to fulfill immediately its unequivocal obligation under the EU-mediated August 12, 2008 ceasefire agreement to withdraw its forces to pre-conflict positions, as well as to uphold its commitments to allow unrestricted access for the delivery of humanitarian assistance and not impede international security arrangements on the ground. The occupation of 20 percent of Georgia's territory by Russia's forces undermines Georgia's sovereignty and territorial integrity, as does Russia's ongoing borderization. Abkhazia and South Ossetia are internationally recognized and integral parts of Georgia. The United States applauds Georgia's long-held commitment not to use force to resolve the conflict.

The United States called upon the Russian Federation to promptly fulfill its obligations under the EU-brokered ceasefire agreement of August 12, 2008, by withdrawing its forces to preconflict positions. "From our side, we emphasized that all participants should consider how to create an atmosphere where people living near the administrative border will not be afraid to go to the church or cemeteries because they might be arrested or killed.

The Geneva platform is the only one we have. It's not ideal; we've been having these meetings for 15 years, and it's probably fair to say that it would be nice to have more progress. At the same time, the fact that we have the opportunity to meet and discuss various issues is certainly important. We all wish we have more results 15 years from now," Klaar stated.
