# Parliament Chairman Shalva Papuashvili Defends 'Foreign Agents' Law

eorgian Parliament Chairman Shalva Papuashvili tried to defend a newly adopted "Foreign Agents" law, stating that any foreigner questioning the law is questioning Georgian democracy. He compared such actions to Russian tactics in Ukraine.

According to Papuashvili, only the Georgian government, elected by its citizens, has the right to speak for the people. He criticized foreign officials for making statements about the will of the Georgian people, suggesting that such statements lack legitimacy.

"I have seen many statements where foreign politicians talk about what the Georgian people want, what the will of the Georgian people is. Do not believe any foreigner who speaks to you on behalf of the Georgian people. Because it is the most dishonest act to speak for the people of another country

This law was adopted on behalf of the Georgian people. Any foreigner who questions this, he questions democracy, and this is a Russian style, Russia is doing this to Ukraine when it says that the government does not actually represent the Ukrainian people. This is a Russian style. We have seen this kind of attitude towards our country when the Russian authorities spoke to us on behalf of the Georgian people and told us that the people were good and the government was bad. I call on everyone to think that it is not right to talk to the Georgian people in the Russian style," Papuashvili said.

The Minister of Economy Levan Davitashvili has announced that the Chinese consortium company China Communications Construction Company Ltd, in partnership with China Harbour Investment, has been selected as the private investor for the construction of the new deep-sea port of Anaklia. According to Davitashvili, the Chinese company was the only entity to present an offer for the project.

Notably, China Communications Construction Company Ltd has been sanctioned by the United States on August 26, 2020, for engaging in corruption, predatory financing, environmental destruction, and other abuses across the world.

"On May 20, a proposal was submitted to the Anaklia Development Agency by a Chinese consortium, consisting of two important subcontractors, CRBC and Qingdao Port International. It's worth noting that Qingdao Port International ranks sixth-seventh in the world by port cargo turnover. In the near future, the commission will evaluate the proposals and reveal the winner.

According to the initial assessment, the proposal is complete, and there is a great chance that the Commission will declare it the winner. However, several

clarifications are needed for this. I believe that in a few days, we will announce the Chinese consortium as the winner," said Davitashvili.

According to the minister, the initial phase of Anaklia port development involves constructing a berth capable of handling 7 million tons of cargo and a 600,000container terminal, with a total investment value of \$600 million.

The government will hold a controlling stake of 51% in the port.

The leader of 'Lelo', Mamuka Khazaradze, considers the "capture of the port of Anaklia by China" as part of the Russian government's plans.

"What does the Black Sea need Americans for and what does Georgia need from the European Union? The plans of the Russian government were openly announced to us for the first time by stopping the Anaklia project. Today, everything is clear to everyone - Russian law, visits to Iran, standing by Hezbollah, and ultimately transferring the Anaklia project into the hands of China, rejecting American and European investments!" Khazaradze wrote on social media.

Lelo leader Mamuka Khazaradze claims that during the meeting in 2017, while discussing the Anaklia port, Ivanishvili told him there is no place for "Americans in the Black Sea".

# EU 'considering all options' after passing of Georgian law

The EU and its Member States are considering "all options" after the final adoption of the law on transparency of foreign influence in Georgia today, EU High Representative Josep Borrell said in a statement together with the European Commission this evening.

"The European Union deeply regrets that the Georgian Parliament decided to override the President's veto on the law on transparency of foreign influence, and to disregard the Venice Commission's detailed legal arguments leading to a clear recommendation to repeal this law," the statement said, adding: "The EU and its Member States are
