Parliament Chair Shalva Papuashvili Accuses EU of Sheltering Criminal Politicians

The Chairman of the Parliament of Georgia, Shalva Papuashvili, emphasized the Georgian people's loyalty to European values while criticizing some European politicians for being misled by bureaucracy. He accused European institutions of covering for Georgian political figures such as Zurab Adeishvili, Davit Kezerashvili, and Mikheil Saakashvili, whom he referred to as part of a "criminal clan" hiding in Europe.

"Today, some European bureaucrats, diplomats, and politicians talk to us about values from moral pedestals," Papuashvili stated, accusing the European Union of allowing criminals like Adeishvili and Kezerashvili to move freely. "It is a shame when the door is open for Zurab Adeishvili in various institutions of the European Union. What prevents the European Union from handing over the criminal Adeishvili to us, what prevents the European Union from handing over the criminal Kezerashvili, and why did Mikheil Saakashvili have the freedom to move freely on the territory of the European Union and from there to get involved in the politics of Georgia as a citizen of Ukraine?"

Papuashvili also addressed the election of Giorgi Gabitashvili as the General Prosecutor of Georgia, expressing the ruling team's positive attitude towards him. "The prosecutor's system and prosecu-



tors of Georgia deserve only praise and thanks from the Georgian people and the Parliament of Georgia. Of course, when we are talking about the candidate who was the deputy general prosecutor in this system, these successes were achieved with his participation, and it is natural that we have a positive attitude towards this candidate," he said.

Regarding allegations linking Gabitashvili to former prosecutor Otar Partskhaladze, Papuashvili dismissed the connection, stating, "I don't understand what this person has to do with this issue."

Giorgi Gabitashvili's candidacy for General Prosecutor has

been submitted to the Parliament and referred to the Legal Affairs Committee for consideration. The election is scheduled for an extraordinary session on July 18-19.

report by the Democracy AResearch Institute titled "Protests under Observation" has accused the Georgian government of employing physical retribution against civilians and civil activists as a political strategy. The report covers observations from protests held between November 6, 2024, and May 30, 2024, organised by political parties, civil movements, and activ-

According to the institute's assessment, the protests witnessed gross violations of international standards, the constitution, and current legislation. These include incidents of incitement to violence, inaction by the Special Investigation Service and Ministry of Internal Affairs, and attempts to intimidate and influence protest participants.

The DRI's report highlighted that demonstrators generally

acted within the law during protests against the "Foreign Agents" law (or "Russian law",) with no major violations that would justify forceful dispersals. However, it criticized law enforcement's disproportionate use of force, resulting in injuries to peaceful rally participants.

Furthermore, the Ministry of Internal Affairs was accused of failing to warn demonstrators before dispersing protests and obstructing media coverage. Over 200 individuals were reportedly arrested during these protests, often without proper explanation of their detention or adequate procedural rights.

The report also pointed out instances where law enforcement physically assaulted detainees, causing injuries such as facial injuries and broken teeth, which were seen as reprisals against political opponents

rather than legitimate policing measures.

Moreover, the institute criticized the low standard of evidence in court cases related to administrative offenses during protests. It highlighted a coordinated campaign of intimidation against protesters, including

telephone threats and vandalism targeting leaders of non-governmental organizations.

The report concluded with allegations that the ruling party, Georgian Dream, not only condones police violence but also supports attacks on leaders of public organizations, civil activists, and politicians, as evidenced by public statements and videos.

The announce-**Comments on Trump** ment was made by Giorgi Assassination Attempt Mskhiladze, Parliamentary Sec-Matthew Miller, the spokesretary to the President, during a briefing where he emphasized the President's firm stance on the law's constitutionality.

Mskhiladze highlighted that this legal action is unprecedented in Georgia's political history, marking the first time a sitting President has directly engaged the Constitutional Court in this manner.

"For the first time, the President of Georgia applies to the Constitutional Court with a lawsuit. The lawsuit concerns the Foreign Influence Transparency Act, the so-called Russian law. The mentioned law is unconstitutional. It contradicts Article 78 of the Constitution of Georgia. A number of norms of the

person of the US State Department, urged both the American public and foreign countries to refrain from speculation regarding the assassination attempt on former President Donald Trump. speculation, from making irresponsible statements before knowing the facts. I think I would extend the same appeal to foreign countries as well."
