

## Majority of Georgians Believe Country is Developing in Wrong Direction, Edison Research Finds

A recent survey by Edison Research reveals that 63% of Georgians think the country is developing in the wrong direction, while 37% believe it is heading in the right direction. The study, commissioned by Formula TV company, highlights a growing dissatisfaction among the Georgian population.

According to the last three surveys, the number of those who think the country is developing in the wrong direction has steadily increased. In December, 57% of respondents held this view, and in April, this figure rose to 59%. The latest data, collected in July, indicates a continued upward trend in public discontent.

The sentiment is particularly strong among younger age groups. In the 25-34 age group, 72% believe the country is on the wrong path, and in the 18-24 age group, the figure is 71%. Even in other age brackets, a majority share the view that the country is not moving in the right direction.

- Georgian Dream/ People's Power: 32.4%

- Unity: National Movement/Strategy Aghmashenebeli: 17.3%

- Strong Georgia: Lelo/ For the People/Freedom Square: 12.8%

- For Georgia - Giorgi Gakharia: 11.2%

- Coalition Ahali/Girchi/ Droa: 9.9%

Edison Research conducted the survey from July 11-24, interviewing 1,000 eligible voters aged 18 and older through faceto-face interviews nationwide. The margin of error is +/-2.5% for Georgia as a whole and for Tbilisi, with a 95% confidence interval.

These findings come at a critical time for Georgia, as the government faces increasing pressure to address various political, economic, and social challenges. The growing discontent among the population, especially among the youth, signals a potential demand for significant changes in policy and governance.

At the 105<sup>th</sup> anniversary event of the National Statistics Office (GeoStat), H.E. Lasha Khutsishvili, Minister of Finance of Georgia, emphasized the critical importance of high-quality, reliable, and comprehensive statistical information for effective fiscal policy planning. In his address, Minister Khutsishvili praised GeoStat's role in Georgia's development, noting its adherence to international best practices in data production.

"The national statistics office is an exceptional institution that consistently enhances its work quality and provides valuable information to policymakers and other stakeholders,' stated Khutsishvili. He highlighted several milestones, including the successful transition to the SNA2008 methodology in 2019, the review of GDP and national accounts indicators this year under the Harmonized European Revision Policy, and GeoStat's early adoption of the new ILO methodology for labor statistics in 2020. According to World Bank data, Georgia's statistics system ranks 15th globally and 14th among European countries. Khutsishvili also discussed the collaborative efforts between the Ministry of Finance and GeoStat, emphasizing the importance of task force work and efficient data exchange. "Our cooperation includes addressing various challenges and advancing reforms in statistics as we pursue EU candidate status," he noted.



Minister Khutsishvili congratulated the staff of GeoStat on their anniversary and extended best wishes for their upcoming significant project - the nationwide population census.

# **ADB Invests \$40 Million in Green Bonds for a Climate-Resilient Water Supply in Georgia**

BILISI, GEORGIA (26 July 2024) — The Asian Development Bank (ADB) has invested \$40 million in a bond issuance by Georgia Global Utilities JSC (GGU). The certified green bond-the largest ever issued from a Georgian private corporate entity-aims to enhance the water system in Tbilisi and neighboring municipalities, building resilience against climate change on surface and groundwater resources.

The financing includes debt investments of \$20 million from ADB's ordinary capital resources and \$20 million from Leading Asia's Private Sector Infrastructure Fund 2, administered by ADB, on behalf of the Japan International Cooperation Agency (JICA). The investment forms a part of a \$300 million, 5-year issuance by GGU.
