U.S. Expresses Deep Concern Over Georgia's **Political Situation Ahead of Elections**

mbassador Michael R. Car-Apenter, Special Advisor to President Joe Biden and Senior Director for Europe at the U.S. National Security Council, expressed deep concern about political developments in Georgia during an interview with the Voice of America on September 12. Carpenter highlighted the upcoming parliamentary elections as a critical moment for Georgia's democratic future, warning that the misuse of administrative resources and pressure on civil society and opposition figures could severely impede the country's democratic progress. He also confirmed that the U.S. will be closely monitoring the pre-election environment and election day itself.

Carpenter stated that the U.S. is worried about Georgia's current trajectory, noting that these concerns have been present for a long time. He pointed to the Foreign Agents Law as a symptom of the broader issues within the country. He also criticized statements made by Georgia's ruling party but emphasized that mere concern is insufficient to address the challenges.

When asked about possible U.S. actions before the elections, Carpenter declined to announce any sanctions but stated that the U.S. would hold individuals accountable for corruption, anti-Western activities, and abuse of power. He stressed that Wash-



ington has the necessary tools to take action if required.

Regarding the upcoming elections, Carpenter expressed hope for a free and fair process but raised concerns about the ruling party's recent moves, including the misuse of government resources and a pledge to ban opposition parties post-election. He stressed that the U.S. would continue to monitor developments, particularly in the lead-up to election day.

On the issue of Russian interference, Carpenter acknowledged Russia's malign influence across Europe and Georgia, but emphasized that it is the behavior of Georgian officials that remains under scrutiny. He noted that while Russia's involvement remains unclear, the focus should be on the actions of Georgia's

government.

Carpenter also addressed the question of U.S.-Georgian relations, stressing that Georgia has benefited from bipartisan support in the U.S. for many years, a trend he expects will continue, regardless of the outcome of the U.S. elections.

Ambassador Carpenter underscored the importance of free and fair elections, stating that

every election provides an opportunity to renew a country's democratic institutions. He warned that Georgia's democratic development could be hindered if the elections are not conducted properly, and called on the government to end pressure on civil society and opposition politicians, and to refrain from using administrative resources to influence the outcome.

Russia Accuses U.S. of Election Interference in Georgia

woman Maria Zakharova accused the U.S. of plotting to interfere in Georgia's upcoming elections by using the OSCE Of- Zakharova claimed that the

fice for Democratic Institutions and Human Rights (ODIHR). In her response to media inquiries,



ODIHR is preparing to "heat up the situation in Georgia" before the elections. She warned that if the election results are unfavorable to the West, ODIHR's findings might be used to provoke protests or challenge the results, potentially leading to another "color revolution."

Zakharova denounced ODIHR as a tool of the "collective West," asserting that it fulfills political orders and delivers conclusions tailored to its sponsors' expectations. "ODIHR is fulfilling the political orders given to it and provides the conclusions and findings that its sponsors expect," she stated. She criticized the ODIHR's interim reports, which are often released shortly before elections, alleging they are produced by "a small group of hired persons who bear no responsibility for their actions." According to Zakharova, these reports do not accurately reflect the situation but rather align with a predetermined narrative: "The result is not a reflection of the real state of affairs but an essay on a theme set by the customer."

Zakharova advised disregarding ODIHR's findings, suggesting, "International observer obligations can be fulfilled without involving ODIHR." She argued that elections can proceed effectively without the organization's involvement and that "the legitimacy of elections is determined by the will of the voters and nothing else, not by ODIHR's assessments."

Additionally, Zakharova mentioned that Russia sometimes sends its experts to ODIHR missions upon request from friendly countries. These experts are meant to "monitor the voting process directly, counteract the excesses of the West, and obtain an adequate picture of what is happening," she said. This, she argued, helps to "significantly mitigate the potential for pressure on local authorities and prevent manipulations with statistical data."

OSCE/ODIHR Launches Election Observation Mission for Georgia's Parliamentary Elections On September 12, the OSCE Office for Democratic Institutions and Human Rights (ODIHR) announced the opening of an election observation mission for Georgia's upcoming parliamentary elections. Night Oclear Low: 16°C on the OSCE website, the mission will be led by Eoghan Murphy and will include 12 international experts based in Tbilisi, along with 30 long-term observers to be deployed across Georgia starting September 19. Additionally, the mission plans to request 350 short-term observers to arrive before October 26, the election day.

The OSCE/ODIHR mission aims to assess the elections' compliance with OSCE commitments, international democratic standards, and national legislation. Observers will monitor key aspects of the election process, including campaign conduct, election administration, dispute resolution, and media coverage, as well as review the implementation of previous ODIHR recommendations.

On election day, October 26, the mission will collaborate with delegations from the OSCE Parliamentary Assembly, the Parliamentary Assembly of the Council of Europe, the European Parliament, and the NATO Parliamentary Assembly to oversee polling stations, voting, ballot counting, and result tabulation. Preliminary findings will be released the day after the elections, with a final report and comprehensive assessment expected several months later.

The ODIHR emphasized that interactions with state authorities, political parties, civil society, media, and the international community are crucial components of their observation process
