Kobakhidze Responds to Antony Blinken's Statement and Ukraine's Sanctions on GD Officials

Prime Minister of Georgia Irakli Kobakhidze responded to a statement by U.S. Secretary of State Antony Blinken, who announced that the United States is preparing to take additional measures regarding the ongoing events in Georgia, including sanctions. Kobakhidze said the current U.S. administration is "trying to leave the new administration in as difficult a situation as possible," and that Blinken's statement is part of this effort.

"One thing is that this statement is completely false. We are talking about peaceful protesters, and when you see how peaceful the rallies organized in Georgia were, such a falsehood from the head of the State Department is certainly extremely disturbing. I very much hope that after January 20 [Trump's inauguration], we will not encounter such falsehoods in any American statement. Of course, this announcement is also a continuation of this process."

The current administration is trying to leave the worst possible situation in the entire region for the new administration. This applies to Ukraine, Georgia, and this statement is, naturally, a continuation of all of this," said Kobakhidze.

Kobakhidze also addressed Ukraine's imposition of sanctions on Bidzina Ivanishvili and 18 other individuals, stating that this reflects the difficult situation within Ukraine itself.

The Prime Minister of Georgian Dream claimed that there are two reasons for the sanctions: "Georgia did not impose sanctions on Russia and did not send volunteer fighters to Ukraine."

Kobakhidze spoke about "two fronts".

"From here, it became apparent what the actual intention was. There was a plan for not one front, but two fronts. Of course, this decision taken by the Ukrainian authorities at the time was a continuation of that plan."

He also mentioned the expulsion of Georgia's ambassador from Ukraine, a man who had remained in Kyiv since the start of the war. "Expelled — why? Because Russia was 'killing Saakashvili by torture in Georgia with our hands'," Kobakhidze said.

"Today, the situation of the Ukrainian government is even more difficult, and the probable decision we are talking about is an echo of this difficult situation," he added.

Kobakhidze also addressed the arrests of opposition leaders, stating, "The main source of violence was the party offices, and as soon as we entered the party offices and removed the relevant weapons of violence, the violence immediately ended."

"Yesterday, you saw that violent party groups no longer had the resources for violence. As soon as the source of the violence was removed, the Ministry of Internal Affairs did not need to react immediately."

A leksandre Elisashvili, a leader of the opposition's Strong Georgia coalition, was transferred to the Vivamed clinic following his arrest on December 4. His lawyer reported that Elisashvili had been subjected to physical violence during the arrest, resulting in visible injuries.

"Serious violence was committed against Aleko Elisashvili during the arrest. He has injuries, bruises on his face, and potentially a broken rib," the lawyer stated.

Elisashvili was detained at the Courtyard Marriott hotel in Freedom Square. According to the Ministry of Internal Affairs, his arrest is connected to an incident involving Ali Babaev, chairman of the National Congress of Azerbaijanis in Georgia and a cofounder of the *Georgian* Dream of Democratic *Georgia* party.

Authorities allege that on December 2, near Kostava Street in Tbilisi, Elisashvili verbally and physically assaulted Babaev on political grounds. Elisashvili has

been charged under Article 156, Part 2, Sub-Clause "A" of the Georgian Criminal Code, which addresses persecution related to political activities committed with violence. If convicted, he faces up to three years in prison.

The Public Defender has addressed the treatment of Elisashvili, claiming that police used excessive force during his arrest.

"The police used disproportionate force against Aleko Elisashvili during his detention. We visited him yesterday, and he has visible injuries, including bruises and scratches on his face. He also reported back injuries from the beating," stated Public Defender Ioseliani.

The Public Defender's office has notified the Special Investigation Service about the alleged mistreatment and confirmed it will monitor the ongoing investigation.

This was Kobakhidze's response when asked if members of the Georgian Dream government had communicated with their European partners following the elections.

"Communication continues on a regular basis. The new Ministions are primarily in multilateral formats, such as with the OSCE and the European Union. We will wait for each country to recognize the legitimacy of the elections, and once that happens, we will activate bilateral relations. It is crucial that everyone accepts the OSCE/ODIHR's conclusions. Once we receive this recognition, we will engage actively with any country,' Kobakhidze added.

Public Defender Reports Police **Misconduct Against Protest Detainees**

Public Defender Levan Ioseliani has reported widespread allegations of police misconduct against detainees arrested during ongoing protests.

"My office continues visiting arrested and injured individuals. So far, my trustees have visited 260 people, and it is regrettable that 188 of them report improper treatment by the police," Ioseliani stated.

Representatives of the Public Defender's office have conducted visits to temporary detention centers and civil clinics across multiple locations, including
