INTRODUCTION

COMMON SENSE VERSUS FIELD THEORY

Everything flows and nothing is. No man ever steps into the same river twice. The road up and the road down are one and the same. Twenty five hundred years ago, these words were spoken by a philosopher of antiquity who acquired notoriety among colleagues. They condemned him for views which defied sanity and common sense. When Heraclitus proclaimed that reality consists of pure change without the existence of anything which changes, and hence that nothing is at it is, and A is non A, and that this ever flowing river produces the unity of opposites, he was called "the dark" and "the obscure," and held up to public shame and ridicule. Classical Culture adhered to the common sense view championed by its greatest philosopher, Aristotle, who affirmed that the world outside the mind is a world of physical objects which are as they are, and that change is certainly real but is not the primary reality. He affirmed that change presupposes the existence of objects which change, from something to something else, and that there no such thing as pure change or change as such. He affirmed that existence is noncontradiction, and that the most fundamental law of the universe is the law which says that a thing cannot both be and not be something at one and the same time, that a thing cannot be both black all over and white all over at one and the same time, and that those who deny this law cancel themselves because their denials are both true and false at one and the same time: "Clearly then it is a principle of this kind that is the most certain of all principles. Let us next state what this principle is. *It is impossible for the same attribute at once to belong and not to belong to the same thing and in the same relation.* This is the most certain of all principles, since it possesses the required definition, for it is impossible for anyone to suppose that the same thing both is and is not, as Heraclitus says. Is the man wrong who supposes that a thing is so or not so, and supposes both right? If he is right, what is the meaning of saying that 'such is the nature of reality'? And if he is not right, reality will at once have a definite nature, and this will be true, and *not* at the same time *not true*. And if all men are equally right and wrong, an exponent of this view can neither speak nor mean anything, since at the same time he says both *yes* and *no*. And if he forms no judgment, but thinks and thinks not indifferently, what difference will there be between him and the vegetables?" (*Metaphysics* by Aristotle, Book IV). In the twentieth century, the process theology of Heraclitus made a comeback in the domain of physics with the formulation of relativity theory, and the past one hundred years have seen the acceptance by the physics community of the view that reality is pure field and particles do not exist. The physics community also accepts quantum theory, which denies field ontology and affirms that everything is particles. Proclaiming in accordance with common sense that reality is "quantized" or is multiple and differentiated in character and consists of separate units, and that objects and objects alone exist outside the mind, quantum theory departs from common sense in its view that objects move by chance and cannot be known with any certainty to be located anywhere, because no such certainty exists in nature. The choice between relativity theory and quantum theory is the choice between a picture of reality which says that everything is field, in defiance of sanity and common sense, and a picture of reality which says that everything is particles but the particles can be located anywhere at anytime, and that if fire is brought into contact with paper enough times, at some point it will not burn the paper. The proponents of field theory have issued a program and manifesto for the rejection of sound judgment and empirical science, and the reversion of physics to the superstitions of Heraclitus. They proclaim that progressive physics rejects the existence of physical things perceived by the senses. They proclaim that progressive physics affirms that a common sense object ontology fails to capture the shades and ambiguities inherent in the world, and must be replaced by an object ontology. They proclaim that progressive physics affirms that a process ontology which projects existence as contradiction is the only ontology capable of reflecting the advances made by information technology. They proclaim that progressive physics affirms that a common sense ontology of objects is useless for the comprehension of the advancements made by modern technology. They proclaim that progressive physics affirms that there exist no particles which change, only pure

changes, forces and fields themselves. They proclaim that progressive physics affirms that a process ontology which denies that anything exists or is as it is, is the only means of grasping reality. They proclaim that progressive physics affirms that a process ontology which says that a thing can be both A and non A, a unity of opposites, and be both a square and a circle at one and the same time, is corroborated by all the evidence of science reaching across all scientific discipline. They proclaim that progressive physics affirms that a process ontology which says that existence is both A and non A at one and the same time, and is thus indetermination and nothingness, is the basis of all true philosophy and science. They proclaim that progressive physics affirms that reality is pure variation and oscillation without the existence of anything which varies or oscillates. They proclaim that progressive physics affirms that there exist no definite entities, points, air temperatures or chemical compositions in the world, and the belief that there does betrays a lack of flexibility in studying reality. They proclaim that progressive physics affirms that the belief in the existence of individuals is irrelevant to the course and progress of science. They proclaim that progressive physics affirms that reality is pure violence, trembling, revolution, leveling and a whirling flux of rubble. They proclaim that progressive physics affirms that the belief that reality is intelligible and noncontradictory is static, stagnant and mind shackling. They proclaim that progressive physics affirms that there exists change over time but nothing individual which in fact changes over time. They proclaim that progressive physics affirms that reality can only be grasped mystically, holistically, not in terms of individual objects, but as a single, undifferentiated one in eternal change and movement with nothing which changes or moves. They proclaim that progressive physics affirms that reality is a mystical antisystem containing contradictory elements. They proclaim that progressive physics affirms that reality consists of peaks and valleys of change with nothing which rises or falls. They proclaim that progressive physics is pure dynamism, interaction and interconnection with nothing which accelerates, interacts, interconnects or related to anything else. They proclaim that progressive physics affirms that reality is a continuous flowing in and flowing out with nothing which flows in or out or is bounded or limited by anything, and is pure endless insanity: "Traditionally, conceptual modeling has followed the ontology of individual substances, which suggests reality consists of independent substances, often described as objects, entities, individuals, or things. These substances possess properties or attributes and experience changes, leading to events and processes. This perspective is best represented by Bunge's ontology, which asserts that the world is composed of things that are substantial individuals. However, this perspective may limit our ability to model and capture nuances represented in our world. To continue aligning conceptual modeling with modern information technology landscape, we consider an alternative ontology. Although the traditional ontology of individual substances is useful in many situations, it may encounter limitations when dealing with today's IT [Information Technology]. Notably, a similar challenge has been identified in philosophy and the natural sciences. For example, advances in physics led to the assertion that 'there are no particles, only fields.' This conclusion was reached based on the accumulation of evidence from various scientific disciplines. A unique aspect of the ontology of fields is the notion of a field. The concept of a field is central in both modern science and philosophy, offering a valuable model for understanding reality. A field is defined as any physical or conceptual entity that displays varying values across space and time, driven by the oscillations that form and maintain these fields. By embracing the scientific notion of a field, we can conceptualize a wide range of aspects of existence. Fields provide powerful flexibility during analysis. Fields can be analyzed by studying properties at specific points within them, and also considered more broadly as an entity with global or even emergent properties in and of itself. For instance, a particular point in the sky modeled as a field might have attributes like its chemical composition. However, when considered collectively, other properties of interest emerge such as air temperature and humidity. The notion of shifting modeling perspectives from individual objects to fields may result in new conceptual modeling constructs. It could be that some properties depicted in conceptual models are only relevant as we move from the individual object focus to the

focus on fields. It is recognized that fields can change over time. At one minute, a mountain might exist. However, after a sudden and violent earthquake occurs, that very mountain might be leveled to rubble. Unfortunately, conceptual models themselves have remained somewhat static and stagnant after their creation, often leaving those who consult them wonder if they are current. The ontology of fields explicitly encourages conceptual modeling to consider how some aspects of a model might change over time. Applying field theory to conceptual modeling encourages a holistic view, considering the entire ecosystem of interactions and dynamics rather than primarily isolated components." (*The Ontology Of Fields As A Foundation For Conceptual Modeling* by Arturo Castellano, Jon Beard, et al). Particle physics commenced with the Greek philosopher Democritus in the sixth century BC and progressed through Isaac Newton, Roger Boscovitch, Michael Faraday and Ernest Rutherford, followed by quantum physics in the twentieth century. Since the 1950s, discoveries in particle physics have sparked the assembling of a veritable particle zoo containing a gargantuan list of subatomic particles. Every discovery of a subatomic particle has driven one more nail in the coffin of field theory. In 2012, the European Center for Nuclear Research in Geneva, Switzerland discovered the Higgs particle, the source and symbol of the existence of mass, weight and particles in the universe. The high energy particle colliders in the world today have done something which common sense accomplished over two thousand years ago. They have smashed the superstitions of field theory.

RED PRIEST GATHERED THE FAITHFUL

It is the brightest body in the sky. It is more dazzling than any star and does not twinkle, but glows and emits a steady silver light. It has many names, and for centuries, these names were thought to refer to different objects. It is called the Morning Star, the Evening Star, the Shepherd's Star and the Night Light Of The Sky. It is the planet Venus, and its different names provide a vivid illustration of the common situation in which a host of different names refers to one and the same reality. On October 22, 2024, a Catholic priest, professor and theologian died who had achieved worldwide fame and notoriety for having given an old movement a new name, and peddling it among the faithful under this new name. The old movement, gathering the diseased, delinquent and disaffected classes swimming in the sewers of the world, was Marxism, and the name Gustavo Gutierrez gave to it was liberation theology, and his 1971 book, *A Theology Of Liberation*, launched this Marxist movement within the church, a movement which would gain a worldwide following in and out of Catholicism. Able to see what high officials in the Catholic Church, including Cardinal Joseph Ratzinger, later Pope Benedict, refused to see, refusing to see the affinity between Marxism and Christianity, an affinity in which the Church's defense of the poor appears in Marxism as a defense of the proletariat, Gutierrez issued a program and manifesto for a Christian-Marxist destruction of the traditions and institutions of the Enlightenment. Listen to the program and hear the tanks of Marxist imperialism roll into free nations and spread panic in the streets. Father Gustavo Gutierrez, Christian, Marxist and dedicated revolutionary, proclaimed that a true Catholic Church advocates political violence as a means to popular liberation. He proclaimed that a true Catholic Church advocates communism in every sector of society, among youth, in chess clubs, in music concerts, in cinemas, at weddings, and in the filthiest basements and beerhalls inhabited by subhumanity: "A Peruvian priest who founded liberation theology, a movement advocating an active role for the Roman Catholic Church in fighting poverty and injustice but reviled by some as Marxist, has died. Father Gustavo Gutierrez was 96 when he passed away on Tuesday in his hometown of Lima. A theologian who later became a Dominican friar, he revolutionized Church teachings with his 1971 book *Theology Of Liberation*. His progressive theories were embraced by many in his native Latin America but were also met with opposition and even disdain from more conservative voices within the Church. He drew criticism from no other than Cardinal Joseph Ratzinger, who later became Pope Benedict. The cardinal feared that liberation theology's Marxist ideas would foster rebellion and division, even labelling it as a 'fundamental threat to the faith of the Church.' Relations between the Vatican and Father Gutierrez thawed somewhat after his fellow Latin American, Jorge Mario Bergoglio, became Pope. Father Gutierrez praised Pope Francis for speaking about 'a poor Church for the poor' and in 2018, Pope Francis sent Father Gutierrez a letter for his 90th birthday thanking him 'for what you have contributed for the Church and humanity through your theological service and your preferential love for the poor and the discarded of society.' Before becoming a priest, Gustavo Gutiérrez had studied medicine and literature in Peru, philosophy and psychology in Belgium, and theology in France. During his time in Europe, he read the works of German philosopher Karl Marx. His detractors often said his emphasis on helping the poor was Marxist and decried him as a communist. Liberation theology became particularly controversial when priests who followed a radical strand of liberation theology joined revolutionary movements such as the Sandinistas in Nicaragua, who overthrew the dictatorial government of the Somoza family. But Father Gutierrez maintained that his teachings were far from revolutionary but rather squarely rooted in the Bible. He said that upon his return from Europe to Peru, he had found that the Church was often 'answering questions that weren't being asked,' implying that the Church hierarchy had become too far removed from the troubles of its parishioners, especially in deprived and poor areas. He argued that the clergy had a lot to learn from the faithful in the poorest parishes who, he said, demonstrated day after day how hope could spring amidst suffering. In his book *The Hermeneutic Of Hope*, he recalled how he had fought against a view prevalent among many faithful at the time that 'we are born to suffer.' 'No one is born to suffer, but to be happy,' he wrote. 'Poverty is a human construction; we have made these conditions.' Described by his parishioners as a 'humble man with a great capacity to make friends,' he combined his work as a theologian and lecturer at top universities with his work as a priest, officiating at weddings and holding retreats. Felix Grandez, a Peruvian sociologist who first met Father Gutierrez at a spiritual retreat in 1978, said the priest radiated 'a happiness which stemmed from doing good, from his dedication to the poor.' Mr Grandez told the BBC that one of the priest's gifts was to distil theology into clear messages which appealed to the young, something he said he saw Father Gutierrez do when he officiated at Mr Grandez's own wedding and again at that of his daughter. 'He was well known as a theologian but the way he connected with people was through talking about chess, traditional music, cinema, and his support for Alianza Lima football club.' Another parishioner who was married by Father Gutierrez said she felt 'immense gratitude for his life and all that he has contributed to the Church.' " (*Liberation Theology Icon And Champion Of The Poor Gutierrez Dies* by Vanessa Buschschluter). Marxist Father Gustavo Gutierrez proclaimed that a true Catholic Church is an organization of Marxists. He

For many years, DIALOP has 'been committed to promoting the common good through dialogue between Socialists/Marxists and Christians,' the pope said in his address, calling its endeavor 'a fine program!' 'Never lose the ability to dream!' he told them. 'Don't back off, don't give up, and don't stop dreaming of a better world.' The leaders of DIALOP credit Pope Francis as the inspiration for their project, noting that the pope met with two left wing politicians in 2014, Alexis Tsipras and Walter Baier, and discussed the environmental crisis and the worldwide social crisis. 'At the end of that audience, Pope Francis called the visitors to launch a transversal dialogue, capable of involving the broadest strata of society and above all of the youth,' DIALOP's website states. 'We agreed on the need to continue the dialogue between the European left and the Christian church,' Tsipras said. 'There is a need to create an ecumenical alliance against poverty, inequalities, against the logic that markets and profits are above people.' In its 2022 position paper, DIALOP compared the words of the Virgin Mary in the *Magnificat* to Karl Marx's 'categorical imperative.' 'As careful readers of the Marxian tradition rightly stress, to overthrow the powerful from their throne is similar to the categorical imperative of Karl Marx, which demanded that all conditions should be reversed in which man is degraded, enslaved or abandoned,' the paper states. Little by little, the Catholic Church has moved from its position of early condemnations of socialism to a more welcoming attitude, the paper asserts. 'Probably the best comment on the change in mentality that this represented came from liberation theologian L. Boff when he stressed that the pope (Francis) has made liberation theology a full part of the official narrative of the

Church,' it declares." (*Pope Francis Praises Marxist-Christian Dialogue: 'A Fine Program'* by Thomas Williams). Carl Bloch was a nineteenth century Danish artist specializing in scenes from the life of Jesus. His most famous work is the 1877 oil painting *Sermon On The Mount*, depicting Jesus evangelizing among his disciples. Jesus prays to his Father: "Your kingdom come, your will shall done on Earth as it is in heaven." The will of God, says Jesus, the will of Society, says Marx. The first is the precursor of the second, the second is the terrifying implementation of the first, submerging the world in rivers of blood.

GEOLOGY CRUMBLES

It all began with Theophrastus. In the fourth century BC, this Greek philosopher and colleague of Aristotle wrote a book called *On Stones* and inaugurated the science of geology. In the first century AD, the Roman naturalist Pliny the Elder advanced the field with his multivolume, encyclopedia *Natural History*, in which he studies an extensive variety of minerals and metals. In the sixteenth century, Georgius Agricola wrote the groundbreaking book *Fossils Of Nature*. The eighteenth century saw the publication of *On The Strata Of The Earth* by Mikhail Lomonosov and *Theory Of The Earth* by James Hutton. The nineteenth century saw the publication of Charles Lyell's famous *Principles Of Geology*. The twentieth century saw the development of plate tectonics, the theory that the Earth's lithosphere is comprised of large, slow moving tectonic plates, by astrophysicist John Wilson. In the twenty first century, this venerable, illustrious 2500 hundred year old scientific study of the Earth's history, structure and substance has been struck by an earthquake. It has been reduced to rubble by an invasion of a movement which for the past one hundred years has been the number one religion of our time. It has been transformed beyond recognition by the onrushing tides of a party, a faction and a group of people working to advance their terrifying goal of overthrowing the traditions of the Enlightenment. As 'end times' frame climate change conversations, this book goes back to look at the beginnings of the field of geology as a colonial practice that created normative orders of materiality and destroyed worlds. I investigate how we might understand geology as an ideological and material infrastructure of matter and materialism that shapes subjective and planetary states. And how calculative regimes of geology organized both the temporal and political surfaces of power, and its racialized undergrounds." (*Geologic Life* by Kathryn Yusoff). The new Marxist invaders of geology proclaim that empirical geology is a system of racial segregation and apartheid enforced by whites. Empirical geology is a

Alongside the transformation of environments, paleontology (paleontology) named and raced persons as geologic subjects through the category of the *inhuman*. The designation as inhuman, used for both raced subjects and subjectless matter, diffused the violence of geology and maintained the colonial prerogative of value and its progressive scripting of extraction as a genealogical achievement of whiteness. Antagonism to white geology is also an attachment to other kinds of earths and inhuman intimacies not continually wrecked by the accumulative geologies of those practices. We can see resistant earth and ecological practices as a defining continuum of struggle against colonial forces of transformation and white geopower." (*Geologic Life* by Kathryn Yusoff). Valley View High school is a public high school located in Moreno Valley, California. Its school colors are red, white and black, and its mascots are the Eagles. It offers sports teams such as soccer, swimming, football, volleyball, basketball, golf, tennis, wrestling, and track and field. It offers a variety of clubs for students to join, such as the Anime Club, the Art Club, the Eco Club, the Mental Club and the National Honor Society. It hosts a Journalism Class which is respected throughout the state, and a Yearbook Class which trains students in life skills. This seemingly all American high school has a dark side which exploded on November 6, 2024. After complaining that 'black and brown men' didn't turn up on Election Day to vote for Kamala Harris. Perez tells his class he knows 'a lot of Latino men who wish they were white'—including students' 'fathers, uncles, and grandfathers. God, they want to be white so bad but they never will be. I hate that shit. I hate Latino men that oppress the women in their family, their own daughters. And then they turn around and vote for men who want to oppress them.' Perez then turns his focus on women: 'God I fucking hate the patriarchy. If you're a young man right now in front of me, I hope you hate it too. You get the privilege of not being born with a uterus.' After exhaling loudly, Perez says 'I'm so fucking sorry, guys. You deserve better.' (presumably a reference to Trump, not himself). Continuing through the 'oppression' matrix, Perez tells his charges that they have 'a fuck ton of privilege living in this great state' because there's a 'poor Palestinian boy in Michigan that's going to get beat up today.' Perez then calls Trump 'treasonous scum' and a 'rapist, draft dodging coward,' and asks the class to ponder why people would vote for Joe Biden—a 'geriatric, old Republican racist who's running as a Democrat'—but not Kamala Harris, who has an 'effective policy for the future.' As such, there needs to be a 'balanced environment where all students feel safe to ask questions' and 'engage in respectful dialogue.' As of Saturday, DeAngelis also obtained an email from Moreno Valley Unified School District officials to parents noting they are aware of an incident in which a teacher behaved in an 'unprofessional' manner. It has begun an investigation, and Perez has been put on administrative leave in the interim. According to *US News*, Valley View HS is three quarters Hispanic, 12.4 percent black, and just over seven percent white. Seventeen percent of students are

High school teacher Maximiliano Perez proclaims that a progressive school is a malarial fever swamp swirling with mad expletives directed against Donald Trump. I stopped and looked out over the fjord: the sun was setting, and the clouds were turning blood red. I sensed a scream passing through nature. It seemed to me that I actually heard the scream. I painted this picture, painted the clouds as actual blood. The color shrieked. This became *The Scream*." One of the supporting briefs, filed by the Foundation for Individual Rights and Expression, pointed out that the lower courts couldn't even agree on why they were attacking the student's rights. 'The district court denied LM's request for a preliminary injunction and later entered final judgment against him, reasoning that the shirt constituted an impermissible 'invasion of the rights of others.' The First Circuit affirmed on alternative grounds, adopting a novel test that would allow schools to censor speech that neither targets nor harasses a specific student,' the brief charges. That precedent, FIRE said, allows schools to target 'passive, silently expressed speech that targets no student in particular if the student's expression (1) is reasonably interpreted to demean one of those characteristics of personal identity, given the common understanding that such characteristics are unalterable or otherwise deeply rooted and that demeaning them strikes a person at the core of his being, and (2) the demeaning message is reasonably forecasted to poison the educational atmosphere due to its serious negative psychological impact on students with the demeaned characteristic and thereby lead to symptoms of a sick school—symptoms therefore of substantial disruption.' Essentially, such a ruling would allow virtually unlimited censorship based on the reaction of others to the speech involved, long described as a 'heckler's veto' which has been disapproved at the Supreme Court level. The ADF, representing the student, applauded the support for the student from education experts, free speech advocates, and 18 states. It explained, 'In June, the US Court of Appeals for the 1st Circuit affirmed the school's decision, prompting Alliance Defending Freedom attorneys, who represent the student, to ask the high court to review the case and rule that Nichols Middle School in Middleborough violated the First Amendment when it stopped the student from wearing his shirts to school.' 'Students don't lose their free speech rights the moment they walk into a school building,' said ADF lawyer David Cortman. 'This case isn't about T-shirts; it's about a public school telling a middle schooler that he isn't allowed to express a view that differs from their own. The school actively promotes its view about gender through posters and Pride events, and it encourages students to wear clothing with messages on the same topic—so long as that clothing expresses the school's preferred views on the subject. Our legal system is built on the truth that the government cannot silence any speaker just because it disapproves of what they say. We appreciate the many states and organizations that have joined us in urging the Supreme Court to take this critical free speech case.' " (*T Shirt With Factual Message Gets Boy Suspended: Supreme Court Now Involved* by Bob Unruh). As a result of zero tolerance policies, public schools across America have utilized law enforcement authorities to assist in the task of disciplining students. Students caught in possession of illegal drugs or weapons are turned over to the police and courts. Public schools across America have adopted the nation's official creed of Marxism, and assaulted students from all directions with pride flags and diversity posters celebrating transgenderism. At the end of Trump's trial, Merchan and Bragg revealed that the second crime was a New York law to 'promote or prevent the election of any person to a public office by unlawful means.' But those jury instructions never specified the 'unlawful means.' In other words, the second crime now depends on a third crime. But then Merchan's jury instructions go on to hint at that third crime: violating the Federal Election Campaign Act (FECA). Specifically, Bragg alleges that Trump made a payment as part of a nondisclosure agreement (NDA) to keep quiet an alleged interlude that the president steadfastly denies, with Merchan instructing the jury that they can consider that an illegal federal campaign expense. But that too would be unconstitutional. NDAs are not FECA violations under federal law. Only the US Department of Justice (DOJ) or the Federal Elections Commission (FEC) can say otherwise, and they have done the opposite. A county prosecutor in charge of enforcing New York state law cannot create a new federal crime by interpreting federal law differently from the federal government. That violates the Supremacy Clause of the US Constitution. Merchan then committed another error that would lead to the reversal of Trump's prosecution on appeal by not allowing former FEC Chairman Brad Smith to testify at the trial to explain to the jury that NDA payments are not illegal campaign expenses, and therefore that even if all the factual allegations were true, it would not violate federal law. But Merchan's presiding over this case is also unconstitutional, violating due process. Merchan gave political contributions to opponents of President elect Trump, specifically the Democratic Party and Joe Biden. Federal judges never give such contributions, and if they did, they would be required to recuse from a matter. That is because the Constitution entitles every defendant to a judge who is fair and impartial, so it violates the Fourteenth Amendment Due Process Clause for a state judge to preside over the prosecution of a politician where he has donated money to that politician's opponent. Merchan then violated the Constitution yet again by giving the jury multiple crimes to choose from for this 'unlawful means' aspect of the case. He said each juror could look at a menu of options, and so long as the juror found one crime he liked, he could vote to convict Trump—which resulted in 34 felony counts. But when a person is charged with a felony, the Sixth Amendment commands that a 12 person jury must unanimously vote to convict the defendant of that crime. Merchan's choose your own adventure instruction saying the jurors could disagree about what the crime is yet still convict Trump is a shocking violation of his constitutional rights. President elect Trump's lawyers are asserting additional legal grounds for reversal as well, but you get the point. This was a thoroughly illegal prosecution from the very beginning, weaponizing law enforcement and the court system in Banana Republic style lawfare to criminalize political opposition. For all those reasons, if Merchan refused to set aside the convictions, many people have rightly been waiting to get this case out of Merchan's courtroom so Trump's convictions could be thrown out on appeal. Then came the watershed Supreme Court decision in *Trump v. United States* on July 1 regarding presidential immunity. Although the court decision merely made official something that constitutional scholars have always believe existed—and the left has melted down over it, gaslighting voters with ridiculous lies about the court's decision—it became a new reason to throw out Trump's convictions." (*Juan*

Merchan Delays Ruling On Trump Prosecution, Either Backing Down Or Setting Trap by Ken Klukowski). A police spokesperson told *De Morgen* that five people had been put under administrative arrest on Sunday, a special form of arrest used in Belgium as a preventative measure rather than as part of a criminal investigation, which can last up to 12 hours. All five were released from administrative arrest that night in accordance with Belgian law. Belgium was not immune from the global rise in antisemitism stemming from Hamas's October 7 attacks. City authorities recorded over 90 reports of antisemitism in the first two months of the war, according to a *Sky News* report. In the same report, residents highlighted that they were much more visible as the majority of the community is haredi (ultraOrthodox). They proclaim that a just society organizes pogroms against Jews. After the Amsterdam pogrom, calls began to appear on social media from Thursday to Friday for local youth to organize a *jodenjacht* (Jew hunt). In order to avoid frightening the locals, police did not publicize the calls for violence in the neighborhood, according to *The Brussels Times*. Anyone found in possession of flags, balaclavas, or other material that could point to imminent action risked an administrative arrest. The same applied to those who did not respond to police requests to leave the area. The spokesperson also said that there were several minors among those arrested. Police said that there were no incidents recorded on Sunday. Police also identified the social media posts as belonging to a 17 year old, who was detained and questioned. He was released after questioning. Shmira, the local Jewish security patrol, was also active on Sunday with about 20 officers deployed, according to *De Morgen*. Recent posts on social media have raised the fear of attacks on Jewish residents of Antwerp; however, *De Morgen* found that these posts largely date to before last week's pogrom. In one video, a young man can be seen being attacked and beaten as his attackers shout, *Free Palestine!* His mother told local media that the attackers were lying in wait for him. In another video, a Jewish man cycling through central Antwerp was attacked. Antwerp Police confirmed they were investigating this incident. Police said that at this time, no charges had been filed and encouraged anyone who was a victim of a hate crime to come forward and report it. Outgoing Justice Minister Paul Van Tigchelt tried to reassure the Jewish community following the Amsterdam pogrom in a meeting on Sunday. He told them that the Belgian antiterror service was working to stop copycat attacks. 'Can this happen in Belgium? The honest answer is: Why wouldn't it happen here? We have to be realistic about that.' Belgian PM Alexander De Croo also spoke out against the violence, saying, 'There is no place for antisemitism in Europe.' " (*Antwerp Police Arrest Five, As Fears Of A 'Jew Hunt' Rise Following Calls To Action On Social Media* by Yuval Barnea). Belgium's Muslims proclaim that a just society has no desire to protect the rights of its Jewish inhabitants. They proclaim that a just society is a proPalestinian society seeking to abolish Israel. This stadium, which opened in 2021, seats 9,000 people. The September 6 was originally scheduled to take place in Brussels's Stade Roi Baudouin (where the Belgian Football Federation's official website still lists this fixture taking place). In late June, Brussels mayor Philippe Close and first alderman for climate and sports Benoit Hellings said their city could not host the game, citing heightened risks and serious security concerns. The city officials said they did not want to take risks, amid the ongoing Gaza conflict and strong pro-Palestinian sentiment within the Brussels' migrant population. On June 19, Hellings said 'given the chance of riots, in the stadium itself, in the immediate vicinity and in the city center, we cannot take the risk of endangering the safety of our fellow citizens.' The match posed 'a disproportionate risk,' even if played behind closed doors, said Hellings. Brussels has witnessed frequent public demonstrations in support of Palestine and against Israel. The city has permitted protests by organisations such as Samidoun, which often defends Hamas, and the chant 'from the river to the sea' is frequently heard in Europe's capital. Some observers argued Hungary's choice was ironic, after the country received criticism for not opening its borders to migrants from majority Muslim countries. Now, they say, Hungary appeared to offer Europe's only safe location to organize a football game against Israel, without threat of terror or attacks. 'Outside of a war situation, this is the first time, to my knowledge, that a European country has officially recognized that it is no longer master of its territory, due to an overly pressing Arab-Muslim presence,' said French political activist Damien Rieu." (*Belgium-Israel Football Match To Be Played In Hungary For Security Reasons* by Carl Deconinck). Time: 1914 to 1918. Place: Waregem, West Flanders, Belgium. Flanders Fields form a no man's land ablaze with scarlet poppies. They had never grown so abundantly before in the history of the region. The war made them flourish. The bombs dropped plowed the soil and brought poppy seeds to the surface. Today's schoolteachers use profanities and vulgarities to promote Marxist race politics, and proclaim that blacks and hispanics are genetic Marxists and those who vote for Trump are betrayers of their own race and instruments of the white man's capitalist system: "Supporters and critics of a Moreno Valley history teacher who was placed on leave after a profane antiTrump rant in class clashed over his fate at Tuesday's Moreno Valley Unified District board meeting. Less than a century after the prestigious British publishing house of Secker and Warburg allowed the world to be educated by the most renowned cautionary tale in history, the monster of totalitarian control has rendered Britain, the nation which first gave voice to freedom in modern times, morally and spiritually unrecognizable. Less than a century after Orwell described his Britain of the future as Airstrip One, a province of Oceania under the leadership of Big Brother, this nation, whose *Magna Carta* 1215, *Petition of Right* 1628, *Bill of Rights* 1689 and *Claim of Rights Act* 1689 first codified freedom in the West and was a light for all mankind to follow, has fulfilled Orwell's prophecy and plunged into a place of fright in which truth and facts are suppressed, and a barbed wire fence has been constructed around freedom of thought and conscience. Children as young as nine are currently being investigated by the police for *noncrime* hate incidents. According to the *Daily Mail*: 'A nine year old child is among the youngsters being probed by police over hate incidents. Officers recorded incidents against the child, who called a fellow primary school pupil a 'retard', and against two schoolgirls who said another student smelled 'like fish.' The youngsters were among multiple cases of children being recorded as having committed *noncrime* hate incidents (NCHIs). *The Times* discovered through freedom of information requests to police forces.' 'Noncrime hate' is not exactly new. In 2014, the police introduced the *Hate Crimes Operational Guidelines*, which have since been updated. According to the guidelines, any noncrime incident that is perceived, by the victim or any other person, to be motivated by a hostility or prejudice based on a person's race, religion, sexual orientation, disability or transgender identity must be recorded, even if there is no evidence of the hate element: 'For recording purposes, the perception of the victim, or any other person is the defining factor in determining whether an incident is a hate incident. The victim does not have to justify or provide evidence of their belief, and police officers or staff should not directly challenge this perception. Evidence of the hostility is not required for an incident or crime to be recorded as a hate crime or hate incident.' Since 2014, British police have reportedly recorded more than 250,000 noncrime hate incidents in England and Wales. The noncrime incidents, logged in a system, can even show up, when employers ask for a copy of a prospective employee's criminal record. In late June, a 12 year old Jewish boy had counterterrorism police come to interrogate him at his home for saying there 'are only two genders'; and for saying that Hamas should be 'exterminated.' His mother said the counter terror officers 'raised concerns over the fact that her son, who is Jewish, harbored extremist views on account of his response when asked if there were any groups that shouldn't exist. Her son responded that 'Hamas (the Gaza based terror group) should be wiped out'. He was also accused of 'unhealthy interest in weapons' for owning a toy crossbow. Mainstream Britain's better late than never acknowledgement of the tragic demise of sanity and liberty in the UK is recent, and has especially grown since *Daily Telegraph* journalist Allison Pearson was visited by police earlier this November, informing her that she was accused of a 'noncrime hate incident.' A tweet she had posted more than a year ago, the police told her, was 'stirring up racial hatred.' She asked who accused her and why, but the police told her she could not be told what her offending tweet was, nor the 'victim's' name. She is now under investigation for spreading material allegedly 'likely or intended to cause racial hatred.' 'This is not what people fought and died for in the war,' Pearson wrote in the *Telegraph* about her ordeal, which she described as proof of Britain's two-tier justice system. There are lots of things that people did not fight and die for in the war but that the mainstream British media has ignored for decades: Mass migration from the Muslim world; rampant violence and terrorism; Muslim grooming gangs, raping, torturing, sometimes killing, hundreds of thousands of British children and young women while the police covered up their crimes." (*Mad Britain: Nine Year Olds Being Investigated by Police for Non Crime Hate Incidents* by Robert Williams). Less than a century after Germany was reduced to smouldering ruins in the aftermath of World War II, race politics is back in business and has taken over a venerable state university in America. It has taken over the State University of New York and installed ideological monsters in its administration. favor of racial minorities and women calls its discrimination building paths and bridges to women and nonwhites. It proclaims that a progressive university rejects nondiscriminatory hiring in favor of achieving gargantuan percentages of nonwhites surpassing the population of the Earth. It proclaims that a progressive university rejects liberal race blind and gender blind hiring policies and discriminates in favor of women, hispanics, blacks, Native Americans and Pacific Islanders. It proclaims that a progressive university is a biased university in its hiring and discriminates in favor of minority scholars. It proclaims that a progressive university fills up job applicant pools with blacks before it undertakes hiring. It proclaims that a progressive university hires faculties which reflect the demographics of the general population. It proclaims that a progressive university hires faculties which reflect the racial composition of society. It proclaims that a progressive university hires faculties whose ideological makeup is black Marxism. It proclaims that a progressive university hires faculty whose theoretical orientation is communism and color. It proclaims that in a progressive university, racism is foundational to its teaching and scholarship. It proclaims that a progressive university requires the exclusion of whites from its faculties. It proclaims that a progressive university promotes the policies, systems and institutions of black national socialism. It proclaims that a progressive university hires faculties which are overwhelmingly nonwhite. It proclaims that a progressive university is systematically biased against white males in its hiring. It proclaims that a progressive university hires nonwhite faculties only in the name of fairness and justice. It proclaims that a progressive university is a social advocacy institution whose merchandise is black Hitlerism. It proclaims that a progressive university hires black professors only because black students demand to be taught by people who look like them. It proclaims that a progressive university hires on the basis of black identity, and in the name of antibias and antiracism has abolished knowledge, learning and the defense of civilization from its campus: "The Supreme Court in *Students for Fair Admissions v. Harvard (SFFA)* banned the use of race in admissions in higher education. In the State University of New York system, however, race conscious methods are alive and well in another domain: faculty hiring. After the ruling, Chancellor John B. King, Jr and the SUNY Board of Trustees declared that the Court had 'attempted to pull our nation backwards in the journey toward equity and civil rights.' Blacks and latinos 'are still underrepresented across institutions of higher education as students, faculty members, and administrators,' they said, so 'better paths and bridges' would be needed to dismantle 'roadblocks and barriers.' In the SUNY system, these 'paths and bridges' take the form of three diversity awards and scholarships: Promoting Recruitment, Opportunity, Diversity, Inclusion and Growth (PRODIG+); the Empire State Diversity Honors Scholarship; and the Graduate Diversity Fellowship. The first is a recruiting program designed to induce 'over 400 postdoctoral fellows to enter tenure track faculty positions at state operated campuses'; the latter two are DEI focused scholarships for undergraduate and graduate students, respectively. SUNY's PRODiG+ program is explicitly designed to 'increase the number and share of excellent diverse faculty committed to advancing the ideals of diversity, equity, and inclusion (DEI).' In practice, 'diverse faculty' apparently refers to racial minorities and women. SUNY Cortland's PRODiG proposal, for example, stated clearly that it intends to 'hire a percentage of URM [underrepresented] faculty that equals or surpasses the diversity of our student population.' Cortland's 2022 program overview clarified further that 'underrepresented' groups included 'women in STEM disciplines [WSTEM], hispanic/latinx, African Americans, Native Americans, and Pacific Islanders.' One of the school's PRODiG+ initiatives is called the Diversity Faculty Fellows (DFF) program; it is intended to 'attract diverse faculty of promise to [Cortland's] campus.' These postdoctoral fellowships are effectively employment programs, and university documents reveal that administrators put their thumbs on the scale to benefit minority scholars. For example, officials asked search committees to revisit the qualifications of URM candidates who were not selected for a campus interview 'to determine if apparent bias' led to their rejections. Additionally, several SUNY Cortland departments allow DFF searches to be extended or postponed due to 'insufficient

diversity' in the applicant pool; in the 2019-2020 application cycle, one DFF search was cancelled entirely 'due to lack of diversity in the pool.' These efforts produced the desired demographic effect. In a progress report, SUNY Cortland states that, thanks to PRODiG, '39% of our hires over those two years [2020-2022] resulted in the hire of URM or WSTEM candidates' compared with only 18 percent over the preceding two years. The program is changing not only the racial composition but also the ideological makeup of SUNY's faculty, selecting for, in the university system's words, 'faculty committed to advancing the ideals of diversity, equity, and inclusion.' Indeed, all three of SUNY's system wide diversity award programs (PRODiG, the Graduate Diveristy Fellowships, and the Empire State Diversity Honors Scholarship) probe applicants' commitment to equity. For example, SUNY Cortland's Foundation and Social Advocacy Department asks DFF candidates which 'theorists have influenced your scholarship and/or teaching' to better gauge candidates' 'theoretical orientation'; candidates are also asked to provide 'definitions of inclusion.' At SUNY Cortland, department chairs' commitment to diversity extends beyond hiring faculty. Indeed, they indicate, DEI is foundational to their teaching and scholarship. The history department, for example, believes that 'questions of equity and inequity, inclusion and exclusion, and human created systems and cultures drive the study of history.' Art history relates that teaching students 'how our government, policies, systems, and institutions have all contributed to perpetuating racism and injustice' has 'always been an important goal' of the department, hobbled as it is by being 'a field that is, to its detriment, overwhelmingly white.' The psychology chair, meantime, sent out a letter 'explaining the systematic bias that caused historical figures in psychology to be disproportionately white and male,' and the literacy department seeks to 'leverage multiple theories of literacy as a tool for equity and justice.' " (*SUNY Has Adopted A Program To Hire Minority Professors* by Louis Galarowicz). The Fuhrer of Germany had a special affinity for wolves. He savored the etymology of his name: *adel*, meaning noble, and *wolf*, and he used *Wolf* as a pseudonym for himself. Ireland Act, which abolished all statutory roles of the British monarchy, and established the free and independent Republic of Ireland. In the twenty first century, Ireland has lost its independence and fallen under the control of an international movement. The nation which for decades fought for its independence from the British Empire has become a satellite of a global empire of civilizational collapse known as Marxism, and its new satellite status has rendered it morally and spiritually unrecognizable. Pupils taking

the 'Politics and Society' subject as part of Ireland's Leaving Certificate exams—an examination process similar to England's A Level system, which largely determines what universities a high school leaver is able to go to—were presented documents praising BLM and promoting the concepts of 'White Privilege' and 'Micro Aggressions.' Split into two different levels—higher and ordinary—for the purpose of assessing students of different competencies in the subject, both of the nationwide exams conducted earlier this week contain material pushing concepts frequently associated with the far left. For example, in the ordinary level paper, students were asked to examine two sources and answer questions about 'undocumented' (illegal) migrants. The first source was an infographic titled *Live Here, Work Here, Belong Here* published by Migrant Rights Center Ireland, containing various statistics regarding illegal immigration in Ireland. The second source was an adapted extract from left wing publication *The Journal*, which contained suggestions that a near blanket amnesty for illegal migrants currently taking place in the country might not go far enough. Among the host of questions pupils were asked to complete on these documents, pupils were told to 'describe a citizenship project you could undertake, based on organizing an event to raise awareness about the plight of undocumented migrants in Ireland.' Other notable questions within the paper include Question A(t): 'Describe two ways that Ireland benefits from being a member of the European Union' and Question 7: 'Using the infographic below discuss issues of inequality in the world today and suggest what can be done to address these issues.' The latter of these linked to another graphic referencing the Black Lives Matter movement. The higher level paper was similar in tone to the ordinary level examination, with pupils being asked to consider two documents, the first of which discussed 'white privilege' and 'microaggressions.' The second document was another infographic, this time from George Soros linked Irish Network Against Racism and the NGO's so-called racism reporting system iReport. This latter document was also listed as being penned by Dr Lucy Michael, a major 'antiracist' academic in Ireland who became embroiled in a scandal after being recorded talking to an undercover conservative journalist in the country who was posing as a member of Antifa at the time. When asked by the undercover reporter from *The Burkean* if she was 'okay with getting potentially physical with' the so-called 'far right' and 'doing what needs to be done,' she responded that she 'wouldn't say no', with the academic also describing her 'professional [and] personal opinion' as being separate. Pupils were also asked a whole host of questions on the topic of climate change, including one on how the Irish government should interpret poll results regarding 'higher taxes on energy and fuel.' Speaking to *Breitbart Europe* regarding the contentious exams, Brexit campaign veteran and former Irish schoolteacher Hermann Kelly slammed the papers, saying that they were 'clearly not about education and debate but the regurgitation of a worldview and value system formed by cultural Marxism.' 'This is pure propaganda well off the Richter scale, and worthy only of a communist state,' the former secondary school teacher of Science, Maths, Classical Studies, said. 'All the far left shibboleths are in there,' the Irish Freedom Party president continued. 'Class warfare, climate action, gender ideology, proEU empire, promass immigration. The most outrageous section is the fawning survey by Migrant Rights Center about people living in Ireland illegally, what it calls the 'undocumented'. It proclaims that Thanksgiving must be canceled because it celebrates a culture, the West, which through its civilizing mission in the New World, caused untold suffering and distress to people who for millennia acted and lived in the manner of animals. It proclaims that Thanksgiving must be canceled in the name of native liberation and the superiority of socialist, tribalist, anticapitalist modes of living: "The University at Buffalo in New York held a 'Decolonizing Thanksgiving' event last week, which questioned if it was 'right to celebrate Thanksgiving' and the United States' 'history of settler colonialism.' The event, which was hosted by the university's Intercultural and Diversity Center (IDC) on November 21, was part of a segment called *Tough Topics*. *Tough Topics*

events are described as a 'weekly open forum' where national, global, and current events are talked about. 'Is it right to celebrate Thanksgiving and America's history of settler colonialism?' the description of the event said. 'What can we do to honor this day of mourning for Native communities? We can redefine the meaning of Thanksgiving and respect indigenous people's histories.' This is not the first time that the IDC at the university has hosted an event criticizing Thanksgiving. In 2021, the IDC held an event titled *The Real History Of Thanksgiving*, which described the holiday as 'whitewashed' and discussed alternatives for Americans to 'do in place' of Thanksgiving, according to Campus Reform. Other universities, such as the University of Michigan and Washington University in St Louis, Missouri, have held similar events talking about decolonizing Thanksgiving. In a press release from the Center for Social Solutions at the University of Michigan in 2021, Thanksgiving was described as a 'national day of mourning' for a lot of Native Americans and a 'reminder' of the 'genocide and decades of suffering' that they endured from the Europeans' arrival. The press release offered ways for people 'to decolonize' their Thanksgiving celebrations such as learning the 'real story behind Thanksgiving' and for people to 'support the land back movement.' Washington University also recently offered a 'Decolonizing Thanksgiving' event that was hosted by the university's Office for International Student Engagement and Cross Cultural Connections. Students were encouraged to join in for the event to 'learn about the holiday's origins,' and the 'impact of colonization on Native American communities.' *Breitbart News* reached out to the Intercultural and Diversity Center at the University at Buffalo for a statement but did not receive a response by the time of publication." (*University At Buffalo Hosts Forum To Discuss 'Decolonizing Thanksgiving'* by Elizabeth Weibel). The Western establishment proclaims that capitalism is a regime of imperialism and violence. It proclaims that corroborated accounts of Native Americans as merciless, bloodthirsty savages are products of white capitalist narratives and misrepresentation. It proclaims that social justice requires that America give its land back to Native Americans and place itself under the control of indigenous activists. It proclaims that the indigenous perspective on Thanksgiving, that it is day of celebration of capitalist genocide of innocent, noble savages, is the only true and valid perspective. It proclaims that capitalism is a regime of land theft, killing and destruction of the indigenous American proletariat. It proclaims that capitalism is a regime of massacre of native animal communities housed in skins, clothes and canvases. It proclaims that a progressive society rejects the Enlightenment values of reason and science and peddles indigenous mysticism, tribalism, collectivism, brutality, human sacrifice and the destruction of civilization: "*The Nation* is honoring this year's Thanksgiving by featuring a debate over whether America should keep celebrating the national holiday or not. One side is claiming it is 'steeped in colonialism, violence, and misrepresentation' and needs to be 'decolonized,' while the other goes further, describing Thanksgiving as a 'lie' that should be completely abolished and replaced with a 'Truthsgiving,' where Americans can 'give thanks by giving land back.' The essay, titled *Should America Keep Celebrating Thanksgiving?* and published in the left wing magazine's latest issue, details the positions of Lakota Chef Sean Sherman, who argues for the need to 'decolonize Thanksgiving,' and indigenous activist Chase Iron Eyes, who calls for completely 'replacing' Thanksgiving with a 'Truthsgiving' in its stead. Describing himself as a 'proud member' of the Oglala Lakota Nation, Sherman slams the image of Thanksgiving as one of unity, where many Americans portray 'Pilgrims and Indians' gathered in a 'harmonious feast.' 'This version obscures the harsh truth, one steeped in colonialism, violence, and misrepresentation,' he writes. 'By exploring the indigenous perspective on Thanksgiving, we can not only discern some of the nuances of decolonization but gain a deeper understanding of American history.' According to Sherman, the 'sanitized version' of Thanksgiving 'neglects to mention the violence, land theft, and subsequent decimation of indigenous populations,' something he asserts 'causes tremendous distress to those of us who are still reeling from the trauma of these events to our communities.' Describing Thanksgiving's roots as 'intertwined with colonial aggression,' Sherman notes that one of the first documented

'Thanksgivings' followed the 'colonists celebrating]their massacre of an entire Pequot village.' However, even the far left fact checking outlet *Snopes* has debunked the notion of an association between Thanksgiving and the assault on the Pequots, an indigenous tribe living in present day Connecticut, citing George Washington University Professor David Silverman who argued that 'to draw the connection between that and the modern holiday is untenable.' While Sherman does not believe in a complete 'end' to Thanksgiving, he does call for a need to 'decolonize' the national holiday: 'That means centering the indigenous perspective and challenging the colonial narratives around the holiday (and every other day on the calendar). By reclaiming authentic histories and practices, decolonization seeks to honor indigenous values, identities, and knowledge. This approach is one of constructive evolution: In decolonizing Thanksgiving, we acknowledge this painful past while reimagining our lives in a more truthful manner.' " (*Far Left Nation Debates Whether US Should Abolish or 'Decolonize' Thanksgiving: Americans Can 'Give Thanks By Giving Land Back'* by Joshua Klein). Jennie Augusta Brownscombe was a nineteenth and twentieth century American painter of colonial history. Her most acclaimed work is *The First Thanksgiving At Plymouth*, an oil on canvas painted in 1914. It depicts Pilgrims feasting at a table of abundance produced by human skill, effort and intelligence. It depicts civilization advancing in the midst of savagery for whom human skill, effort and intelligence are alien and incomprehensible. The judge ruled that the litigants seeking to exclude Fleming did not 'meet their burden to show irreparable harm, a likelihood of success on the merits, or that the balance of harms or equities is in their favor.' Crews also insisted that removing Fleming now as the tournament is just preparing to kick off is 'not reasonable.' NCAA women's volleyball players Brooke Slusser, Kaylie Ray, Macey Boggs, Sierra Grizzle, Jordan Sandy, Katelyn Van Kirk, and Kiersten Van Kirk were all listed on the complaint, and their legal representative is speaking out in the wake of the liberal judge's ruling. ICONS legal counsel Bill Bock is now speaking out. 'It is shameful that the administrators at the Mountain West Conference and the NCAA are unwilling to do their jobs, which is solely to protect fair competition and the safety of athletes who compete in college sports. However, because Mountain West Conference Commissioner Gloria Nevarez and NCAA President Charlie Baker won't do their jobs and are apparently afraid to stand up for the rights of women student-athletes, we are forced to ask the federal courts to do their jobs for them,' Bock said according to *Fox News*. Bock added that the Mountain West Conference, the NCAA, and San Jose State University 'have delayed justice, but will not escape justice,' and they will press their case. 'The Court of Appeal's statement that the Plaintiffs appear to have presented a substantial and meritorious legal claim calls into question the legal reasoning of the district court and confirms Plaintiffs' conviction that the harm caused to numerous women and women's teams by a trans-identifying male competing in Mountain West Conference women's college volleyball stems from illegal Conference and NCAA rules which are resulting in substantial and continuing violations of federal law,' Bock insisted. 'Plaintiffs look forward to ultimately receiving justice in this case when they prove these legal violations in court, and Plaintiffs look forward to the day when men are no longer allowed to wreak havoc in women's sport.' For her part, Slusser, who plays for San Jose State along with Fleming, says that her teammates don't feel safe with Fleming on the team. 'After we found out that she was released, a lot of the team just kind of broke down and was kind of freaking out, and even one of my teammates was like, 'I don't feel safe anymore,' because there's no one now that we feel like we can go and talk to about our concerns or our actual feelings and can actually speak freely in front of,' Slusser told *Fox News*. Slusser added that the team is not safe and fears retaliation from school officials who 'have decided that they will basically do anything to keep supporting Blaire.' " (*I Don't Feel Safe Anymore': Female Players Fearful After Biden Judge Allows Trans Athlete To Compete In Tournament* by Warner Todd Huston). **75 million people, 48 percent of the voters.** One half of America believes that the nation should become a sanctuary for migrant scum streaming in from the cesspools of the world. One half of America believes that racism against whites and sexism against males is a justified achievement of diversity and inclusion. One half of America believes that a progressive society is a racially diverse society and a racially inclusive society, or a society which does not treat people as people but selects people on the basis of race. Thus speaks Kim, a student at Sarah Lawrence College, a private liberal arts college Yonkers, New York, established in 1926, and for a century among the top ten far left universities in America. Sarah Lawrence College: promoted far left ideologies in the 1930s and 1940s under the flags of Progressive Education and the Dewey Method. The founder of Progressive Education, John Dewey justified communism in the name of pragmatism, problem solving and superior consequences: "But in the proper interpretation of 'pragmatic,' namely the function of consequences as necessary tests of the validity of propositions, *provided* these consequences are operationally instituted and are such as to resolve the specific problem evoking the operations, the text that follows is thoroughly pragmatic." (*Logic: The Theory Of Inquiry* by John Dewey). Sarah Lawrence College: promoted far left ideologies in the 1960s under the flags of Civil Rights and opposition to the war in Vietnam. In the twenty first century, this movement of reds and radicals which has disgraced Sarah Lawrence since its inception has reached a climax and submerged the campus in a malarial fever swamp ignited by Marxists and their Islamist allies. In the twenty first century, Sarah Lawrence College has fallen under the control of a Marxist-Islamist axis of terror which has intensified to a white heat the trend lines moving in the college over the course of a century, and has made it advocate the destruction of Israel, Jews, America and the West. It proclaims that a progressive university sanctions far left, black masked hoodlums who barricade doors, block windows, trap students in dormitories, prevent access to offices, post signs inscribed with Jew hatred, and shut down educational and administrative activities. It proclaims that a progressive university sanctions mass riots staged by far left students and banishes law enforcement from the campus. It proclaims that a progressive university is a political university which officially condemns zionism as a capitalist imperialist movement. It proclaims that a progressive university excludes students who have antiMarxist, proIsraeli backgrounds and beliefs. It proclaims that a progressive university seeks to protect the health, safety and well being of its far left students and no other students. It proclaims that a progressive university relocates classes and suspends shuttle service in the face of far left violence and under no circumstances condemns or seeks to eliminate such violence. It proclaims that a progressive university sanctions the bullying and intimidation of students opposed to Marxism and antisemitism. It proclaims that a progressive university sanctions the construction and expansion of permanent tents and settlements by far left students protesting against the existence of Israel and the capitalist system. It proclaims that a progressive university welcomes outside far left agitators and terrorists as guests and friends and makes them members of the campus community. It proclaims that a progressive university is antisemitic, illiberal, intolerant and prohibits all thought and behavior opposed to Marxism and Islam. It proclaims that a progressive university broadcasts messages of hate and violence to its Jewish students. It proclaims that a progressive university encourages students to wear symbols of terror, such as the Palestinian keffiyeh, for the same reason that Hitler's Germany encouraged the display of the swastika, to display hatred toward Jews and free societies. It proclaims that a progressive university is festooned with hate slogans, such as *Long live the intifada!*, demanding the destruction of Israel and Jews. It proclaims that a progressive university sanctions brave, committed far left students who fearlessly spread defamation and disinformation against Jews, Israel, America and the West. It proclaims that a progressive university sanctions the disruption of campus activities by far left students protesting against Israel, Jews, America and the West. It proclaims that a progressive university outlaws freedom of speech and only allows speech which supports Islamic theocracy and the totalitarian left. It proclaims that a progressive university makes students afraid to enrol in classes critical of Marxism and Islam. It proclaims that a progressive university is opposed to the values of the Enlightenment, the values of objective truth, rational judgment, liberal thinking, nonpartisan inquiry, academic integrity, human universalism, respect for the rights of others, and civilized manners, and seeks with Marxist hands to turn back the clock to the year zero: "In the dead of night on November 21, a group of students linked to Sarah Lawrence College's (SLC) Divestment Coalition stormed Westlands, the school's main administrative building, and announced their occupation through social media. This was no quiet protest. Hiding their identities behind masks, the group decorated the building with signs, barricaded doors, and blocked windows with plywood, effectively shutting down the school's operations. Dozens of students living in the dormitory above were trapped and access to key school offices were blocked. Outside, an encampment took shape, turning the scene into a spectacle broadcast across social media for the world to witness. Over the course of the first chaotic day, the school's administration failed to condemn the behavior or intervene to end the occupation of the building. By remaining silent and inactive in response to such a highly visible breach of rules, the school effectively took a political stance against zionism. This inaction stands in direct contradiction to its March declaration to 'provide an environment in which *all* of our students—regardless of background, belief, or circumstance—have the unimpeded opportunity to actively and fully participate in the educational experience that is at the center of Sarah Lawrence's mission.' To date, no public statement condemning the actions of the Divestment group has been made by SLC's President, Cristle C. Judd. Only in an email to SLC community members did she say that the situation merely required

the 'relocation of some classes and administrative functions out of Westlands and temporarily suspend shuttle service.' She further stated that school's 'top priority is the safety and well being of all on campus,' and noted that the 'Dean of Students Dave Stanfield and his staff have communicated with students who reside in Westlands to offer support and resources and to open a line of communication should these students have any needs throughout the day.' But even if arrangements for students residing in the building were made, the group's barricading of the building should be seen as an act of intimidation by the protesters—no student should have to navigate such a demonstration just to access their residence. In the same email, the president demonstrated yet another act of complicity—or, at best, naivety—towards the protesters, stating: 'The College has not summoned outside law enforcement. Having been informed of their safety violations, we trust that today's participants and their events will proceed in a manner consistent with clearly communicated college policies. We are confident we will navigate this moment together as a community. The following day, while the building occupation had ended, the encampment outside only expanded, making President Judd's email to the campus community on November 22 all the more difficult to reconcile with reality. She wrote, 'Today, campus operations are back to normal.' They were not—the encampment remained firmly in place.' Adding to this surreal scenario, the Dean of Students issued a statement on November 23 that ostensibly framed the rules for guests as stricter but, in effect, welcomed outside agitators and radical participants as 'guests. These individuals were permitted on campus from dawn to dusk, purportedly to maintain the 'health and safety of our community.' Here is how the Dean phrased it: The safety of all members of our campus community remains our top priority and chief concern. Given your repeated calls inviting numerous individuals not affiliated with the College to campus, whose identity and intentions are not known, and following consultation with members of the senior team, effective immediately the guests you have invited to participate will only be permitted on campus from dawn to dusk in order to maintain the health and safety of our community. *Struggle Video News* released a short documentary on *YouTube*, which was filmed on Day 3 of the protest, according to its creator. The footage showcases the encampment and includes a statement from one of the coalition's members, who goes by the name Armand. For decades, Sarah Lawrence College has permitted antisemitic and illiberal behavior to go unchecked." (*Sarah Lawrence Has Fallen* by Samuel Abrams). A crescendo is the highest point reached in a progressive increase of intensity. The term comes from the world of music where it is opposed to *decrescendo*, which means "decreasing." The past one hundred years at Sarah Lawrence College, since the time of its founding, have formed an ideological crescendo, and the twenty first century has brought forth its loudest point. The college's eighteen hectare suburban campus has been shaken by ear splitting decibel levels condemning liberal society as an engine of genocide and crimes against humanity and demanding a Marxist-Islamist revolution of destruction.

Heck, Hostin disparaged a huge group of women just before the midterms. Noting a poll found a shift to Republicans among white suburban women, she declared, 'It's almost like roaches voting for *Raid*.' " (*The View Is The Biggest Source Of Misinformation In America* by Kelly Jane Torrance). The witches in *Macbeth* stand out in the play. They are supremely powerful, supremely evil and embody blind, unreasoning hatred. In the twenty first century, they have been reanimated as rabid radicals on American national television. Condemning as fascist, nazi, racist garbage Donald Trump and the voices of freedom which support him, the voices of liberal order, the rule of law and a society purged of gender, race and class hoodlums, ABC's *The View* is a presentation of civilizational collapse storming the airwaves.

INTERNATIONAL COMMUNIST COURT ARRESTS ISRAEL

Politicization is a key concept in political science and describes how nonpolitical organizations are given a political character and become instruments of red factions. When an organization is politicized, its commitment to objectivity, fairness and justice is destroyed and it becomes a lash of tyranny and persecution. Majoritarian institutions such as parliaments, representing mob rule, do not have an intrinsic commitment to fairness or justice, while judicial institutions are supposed to be free of politics and to enforce the law. When a court of law is politicized, it ceases to be a court of law and becomes a star chamber of red subversion of free institutions. Founded on July 1, 2002 pursuant to the Rome Statute, the International Criminal Court is ostensibly dedicated to the prosecution of individuals for the crimes of genocide, aggression and crimes against humanity. Proclaimed by its proponents to be a major step forward in the protection of human rights, international law and the pursuit of justice, the court plunged into the turbulent waters of politicization on November 21, 2024, and two decades after its founding, disgraced itself. The court which on March 17, 2023 issued an arrest warrant for Vladimir Putin for his illegal, genocidal invasion of Ukraine, on November 21, 2024 renounced the work of justice it had done, when it issued an arrest warrant for Israeli Prime Minister Benjamin Netanyahu and Israeli Defense Minister Yoav Gallant on fabricated charges of starvation, extermination, persecution and crimes against humanity. On November 21, 2024, the International Criminal Court issued an arrest warrant for the rule of law and placed it behind bars in a prison constructed by the international communist movement. On this day, the movement assumed control over the court and transformed it into an enforcer of a program to overthrow Western liberal democracy and establish the global hegemony of a Marxist-Muslim axis. Listen to the program and hear the death knell of civilization sounded by the sworn enemies of the Enlightenment. Marching under the banners of Islam and Marxist gender, race and class politics, the program is the sound of a sickroom called the West during its final stages of collapse. The program proclaims that a progressive criminal court seeks to jail Israeli Prime Minister Benjamin Netanyahu and Defense Minister Yoav Gallant for the crime of defending a liberal democracy against Islamic terror attacks. It proclaims that Israeli has no right to defend itself because it is a secular, capitalist society. It proclaims that Israel has no right to protect its people from extermination because its people support liberal order and oppose Islamic theocracy. It proclaims that Western outposts of freedom such as Israel deserve to be subjected to criminal acts of aggression, criminal seizures of hostages and criminal terror attacks perpetrated by Muslims. It

proclaims that a progressive criminal court allows Muslim nations to perpetrate atrocities against Israel and violate the norms of international justice. It proclaims that a progressive criminal court is controlled by Marxist dogmas and its staff of judges and prosecutors allows communist dictators to commit crimes against humanity with impunity. It proclaims that a progressive criminal court allows socialist regimes to commit human rights abuses and create a state of fear among their citizens with impunity. It proclaims that liberal democracies are by their very nature genocidal and commit war crimes and crimes against humanity. It proclaims that Israel is a genocidal terrorist gang by virtue of being a liberal democracy, while antiliberal Muslim states are the liberators of the people. It proclaims that Israel, by virtue of being the only free society in the Middle East, deserves to be invaded and to have its Jewish citizens slaughtered. It proclaims that a progressive criminal court allows Muslims to rape, torture and kill men, women, children and infants so long as the victims are Jews. It proclaims that a progressive criminal court charges the Israeli Defense Forces with crimes against humanity because they defend a liberal democracy, while it supports the terrorist infrastructure, weapons, stockpiles and cells of Hamas. It proclaims that a progressive criminal court is an antisemitic court, a Hamas court, a Hezbollah court and a Palestinian court dedicated to the overthrow of freedom in the Middle East. It proclaims that a progressive criminal court is a biased, hate filled, discriminatory court whose remit is to greenlight Muslim massacres of Jews. It proclaims that a progressive criminal court is an Iranian axis of terror on a mission to continue Hitler's Holocaust throughout the Middle East. It proclaims that a progressive criminal court is a government of terror and dictatorship which has declared war against the free world. It proclaims that a progressive criminal court has placed liberty, capitalism, Jews and Israel in the prisoner's dock and marched them up to the gallows. It proclaims that a progressive criminal court pledges eternal solidarity with the Muslim bombers of the world. It proclaims that a progressive criminal court is a proxy terrorist organization whose wire pullers wear the robes of the Prophet. It proclaims that a progressive criminal court is a Marxist, Islamist, antiWestern court which has indicted, arrested, convicted and jailed the right to life, liberty and property of the people. It proclaims that a progressive criminal court is a Marxist-Islamist mutual assistance organization. It proclaims that a progressive criminal court is an international body for the defense of radicalism and revolution smashing civilization with the sledgehammers of Marxism and Islam: "The Office of Argentine President Javier Milei issued a statement announcing its 'categorical rejection' of the International Criminal Court (ICC) choosing to issue arrest warrants for Israeli Prime Minister Benjamin Netanyahu and former Defense Minister Yoav Gallant. Milei's office accused the ICC of 'criminalizing the legitimate right of a nation to self defense' and supported Israeli's right to protect 'the population of their country from extermination.' 'Israel faces a brutal aggression, an inhuman seizure of hostages, and the indiscriminate launch of attacks against its population,' the president's statement declared. 'Criminalizing the legitimate defense of a nation while these atrocities are omitted is an act that distorts the spirit of international justice.' Milei's office accused the ICC of being 'influenced by politics' and noted that the ICC prosecutor who requested the arrest warrants, Karim Khan, 'still owes [the public] a resolution against communist dictator Nicolas Maduro for his crimes against humanity.' The ICC launched a formal investigation into Maduro's rampant human rights crimes against his own people in 2021 but announced that Maduro's socialist regime would play a major role in investigating itself, outraging human rights activists. 'Argentina expresses solidarity with Israel, reaffirms its right to protect its people, and demands the immediate liberation of all the hostages,' the statement concluded. The ICC is a unique international platform that prosecutes individuals only on charges of genocide, war crimes, and crimes against humanity. It has no enforcement mechanism and only states that have signed and ratified the Rome Statute, which created the court, have an international legal obligation to obey it. Argentina is a signatory to the Rome Statute, while Israel has signed the statute but not ratified it, so it has no obligation to the court. As a signatory, Argentina in theory has an obligation to arrest Netanyahu and Gallant if they visit the country, an obligation Milei has rejected and would likely ignore. ICC prosecutor

Khan requested that the court issue arrest warrants for Netanyahu and Gallant—as well as three leaders of the Hamas genocidal terrorist gang, Ismail Haniyeh, Yahya Sinwar, and Mohammed Diab—in May. Khan accused the Israeli leaders of 'war crimes' and three kinds of 'crimes against humanity': 'starvation, extermination and persecution.' The warrant requests stem from the horrifying events of October 7, 2023, in which Hamas terrorists invaded Israel and conducted an unprecedented slaughter of an estimated 1,200 people, many killed in door to door raids on residential communities. Survivors recounted large numbers of incidents of gang rape, torture, and the torture and killing of children, including babies. The terrorists also abducted more than 200 people, many of them Argentine-Israelis, of which about 100 are believed to remain in captivity to this day. Khan listed these crimes as the reasons for requesting warrants for the Hamas chiefs but equated those actions to the self defense operations by the Israel Defense Forces (IDF) in the immediate aftermath of the attack. The IDF invaded Gaza, which is controlled by Hamas, and sought to eliminate terrorist infrastructure, weapons stockpiles, and cells of trained terrorists who could repeat the atrocities of the October 7 attack. Khan accused Netanyahu of deliberately starving and persecuting Gazan civilians, an accusation Jerusalem has energetically denied. The ICC granted all warrants requested related to the October 7 attack. Haniyeh and Sinwar died before the ICC decision this week. Netanyahu's office issued a blistering statement condemning the issuance of the warrant, calling the move antisemitic and supportive of Hamas. 'Israel utterly rejects the false and absurd charges of the International Criminal Court, a biased and discriminatory political body,' the statement read. 'No war is more just than the war Israel has been waging in Gaza since October 7th 2023, when the Hamas terrorist organization launched a murderous assault and perpetrated the largest massacre against the Jewish People since the Holocaust.' Netanyahu promised he would 'not give in to pressure' and 'continue to pursue all the objectives that Israel set out to achieve in its just war against Hamas and the Iranian axis of terror.' For decades, The Hague had been acclaimed as the center of international law. It is the headquarters of the Permanent Court of Arbitration, the Organization for the Prohibition of Chemical Weapons, Europol, and the International Court of Justice, the judicial arm of the United Nations. In December 2015, the International Criminal Court joined this list when it moved its headquarters to the city. On November 21, 2024, the ICC initiated arrest warrants against Israel for the crime of retaliating against Hamas terror attacks launched on October 7, 2023. On November 21, 2024, the ICC equated Israel's military operations against Hamas with the latter's door to door massacres of Israelis. It equated Israel's counterattack against Islam with the latter's mass rape, torture and killing of Israeli men, women, children and infants. On November 21, 2024, The Hague become, in the eyes of the free world, a byword for infamy.

THE LANCET REMOVES MEDICINE

In 1823 in England, Dr Thomas Wakeley founded the oldest and most prestigious medical journal in the world. It is a weekly, peer reviewed journal which is the most cited by professionals, ranking above the *British Medical Journal*, the *New England Journal of Medicine* and the *Journal of the American Medical Association*, and by general newspapers. In the twenty first century, this forum for today's medical professionals has received marching orders from the medical establishment to depart for the fever swamps of the radical left. In the twenty first century, *The Lancet* has renounced medical science and become a journal of politics and ideology colored as brightly red as the blood flowing through the veins of the living, whose medical welfare it once was dedicated to advancing. Stung by religion and bleeding on every page, *The Lancet* proclaims that progressive medicine has redefined sexual differentiation along ideological lines. It proclaims that progressive medicine rejects the existence of genes and DNA in the determination of human gender and enforces the dogma of transgenderism, according to which human gender can be changed by human belief or action and is not intrinsic or immutable. It proclaims that human gender has no relation to reality and exists apart from chromosomes, hormones and anatomy. It proclaims that progressive medicine champions the cause of climate activism and environmental doomsday and seeks to dismantle industrial and technological civilization in the name of eliminating greenhouse gas emissions. It proclaims that progressive medicine champions the cause of mass migration by the sewers of the world and the dissolution of national borders. It proclaims that progressive medicine rejects the notions of objective truth and individual rights as products of toxic masculinity and champions the cause of tribal rights. By the *Lancet*'s reckoning, sex is an observable, objective, anatomical phenomenon (which is the province of science), whereas gender embraces the foggy, gray sphere of how a person views himself in any given moment, which inexplicably overrides biology. To be true to gender ideology, scientists must pretend not to know whether a person is male or female and abandon their empirical observations when these conflict with a patient's current mindset. Gone are the days where gynecologists treated women. Now—at least by the *Lancet*'s warped standards—they treat individuals with two X chromosomes, whether they identify as women or not. While systematically dismantling biology, the authors also take a gratuitous swipe at English grammar, painfully asserting that gender expression means 'how a person outwardly presents themselves in relation to gendered forces.' If this is how low the U.K.'s flagship medical journal has sunk, one can only mourn the death of serious medical journalism." (*Woke Lancet Trades Science For Radical Gender Ideology* by Thomas Williams). In the twenty first century, *The Lancet* proclaims that progressive medicine rejects the notion of objective truth and champions the politics of race and gender. It proclaims that progressive medicine is racist medicine, gives preferential treatment to black students and professors in medical schools, and justifies its racist policies the achievement of diversity and inclusion. It proclaims that progressive medicine justifies its racist and sexist affirmative action policies favoring black female students and professors in the name of rectifying black female underrepresentation. It proclaims that university admissions and employment policies which do not discriminate on the basis of race or gender, and do not give preferential treatment to blacks or females, are committing exclusionary violence against these groups. It proclaims that race blind admissions and employment policies represent antiblackness. A lancet is a special double edged scalpel and has been in use for thousands of years

beginning with the ancient Egyptians. Today's medical establishment, on the pages of *The Lancet*, has cut open the method and body of knowledge known as medical science and eviscerated it. It has thrown empiricism, nonpartisanship and objectivity into the dustbin of history.

JOE BIDEN PARDONS HIMSELF

*In the constitution of this small, maritime banana republic was a forgotten section that provided for the maintenance of a navy. This "banana republic" was the fictional Republic of Anchuria, described by O Henry in his story *Cabbages and Kings*, a story based on the author's experiences living in Honduras in the 1890s. Coined by O Henry, the term *banana republic* has become a staple of political science. A banana republic is a nation operated like a private business for the benefit of the rulers, and is marked by corruption, repression and uncontrolled executive power. In the twenty first century, the nightmare described by O Henry has come alive in the nation whose commitment to the rule of law and the cause of freedom had been the envy and inspiration of the world. It has come alive in the world's former arsenal of freedom which led free nations onto victory in two world wars. It has come alive in a nation conceived in the Enlightenment, whose volleys for freedom in its war of independence from Britain were shots heard around the world. In the twenty first century, one hundred years after O Henry coined the term, it has come alive in the United States of America and become a tragic byword for the nation. On December 1, 2024, the American banana republic accelerated at lightning speed when Joe Biden made history. On this day, Biden granted a pardon to his son Hunter for criminal convictions on gun and tax charges and for any other crimes his son may have committed since 2014. In the past, presidents have granted pardons to friends, donors and political allies, but no president before Biden had ever granted a pardon to his son. But Biden did more than this. In pardoning his son, he ended investigations into his own scandals and a granted a pardon to himself for illegal business activities and the influence peddling operation he ran while he was vice president. On December 1, 2024, Joe Biden pardoned himself for financial fraud committed with his family. He pardoned himself for using the office of the vice president for financial gain. He pardoned himself for taking bribes from foreign agents. He pardoned himself for selling his influence, through his son, to the Burisma Energy Company. He pardoned himself for selling the Biden brand to the highest bidders around the world. He pardoned himself for crimes committed while in office in the belief that he is above the law. He pardoned himself for influencing American public opinion and government policy for a Romanian businessman in exchange for one million dollars. He pardoned himself to cover up facts about his time as vice president when he peddled his official powers to foreign actors. He pardoned himself for weaponizing the Department of Justice to target his political enemies. He pardoned himself for his involvement in his son's overseas business dealings. He granted a broad pardon to his son, pardoning him for uncharged crimes reaching back ten years, in an attempt to prevent future disclosures of his eight year influence peddling operation conducted while he was vice president. He used the FBI and the Department of Justice to prevent criminal charges from being brought against Hunter, and when that attempt failed, he granted a pardon to Hunter in a cynical attempt to save himself from legal disaster: "President Joe Biden's unusually expansive pardon for his son could be an effort to guard against further investigations into his own alleged corruption. The pardon isn't limited to crimes already charged but extends to cover offenses Hunter Biden 'may have committed' over a nearly eleven year period beginning in 2014, when the younger Biden joined the board of Ukrainian energy company Burisma. Biden's decision will 'hamper any further investigation into the financial corruption of the president and his family and their use of his office for financial gain,' Hans von Spakovsky, senior legal fellow at the Heritage Foundation's Edwin Meese III Center for Legal and Judicial Studies, told the DCNF. 'Despite the overwhelming evidence that he violated FARA [Foreign Agents Registration Act], the Justice Department never indicted Biden despite multiple indictments of other individuals for similar violations,' he said.*

Biden and his business partner Devon Archer each made \$1 million a year sitting on Burisma's board of directors, according to the House Oversight Committee. In December 2015, Hunter Biden 'called DC' to discuss government pressure facing Burisma, Archer told the House Oversight Committee. Archer also said the Biden family brand was part of what made Hunter Biden valuable to Burisma. 'Joe Biden says his son was the victim of selective prosecution; the only selective prosecution Hunter Biden was subject to, as revealed by numerous whistleblowers, was the selective effort by FBI and DOJ officials to delay, sidetrack, hinder and prevent serious criminal charges from being brought against Biden,' von Spakovsky said. 'This pardon is a grand example of Joe Biden's arrogance, mendacity, and obnoxiousness, and his view that he and his family should be above the law.' Hunter Biden may not have been charged at all without a judge's careful questioning of his initial sweetheart plea deal, which prompted disagreement in open court about the extent of a provision the defense believed offered broad immunity. A Delaware jury convicted Hunter Biden on federal gun charges in June, and he was scheduled to be sentenced this month. In September, Hunter Biden pled guilty to felony tax charges, avoiding a trial in California after he was accused of failing to pay \$1.4 million in taxes while spending extravagantly on 'personal' expenses like drugs and strip clubs. If the case had gone to trial, prosecutors wanted to call Hunter Biden's business associate to the stand to testify about money he received from a Romanian businessman trying to influence public opinion and policy in the US. The associate was compensated over \$3 million between November 2015 and May 2017, which he split with Hunter Biden and another partner, according to the DOJ's indictment. Biden could have commuted any prison term after his son's sentencing or simply issued a narrow pardon for the charges he faced, former federal prosecutor Joseph Moreno told the Daily Caller News Foundation. His decision to instead issue a broad pardon reveals that he 'knows there are even more skeletons in the family closet that need to be scrubbed from existence.' It also means the Bidens 'will now never face justice for their collection of over \$20 million in revenue from sources which have never been fully accounted for,' he said, creating an expectation of future 'pardons of Biden's brother and other family members between now and January 20.' 'This is a disgraceful end to Biden's legacy as President, during which he used his Justice Department both to harass his political enemies and protect his son from the consequences of his actions,' Moreno said. 'Biden's memory will now likely be associated with a Nixonian degree of corruption and abuse.' Other evidence unveiled by the House Oversight Committee has revealed potential ties between Biden and his son's overseas business dealings. In one July 2017 text [message](#) to a Chinese business associate, Hunter Biden allegedly warned he was sitting next to his father. 'The step between this and a self pardon is less than a nanometer,' Goldwater Institute Vice President Timothy Sandefur for Legal Affairs [wrote](#) on X." (*More Skeletons In The Family Closet': Biden's Broad Pardon For His Son Looks Like Cover For Nixonian Corruption* by Katelynn Richardson). Joe Biden pardoned himself for his peddling of influence in Ukraine. Joe Biden pardoned himself for selling the nation's foreign policy for financial gain. He pardoned himself getting his son illegally appointed to the board of directors of Burisma Energy Company. He pardoned himself for aiding his son to evade his legal requirement to register as a foreign agent while working in Ukraine. He pardoned himself for directing his son's business interests, associates and selling of an office, the vice presidency, which he occupied in disgrace for eight years: "President Joe Biden allowed himself to cover up his own apparent role in his son Hunter's influence peddling by issuing a pardon Sunday evening that extended back through 2014, including Hunter's corrupt role in Ukraine. While President Biden focused on his son's conviction for gun crimes, and his son responded with a statement about addiction, the reality is that the pardon covers more serious conduct: selling US foreign policy for monetary gain. The pardon covers actions between January 1, 2014, and December 1, 2024. Hunter Biden's appointment to the board of the corrupt Ukrainian gas company Burisma was announced in May 2014. Reporters and State Department staff immediately flagged the appointment as a potential conflict of interest, given that then Vice President Joe Biden was in charge of the Obama-Biden

administration's foreign policy in Ukraine (which is likely why Hunter was appointed). Joe Biden was directly implicated in his son's role in Ukraine—especially when evidence emerged on his son's laptop in 2020 that then Vice President Biden had met with one of Hunter's Burisma associates. That exposed Joe Biden's repeated claims to have had nothing to do with his son's business interests as a lie. More importantly, it exposed the fact that Biden may have been an accomplice in his son's knowing refusal to register as a foreign agent for Ukraine." A timeline is a list of events arranged in chronological order. The length of the timeline depends on the nature of the events. The timeline of evolution extends to millions of years, while the timeline of the day of the September 11 terror attacks is five minutes, and the timeline of a bomb explosion is five milliseconds. A timeline of systemic racism, the racism which exists throughout the whole of society as a result of policies, practices or laws, in recent history extends three centuries. Its highlights include slavery in the United States South, the Jim Crow laws in the United States South, the Nuremberg race laws in national socialist Germany, the apartheid laws in South Africa, and affirmative action policies established throughout the West beginning in the 1960s. **Slavery.** Listen to the US South defend black slavery and its white masters as a natural and necessary order of society: "We deny that slavery is sinful or inexpedient. We deny that it is wrong in the abstract. We assert that it is the natural condition of man; that there ever has been, and there ever will be slavery; and we not only claim for ourselves the right to determine for ourselves the relations between master and slave, but we insist that the slavery of the Southern States is the best regulation of slavery, whether we take into consideration the interests of the master or of the slave, that has ever been devised." (*The Excitement—The Fanatics, The Liberator*, August 29, 1835). **Jim Crow.** Listen to Jim Crow laws enacted in the US South in the late nineteenth and early twentieth centuries establish racial segregation in public schools and on other public property: "The object of the [Fourteenth] Amendment was undoubtedly to enforce the absolute equality of the two races before the law, but in the nature of things, it could not have been intended to abolish distinctions based upon color, or to enforce social, as distinguished from political equality, or a commingling of the two races upon terms unsatisfactory to either." (*Plessy v. Ferguson*, 1896, Justice Henry Billings Brown writing for the majority). **Nuremberg.** Listen to the Nuremberg race laws proclaim that rights and freedoms are a function of race and are not universal: "A Reich citizen is a subject of the state who is of German or related blood, and proves by his conduct that he is willing and fit to faithfully serve the German people and Reich." (*Reich Citizenship Law*, September 15, 1935). **Apartheid.** Listen to the apartheid laws in South Africa proclaim that the nation must limit contact between whites and nonwhites and ensure the purity of the white race: "If a European has to sit next to a nonEuropean at school, if on a railway station they are to use the same waiting rooms, if they are continually to travel together on the trains and sleep in the same hotels, it is evident that eventually we would have racial admixture, with the result that on the one hand one would no longer find a purely European population and on the other hand a nonEuropean population." (Justice Minister Charles Swart, introducing the *Reservation of Separate Amenities Act* to the

Parliament of South Africa, 1953). **Affirmative Action.** In the 1960s, racism reared its monstrous head in the form of affirmative action policies which discriminate in favor of nonwhites. Like Hitler's national socialism, affirmative action is a development of Marxism in the direction of race, and is the doctrine of race Marxism. Substituting nonwhites for Aryans and whites for Jews, this latter day version of German national socialism is a doctrine of nonwhite supremacy explicitly declaring war, like its Hitlerian precursor, on the Enlightenment. Today's affirmative action racists proclaim that racial preferences which discriminate against whites are justified in the name of combating antiAsian hate. They proclaim that discrimination against whites is justified in the name of ending discrimination against nonwhites. They proclaim that a progressive society is a community of color whose blacks, Asians and Pacific Islanders form a master race which has the right to segregate, exclude, disenfranchise and discriminate against the inferior white race: "On Monday's edition of NBC's *MTP Now*, Representative Judy Chu (D-CA) argued that the Supreme Court was wrong to strike down racial preferences in college admissions because discrimination hasn't ended because there have 'been three years of antiAsian hate.' And 'even amongst AAPIs, we see great disparities in education between those on the high end and Pacific Islanders as well as southeast Asians, who have very low numbers with regard to completing a college degree.' In response to a question on whether racial preferences are supposed to be a temporary measure whose time has passed, Chu said, 'Well, can we say that discrimination has ended in this country? I mean, look there [have] been three years of antiAsian hate. We've seen hate crimes on the rise in this country. We have seen very polarized kinds of actions taken against communities of color. No, discrimination has not ended in this country, and there are great disparities, even amongst AAPIs, we see great disparities in education between those on the high end and Pacific Islanders as well as southeast Asians, who have very low numbers with regard to completing a college degree. So, no, discrimination has not ended in this country and there are many, many ways in which we can show it.'" (*Democrat Representative Chu: We Still Need Race Preferences Because We've Had 'Years of AntiAsian Hate* by Ian Hanchett). Today's affirmative action racists proclaim that discrimination against whites is justified in the name of increasing racial diversity. They proclaim that a progressive university throws equal protection, nondiscrimination laws to the winds, makes faculty appointments and admits students on the basis of race, and is a black power, black supremacist, Third Reich style swamp of moral disease: "Video footage appears to show UC Berkeley Law Dean Erwin Chemerinsky telling a class that he discriminates against potential faculty hires to boost racial diversity using what he called 'unstated affirmative action.' The dean tells his audience, 'If ever I'm deposed, I'm going to deny I said this to you.' 'What I mean by 'unstated affirmative action' is, what if the college or university doesn't tell anybody, doesn't make any public statements?' Chemerinsky says at the beginning of the video. 'I'll give you an example from our law school, but if ever I'm deposed, I'm going to deny I said this to you. When we do faculty hiring, we're quite conscious that diversity is important to us,' the Berkeley Law dean continued. 'We say diversity is important—it's fine to say that,' Chemerinsky explained. 'But I'm very careful when we have a faculty appointments committee meeting.' The dean went on to say that whenever someone says they want to hire a certain candidate due to diversity, he instructs them not to say that aloud. 'Any time somebody says to you, 'We should really prefer this candidate or this candidate, because this person would add diversity'—don't say that,' Chemerinsky said. 'You can think it, you can vote it, but our discussions are not privileged.' 'So don't ever articulate that that's what you're doing,' the dean asserted. 'Well, that works more easily with regard to faculty hiring. With regard to student admissions, it becomes more difficult, because of the statistical measure,' he added. The video was posted to social media on the same day the US Supreme Court ruled against affirmative action in college admissions. Additionally, affirmative action has been illegal in California since 1996. And the tablet that can be seen in the video, near Chemerinsky's desk, suggests the clip was taken recently." (*'Unstated Affirmative Action: Berkeley Law Dean Admits He Discriminates Against Potential Faculty Hires* by Alana Mastrangelo). Today's affirmative action racists proclaim

that discrimination against whites is justified in the name of ensuring that organizations such as universities remain diverse. They proclaim that discrimination against whites is justified in order to guarantee the blacks have a place in schools and offices. They proclaim that a progressive society rejects liberal constitutions and principles of equal treatment, denies whites equal opportunities with blacks, and establishes a regime of racial quotas and racial point systems designed to instal a black Aryan race permanently into power: "NBA great Charles Barkley has amended his will to leave as much as \$5 million to Auburn University, his alma mater, upon his death in response to the Supreme Court overturning affirmative action in college admissions. Speaking to TMZ Sports, Barkley said that his phone had been ringing off the hook since the Supreme Court ended affirmative action in a 6-3 ruling. 'That's just my way of trying to make sure Auburn stays diverse. After that ruling yesterday, my phone was blowing up. I was talking to my friends and said, 'I need to make sure black folks always have a place at Auburn.' As *Breitbart News* reported, the Supreme Court argued that affirmative action violates the Equal Protection Clause of the 14th Amendment. The Supreme Court upheld racial preferences—euphemistically called affirmative action—in college admissions in the *Bakke* decision in 1978. Since then, debates have raged about whether to use quotas, point systems, or other ways of favoring one applicant over another based on the color of their skin, with the Supreme Court upholding some approaches while trimming the sails on others. Conservatives have insisted for half a century that the Constitution does not allow any of those approaches. The Equal Protection Clause of the Fourteenth Amendment commands that no state shall 'deny to any person within its jurisdiction the equal protection of the laws.' The Supreme Court has always acknowledged that the central promise of the Equal Protection Clause is to forbid laws and public policies that discriminate on the basis of race." The modern timeline was born in Joseph Priestley's classic *Chart Of Biography* published in 1765. The book covers a timespan from 1200 BC to 1800 AD, contains two thousand famous names organized into six occupational categories, and presents an analogue of the notion of progress exalted at the time, exalted during Priestley's age, exalted during the Age of Enlightenment. The timeline of racism shows no such trend of progress or amelioration of evil. It is a timeline of shame ending in a black power version of *Mein Kampf*, and its pages, like the original, have buried the West.
