# **INTRODUCTION**

These reports are intended for a general, nonspecialist audience. They run the gamut of the arts and sciences, historical and current events, and should provide the reader with useful introductions to given topics. May they encourage a few happy hours of suggestive thought!

### LAST STOP: THE TWENTY FIRST CENTURY

In the fin de siecle disposition, in the tendencies of contemporary art and poetry, in the life and conduct of men who write mystic, symbolic and decadent works and the attitude taken by their admirers in the tastes and esthetic impulses of fashionable society, is the confluence of two well defined conditions of disease with which the psychiatrist is quite familiar: degeneration and hysteria. (Degeneration by Max Nordau). Degeneration. Decadence. Fin de siecle. The turn of the century. The end of one century and the start of a new. Currents of irrationalism, mysticism, subjectivism and collectivism surge across society and incinerate free institutions. Civilizations throughout history have been afflicted with the disease of cultural degeneration; in ancient Rome, the onset occurred in the fourth century AD and saw the mass rejection of pagan reason and the acceptance of Christianity, barbarism, socialism and state worship; and in the West, the disease struck in the twentieth century and sought to revert the culture back to the ages before the Enlightenment. In the new millennium, the disease has completed its work of destruction and the West has been reduced to a wild animal rampaging across the wreckage of a culture and feeding on the souls of the morally and intellectually bankrupt. The vanishing minority of civilized people in the West today look around and see in every directions, in every field of endeavor and in every sector of society the fearsome and terrifying symptoms of cultural degeneration. In philosophy, they see the proclamation that physical objects do not exist and reality is human reality, human Dasein, human "being" or human "thereness." They see the proclamation that reality is a construct of "language games," that the meanings of words are products of the arbitrary rules of languages and have no relation to reality, that the meanings of words are determined by their use within language games and refer to no objects in the world, and that the task of philosophy is to analyse and report on the subjective games, rules and meanings governing language. They see the proclamation that reality is a construct of texts which can be endlessly interpreted or "deconstructed." They see the proclamation that there exist no "metanarratives" or universal truths, morality or human essentialism and reality is a construct of nations, communities and cultures. They see the proclamation that true philosophy is critical theory. This is called such because it is critical of the values of the Enlightenment, the values of reason, objectivity, empiricism, science and individual rights, and graduating from the school of Karl Marx, projects reality as relative, subjective and a creation of tribes based on gender, race and class, and promotes the political agendas of the tribes of gays, lesbians, transgenders, feminists, black racists, proletarian tub thumpers, and the preachers of an antiindustrial revolution. They see the proclamation that true philosophy is critical race theory, which is called such because like its Marxist predecessor it is critical of the values of the Enlightenment. Condemning the liberal order as systemic racism and the lash of white supremacy, it advocates the establishment of a black power, black swastika, black Aryan, black Hitlerite dictatorship. In the field of logic, civilized people see the proclamation that the notion that statements must be either true or false is a prejudice inherited from the Enlightenment. They see the proclamation that the highest form of logic is not the sane, ordinary, common sense binary logic of yes or no, true or false, but is a three valued logic indicating true, false and indeterminate or both true and false. In the field of mathematics, they see the proclamation that any complete mathematical system is in fact not a system at all but is an antisystem, because it contains within itself contradictions and inconsistencies. In the field of physics, they see the proclamation that separate particles do not exist, that physical objects are illusions, and that reality is pure field, energy, vibrations, space and geometry. They see the proclamation that particles do exist but they move by chance and can be anywhere and do anything, and are governed solely by the laws of probability. They see the proclamation that the universe is marked by an expansion of space or an expansion of absolute nothingness. In the field of biology, they see the proclamation that biological entities possess no essence and are indeterminate and contradictory. They see the proclamation that biological species change into other species, not in an instant as required by logic and reality, but

gradually over time, in an evolutionary process, and thus there exist such intermediate species and contradictions as man-apes which are both human and apes at one and the same time. In the field of ethics, they see the proclamation that man's good is to categorically obey the decrees of his will, feelings and intuitions, to obey them without regard to reason or consequences, to obey them for the sake of obeying them, to become rebels without a cause, heroic terrorists who proudly take responsibility for their crimes and boast about them, and killers helter skelter who scrawl out messages of violence with the blood of their victims. In the field of politics, they see the proclamation that the primary reality in society is the collective, that individuals possesses value and worth insofar as they serve its needs and interests, that individuals are defined in terms of the tribes to which they belong, and that a progressive society rejects the notion of individual rights and is predicated on the pursuit of gender, race and class politics. In the field of the arts, they see the proclamation that the highest form of art consists in the free play of pure forms without meaning, content or reference of any kind, that beauty exists in the eye of the beholder and has no relation to any order or harmony of existence, that the highest form of literature consists in streams of consciousness and depicts actions without plot or progression of events, the highest form of painting is nonrepresentational and consists in lines, shapes and colors without objects, and the highest form of music is randomly generated noise. Look at the tribal politics of the twenty first century and see the establishment of race and gender quotas at the workplace and in school admissions. See universities base admissions decisions on gender demographics in place of individual qualifications. See the establishment of institutional racism and sexism, and discrimination against whites and males, as the achievement of diversity and the highest form of fairness and equity. See the inherently racist and sexist notion of diversity exalted as the highest form of social progress. See preferential treatment given to black and female academic candidates in the name of correcting underrepresentation. See the notions of equal protection and equal opportunity sacrificed on the altars of parity and proportional representation. See the promotion of race and gender socialism. See individuals reduced to their race and gender identity groups, affirmative action programs established to benefit women, blacks and transgenders, and society descend into a savage jungle: "The California Institute of Technology's incoming class is 50 percent female for the first time in history, sparking concern from one legal expert about a focus on gender parity initiatives rather than merit. A profile of the undergraduate class of 2028 highlights the students' 'gender diversity,' showing 50 percent of the students are male and 50 percent are female. The private research university described the gender demographics as a 'historic milestone' in an article earlier this month on its website. Caltech has been 'piloting strategic initiatives' such as 'targeted outreach and recruitment efforts' to increase the number of female attendees, according to the article. These efforts are critical in order to 'combat inequities' and 'increase diversity among the undergraduate class,' the institution states. However, a former Department of Education assistant secretary in the Trump administration has concerns about the legality of Caltech's efforts. 'Gender parity initiatives are usually unjust because they tend to involve disparate treatment and disparate impact on the basis of sex,' Adam Kissel, a visiting fellow at the Heritage Foundation, told *The Fix*. According to Title IX, 'No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance.' 'Disparate treatment and intentional disparate impact in university recruitment of students are even more clearly unlawful following the Students for Fair Admission opinions from the Supreme Court,' Kissel said in a recent email to *The* Fix. The 2023 ruling shot down Harvard and University of North Carolina at Chapel Hill's race based admission system on the grounds of the Equal Protection Clause of the Fourteenth Amendment. The university also offers 10 affinity groups specifically for women, but none are listed for male students. Kissel gender parity initiatives 'almost always seek to lift up women at the expense of men, while the same institutions tend to express no interest in supporting men when they are underrepresented.' Kissel said that 'diversity by sex is a poor proxy for the actual viewpoint

diversity that makes a college flourish.' 'Diversity initiatives for the sake of counting identity groups are more of a socialist redistribution exercise or a project in cultural division than a genuine effort to bring diverse views into academic discussion,' he told *The Fix*. With the rise of the transgender movement, Kissel said some universities that have gender parity goals and initiatives 'might be hard pressed to define what a woman is in the first place.' At the bottom of Caltech's article celebrating the incoming class's gender diversity, a disclaimer reads: 'Admissions data reflects students' legal sex per national reporting requirements. Students are not required to report their gender identity on college applications, so admissions data may not accurately reflect students' lived genders.' " (Caltech Boasts 'Diversity' Efforts Result In 50 Percent Female Class by Courtney Graves). At the dawn of the twentieth century, a train left Satan's station and commenced a fearsome journey. It was a train marked civilizational collapse and it carried dangerous freight on board. It carried Faustian philosophy proclaiming the primacy of self assertion and will power over the outer world. It carried Cartesian philosophy proclaiming universal doubt and the "prior certainty of consciousness" and certainty about nothing else. Formally dissolved in 1968, the Red Guards have lived on throughout the world for the past half century and reared their monstrous heads wherever Marxist repression has become the order of the day. In the twenty first century, ten thousand kilometers away from China, the Red Guards have reassembled and gone on the march, and disgraced a Western nation which once exalted the values of the Enlightenment in its phrase "peace, order and good government," which was its counterpart to America's famous phrase "life, liberty and the pursuit of happiness." In the twenty first century, the Red Guards have travelled across the mighty seas and made a home in Canada. They have grown since their days under Mao and are no longer high school or university students, but occupy the highest levels of society, and are journalists, judges, professors, doctors, politicians and senior government officials. Peterson's crime was to reject the religion of transgenderism championed by a fifty year old Marxist dragon breathing the fires of gender, race and class politics, inspired by its master Marx's original founding fire of the proletariat. Commanded by a twenty first century Red Guard, the Canadian establishment proclaims that a progressive society forces psychologists who challenge transgenderism to attend social media training sessions to rectify their politically incorrect viewpoints and make them stand up, confess and recant. It proclaims that a progressive society revokes the licenses of psychologists who refuse to attend such social media training sessions and refuse to stand up, confess the error of their ways and recant. It proclaims that a progressive society forces psychologists who challenge transgenderism to submit to a course in ideological reeducation, programming and indoctrination. It proclaims that a progressive society silences psychologists who refuse to address transgender psychotics with the pronouns of their choice. It proclaims that psychologists who challenge transgenderism treat innocent, healthy, wholesome transgender psychotics with contempt and lower their dignity, and thereby bring their profession into disrepute. It proclaims that psychologists who condemn transgenderist ideologues as fanatics, bigots and dogmatists must be forced to submit to training on how to be a polished, practiced, professional promoter of the people's party line. It proclaims that a progressive society outlaws freedom of speech and forces practitioners of trades and professions to promote the transgenderist orthodoxy. It proclaims that psychologists who challenge transgenderism are guilty of discrimination, hate speech, making false claims and placing transgender psychotics in harm's way. It proclaims that courses of surgery and drug treatment to give transgender psychotics the appearance of being members of the opposite sex are courses of gender affirming health care and are constitutional rights. It proclaims that in a progressive society there is no freedom of speech or expression to promote views the state and government bureaucracy judge to be controversial and inimical to Marxist culture. It proclaims that in a progressive society, civil liberties and the right to practice a trade or profession, and the right to breathe and exist, extend to Marxists and to Marxists alone: "Polarizing psychologist Jordan Peterson now says he will attend the social media training he was ordered to undergo by his professional body

after Canada's top court refused to hear his appeal, according to his lawyer. In 2022, the governing body for Ontario's psychologists told Peterson—who has gained international fame with his views on women, masculinity and gender identity—to undergo a social media training program or risk losing his licence to practise. The College of Psychologists of Ontario said some of his social media posts may be 'degrading,' raise questions about his abilities as a psychologist and risk bringing the profession into disrepute. Peterson—who has been a registered member of the College of Psychologists of Ontario since 1999 but stopped seeing patients in 2017—said his statements were not made in his capacity as a clinical psychologist. In one of the social media posts in question, Peterson refers to a then city councillor who uses they/them pronouns as an 'appalling, self righteous, moralizing thing.' The college's complaints committee noted that during an appearance on The Joe Rogan Experience podcast, Peterson identified himself as a clinical psychologist before demeaning a former client. Last summer, an Ontario court ruled against Peterson and upheld the regulatory body's order for him to undergo training on professionalism in public statements. That decision was affirmed by a panel of three judges with the Ontario Court of Appeal earlier this year. As usual, the Supreme Court of Canada did not explain why it won't hear Peterson's case. It was dismissed with costs. Peterson's lawyer, Howard Levitt, called the decision 'a tragic day for Canada. It seems ironic, even tragic, that he, one of the most adept persons in social media in this country and beyond, is going to attend 'reeducation' from people inherently less skilled and knowledgeable than he is himself,' Levitt wrote in an email to CBC News. 'The decision is a tragedy for freedom of speech in this country.' Levitt, an employment lawyer, said the decision will have a 'chilling' impact on Canadians who are members of regulated trades and professions. 'They now have to concern themselves with political and other enemies making complaints to their regulatory bodies over their political comments, with the risk of their ability to practice their trade. Most simply will avoid debate entirely,' he wrote. Peterson posted on the social media platform X that he's 'bereft of options on the legal front in Canada. This is a hill that's worth not so much dying on as retaking and now boys and girls the gloves are off,' he wrote. Egale Canada, which had intervenor status in the case, celebrated Thursday's Supreme Court decision. It said 2SLGBTQ+ communities can face discrimination in accessing health care. 'This is why a clinical psychologist making transphobic, discriminatory and false claims is particularly harmful and directly interferes with trans people's safety and autonomy,' said the national advocacy group's legal director, Bennett Jensen, in a media statement." (Jordan Peterson Agrees To Social Media Coaching After Supreme Court Declines Free Speech Case by Catharine Tunney). Joseph-Francois Foullon de Doue had an ignominious distinction in history. The Comptroller General of Finances under Louis XVI, he was the first recorded person to have been lynched by a mob from a lamp post. He was killed after the storming of the Bastille on July 14, 1789, and his lifeless form dangling over a Parisian square presaged the Reign of Terror which would engulf the nation. In the twenty first century, a reign of terror has swept through Canada, brought by mobs wearing Marxist shirts. Fueled by the spirit of the times, they have lynched truth from the lamp posts of political correctness.

For over a century, the voices of cultural degeneration have brought to a culmination the philosophies of subjectivism preached beginning with Descartes, and have conducted a frontal assault on the institution of science. At the dawn of the twentieth century, a train loaded with dangerous freight, travelling for five centuries toward a

destination marked the aboliton of science, began accelerating at lightning speed. It carried on board Cartesian philosophy proclaiming universal doubt and the "prior certainty of consciousness" and certainty about nothing else, and it carried on board Kantian philosophy proclaiming that the perception of physical objects is a universal delusion produced by the veils and screens of space and time. In the twenty first century, it has reached the end of the line and completed its work of destruction. The twisted wreckage of science blackens the cultural landscape during the twilight stages of civilization and has put an end to the most glorious discipline invented by man, the systematic discipline which creates knowledge by induction from the data of experience, by observation and experiment, and put an end to it for all time to come. Listen to the voices of destruction and hear the rejection of the sane person's creed of empiricism, accepted in the Enlightenment and in Classical culture, and hear a plunge into raging insanity. The Cartesian-Kantian train wreck has issued a series of proclamations which have riveted the coffin of science. These proclamations are a direct assault against the method of empiricism and the certainty derived therefrom. The method is championed by Aristotle: "induction is the advance from particulars to a universal." (Topics). It is championed by Francis Bacon: "I mean to open up and lay down a new and certain pathway from the perceptions of the senses themselves to the mind." (*Novum Organum*). Now listen to empiricism's enemies in control of the scientific establishment in the twenty first century. They proclaim that the questions, concepts and practices of science do not come from experience but form apriori paradigms produced by cultures and epochs. They proclaim that there is no such thing as progress in science but only arbitrary changes in paradigms. They proclaim that reality does not exist independently of the mind and is not physical in character, but is created by paradigms. They proclaim that experience is not the experience of anything outside the mind; it is not the experience of physical objects; but is created by paradigms. They proclaim that observations, measurements and laboratory experiments are not determined by physical reality but are determined by paradigms. They proclaim that scientists using different paradigms inhabit different realities and cannot communicate with each other using a common language: "The operations and measurements that a scientist undertakes in the laboratory are not the given of experience but rather the collected with difficulty. They are not what the scientist sees—at least not before his research is well advanced and his attention focused. Rather, they are concrete indices to the content of more elementary perceptions, and as such they are selected for the close scrutiny of normal research only because they promise opportunity for the fruitful elaboration of an accepted paradigm. Far more clearly than the immediate experience from which they in part derive, operations and measurements are paradigm determined. Science does not deal in all possible laboratory manipulations. Instead, it selects those relevant to the juxtaposition of a paradigm with the immediate experience that that paradigm has partially determined. As a result, scientists with different paradigms engage in different concrete laboratory manipulations.' (The Structure Of Scientific Revolutions by Thomas Kuhn). The scientific establishment proclaims that we can never know with certainty whether we perceive physical objects. It proclaims that the belief that we perceive physical objects is a groundless assumption and is unprovable, and has no greater truth or validity than the doctrine of solipsism, and is at best only pragmatically superior and more advantageous than solipsism: "As an individual we cannot know that the sensory information we perceive is generated artificially or originates from a real world. Any belief that it arises from a real world outside us is actually an assumption. It seems more beneficial to assume that an objective reality exists than to live with solipsism, and so people are quite happy to make this assumption. In fact we made this assumption unconsciously when we began to learn about the world as infants. The world outside ourselves appears to respond in ways which are consistent with it being real." (joanv.me/atheism/objectivism.php). The scientific establishment proclaims that reality is inherently chaotic and contingent, and the method of induction can never produce any state of knowledge or certainty. It proclaims that there is no way to infer universal statements from particular statements. It proclaims that empiricism is a problematic doctrine because no scientific statements can be held

to be true: "According to a widely accepted view—to be opposed in this book—the empirical sciences can be characterized by the fact that they use inductive methods, as they are called. According to this view, the logic of scientific discovery would be identical with inductive logic, ie with the logical analysis of these inductive methods. It is usual to call an inference inductive if it passes from singular statements (sometimes also called particular statements), such as accounts of the results of observations or experiments, to universal statements, such as hypotheses or theories. Now it is far from obvious, from a logical point of view, that we are justified in inferring universal statements from singular ones, no matter how numerous; for any conclusion drawn in this way may always turn out to be false: no matter how many instances of white swans we may have observed, this does not justify the conclusion that all swans are white. The question whether inductive inferences are justified, or under what conditions, is known as the problem of induction." (The Logic Of Scientific Discovery by Karl Popper). The scientific establishment proclaims that scientific facts and theories are not derived from experience but are determined by the mind. It proclaims that there is no such thing as a scientific statement or theory being refuted by experience and any statement or theory whatever can be made to be true by suitable changes in language: "The totality of our socalled knowledge or beliefs, from the most casual matters of geography and history to the profoundest laws of atomic physics or even of pure mathematics and logic, is a manmade fabric which impinges on experience only along the edges. Or, to change the figure, total science is like a field of force whose boundary conditions are experience. A conflict with experience at the periphery occasions readjustments in the interior of the field. Truth values have to be redistributed over some of our statements. Reevaluation of some statements entails reevaluation of others, because of their logical interconnections—the logical laws being in turn simply certain further statements of the system, certain further elements of the field. Having reevaluated one statement we must reevaluate some others, whether they be statements logically connected with the first or whether they be the statements of logical connections themselves. But the total field is so undetermined by its boundary conditions, experience, that there is much latitude of choice as to what statements to reevaluate in the light of any single contrary experience. No particular experiences are linked with any particular statements in the interior of the field, except indirectly through considerations of equilibrium affecting the field as a whole." (Two Dogmas Of Empiricism by W. V. O. Quine). Epistemological prescriptions may look splendid when compared with other epistemological prescriptions, or with general principles—but who can guarantee that they are the best way to discover, not just a few isolated facts, but also some deep lying secrets of nature? A scientific education cannot be reconciled with a humanitarian attitude. It is in conflict 'with the cultivation of individuality which alone produces, or can produce, well developed human beings' (On Liberty by John Stuart Mill); it 'maims by compression, like a Chinese lady's foot, every part of human nature which stands out prominently, and tends to make a person markedly different in outline' (On Liberty by John Stuart Mill) from the ideals of rationality that happen to be fashionable in science, or in the philosophy of science. The attempt to increase liberty, to lead a full and rewarding life, and the corresponding attempt to discover the secrets of nature and of man, entails, therefore, the rejection of all universal standards and of all rigid traditions. When the price controls were temporarily eased to give producers more breathing room, the pent up demand burst open and pushed prices considerably higher as available supplies of products were not nearly enough to meet the soaring demand. 'We've seen this kind of thing tried in lots of other countries before; Venezuela, Argentina, the Soviet Union, et cetera,' a liberal economic commentator for the Washington Post and CNN, Catherine Rampell, observed. It is 'totally unworkable.' When former President Richard Nixon tried price controls in this country more than five decades ago, the result was an utter disaster. 'Ranchers stopped shipping their cattle to the market, farmers drowned their chickens, and consumers emptied the shelves of supermarkets,' explained Daniel Yergin and Joseph Stanislaw, authors of the book entitled The Commanding Heights: The Battle For The World Economy." #### WESTERN JURISPRUDENCE ATTACKS MAN

A gavel is a ceremonial mallet used in the chambers of law. It is used to call for attention, to punctuate rulings and to symbolise official authority. In the chambers of law, a philosopher's gavel has sounded, asked a question and provided an answer. The question is: what is law, and what should law be? This is the question posed by jurisprudence, the philosophy of law, and the answer is what common sense has known since time immemorial. The answer is that a legal system should reflect an objective moral order, and a legal system which does not do this is illegitimate. The answer was expressed by a maxim common in ancient Rome, a maxim which ruled its legal system for centuries until the ascendancy of statism, and emperor worship and Christian God worship in the twilight stages of Classical civilization. The maxim runs as follows: an unjust law is no law at all. This maxim was expressed in ancient Greece by Socrates, Plato and Aristotle, who affirmed that the state's law should reflect an order of natural justice and natural right external to the state's law. Aristotle in his *Rhetoric* affirms the existence of a natural, universal foundation of the state's law in the absence of which the state's law is law in name only: "Aside from the particular laws that each people has set up for itself, there is a common law that is according to nature." (Rhetoric). This common, natural law which should provide the foundation of the state's law is based on the definition of man as a rational animal. Because man is a rational animal, his proper flourishing consists in a life guided by reason as opposed to passion, and individuals who refuse to pursue such a life are not entitled to enjoy freedom. The purpose and justification of freedom, the rights to life, liberty and property, is to enable the individual to realize the definition of man and to flourish rationally, and freedom has no other purpose or justification, and the state is justified in depriving individuals of their freedom who have misused it. This doctrine that the state's law should be based on natural law, rational flourishing and the definition of man was the accepted doctrine in Classical civilization before the onset of its decline and fall in ancient Rome, but has not been accepted in the West, and has been under attack for centuries. The dominant jurisprudence in the West is that law is founded on society and is a command issued by society to serve its needs and interests. This social view of law and morality has been expressed under a variety of names, which one and all spell out the same rejection of moral objectivism and the definition of man as a rational animal. Listen to John Austin, venerated as the Father of Jurisprudence in the West and the founder of the school of legal positivism. He proclaims that law is positive law, a command issued by superiors to subjects, a rule established by the state for the political guidance of its citizens. He proclaims that the state's law has no relation to anything outside it, such as natural law or universal morality. He proclaims that law is the power of nations, states and governments and has no foundation in justice. He proclaims that there are many criteria for judging what constitutes good law and bad law, no one of which can be held to be more valid or more correct than any other, and all of which are completely arbitrary. A good law can be defined as that which comes from God or divine revelation, or as that which is useful to society, or as that which agrees with one's own inexplicable feelings or intuitions, but on no account can a good ever be defined as that which reflects the facts of man's nature and his definition as a rational animal, and as that which enforces the morality of rational flourishing: "The matter of jurisprudence is positive law: law, simply and strictly socalled, or law set by political superiors to political inferiors. A law, in the most general and comprehensive acceptation in which the term, in its literal meaning, is employed, may be said to be a rule laid down for the guidance of an intelligent being by an intelligent being having power over him. Of the laws or rules set by men to men, some are established by political superiors, sovereign and subject: by persons exercising supreme and subordinate government, in independent nations, or independent political societies. The aggregate of the rules thus established, or some aggregate forming a portion of that aggregate,

is the appropriate matter of jurisprudence. To the aggregate of the rules thus established, or to some aggregate forming a portion of that aggregate, the term law, as used simply and strictly, is exclusively applied. But, as contradistinguished to *natural* law, or to the law of *nature* (meaning by those expressions the law of God), the aggregate of the rules, established by political superiors, is frequently styled positive law, or law existing by position. As contradistinguished to the rules which I style positive morality, and on which I shall touch immediately, the aggregate of the rules, established by political superiors, may also be marked commodiously with the name of positive law. For the sake, then, of getting a name brief and distinctive at once, and agreeably to frequent usage, I style that aggregate of rules, or any portion of that aggregate, positive law. Every law or rule (taken with the largest signification which can be given to the term properly) is a command. By every command, the party to whom it is directed is obliged to do or to forbear. Now where it obliges generally to acts or forbearances of a class, a command is a law or rule. When we say that a human law is good or bad, or is worthy of praise or blame, or is what it should be or what it should not be, or is what it ought to be or what it ought not to be, we mean (unless we intimate our mere liking or aversion) this: namely, that the law agrees with or differs from a something to which we tacitly refer it as to a measure or test. For example, a human law is good or bad as it agrees or does not agree with the law of God: that is to say, with the law of God as indicated by the principle of utility, or with the law of God as indicated by the moral sense. To the adherent of the theory of utility, a human law is good if it be generally useful, and a human law is bad if it be generally pernicious. For, in his opinion, it is consonant or not with the law of God inasmuch as it is consonant or not with the principle of general utility. To the adherent of the hypothesis of a moral sense, a human law is good if he likes it he knows not why, and a human law is bad if he hates it he knows not wherefore. For, in his opinion, that his inexplicable feeling of liking or aversion shows that the human law pleases or offends the Deity. To the atheist, a human law is good if it be generally useful, and a human law is bad if it be generally pernicious. For the principle of general utility would serve as a measure or test, although it were not an index to an ulterior measure or test. But if he call the law a good one without believing it useful, or if he call a law a bad one without believing it pernicious, the atheist simply intimates his mere liking or aversion. For, unless it be thought an index to the law set by the Deity, an inexplicable feeling of approbation or disapprobation can hardly be considered a measure or test. And, in the opinion of the atheist, there is no law of God which his inexplicable feeling can point at. To the believer in a supposed revelation, a human law is good or bad as it agrees with or differs from the terms wherein the revelation is expressed. In short, the goodness or badness of a human law is a phrase of relative and varying import. A law which is good to one man is bad to another, in case they tacitly refer it to different and adverse tests." (The Province Of Jurisprudence Determined by John Austin). Listen to Oliver Wendell Holmes, a leading voice of the school of legal realism and the most influential Supreme Court justice in American history. He proclaims that law is public command, public force, public strength, and public decrees issued by something mightier than the individual, without relation to any principles of morality. He proclaims that law is that which is found in reports, treatises, statutes and constitutions and has no basis in moral ideas. He proclaims that law is state power and state penalties, duty is legal duty, and right is legal right, and no legal powers, penalties, duties or rights have any justification in natural law or in the nature of man as a rational animal: "When we study law we are not studying a mystery but a well known profession. We are studying what we shall want in order to appear before judges, or to advise people in such a way as to keep them out of court. The reason why it is a profession, why people will pay lawyers to argue for them or to advise them, is that in societies like ours the command of the public force is intrusted to the judges in certain cases, and the whole power of the state will be put forth, if necessary, to carry out their judgments and decrees. People want to know under what circumstances and how far they will run the risk of coming against what is so much stronger than themselves, and hence it becomes a business to find out when this danger is to be feared. The object of our study, then, is prediction, the

prediction of the incidence of the public force through the instrumentality of the courts. The means of the study are a body of reports, of treatises, and of statutes, in this country and in England, extending back for six hundred years, and now increasing annually by hundreds. In these sibylline leaves are gathered the scattered prophecies of the past upon the cases in which the axe will fall. These are what properly have been called the oracles of the law. Far the most important and pretty nearly the whole meaning of every new effort of legal thought is to make these prophecies more precise, and to generalize them into a thoroughly connected system. The primary rights and duties with which jurisprudence busies itself again are nothing but prophecies. One of the many evil effects of the confusion between legal and moral ideas, about which I shall have something to say in a moment, is that theory is apt to get the cart before the horse, and to consider the right or the duty as something existing apart from and independent of the consequences of its breach, to which certain sanctions are added afterward." (The Paths Of The Law by Oliver Wendell Holmes). Western jurisprudence is the worship of social power and from its dark, dismal chambers, Classical jurisprudence, the philosophy which defines as law only those state decrees enforcing and rewarding rational flourishing, has been banished forever. The names given to this unbridled social leviathan which stalks the West vary in accordance with the particular school of jurisprudence, and include the majority, the community, the nation, the people, the proletariat, black Marxists and feminist Marxists, but the essence and theme have remained the same. It is the denial that man possesses a rational nature and a rational perfection. It is the denial that man is human.

#### HIGH COURT DECLARES FREEDOM UNCONSTITUTIONAL

A two front war is a military situation in which a nation has to defend itself on two geographically separate fronts. The forces of two nations simultaneously engage their common enemy in order to increase their chances of victory. The attacked nation is forced to divide its troops, defend an extended line, and is cut off from access to trade and external assistance. During the Peloponessian War in the fifth century BC, Athens sought to avoid a two front war against Corinth and Sparta, so it first defeated Corinth before moving on to its stronger rival, Sparta. In the twenty first century, in the world's former arsenal and citadel of freedom, two enemies of freedom, increasing in strength and power during the twilight stages of civilization, are two forces involved in a two front war staged against their common target, and have obliterated it. These enemies have achieved such strength and power in the United States of America that they sit on the nation's high court and control it. These enemies have declared war on freedom, the one in the name of God, and the other in the name of Society, and their target has been defeated in a dark, inglorious, two front war. The voices of two gods, one held to mystically exist in Heaven and the other held to mystically exist on Earth, have pushed the values of the Enlightenment into the dustbin of history and reduced the West to a killing field whose casualties are truth, sanity, science and the rights of man. Classical civilization, during its twilight stages in ancient Rome, was beset by these enemies and went under. It had its mystics of Heaven in the form of Christians, and its mystics of Society in the form of statism, mob rule, emperor worship, welfare entitlements and barbarism, and fighting a two front war, pagan reason, which ruled Classical civilization for a thousand years but had now grown unpopular with the masses, collapsed. Fifteen centuries after Classical civilization fought a two front war and was reduced to the rubble of defeat, the attacking forces have returned and assumed control over the West, and sit on the bench of the United States Supreme Court. In this two front war staged in the venue of the high court, the armies against freedom have adopted schools of jurisprudence as a vehicle for their agendas and a justification for their rulings. The socialists on the court seek to enforce the doctrines of their faith under the cover of a school of jurisprudence known as the living constitution, while the Christians on the court seek to enforce the doctrines of their faith under the cover of a school of jurisprudence known as originalism. Listen to the advocates of the living constitution and the advocates of originalism and hear the death knell toll for the rule of

logic, language, law and the constitution of freedom, for the noble words of a nation's founding document composed by the Age of Enlightenment, in the United States of America. The Living **Constitution.** The advocates of the living constitution proclaim that a nation's constitution does not say what it says but can be changed to suit the changing needs and requirements of the mystical organism called society. They proclaim that words do not mean what they mean but meanings develop and evolve in accordance with social interests. They proclaim that a progressive, scientific society is a totalitarian iron heel which has deprived people of their freedom in the name of the laws of life: "Society is a living organism and must obey the laws of life, not of mechanics; it must develop. All that progressives ask or desire is permission--in an era when development, evolution, is the scientific word--to interpret the Constitution according to the Darwinian principle; all they ask is recognition of the fact that a nation is a living thing and not a machine." (New Freedom by Woodrow Wilson). The advocates of the living constitution proclaim that nations are mystical organisms which exist apart from and superior to the individuals who compose them. They proclaim that the words and text of a constitution are invisible and do not say what they say but can be endlessly rewritten by the mystical organism called the nation in accordance with social needs and interests: "With regard to that we may add that when we are dealing with words that also are a constituent act, like the Constitution of the United States, we must realize that they have called into life a being the development of which could not have been foreseen completely by the most gifted of its begetters. It was enough for them to realize or to hope that they had created an organism; it has taken a century and has cost their successors much sweat and blood to prove that they created a nation. The case before us must be considered in the light of our whole experience and not merely in that of what was said a hundred years ago. The treaty in question does not contravene any prohibitory words to be found in the Constitution. The only question is whether it is forbidden by some invisible radiation from the general terms of the Tenth Amendment. We must consider what this country has become in deciding what that amendment has reserved." (Missouri versus Holland, United States Supreme Court, 1920, Opinion of Oliver Wendell Holmes). The advocates of the living constitution proclaim that the state may ignore the meanings of words and abrogate constitutional rights and freedoms in the name of solving social problems and protecting people in volatile economic times: "In the early twentieth century, this Court regularly struck down economic regulation enacted by the peoples' representatives in both the States and the Federal Government. The Chief Justice's Commerce Clause opinion, and even more so the joint dissenters' reasoning, bear a disquieting resemblance to those long overruled decisions. Ultimately, the Court upholds the individual mandate as a proper exercise of Congress' power to tax and spend 'for the general Welfare of the United States.' I concur in that determination, which makes the Chief Justice's Commerce Clause essay all the more puzzling. Why should the Chief Justice strive so mightily to hem in Congress' capacity to meet the new problems arising constantly in our ever developing modern economy? I find no satisfying response to that question in his opinion." (National Federation of Independent Businesses versus Sebelius, United States Supreme Court, 2012, Opinion of Ruth Bader Ginsburg). Originalism. The advocates of originalism proclaim that in the interpretation of a constitution, a court must determine what the authors of the constitution were trying to achieve, what they were intending to accomplish, without regard to the actual text of the constitution. They proclaim that meaning of a constitution is determined by reference to the intent of its framers and not by reference to the actual meanings of the words in the text. They proclaim that the Constitution does not confer a right to abortion on the grounds that the word abortion is not mentioned in the Constitution and there was no intent to protect the right to obtain an abortion by the framers. They proclaim that the right to obtain an abortion is not part of the history or traditions of the nation and therefore does not exist, notwithstanding the fact that the right to liberty means the right to liberty: "The Constitution does not confer a right to abortion; Roe and Casey are overruled; and the authority to regulate abortion is returned to the people and their elected representatives. (a) The critical question is whether the Constitution, properly understood, confers a right to obtain an

abortion. Casey's controlling opinion skipped over that question and reaffirmed Roe solely on the basis of stare decisis. A proper application of stare decisis, however, requires an assessment of the strength of the grounds on which Roe was based. The Court therefore turns to the question that the Casey plurality did not consider. First, the Court reviews the standard that the Court's cases have used to determine whether the Fourteenth Amendment's reference to liberty protects a particular right. The Constitution makes no express reference to a right to obtain an abortion, but several constitutional provisions have been offered as potential homes for an implicit constitutional right. Roe held that the abortion right is part of a right to privacy that springs from the First, Fourth, Fifth, Ninth, and Fourteenth Amendments. The Casey Court grounded its decision solely on the theory that the right to obtain an abortion is part of the liberty protected by the Fourteenth Amendment's Due Process Clause. Others have suggested that support can be found in the Fourteenth Amendment's Equal Protection Clause, but that theory is squarely foreclosed by the Court's precedents, which establish that a State's regulation of abortion is not a sex based classification and is thus not subject to the heightened scrutiny that applies to such classifications. Next, the Court examines whether the right to obtain an abortion is rooted in the Nation's history and tradition and whether it is an essential component of ordered liberty. The Court finds that the right to abortion is not deeply rooted in the Nation's history and tradition. The Court's decisions have held that the Due Process Clause protects two categories of substantive rights—those rights guaranteed by the first eight Amendments to the Constitution and those rights deemed fundamental that are not mentioned anywhere in the Constitution. In deciding whether a right falls into either of these categories, the question is whether the right is 'deeply rooted in our history and tradition' and whether it is essential to this Nation's 'scheme of ordered liberty.' The term liberty alone provides little guidance. Thus, historical inquiries are essential whenever the Court is asked to recognize a new component of the liberty interest protected by the Due Process Clause. In interpreting what is meant by liberty, the Court must guard against the natural human tendency to confuse what the Fourteenth Amendment protects with the Court's own ardent views about the liberty that Americans should enjoy. For this reason, the Court has been reluctant to recognize rights that are not mentioned in the Constitution." (Dobbs versus Jackson Women's Health Organization, United States Supreme Court, 2022, Opinion by Samual Alito). In the twenty first century, the United States Supreme Court is devoid of light and air. It renders decisions in a moral vacuum and seeks to transform a nation consecrated to freedom into a hermetically sealed chamber of totalitarian repression. The advocates of socialism promote their agenda under the guise of the living constitution and proclaim that A does not mean A, the right to liberty does not mean the right to liberty, and the government has the right to force people to obtain health insurance on the grounds that the Constitution is an organic document which may deny the meaning of words in order to serve changing social needs and exigencies. Seeking to promote a Christian agenda, the advocates of orginalism proclaim that states have a right to violate the First Amendment and establish religion by defining actual human personhood to commence at the moment of conception with a supernatural infusion, and to define the destruction of the one cell zygote appearing at the moment of conception as an act of murder. Two schools of constitutional interpretation, two armies attacking, invading and ranged against freedom, two movements conducting a war on two fronts to shred the constitution. Freedom lost the war. Confronting two enemies together supported by the overwhelming majority of the American people, freedom never stood a chance.

#### **AMERICA'S SALESMAN OF HATE**

On the morning of September 4, 1957, at the Little Rock Central High School in Little Rock,

Arkansas, Elizabeth Ann Eckford, fifteen years old, was followed and threatened by an angy white mob as she was trying to enter the school. She was part of the Little Rock Nine, a group of black students who in that year were the first black students ever to attend the school. Her ordeal was captured in a photograph which flashed across the world and cast a pall over all who saw it. This was a photograph of Eckford yelled out by hate and confronting it with grace. In the twenty first century in America, hatred has risen to the highest office in the land and been shouted out from the bully pulpit of the president of the United States. It is not the race hate which assailed Elizabeth Ann Eckford but a species of hate manufactured in the dark, satanic mills of Karl Marx. It is class hatred, the hatred born of envy by the have nots, the failures and the frustrated of the world toward those who have achieved more than they. It is the hatred of the producers toward the nonproducers, which gives rise to a desire in the latter to discredit and destroy the former. Pioneered by Marx, class hatred was the official religion of the nations of the former Communist Bloc and saw policies of class extermination the likes of which mankind had never seen before. It saw the mass murder of all those labelled the bourgeois by governments which justified their crimes in the name of the proletariat. Committed by the Soviet Union, by Maoist China and by the Khmer Rouge regime in Cambodia, committed from the 1920s through to the 1970s, these crimes of classicide claimed the lives of 100 million people and created the worst bloodbath, the worst holocaust and the worst genocide in the history of mankind. On January 20, 2009, class hatred was elected president of the United States and remained in office for the next eight years. It was elected the forty fourth president by a nation which had descended into a swampland of collectivism, a swampland which had buried all previous free societies throughout history during their twilight stages of decline. This swampland buried ancient Rome in the fourth century AD, in whose dying hours statism, socialism, mob rule, class wars and emperor worship consumed the masses. America made the plunge into collectivism at the dawn of the twentieth century and called its terrifying, new, unAmerican creed progressivism. The American people gave it other names as well. He proclaimed that society is the thinker, the scientist, the inventor, the teacher, the bridge builder, the road digger and the street sweeper which creates all the wealth and success enjoyed by individuals. He proclaimed that individuals achieve wealth and success not by virtue of anything they themselves have done but by virtue of what society had done and the help society has given to them. He proclaimed that only the naive, the ignorant, the untutored and the prejudiced believe that wealth and success are created by the actions of individuals and not by the actions of society. He proclaimed that society is a mystical

being which exists apart from and superior to the individuals who compose it. He proclaimed that this mystical being is the primary reality and unit of value. He proclaimed that no person in this world is ever on his own, no person is separate, independent or exists outside this mystical being, and all wealth which occurs does so by virtue of this being, and the individual is but an agent and instrument for the satisfaction of its needs. He proclaimed that it is this mystical being and not any indiviuals which gave the world the Internet, the Hoover Dam and the Golden Gate Bridge, and which walked on the moon, and progressive individuals are those who bow down in submission to this mystical being and obey all its laws and decrees: "There are a lot of wealthy, successful Americans who agree with me—because they want to give something back. They know they didn't —look, if you've been successful, you didn't get there on your own. You didn't get there on your own. I'm always struck by people who think, well, it must be because I was just so smart. There are a lot of smart people out there. It must be because I worked harder than everybody else. Let me tell you something—there are a whole bunch of hardworking people out there. If you were successful, somebody along the line gave you some help. There was a great teacher somewhere in your life. Somebody helped to create this unbelievable American system that we have that allowed you to thrive. Somebody invested in roads and bridges. If you've got a business—you didn't build that. Somebody else made that happen. The Internet didn't get invented on its own. Government research created the Internet so that all the companies could make money off the Internet. The point is, is that when we succeed, we succeed because of our individual initiative, but also because we do things together. There are some things, just like fighting fires, we don't do on our own. I mean, imagine if everybody had their own fire service. That would be a hard way to organize fighting fires. So we say to ourselves, ever since the founding of this country, you know what, there are some things we do better together. That's how we funded the GI Bill. That's how we created the middle class. That's how we built the Golden Gate Bridge or the Hoover Dam. That's how we invented the Internet. That's how we sent a man to the moon. We rise or fall together as one nation and as one people, and that's the reason I'm running for President—because I still believe in that idea. You're not on your own, we're in this together." The Roanoke hate rally held by Obama was an encore performance demanded by the mob delivered after his State of the Union Address on January 25, 2011. In this address, Obama proclaimed that in a progressive society, every person is his neighbor's keeper, guardian and slave, and no person has the right to be selfish and irresponsible and assert his freedom against the claims made by society. He proclaimed that a progressive society enforces a universal right to receive healthcare subsidized by the people. He proclaimed that a progressive society enforces the duty incumbent upon every person to obtain health insurance and through his insurance premiums to help subsidize the health care of others. He proclaimed that a progressive society enforces social responsibility and requires that every person do his part, contribute his share, renounce his freedom, become a sacrificial lamb, and feed the people's leviathan and monster called the Collective: "Now, even if we provide these affordable options, there may be those-particularly the young and healthy-who still want to take the risk and go without coverage. There may still be companies that refuse to do right by their workers. The problem is, such irresponsible behavior costs all the rest of us money. If there are affordable options and people still don't sign up for health insurance, it means we pay for those people's expensive emergency room visits. If some businesses don't provide workers health care, it forces the rest of us to pick up the tab when their workers get sick, and gives those businesses an unfair advantage over their competitors. And unless everybody does their part, many of the insurance reforms we seek-especially requiring insurance companies to cover pre-existing conditions-just can't be achieved. That's why under my plan, individuals will be required to carry basic health insurance-just as most states require you to carry auto insurance. Likewise, businesses will be required to either offer their workers health care, or chip in to help cover the cost of their workers. There will be a hardship waiver for those individuals who still cannot afford coverage, and 95% of all small businesses, because of their size and narrow profit margin, would be exempt from these requirements. But we cannot have large businesses and

individuals who can afford coverage game the system by avoiding responsibility to themselves or their employees. Improving our health care system only works if everybody does their part. While there remain some significant details to be ironed out, I believe a broad consensus exists for the aspects of the plan I just outlined: consumer protections for those with insurance, an exchange that allows individuals and small businesses to purchase affordable coverage, and a requirement that people who can afford insurance get insurance." On January 30, 1939, Adolf Hitler gave a speech in the Kroll Opera House to members of the Reichstag on the sixth anniversary of his seizure of power. Heard by millions of Germans over the newly produced people's receivers, the speech is notorious for its overt racism and physical threats against the Jews. Hitler proclaimed: "If international finance Jewry inside and outside Europe should succeed in plunging the nations once more into a world war, the result will be not the Bolshevization of the earth and thereby the victory of Jewry, but the annihilation of the Jewish race in Europe." May 10, 1940. Germans attack France and defeat the French army. The French government flees from Paris and on May 14, Germans occupy the city. This structure was built as the centerpiece of the 1899 World's Fair and was used to celebrate the one hundredth anniversary of the French Revolution. Reaching three hundred and thirty meters into the sky, it is the tallest structure in Paris, and for forty one years, this towering symbol of human skill and ingenuity was the tallest man made structure in the world. On September 2, 2024, the new invaders placed their victory sign on the Eiffel Tower. The invasion commenced on July 26, 2024, at the opening ceremony of the Paris Summer Olympics. The peddlers of gender, race and class politics, an offshoot like Hitler's national socialism of master Marx's religion of the proletariat, paraded their creed on a boat along the Seine River, and signaled the destruction of Paris as a free city. The city was now under the control of a global movement dedicated to overthrowing the heritage of the Enlightenment to which France was a major contributor. Transforming the Olympic Games from a festival of sports into a festival of politics, the global movement of Marx's twenty first century family issued a series of proclamations which sounded the death knell of the world of the Enlightenment. The movement proclaimed that a progressive Olympics is a platform for gay and lesbian politics. It proclaimed that a progressive Olympics is a platform for the queer community. It proclaimed that a progressive Olympics is a platform for the promotion of transgenderism. recognition for people who pretend to be members of the opposite sex in the name of inclusion and nondiscrimination. It proclaimed that a progressive Olympics is not a series of sports competitions but is a message, a statement, a voice and a rifle of world revolution blasted out by dancers, drag artists and transgender degenerates: "When Charline Van Snick flirted with another female athlete after winning the bronze medal in Judo in the 2012 London Olympic Games, she said her coach told her she needed to stay in the closet for the future of her career. 'It was a moment when I didn't feel like myself,' the 33 year old retired Belgian Olympian said. 'He said, Charline, you have to fit in the box. Everyone is looking at you and you have to be straight. I understood that it's not a place to be yourself, it's not a place to be LGBTQ+.' While the Olympic Games have made giant strides in the years since—the Paris 2024 Olympics set a record for the most athletes who are openly LGBTQ+ advocates and athletes say international athletics have a long way to go in opening up to the queer community. There has been outcry from religious groups and others to Friday's opening ceremony that showcased DJ and producer Barbara Butch—an LGBTO+ icon—flanked by drag artists and dancers in a scene that critics interpreted as mocking Leonardo da Vinci's *The Last Supper*. Parisian officials kept up their push for inclusion Monday night with the opening of the Olympic Pride House, located on a boat floating on the city's famous Seine River. French sports minister Amelie Oudea-Castera told *The Associated Press* that they were 'sending a message of inclusion' in these Games. 'It's important to Paris, to keep fighting against all types of discrimination,' Oudea-Castera said. 'We need to drive this progress in society and the reason I am here today is because sport is a very powerful agent to do that.' " (Paris Olympics Set Record For Number Of Openly LGBTQ+ Athletes, But Some Say Progress Isn't Finished by Megan Janetsky). The Paris branch of the global Marxist movement is led by the city's communist, socialist mayor, Anne Hidalgo. On September 2, 2024, Mayor Hidalgo decreed that the five Olympic rings hanging on the Eiffel Tower during the games would stay there indefinitely as a sign of the successful invasion of the city by the global Marxist movement. Mayor Hidalgo issued a series of proclamations which celebrated the transformation of a free city into a satellite of the movement. She proclaimed that a progressive society defaces monuments to freedom in the name of gays, lesbians and transgenders. She proclaimed that a progressive society hangs the five interlaced rings of the Olympic Games in its public squares to symbolize the victory of Marxism across the five continents of the Earth. She proclaimed that a progressive society has fallen in love with Marxism and stages festivals of revolutionary violence. She proclaimed that the Olympic rings on the Eiffel Tower add the banners of race, gender and sexual orientation politics to the monument and bring it up to date in the twenty first century. She proclaimed that a progressive society is a city of Marxist hellfire extinguishing the noonday light of freedom which lit up the Enlightenment skies. the She proclaimed that a progressive society smashes cultural icons by hanging Marxist flags on them. She proclaimed that a progressive society defaces famous memorials by splashing Marxist colors on them. She proclaimed that a progressive society bans rental electric scooters, sports utility vehicles, automobiles in downtown streets, and nonpolitical, nonpartisan sporting events, and is an onrushing, everflowing, torrential river of radical politics which is unfit for human habitation: "Paris Mayor Anne Hidalgo has triggered a heated debate by saying she wants to keep the Olympic rings on the Eiffel Tower after the summer Games are over. 'The decision is up to me, and I have the agreement of the IOC [International Olympic Committee],' she told the Ouest-France newspaper over the weekend. 'So yes, they [the rings] will stay on the Eiffel Tower,' she added. Some Parisians backed the move, but others--including heritage campaigners--said it was a bad idea and would 'defile' the French capital's iconic monument. The five rings--29m wide, 15m high and weighing 30 tonnes--were installed on the Eiffel Tower before the Paris Olympics opened on 26 July, and were expected to be taken down after the Paralympics' closing ceremony on 8 September. But Ms Hidalgo said she wanted to keep the interlaced rings of blue, yellow, black, green and red, symbolising the five continents. She added that the current rings--each one measuring 9m in diameter--were too heavy and would be replaced by a lighter version at some point. The Socialist

mayor also claimed that 'the French have fallen in love with Paris again' during the Games, and she wanted 'this festive spirit to remain'. Some Parisians as well as visitors to the French capital supported the mayor. 'The Eiffel Tower is very beautiful, the rings add color. It's very nice to see it like this,' a young woman, who identified herself as Solene, told the France Bleu website. But Manon, a local resident, said this was 'a really bad idea. It's a historic monument, why defile it with rings? It was good for the Olympics but now it's over, we can move on, maybe we should remove them and return the Eiffel Tower to how it was before,' he told France Bleu. Social media user Christophe Robin said Ms Hidalgo should have consulted Parisians before going ahead with her plan. The wrought iron lattice tower was initially heavily criticised by Parisian artists and intellectuals--but is now seen by many as the symbol of the City of Light. Ms Hidalgo, who has been running Paris since 2014, is known for her bold--and sometimes controversial--reforms. Under her tenure, many city streets, including the banks of the river Seine, have been pedestrianised. Last year, she won convincingly a city referendum to ban rental electric scooters. However, fewer than 8% of those eligible turned out to vote. In February, Ms Hidalgo was again victorious after Parisians approved a steep rise in parking rates for sports utility vehicles. But both drivers' groups and opposition figures attacked the scheme, saying the SUV classification was misleading as many family size cars would be affected. France's Environment Minister Christophe Béchu said at the time that the surcharge amounted to 'punitive environmentalism.' And just before the Paris Olympics, Ms Hidalgo and other officials went into the Seine to prove the river was safe to swim." (Row Over Plan To Keep Olympic Rings On Eiffel Tower by Jaroslav Lukiv). The 2024 Paris Olympics ignited a rolling thunder of rage in the vanishing communities of civilized people. Civilized people saw an exhibition of moral pollution float down the bacterial pollution of the River Seine and surpass it in virulence and lethality, and reeled back in horror. They saw an exhibition of transgender activists, Muslim terrorists, black, feminist and gay and lesbian tribalists, and the ignominious suicide and collapse of civilization: "The opening ceremonies of the Paris Olympics, which featured a transgender parody of the *Last Supper* while highlighting a controversial Muslim performer, have been branded as a national 'suicide' by a former French government cabinet member. It was taken in Paris at noonday and at noonday its subject took away light from the city. It was a picture of Adolf Hitler standing in front of the Eiffel Tower, less than a month after his forces had invaded the city, contemplating his victory over a free nation. Less than a century after the liberation of Paris, the invaders of freedom have returned to the city. They have new names, new faces, and a new creed fashioned in the factory of Marx which gave the world Hitler. They are the peddlers of gender, race and class politics, and like Hitler they stand in front of the Eiffel Tower. On its storied wrought iron lattice work, they have placed a symbol of their victory. The five rings of the Olympic flag, which once symbolized a 3000 year old celebration of athleticism and the perfection of the human form, acquired a new meaning in the 2024 Paris Summer Olympics. Fixed forever in the Eiffel Tower on orders of the mob, the five rings are a sign of victory of the forces of world revolution.

#### WELFARE STATE TOPPLES THE WEST

Parasitism is a relationship between living species in which one organism, called the parasite, lives off another organism, called the host, deriving food and multiplying at the host's expense, and causing the host great harm. Parasites in nature include single celled organisms such as agents of

malaria, funguses such as agents of ringworm, and animals such as lice. In human society, parasites have existed since time immemorial and are individuals who exploit others and give nothing in return. Civilized societies in the twilight stages of decline, when the virtues of work and self responsibility are denigrated and mobs clamor for the wealth produced by others, legalize parasitism and fashion it into a human right. Ancient Rome, during its centuries of decline, commencing in the late Republic and extending into the Empire, legalized parasitism in the form of the grain dole, which distributed free grain to the unskilled, the indolent, the unemployed and the unemployable, called the plebeians, and fashioned free grain into a human right. Thus was born in the twentieth century that which ancient Rome had established during its dying centuries. Thus was born the welfare state. The welfare state, called the New Deal, Social Security, National Health Insurance, the National Insurance Scheme, and called a myriad of other names, is the official religion of our time, and its enactment into law has been the most significant and far reaching political development in the past one hundred years. Rejecting the consensus among liberal nations in the West, prior to the twentieth century, that the individual is born free and not born in chains to his neighbor, and that the individual, as a free born agent, is responsible for himself and not responsible for others, the welfare state established the twentieth century as the first century of decline in the West, giving it the role the first century BC, which saw the rise of Julius Caesar, the last decades of the Roman Republic and start of the rule of the emperors, played in the decline and fall of Classical civilization. Born in the twentieth century, morally bankrupting the West, and ensuring that the twenty first century will be the final century of civilization, the doctrine of the welfare state has issued a series of proclamations which have sent the clock of history racing backward into the epochs before freedom existed and into the primordial jungle. The doctrine proclaims that a progressive society fights and never stops fighting for the rights of the mob to receive benefits from the producers of wealth. It proclaims that a progressive society affirms the right of the mob to receive subsidies for home mortgages, forgiveness of student loans and free universal preschool programs. It proclaims that a progressive society is an entitlement society which confers lifetime welfare benefits to the ne'er do well living next door, paid for by other people's money. It proclaims that a progressive society is a purveyor of free services to the failures and the incompetent. It proclaims that a progressive society is a social spending extravaganza lavished on those who have achieved nothing in life. It proclaims that a progressive society is a limitless fountain of government services for the lowest and most contemptible social strata. It proclaims that a progressive society is a benevolent thief of the producers' wealth for the good of the mob. It proclaims that a progressive society taxes the producers at a rate of one hundred percent to support those who refuse to work. It proclaims that a progressive society writes multimillion dollar welfare checks to the mob in the name of emergency expenditures and battling the covid pandemic. It proclaims that a progressive society is a culture of welfare spending and unlimited taxing and borrowing to finance the spending. It proclaims that a progressive society runs up a public debt

greater than the value of the goods and services it produces in the name of protecting the mob's social rights. It proclaims that a progressive society makes every man, woman and child a beneficiary of endless welfare largesse. It proclaims that a progressive society is a maximum consumption and zero productivity society. It proclaims that a progressive society burdens future generations with a massive public debt incurred by massive welfare spending. It proclaims that a progressive society makes welfare overpayments to the mob in the name of the people's democracy. It proclaims that a progressive society gives lifetime welfare support to earthworms in human form in the name of fighting economic downturns, depressions and recessions. The responses to the Great Depression and the Covid crisis were especially harmful. The New Deal failed to end the depression. We have WWII to thank for that. But the traumatic experience convinced many Americans to think of the government as their benevolent caretaker. The economic deprivations caused by the Covid crisis were due to mostly self inflicted wounds like the economic and educational shutdowns. Worse, long after the crisis had passed, the checks kept coming to Americans who were not impoverished. The emergency expenditures morphed into entitlements. America has developed a culture of spending which caused the national debt in 2023 to exceed 120% of GDP while 100% has long been considered the outer limit of acceptable indebtedness. We also have hundreds of trillions more in future obligations to beneficiaries with no funding source available. Time and demographics are not on our side. In just the next 12 years, aging baby boomers will reduce the ratio of workers (25 to 64) to retirees (65 and older) from 3:1 to 2:1. The fastest growing demographic group is those 85 and older, who require extra funding. Moreover, increased security risks like war and terrorism will create additional budgetary stresses. There are fewer alternatives to reduced spending than ever available Tax increases are politically unpopular and often don't produce the hoped for outcomes because they reduce productivity. European countries have about 50% higher tax revenues than America, yet their real GDP per capita is lower, even factoring in the government services and subsidies they receive. We're hearing a lot about democracy lately. Both parties claim the other one is an existential threat. Advice to would be political leaders who are courageous enough to go beyond pontificating and do something that might actually preserve our democracy is simply this: cut the spending." (Americans Blissfully Drift Toward Financial Collapse by Tom Patterson). Seven hundred kilometers off the coast of Newfoundland, at a depth of 4000 meters, lies the wreck of the world famous *Titanic*, at the time the largest and most luxurious ship ever to sail, which sank in 1912 as a result of a collision with an iceberg. The wreck lies in two pieces, the bow and the stern, 600 meters apart, and is surrounded by a debris field containing hundreds of thousands of items which spilled from the ship as it sank. The field is decomposing by the second from the action of sea organisms. A little over a century after catastrophe struck the *Titanic*, the largest and most powerful civilization in the history of mankind

has been reduced to ruins and its debris field encompasses the Earth. (Fascist Ecology: The Green Wing Of The Nazi Party And Its Historical Antecedents by Peter Staudenmaier). This rejection of the Enlightenment beneath the darkness of the swastika left a residue of opposition to technological and industrial advancement which persisted after the fall of the Third Reich and has persisted up to the present day. This German national ethos of antiEnlightenment placed within its crosshairs the preeminent symbol of technological power and pulled the trigger. Before the rifle blasts of Germany's national socialist based environmentalist movement and green politics, nuclear energy was obliterated and the Germany was deprived of a source of energy vital to the survival and success of civilization. Germany in the twenty first century has been razed to the ground by the bulldozers of the environmentalist movement and is unable to sustain its modern industrial and technological life. Die Energiewende initiated a massive expansion of solar and wind power, resulting in a commendable 25 percent reduction in carbon emissions by 2022 compared to 2002. But while *Energiewende* slashed pollution through building out renewable energy sources, it also phased out Germany's fleet of safe, carbon free nuclear power plants, a longtime goal of environmental activists afraid of nuclear's salient-but in actuality small-dangers. The result, according to a new <u>analysis</u> recently published to the *International Journal Of Sustainable Energy*, has been a boondoggle for consumers and for the environment. In 2002, nuclear power supplied about a fifth of Germany's electricity. Twenty one years later, it supplied none. A layperson might think that cheap wind and solar could simply fill the gap, but it isn't so simple. Once up and running, nuclear reactors provide reliable, affordable baseload power-electricity that's available all the time. Ephemeral renewables simply can't match nuclear's consistency. And since an advanced economy like Germany's requires a 100 percent reliable power grid, fossil fuel power plants burning coal and natural gas were brought online to pick up wind and solar's slack. The net result of German politicians' shortsightedness in phasing out nuclear power is a vastly pricier grid. The new analysis shows that if Germans simply maintained their 2002 fleet of reactors through 2022, they could have saved themselves roughly \$600 billion Euros. Why so much? Well, in addition to their construction costs, renewables required expensive grid upgrades and subsidies. Moreover, in this hypothetical scenario where nuclear remained, Germany enjoyed nearly identical reductions in carbon emissions. Jan Emblemsvag, a Professor of Civil Engineering at Norway's NTNU and the architect of the analysis, imagined another scenario out of curiosity. What if the Germans had taken the money spent on expanding renewables and instead used it to construct new nuclear capacity? According to his calculations, they could have slashed carbon emissions a further 73% on top of their cuts in 2022, while simultaneously enjoying a savings of 330 billion Euros compared to the massive costs of Energiewende. Policymakers in other countries looking to decarbonize their grids should take note." (Why This Industrialized Nation Had To Return To Fossil Fuels When Wind, Solar Failed by Ross Pomeroy). Germany's environmentalist movement proclaims that a progressive society is a powerful, far left, antinuclear movement. It proclaims that a progressive society foments mob hysteria over the Chernobyl nuclear accident, the Fukushima nuclear accident and the possibility of nuclear world war and leads the mob to smash the safest form of large scale energy generation known to man, in obedience to its far left, anticivilizational agenda. Europe's largest economy has been looking to leave behind nuclear power since 2002, but the phase out was accelerated by former chancellor Angela Merkel in 2011 after the Fukushima nuclear disaster in Japan. The exit decision was popular in a country with a powerful antinuclear movement, stoked by lingering fears of a Cold War conflict and atomic disasters such as Chernobyl in Ukraine. 'The risks of nuclear power are ultimately unmanageable,' said Environment Minister Steffi Lemke, who this week made a pilgrimage to the

ill fated Japanese plant ahead of a G7 meeting in the country. Antinuclear demonstrators took to the streets in several German cities to mark the closures. Greenpeace, at the heart of the antinuclear movement, organized a celebratory party at the Brandenburg Gate in Berlin. 'We are putting an end to a dangerous, unsustainable and costly technology,' said Green MP Juergen Trittin. In front of the Brandenburg Gate, activists symbolically slayed a model dinosaur." (Germany Ends Nuclear Era As Last Reactors Power Down, Agence France Presse, April 15, 2023). He lived at the limits of Earth and at the extremity of Heaven. He was the ancient Roman god of beginnings, endings, dualities and transitions. His name was Janus and he died 1500 years ago during the fall of Rome into the savage plains of Christianity and barbarism. The Russian dominated Polish Government has been encouraged to make enormous and wrongful inroads upon Germany, and mass expulsions of millions of Germans on a scale grievous and undreamed of are now taking place. The communist parties, which were very small in all these Eastern States of Europe, have been raised to preeminence and power far beyond their numbers and are seeking everywhere to obtain totalitarian control. Police governments are prevailing in nearly every case, and so far, except in Czechoslovakia, there is no true democracy. This is certainly not the liberated Europe we fought to build up. Thus spoke Winston Churchill on March 5, 1946 in a speech delivered at Westminster College in Fulton, Missouri. In the ears of civilized people, the speech echoes as a clarion call to vigilance against the totalitarian enemies of freedom and a warning of the fate which befalls nations which ignore the threat posed by movements seeking to turn back the clock of history. 'If you're curious about LGBTQ+ topics, have some questions that you've always wanted to ask, or wish to learn what all the letters mean, this training is for you.' Language and statistics on 'LGBTQ+ youth suicides' were on the agenda, as well as 'ways to be inclusive of nonheterosexual orientations.' They proclaim that a progressive society is a national welfare feeding trough in which every man, woman and child is eligible for life. They proclaim that a progressive society consists of unemployed households, unemployed parents and unemployed children given lifetime government benefits without work requirements of any kind. This was 65 percent of the entire budget, absorbed 83 percent of all tax receipts, and equivalent to 16.3 percent of GDP. By comparison, the government spent 2.8 trillion dollars on these programs in 2019, 62 percent of the budget, 80 percent of revenues, and 13 percent of GDP. Transfer payments increased 46 percent from 2019 to 2022. Government spending on transfer payments to individuals has vastly grown in real terms: In 1945, the government spent just \$15.6 billion (in 2019 inflation adjusted dollars) on these programs, 1.5 percent of the budget, equal to 0.6 of GDP. By 1969, spending on transfer payments to individuals totaled \$263 billion (in 2019 inflation adjusted dollars), 26 percent of the budget, equal to 4.8 percent of GDP. By 1994, transfer payments to individuals grew to 50 percent of total spending. More people are receiving welfare benefits today than at any time in our nation's history. In 2022, 81 million people were enrolled in Medicaid (24.3 percent of the population) and 41 million received Food Stamps (12.4 percent of the population). This is even higher than at the height of the pandemic and government lockdowns. America's welfare rolls have grown since the War on Poverty was declared. The percent of the population enrolled in Medicaid grew from 9.3 percent in 1975 to 24.3 percent in 2022. Food Stamps grew from 7.9 percent in 1975 to 12.4 percent in 2022. The Earned Income Tax Credit (EITC) grew from 2.9 percent in 1975 to 9.3 percent in 2021. Supplemental Security Income (SSI) grew from 2 percent in 1975 to 2.3 percent in 2021. In contrast, the percent of the population on Aid to Families with Dependent Children (AFDC) shrank from 5.2 percent in 1975 to 0.9 percent on Temporary Assistance for Needy Families (TANF) in 2019 after welfare reform. Congress spent trillions creating new transfer payment programs (such as stimulus payments), expanding existing benefits (such as Food Stamp payments), and relaxing eligibility for welfare (such as preventing eligibility reviews for Medicaid). The new benefits (as well as many existing government benefits) are ignored or undercounted in determining eligibility for welfare programs. As Matt Weidinger of AEI has described the result, 'a household with two unemployed adults and two young children could have collected more than \$67,000 in federal pandemic payments without a penny being counted in determining its eligibility for Medicaid. That's more than twice the federal poverty level for a family of four. Two thirds of that amount, or nearly \$47,000, would have been similarly ignored when the family applied for food stamps.' The Families First Coronavirus Response Act waived the Food Stamp work requirements for able bodied adults during the public health emergency declaration. Since 2019, 5.5 million people have been added to the Food Stamp rolls. Congress also increased federal Medicaid funding and prohibited states from removing anyone from the program-even if they were ineligible. The Foundation for Government Accountability estimates that '90 percent of enrollment growth was a direct result of ineligible individuals,' and that 'an estimated 21 million individuals that do not meet Medicaid eligibility standards remained on the program in October 2022.' The FY 2023 Omnibus Appropriations law ends this requirement on March 31, 2023." (A Growing Culture Of Government Dependency, Budget Committee, United States House of Representatives, April 4, 2023). On July 15, 2020, scientists at the California Institute of Technology made a remarkable discovery. They discovered that bacteria can eat metal.

Scientists Jared Leadbetter and Hang Yu described their findings in the July 16 issue of *Nature*: "A wonderful aspect of microbes in nature is that they can metabolize seemingly unlikely materials, like metals, yielding energy useful to the cell." Volkswagen (VW) said it aims to save the company €4 billion (\$4.25 billion) by moving ahead with the job cuts.

VW said earlier this week it could not rule out shutting factories in its home country—a first in its nearly 90 year history. The automotive sector is the important economic engine in Germany, VW's worker representatives argue. They say cuts could have a wider impact on communities. Volkswagen's shares have fallen by nearly a third in five years. Around 25,000 workers gathered at Volkswagen's headquarters in the northern city of Wolfsburg earlier in the week to hear VW management's plans to deepen cost cuts. 'Fewer cars are being sold in Europe and new competitors from Asia are pushing aggressively into the market,' Blume told the Bild am Sonntag newspaper this weekend. 'The cake has got smaller and we have more guests at the table.' Blume said the board was working on 'further measures' to survive a slump in car sales, without offering details. He said VW was still 'firmly committed' to Germany, as it has been for generations. 'We have employees whose grandfathers worked for Volkswagen. And I want their grandchildren to be able to work here, too.' In response to the turmoil at Volkswagen, the Federation of German Industries (BDI)—which represents more than 100,000 German companies employing around eight million people—has demanded better economic conditions for German industry. 'The problems in Germany are obvious,' BDI president Siegfried Russwurm told the Welt am Sonntag broadsheet by pointing at increasing energy prices, high taxes, sprawling bureaucracy and 'unreliable public infrastructure.' He said the issues effect 'large parts of industry, not just individual companies,' adding that Germany's politicians had 'not understood' the magnitude of the problem. (Volkswagen CEO Defends Job Cuts Citing Economic Pressures, Deutsche Welle, September 8, 2024). The communists in the government proclaim that a progressive society is a climate protest movement advocating stringent CO2 emissions limits in a campaign to destroy the car industry. They proclaim that a progressive society seeks to abolish private transport in the name of a transport revolution and to confine people to public trains, trams and buses. They proclaim that a progressive society forces people to drive electric cars, which they neither want nor need nor can afford to purchase, in order to avoid the incineration of the planet at the hands of greenhouse effect predicted by the green parties' Project Fear. The VW boss's concerns are shared across the European car industry. According to *Reuters*, reporting on the eve of Frankfurt's biennial International Auto Show (IAA), which opens on Thursday: 'You have cars that cost an extra 10,000 euros to build, fleet emissions targets requiring a certain sales volume and consumers who may or may not want them,' said one PSA executive. [PSA: French holding group for brands including Peugeot, Citroen, Opel and Vauxhall] 'All the ingredients are there for a powerful explosive.' By next year, CO2 must be cut to

95 grams per kilometer for 95% of cars from the current 120.5 g average--a figure that has risen of late as consumers spurn fuel efficient diesels and embrace SUVs. All new cars in the EU must be compliant in 2021. Motor manufacturing is Germany's biggest industry. It employs around 830,000 people. But it now faces a perfect storm of disasters: from ever more stringent EU carbon emissions regulations; from Angela Merkel's ailing coalition government trying to appease greens with a new comprehensive climate strategy; from lack of consumer interest in all the electric cars it has built but appears unable to sell; from Germany's Energiewende-the replacement of fossil fuels with more expensive renewables; and from environmental campaigners calling for a 'transport revolution' which will lead to the phasing out of private cars altogether. No country in the world has pushed the green agenda harder than Germany. Now, just as it was in the last war-only with a differently couched, more virtue signalling political agenda-Germany is being destroyed by totalitarian ideology. 'Germany is self destructing and it really couldn't happen to a nicer country,' says the Global Warming Policy Foundation's Benny Peiser, himself a German. Peiser was originally a member of Germany's green movement, before seeing the light. To make matters worse for the struggling Germany economy, a report by McKinsey warns that Energiewende is increasingly jeopardizing Germany's energy supply." They proclaim that a progressive university promotes singing, song writing and musical ceremonies in honor of witchcraft. They proclaim that a progressive university requires students to greet each other with salutations, seig heils, and prayers to the Antichrist. They proclaim that a progressive university requires students to study the great books of witchcraft in history, and learn how to read tarot cards and foretell the future. They proclaim that a progressive university is a campus wide witches' meeting peddling broomsticks, black cloaks and pointed hats at bargain basement prices. They proclaim that a progressive university is a Devil's divinity school engaging in brainwashing, programming and the unleashing of Manchurian candidates. They proclaim that a progressive university invades the minds of students, implants the dogmas of witchcraft spirituality and Marxist gender, race and class wars, and promotes the politics of the new little fuhrers in the name of diversity and inclusion: "Yale's Divinity School coerced students to read from a 'spell' written by a 'witch' as part of its Before the Fall Orientation. The three day orientation between August 21 to 23 saw a series of talks and activities preparing incoming students for the year ahead, interspersed with small group discussions. One of these small group periods was the first activity of orientation. Participating as an incoming student in one of these circles, I saw how the discussion opened with a set of Restorative Circle Rules. These rules boiled down to a warning to be open minded: all viewpoints were expected to be heard, that you only have to take what you want from the circle and participate as wanted--at least nominally. After this show of inclusion, we as students were led to read aloud, line by line and one by one, from Adrienne Brown's Radical Gratitude Spell. Brown has been described by Meeting of Minds as a 'mixed race black queer American writer, community organizer, facilitator, witch and--may I say--goddess.' Brown herself subscribes to witchcraft, and it informs her public work. Her website describes her as someone who 'grows healing ideas in public' through 'her writing, which includes short and long form fiction, nonfiction, spells, tarot' and 'her music, which includes songwriting, singing and immersive musical rituals.' This context of Brown, her work, and her particular spiritual inclinations was not given to students before participating in the reading. As such, the group reading of the spell took on an undeniable coven like feeling, with students unable to fully consent to the pseudoritual knowingly, despite the Circle Rules. A second year student, who requested to remain anonymous, expressed to me a deep concern over this act by the orientation staff. The student called the provided spell 'bizarre,' and 'gross,' especially for students to not be told of the author or intentions behind the spell before being led to participate. Another student participant told *The Fix* he felt he would have been punished for not participating. Other recent Yale College graduates and members of the campus Catholic community commented to me in conversation, in a simultaneously tongue in cheek, yet serious manner, that 'the very campus of the Divinity School needed prayer.' They were unsurprised at the inclusion of the spell into orientation. Apparently, it is a popularly known fact amongst more conservative and religious circles in the Yale community that there is little still divine about the Divinity School. As a student who experienced the Radical Gratitude Spell first hand, it was a deeply concerning experience for the state of higher education. Under the name of inclusion, acts of pagan spirituality are being blindly normalized in educational spaces, Yale Divinity School being a prime example of such. Conversely, the preference for diversity comes at the expense of the sanctity of other students' faith. While it was proclaimed that 'you only have to take what you want from this

circle,' personally I did not feel safe to opt out of the spell, being all too aware of the power imbalance and the risk of social stigma against me in this completely new environment. I cannot imagine myself being the only one to feel this way. Diversity and nominal comfort come at a cost. Its inclusion in orientation raises deep concerns over the boundary that exists between said diversity and the religious rights of individual students. This worry is especially poignant in the nearly blind way which the spell was integrated into our first moments as students at Yale." (Yale Divinity Students Forced To Read From Witch's 'Spell' At Orientation by Raleigh Adams). (Radical Gratitude Spell by Adrienne Marie Brown). Listen to the witches running Yale proclaim that a progressive university is a course of study in magical spells and mystical poems. Its spirit and soul entered the ranks of one of America's main political parties and was greeted there with open arms. This party had embraced communism in the 1930s under the administration of Franklin Roosevelt, and called its communism by such names as Progressivism, Social Security and the New Deal. Prices overall rose 19% over the first 42 months of Biden's term compared with 6% during Trump's first 42 months, according to Forbes. Year over year inflation peaked under Biden at a four decade high of 9% in 2022. Harris said she is the only candidate promoting an opportunity economy, but Trump's Tax Cuts and Jobs Act gave the 82% of middle income earners a tax cut that averaged about one thousand and fifty dollars, according to FactCheck.org. 'I was raised in a middle class home,' Harris said, 'And I am actually the only person on the stage who has a plan to lift up the middle class and the working people, and when you look at his economic plan, it's all about tax breaks for the richest people.' But even the Biden-Harris administration's Treasury secretary, Janet Yellen, acknowledged that Trump's 2017 Tax Cuts and Jobs Act cut taxes for all. The year following the Tax Cuts and Jobs Act, new job openings surged, and about 83,000 more Americans voluntarily left their jobs for better opportunities at the end of 2019, compared with the trend before the reform. The claim that Harris' father is a Marxist was fact checked by *Snopes* as 'true' after a viral X post from political economist Maxine Fowe: 'Did you know that Kamala Harris' father, Donald J Harris, was a postKeynesian & Marxian economist? His research focused on economic inequality, uneven development & how the growth rate of an economy is fundamentally dependent on the class structure of society.' Donald Harris, a now retired professor of economics at Stanford University, was the author of a 1978 book, Capital Accumulation And Income Distribution. It features ideas on Karl Marx's theory of capital. 'His book, Capital Accumulation and Income Distribution, published in 1978 and dedicated to Kamala and her sister, examines the pitfalls of relying on profit seeking capitalists to direct an economy,' writes The Economist. The New Yorker wrote of Donald Harris being 'a renowned Marxist economist from Jamaica who taught at Stanford University for decades.' With the border and illegal immigration being one of the most important issues among voters in the 2024 presidential election, it's no surprise moderators raised the issue early on in the debate. Muir began by asking Harris why the Biden administration waited 'until six months before the election' to take action on the border, referring to Biden's recent executive order limiting illegal border crossings. Harris answered by touting her work prosecuting 'transnational criminal organizations,' before attacking Trump for opposing a controversial border bill that failed in the Senate twice. Harris said the failed bill 'would have allowed us to stem the flow of fentanyl' coming into the US, and would have provided 'more resources to prosecute transnational criminal organizations.' The failed bill directed the Department of Homeland Security to close the southern border 'during a period of seven consecutive calendar days, if there is an average of 5,000 or more aliens who are encountered each day.' Over 1.8 million illegal aliens a year still would have been permitted to enter the United States under the now twice failed legislation. Harris blamed Trump for the bill's failure, saying the former president 'got on the phone' and told Republican members of Congress to 'kill the bill.' Trump, and many GOP members of Congress, were clear about their opposition to the proposed border security bill, arguing it would enshrine harmful border policies into law. The Senate border bill 'codified Joe Biden's open border,' Senator Ted Cruz, R-Texas, said of the bill in February. Senator James Lankford, R-Okla., led the way in negotiating the terms of the bill with

Democrats. Even if the Senate had successfully passed the bill, House Speaker Mike Johnson said the bill would have been 'dead on arrival' in the House. Trump claimed Haitian immigrants that have flocked by the thousands to Springfield, Ohio are 'eating the pets of the people that live there, and this is what's happening in our country, and it's a shame.' A recording of a police phone reveal(ed) a local resident reporting a group of Haitian migrants carrying four geese in Springfield two weeks ago, according to a Federalist report. 'A recording of a police phone call obtained by The Federalist reveals a local resident reporting a group of Haitian migrants carrying four geese in Springfield, Ohio two weeks ago. I'm sitting here, I'm riding on the trail, I'm going to my orientation for my job today, and I see a group of Haitian people, there was about four of them, they all had geese in their hand, the caller tells the public services dispatcher in the audio recording of the call. " (Fact Checking Claims Made In Trump-Harris Debate by Virginia Allen, Fred Lucas et al). Alberto Fujimori: won standing ovations and landslide victories from the people due to his defeat of Marxism in the economy and on the streets. Alberto Fujimori: he was forced to flee to Japan and lived there for five years. Alberto Fujimori: he was arrested in Chile, extradited to Peru, framed on a variety of criminal charges, from embezzlement to electoral fraud to human rights abuses, all payback for his campaign, supported by the civilized half of the nation, to rid public life of the cancer of Marxism: "The controversial former Peruvian president, Alberto Fujimori has died aged 86. To his supporters, Fujimori was the president who saved Peru from the twin evils of terrorism and economic collapse. To his opponents, he was an authoritarian strongman who rode roughshod over the country's democratic institutions to preserve his hold on power. In 2009, he was sentenced to 25 years in jail for human rights abuses committed during his time in office--including authorizing killings carried out by death squads--but he was released from prison in December after a pardon on humanitarian grounds was reinstated. An agricultural engineer born of Japanese parents, Fujimori upset the odds when he won the Peruvian presidency in 1990 against Nobel Prize winning author Mario Vargas Llosa. Fujimori was a political unknown until weeks before the vote. Few knew what to expect from him when he inherited a country on the verge of economic collapse and racked by political violence. He implemented a radical program of free market reforms, removing subsidies, privatising state owned companies and reducing the role of the state in almost all spheres of the economy. Though this shock therapy brought great hardship for ordinary Peruvians, it ended rampant hyperinflation and paved the way for sustained economic growth in the second half of the 1990s. Fujimori also tackled the left wing rebels whose 10 year insurgency caused thousands of deaths. But he says he never approved a 'dirty war' against the rebels. In 1992, with the support of the military, the president dissolved the Peruvian congress and courts and seized dictatorial powers. He justified the measure by arguing that the legislative and judiciary had been hindering the security forces in their fight against the rebels. Opposition politicians said he was really seeking to escape democratic accountability. But that same year he was vindicated in the eyes of many Peruvians by the capture of the leader of the main rebel group, the Shining Path. In 1995, Fujimori stood for reelection and won an overwhelming victory.

Most voters cited his victories over left wing insurgents and hyperinflation as the reason for giving him their support. One of the key moments of his presidency was the hostage siege by Marxist MRTA rebels at the Japanese ambassador's residence in Lima in 1996-97. After a four month stand off, commandos were sent in to take the building. All 14 rebels were killed and nearly all the 72 hostages were rescued in an operation that at the time cemented Mr Fujimori's reputation of a man of action. In his second term though, a growing number of Peruvians began to voice concern that the methods used against the insurgency were also being employed against the president's democratic opponents. His critics accused him of using the intelligence service led by Vladimiro Montesinos to intimidate and spy on rivals. They said he exerted unfair control on the media and the judiciary, and used government resources to support his own campaigns. This criticism increased when he announced he was to stand for an unprecedented third successive term. Although he won the May 2000 elections, the victory marked the start of his downfall. A tape emerged showing Montesinos apparently bribing an opposition member of Congress. After the scandal broke, the opposition gained control of Congress for the first time in eight years and dismissed Fujimori on grounds of 'moral incapacity.' In November 2000, he fled to his parents' native Japan, where he lived for five years in self imposed exile. In an effort to resurrect his political career and launch a new bid for the presidency, he flew to Chile in November 2005, only to be arrested at the request of the Peruvian authorities." (Peruvian Strongman Alberto Fujimori's Death Leaves Divisive Legacy, BBC News, September 11, 2024). In the American Old West, a Texas Ranger fought outlaws with his Indian friend Tonto and his white horse. An shining icon of American culture, the Lone Ranger lived by a strict moral code, which stated: I believe in being prepared physically, mentally, and morally to fight when necessary for what is right. On September 11, 2024, weeping Peruvians gathered outside the home of Alberto Fujimori after his children had announced his death. They chanted Alberto Fujimori, national hero! They praised him for defeating the Shining Path and its Marxist invasion of the nation. They praised him for storming the Marxist Tupac Amaru, releasing the hostages it was holding, and killing the members of the group. They praised him for placing the economy back on the track of freedom and eliminating skyrocketing inflation. They praised him for draining the swampland called democracy because the mobs in Congress and the courts had prevented him from taking the measures necessary to eliminate Marxist terror. On the day of Fujimori's death, the Peruvian government declared three days of national mourning for the nation's Lone Ranger.

# **RED ARMY INVADES AMERICA**

"There is only one way to prevent the restoration of the police, and that is to create a people's militia and to fuse it with the army. The standing army must be replaced by the arming of the entire people. Thus spoke Vladimir Lenin in September 1917 in The Tasks Of The Proletariat In Our Revolution. Thus were seeds planted in revolutionary Russia for the establishment of a Red Army to enforce communism. On January 28, 1918, the Council Of People's Commissars ordered the formation of such an army. The seizure of power by the workers and propertyless persons renders necessary the formation of a new army. The tasks of this new army will be the defense of the Soviet authority, the creation of a basis for the transformation of the standing army into a force deriving its strength from a nation in arms, and, furthermore, the creation of a basis for the support of the coming socialist revolution in Europe." (Scheme For A Socialist Army, Decree of the Council of People's Commissars, January 28, 1918). Acting under the slogan exhortation, organization and reprisals, the Red Army was the hammer of control in the nations under its occupation, and for seven decades it held Europe in the grip of fear. On May 7, 1992, following the dissolution of the Soviet Union, the Red Army ceased operations, and a new Russian

Army took its place. The Red Army died in body but its soul migrated, and found a new home 9000 kilometers away in the nation which led the free world's struggle against communism during the Cold War. In a fact stranger than fiction, a fact which had to be seen to be believed, the Soviet Red Army found a new home in the United States of America, and carried on its task with new names and new slogans. In a fact which illustrated like nothing else the relentless advance of cultural decay when set into motion by the mass abandonment of reason, an advance sparing no nation or society great or small, America, the world's arsenal and lighthouse of freedom for one hundred years, fell to the enemies of freedom in the twenty first century when the resurrected ghost of the Soviet Red Army invaded its shores. The mission statement proclaims that a progressive military is not a defense of the nation against the external enemies of freedom but is a research, teaching and experimentation station for the advancement of Marxism. It proclaims that a progressive military enforces the religious dogma of critical race theory. According to this, legitimate political theory is critical of Enlightenment values and rejects human essentialism and universality. It is a doctrine of race essentialism and black Hitlerite politics which condemns liberal democracy as a regime of white privilege and subconscious racism, and it advocates the overthrow of liberal democracy and the extermination of whites. The mission statement of the new Red Army proclaims that a progressive military enforces policies of race and gender discrimination, and calls its racism, sexism and exclusion of white males the achievement of diversity, inclusion, and the highest form of fairness and equity. It proclaims that a progressive military rejects the principle of merit and the equality of all before the law, and enforces affirmative action, the diversity, equity and inclusion policies of exclusion of white males, in every workplace, community, immediate family and extended family in the land. It proclaims that a progressive military affirms that capitalism equals systemic racism and the rejection of equal rights for minorities. It proclaims that a progressive military affirms that American constitutionalism and the capitalist system are regimes of white slaveholding. It proclaims that a progressive military requires all white personnel of all ranks and titles, including civilians, to undergo workplace sensitivity training which will order them to treat black personnel as members of a master race, and to bow down in submission to them as members of a subaltern white race. It proclaims that a progressive military is a politicized military and rolling tank fleet of Marxist imperialism. It proclaims that a progressive military rejects America's founding motto, Out of Many One, the motto of assimilation to a common set of liberal values and the cause of universal freedom transcending tribal differences, and rolls its tanks through the nation enforcing the Marxist motto, Universal Tribalism and Gender, Race and Class Politics: "The sole purpose of the U.S. Armed Forces is to defend the nation against its external enemies. The service academies train officers committed to fulfilling this mission. This mission—defense of the

nation—makes the US Armed Forces arguably the most important institution in the United States. Without a nation, other institutions are meaningless because they would not exist. Given its importance, the US Armed Forces should not be a laboratory for social experimentation, especially one based on Critical Race Theory, a contentious and abstract social theory. Yet, as this Commission Report on Civic Education in the Military shows in great detail, Critical Race Theory is promoted within Diversity, Equity, and Inclusion (DEI) training throughout the military from the Pentagon through the ranks and in our service academies. Critical Race Theory is based on an assumption that no matter what progress is made on ensuring equal rights for minorities, 'white privilege' and 'subconscious' racism continues to prevail among whites, no matter their professed support for diversity and inclusion in their workplace, community, or immediate and extended families. Critical Race Theory assumes that racism is systemic from the very founding of the United States and that the US Constitution was drafted to ensure the white privilege of slaveholders. Whatever the appearance of progress—constitutional amendments and legislation to protect equal rights for racial minorities—is a facade that still preserves white privilege. Critical Race Theory is based on assumptions, not empirically derived evidence, and is by nature divisive. Diversity, Equity, and Inclusion programs, which rely on Critical Race Theory, should not be seen as workplace sensitivity training. The Commission on Civic Education in the Military began as a project to review civic education in the military. Our research team did not expect to find Critical Race Theory so embedded and pervasive. Diversity, Equity, and Inclusion programs are found throughout the US Armed Forces and our service academies. This year long study documents just how pervasive these training programs are in our Armed Forces and Service Academies and that DEI extends well beyond just formal training programs in the military and service academies. The Founders of our nation understood and feared a politicized military. History had shown them that a politicized army easily became the tool of tyranny. The Armed Forces of the United States has proudly upheld this long tradition of separating mission from politics. The commissioners for this project believe that military training for service men and women in all ranks needs to inculcate and reinforce pride in our nation, pride in service, and in our country's motto, E Pluribus Unum (Out of Many One)." (Civic Education In The Military, National Commission On Civic Education In The Military, Arizona State University). The mission statement of the new Red Army proclaims that a progressive military defends its nation against the enemies of Marxism in foreign lands. It proclaims that a progressive military rejects the liberal essence of America and the belief that freedom belongs to all persons, and promotes race, gender, ethnic, cultural differences. It proclaims that a progressive military rejects America's founding motto, Out of Many, One, which means, Out of Many Tribes and Backgrounds, a Liberal, Assimilated Nation, and promotes race and gender divisions, discrimination and the exclusion of white males in the name of achieving diversity, equity and inclusion. It proclaims that a progressive military rejects the liberal vocabulary of freedom and individual rights and teaches its recruits, officers and civilian personnel at all levels the Marxist vocabulary of gender, race and class dictatorship. It proclaims that a progressive military affirms that America's liberal thoughts, ideas, daily life and political institutions are the voices of racism, oppression and white supremacy and must be subverted by a diversity, equity and inclusion agitation vocabulary and a global Marxism revolution: "The American people hold our service men and women and their leaders, who defend this nation from foreign enemies, in the highest esteem. The men and women serving in our Armed Forces stand ready to sacrifice life and limb to protect this exceptional nation. E Pluribus Unum, (Out of Many, One), our country's motto, captures the essence of our nation. Ethnically, racially, religiously, and culturally diverse, we stand united in our belief that liberty binds us as a nation. Today our cadets and midshipmen in our military service academies are instructed through Diversity, Equity and Inclusion (DEI) training that belies—indeed, subverts—the concept E Pluribus Unum. In extensive and multiple DEI training programs that are implemented through every rank, our service men and women are instructed to believe that this nation was built on systematic racism embedded in the founding of our country and that that system

underlies daily life in the country today. Racism is so endemic, these DEI programs declare, that people are not even aware of their racism. DEI training insists that white supremacy permeates every facet of American life, institutions, and individual thought and insists service members utilize the divisive vocabulary of oppressed vs oppressor." (*Civic Education In The Military*, National Commission On Civic Education In The Military, Arizona State University). *Upon the ashes of the great war, the Bolsheviks created a new army. These facts demand no explanation for any one who has even the slightest knowledge of the language of history. The strongest cement in the new army was the ideas of the November revolution, and The Train supplied the front with this cement. Thus spoke Leon Trotsky in his autobiography <i>My Life*. This People's Commissar of Army and Navy Affairs, this first commander of the fearsome Red Army, had a successor one hundred years later in the New World in the new millennium. They have ignored this town's problems for years. Now, they pay attention-not to focus their considerable wealth and power on helping their fellow citizens. But to use their platform as a weapon against those who dare to notice that their lives have gotten worse. Some establishment media reports acknowledge some of the economic costs that the large scale, government funded arrival of perhaps 20,000 illegal immigrants in a small town of almost 60,000 Americans have imposed. However, very few media outlets admit how migration disadvantages Americans and aids migrants when seeking housing and jobs. 'For our government to totally throw aside national citizens, people that were born and raised here [is wrong]. They're treating us like we're the trash,' one American told a reporter. Instead, media outlets and Democrats portray citizens and Trump's campaign as threats to Haitian migrants even though citizens are protesting President Joe Biden's policy of importing migrant labor to fill low wage jobs that vast budget deficits have created. For example, on Friday, many media outlets spotlighted Biden blaming Trump after anonymous bomb threats forced the closure of schools and government buildings. The Washington Post wrote: 'I want to take a moment to say something [about the] Haitian American community that's under attack in our country right now,' Biden said during a White House event celebrating black excellence. 'It's simply wrong. There's no place in America. This has to stop, what he's [Trump's] doing. It has to stop!' Vance, however, pushed back: 'Nothing justifies violence or the threat of violence levied against Springfield or its residents. We condemn both. But the existence of threats doesn't justify silencing those who wish to petition their leadership for a better life. There is no heckler's veto in our country. Donald Trump was shot in the head, and yet they still call him a threat to democracy. Yet it is Kamala Harris who is a threat to democracy. It is Kamala Harris who would rather import new voters than persuade the ones who are already here. It is Kamala Harris who would rather ignore the citizens of Springfield than undo the policies that hurt them. It is Kamala Harris who would rather censor her fellow Americans than listen to them. What we are seeing from Kamala Harris and her enablers in the media is disgusting. And there is only one person who has consistently stood up to Kamala Harris and the entire corrupt system she represents. There is only one person who has consistently fought for the people Kamala Harris laughs at or ignores. Donald J. Trump for President, Vance concluded.' Since 2021, Biden and his deputies have imported almost ten million legal and illegal immigrants—around one immigrant for every American birth." (JD Vance: Democrats Scoff At Americans Harmed By Migration by Neil Munro). Look at America in the twenty first century and see a Haitian plague proliferate to infinity and overwhelm towns. See it turbocharge the crime rate and smash up roads and bridges with traffic accidents. See it attack people on the streets and steal their money and cars. See it invade schools and send students running for their lives before alien, incomprehensible speech and violent, disruptive behavior. See it bankrupt schools by forcing them to establish massive remedial English programs. "Charleroi, Pennsylvania, like Springfield, Ohio, is also experiencing a growing number of problems from a tidal wave of Haitian migrants flooding into their small town. While the media focuses on the woes of Springfield, Ohio, and its recent flood of Haitian migrants putting pressure on the small town, other small towns are experiencing similar problems. One of them is Charleroi, Pennsylvania, nestled on the banks of the Monongahela River south of Pittsburgh in the western part of the state. According to the activist group America-2100, the rural town has suffered a 2,000 percent increase in its population of Haitian migrants—and crime and traffic altercations have soared as a result. Residents have been flooding social media with reports that migrants are attacking people on the street and mugging them, stealing cars, and ending up in traffic accidents throughout the area. WPXI-TV reported in March that the rising number of immigrant children has stretched the local schools to the breaking point as administrators and teachers toil to educate migrant children, many of whom do not speak English, and some of whom have never gone to school in their entire young lives. One eleventh grade student told the station that a big problem is that many of these migrant students are really not learning anything despite being enrolled in free schools because they don't understand what is being said in class. 'The biggest challenge that every Haitian has is they don't know what you are saying. For them, it's like blah blah blah, you don't say nothing you are just sitting in the class listening and you just don't understand,' the child, who is also a Haitian migrant, said. Charleroi schools superintendent Dr Ed Zelich noted that the new students are costing his school hundreds of thousands of dollars spent to accommodate them. 'Just in the last year we had over \$400,000, we had to add two ELL [English language learner] teachers, an ELL coach for our teachers, a registrar, an interpreter,' Zelich told WPIX." (Not Just Ohio: Small Pennsylvania Town Also Mired in Tidal Wave of Haitian Migrants by Warner Todd Huston). Night has fallen on America in the twenty first century. It was brought down by two forces implacably hostile to this child of the Enlightenment, for which its founding heroes fought and died on the battlefields of Lexington and Concord. It was brought down by an enemy within and an enemy without. The former enabled the latter to settle, multiply and expand across the length and breadth of this storied land. He registered to vote on turning 18 in September of that same year as a member of the GOP, records seen by the New York Post show." The second event occurred at the Trump International Golf Club in West Palm Beach Florida on September 15, 2024, when Ryan Routh aimed an SKS rifle at Trump, intending to kill him. He was fired on by authorities and was later captured. Ryan Routh. Donated money to ActBlue, the Democrat Party and Democrat candidates across the nation: "The suspect apprehended

for reportedly attempting to kill former President Donald Trump on Sunday has a history of donating to Democrat political campaigns. Beginning in the 2020 election cycle in which ultimately Trump battled Joe Biden for the presidency, Ryan Routh of Hawaii made 19 donations to Democrats through ActBlue, the Democrats' fundraising platform, according to Federal Election Commission records reviewed by Breitbart News. Routh's 19 donations were small—the largest only \$25 to Beto for America, a political action committee supporting Beto O'Rourke's ill Routh's donations shed more light on his motivations as media and Americans across the country scramble to learn more about the suspect. fated presidential run—and totaled \$144.40. Those donations supported Democrat candidates as diverse as Elizabeth Warren, Andrew Yang, Tulsi Gabbard, and Tom Steyer." (Trump Assassination Suspect Donated 19 Times To Democrats by Bradley Jaye). Ryan Routh. Supported communism, the Democrat Party and the assassination of Trump in the name of preserving freedom and democracy: "In an April post on X tagging President Biden's presidential account, he wrote that Biden's campaign should be: 'called something like KADAF. Keep America democratic and free. Trumps should be MASA: make Americans slaves again master. DEMOCRACY is on the ballot and we cannot lose. We cannot afford to fail. The world is counting on us to show the way." (CNN Politics, September 15, 2024). Two assassination attempts, sixty four days apart, staged by one half of the American electorate which no longer supported the founding ideals of the nation. Assassination attempts staged by communists have riddled the American political scene with bullet holes for over a century, commencing with the assassination of William McKinley in 1901 by Leon Czolgosz, mentored by communist doyenne Emma Goldman. While civilized people know the difference between freedom and tyranny, and advocate violence to remove tyranny, communists invert the difference.
