INTRODUCTION

MUSLIMS BRING DARKNESS TO VIENNA

It is called the City of Music. Beethoven, Brahms, Bruckner, Haydn, Mahler, Mozart, Schoenberg, Schubert and Strauss lived and worked here. Its Baroque palaces and gardens, and its great circular boulevard known as the Ring Road, lined with buildings, monuments and parks, define the meaning of the world *civilization*. This home of the world famous *Neue Hofburg*, *KarlsKirche* and Upper Belvedere, this UNESCO World Heritage site, is called Vienna, and over the past one hundred years, it has collapsed twice by the action of Austria's mobs. The first collapse occurred on March 15, 1938, when Adolf Hitler entered the city and was greeted by a cheering mob of 200,000. In *Heldenplatz*, from a balcony in the *Neue Hofburg*, Hitler proclaimed that Austria had been absorbed by the Third Reich. A pogrom against the Jews commenced, carried out by the SS, the SA and the Hitler Youth, which saw the destruction of synagogues and prayer houses and the murder or forced emigration of 185,000 Jews out of a population of 200,000. Vienna ceased to be the capital of Austria because Austria had ceased to exist. During World War II, the city suffered dozens of bombing raids, which saw one third of the city center destroyed and the State Opera and *Burgtheater* reduced to ashes. In the postwar period, the city came back to life and resumed its former station as Austria's most important city and a European cultural mecca. It occupied this station until the new millennium, when its second collapse occurred. This second collapse is permanent because the mobs which inflicted have been felled by a spiritual cancer caused by the spirit of the times. This cancer, this spirit of the times, this symptom of the sickness of the abandonment of reason, has felled Western civilization and reduced it to a wasteland stalked by the horsemen of a latter day religion. They have declared war on the values of the Enlightenment and ride the horses of gender, race and class politics. They are the horsemen of today's mobs and they spread the black gospel of Marxism across the world. Their hatred of freedom runs so deep and is so profound that they have made common cause with another religion which also hates freedom. This religion comes from the East and its adherents multiply like bacteria and spawn progeny by the billions. Seeing the advantages to their cause of having this bacterial army overrun the civilization they hate, the Marxists in charge of the West have made common cause with Islam. See Muslim prayer rooms installed in schools and utilized to plan acts of violence and terror. See Muslim students stab principals. See classrooms transformed into indoctrination pulpits for religious radicalism. See secular values swept away by rolling waves of religious bigotry and intolerance. See liberal minded teachers flee from schools transformed into staging grounds for Muslim revolution. See students who do not speak German but speak the language of Muslim extremism, and spread hatred of women, capitalism, Jews, Israel and the West wherever they go: "A new book from a headmaster in Austria is shining a light on the threat of mass immigration and Islamization in the Viennese school system in terms of women's rights and safety. Christian Klar, the headmaster of a secondary school in Vienna, reports on the dramatic conditions in his new book, which was released last month, entitled, *What's Going On In Our Schools?* 'Islam is now everywhere in Viennese schools,' stated Klar, the principal of a high school in Vienna, who reported on the dramatic conditions prevailing in the schools of the Austrian capital in an interview with the *oe24* news portal. 'Some girls wear headscarves out of fear. Others wear full body veils out of Islamic conviction,' he told *oe24*. 'I would really like a very clear, strict directive on, for example, the dress code, which would also be published in the media. To make it clear to everyone who lives in Austria that this is not what we want,' he said. Klar has banned

headscarves and full body veils in his school, but is now looking for action at the federal level to address the issue. Klar noted that five young girls came to school veiled after being sexually harassed on a massive scale. On the advice of their parents, they wanted to protect themselves from further incidents of this kind. In his book, he tells the stories of students who demand an Islamic prayer room in the school, but have no tolerance for other religions. He pointed out other problems he has seen, including one student threatening to stab the principal at school. Klar is calling for stricter rules from the government to preserve the school system and keep radical religious elements out of the classroom. 'If we want to preserve our secular society, we must take care of it. And intolerance should not be countered with tolerance,' he stated. As *Remix News* previously reported, one third of all students in Vienna are now Muslims. Teachers are fleeing the school system over mass immigration.' According to a study by the Austrian Statistical Office, around 70 percent of school age children in Vienna do not speak German in their everyday life. Now, the rise of mass immigration has created growing problems in the Austrian school system, with the Vienna school system threatening to collapse. 'Everyone who wants a place in a school must have German language skills. There must also be sanctions for violent and extremist students; a suspension of family reunification; and zero tolerance for misogyny and antisemitism,' according to teachers' union member Thomas Krebs, who made the comments earlier this year." (*'Girls Wear Headscarves Out Of Fear,' Warns Austrian Schoolmaster In New Book, Remix News, September 2, 2024*). Look at Vienna in the twenty first century and see Muslims drug, rape and kill children. See Muslims seek refuge and asylum like wild animals. See Muslims given a license to terrorize. See Muslims granted lifetime protection by the state. See Muslims plunge the city into a migrant crisis. See Muslim hoodlums released by the police and granted immunity from prosecution. See Muslim hoodlums granted a license to commit violence against people and property. See Muslim hoodlums protected from deportation by judges. See Muslim hoodlums held to be nonresponsible for their acts. See Muslim hoodlums given therapy and social care in place of punishment for their crimes. See the members of a Muslim International, hailing from the four corners of the Earth, reaching from Austria to Bulgaria to Italy to Serbia to Syria to Turkey, seize control of a world cultural heritage jewel and shatter it beyond recognition, with hammers given to it by the Marxist establishment: "A 14 year old girl was found dead in an Afghan migrant's apartment in Vienna this week after she was allegedly plied with narcotics and sexually abused. It comes in the wake of the nation being shocked by the gang rape of a 12 year old girl by a multicultural gang of mostly foreign men. On Tuesday, police discovered the lifeless body of a 14 year old girl in the apartment of an Afghan migrant in the Simmering district of Vienna. According to investigators, the young girl died of a drug overdose, believed to have been supplied by the migrant man, who is suspected of sexually abusing the girl. The suspect, a 26 year old Afghan national, told police that he had 'consensual sex' with the teenage girl, the *Kronen Zeitung* newspaper reports. The migrant reportedly arrived in Austria in 2015 during the height of the European Migrant Crisis. Although his initial asylum application was rejected, upon appeal, he was granted 'subsidiary protection,' a status allowing migrants who do not qualify as refugees to remain in the country. The judicial order was extended twice, preventing him from being deported from the country before the death of the girl. The incident comes just days after a 17 strong multicultural gang were accused of drugging and raping a 12 year old girl in Vienna over a period of about five months last year, between February and June. The alleged victim came forward last October with her mother to police, claiming that she was coerced by her abusers into performing sexual acts under threat of having indecent pictures and videos published online by her alleged rapists. According to the German *Welt* newspaper, 13 teens were questioned and released by police last Thursday, and are said to have been from Austria, Bulgaria, Italy, Serbia, Syria, and Turkey. All of the 17 suspects in the case were already known to police for either violent or property crimes in Austria. The scandal has prompted politicians to hold a summit to discuss lowering the age of criminal culpability, with current law only allowing for minors under the age of 14 to undergo therapy and social care rather than being held responsible for

violent crimes. However, the left wing Green party, which serves in Nehammer's government, has signalled opposition to the move, saying that it is opposed to 'event based legislation' " (*14 Year Old Girl Found Dead In Afghan Migrant's Vienna Flat After Suspected Sex Assault And Drug Overdose* by Kurt Zindulka). On March 29, 1795, a blinding light spread across Vienna. On this day, Ludwig van Beethoven made his public debut in the city. At the city's *Burgtheater*, radiations of power, intensity, heroism and the triumph of the human spirit bathed Europe in a noonday world which would endure for centuries. In the twenty first century, darkness has engulfed the continent. The music of Beethoven, the music of Vienna, the music of civilization, has been silenced forever. It was silenced by the actions of an enemy within and an enemy without. The enemy within is Marxism, voted into office for life by the mob. TRAIN CRASH KILLS NATION

It started moving in Germany. It first appeared in the sixteenth century as a horse drawn carriage transporting ore on tracks from mines. It was famously illustrated in 1556 in drawings by Georgius Agricola in his work *On Metals*. It was rail transport. On December 7, 1835, steam power arrived in the Bavarian Ludwig Railway, running between Nuremberg and Furth. Four years later, the first long distance railway in history ran between Leipzig and Dresden. Invented in Germany, rail transport is one of the two primary means of land transport, next to road transport, in the world today, and carries ten percent of the world's passengers and freight. For decades, Germany's rail transport was the envy of the world. It occupied the top ranks of the European Railway Performance Index measuring intensity of use, quality of service and passenger safety. It occupied the top ranks of measurements of value for public investment, and measurements of costs spent for performance delivered. In the twenty first century, Germany's acclaimed rail transport system has been shut down, a victim of attacks launched by the nation's far left establishment. The establishment has decreed that Muslims from foreign lands seeking refuge and asylum like wild animals do not have to pay their train fares. It has decreed that train conductors do not have to check migrants for tickets. It has decreed that migrants, due to their violent, threatening and intimidating behavior, must be given free rides on trains. It has decreed that migrants must be given free rides in the name of social peace and deescalation of trouble. It has decreed that there are two classes of people in German society: nonMuslim, nonmigrant, German residents, and migrant, Muslim aliens, and the first class is a subaltern class which has to pay its train fares, while the second class is a master race which is exempt from paying its train fares. It has decreed that migrants do not have to exhibit orderly, respectful behavior while traveling on public transit. It has decreed that a progressive society is a left wing society in which migrants, traveling on trains or walking down streets, are allowed to exhibit maximum savagery toward others and maximum contempt for the rule of law in their campaign to destroy civilization: "German train conductors in the state of Thuringia have been given permission not to check the tickets of foreign passengers after an increase in threatening behavior from asylum seekers towards staff. The *Thüringer Allgemeine* reported on Sunday that railway staff had been informed to do all they can to deescalate troublesome travelers, even if that meant effectively giving them a free pass on their commute. The German newspaper had been contacted by a married couple who had recently traveled on a *Süd-Thüringen-Bahn* train and noticed that those they assumed to be foreigners were not having their tickets checked while German commuters were still scrutinized. Upon contacting the railway service provider, a spokesperson denied the allegation and claimed that tickets had probably been checked before the couple had boarded the train. However, upon further questioning, the rail company did concede that conductors had discretion to not demand to see valid tickets to ride

should they consider the situation is at risk of escalation and they feel threatened or intimidated. The same railway company recently made headlines when its works council complained in a letter to Thuringia's left wing Minister President Bodo Ramelow about the behavior of foreigners on public transport. An excerpt from the letter read: 'State and federal politics repeatedly talk about integration and tolerance of migrants/refugees. We ask you seriously, how can you expect citizens of this country to be open to the refugee policy being practised when they have to witness—practically every day, and not just on public transport!—such violence, brutality, and absolute contempt and mockery of our laws and society, including its so-called values?' " (*Germany: Train Conductors Urged Not To Check Tickets Of Foreigners To Keep The Peace* by Thomas Brooke). Look at Germany's railways today and see damage and disruption caused by Marxist groups. See railways in Berlin and Hamburg descend into vandalism at high speed. See trains forced to travel on alternate routes in order to escape Marxist terror attacks. See the institutions of freedom and the arteries of progress condemned as capitalist infrastructure, and see the carriages of passengers, freight and civilization targeted with rifles blasting out sabotage: "A series of fires hit railway infrastructure in the German city of Hamburg overnight, causing widespread disruption to trains between Hamburg and Berlin and between the port city and the Baltic Sea coast. Police said they suspect that the damage was politically motivated. Railway operator Deutsche Bahn said that trains on the main high speed route between Hamburg and Berlin were canceled because of vandalism. It said it was running some trains on an alternative route that takes up to an hour longer. Long distance trains between Hamburg and Rostock also were canceled. *Deutsche Bahn* said it likely would be able to restore service on the main Hamburg-Berlin line only on Saturday morning. Hamburg police said that cable ducts next to railway lines were set on fire at three locations in the city between 2:30 am and 4 am. They said in a statement that they suspect 'a political motive as the background' and are seeking witnesses, but gave no further details of the reasons for their suspicions. The fires were all extinguished. A claim of responsibility that appeared on a left wing website said that 'transport arteries of the capitalist infrastructure' had been 'sabotaged,' but referred to lines used for freight rather than passenger traffic, German news agency *dpa* reported. Police said they were aware of the claim and it was part of their investigation. (*Infrastructure Underpinning Modern World Again Sabotaged In Germany, Police Suspect Political Motive, Associated Press, September 8, 2023*). Look at Germany's railways today and see adolescent beasts in human form, hailing from the dark, distant mountains of Afghanistan, attack passengers with the knives of Muslim revenge. The 17 year old, who arrived in Germany a year ago as an unaccompanied refugee, injured four people, two critically, in the attack on Monday evening. He was shot dead by police as he fled. The self styled Islamic State group (IS) has released a video purporting to show him making threats. In it, a young man brandishing a knife says he is an 'IS soldier' preparing for a suicide mission. German officials say they later found a hand painted IS flag in his room. Bavarian regional prosecutor Erik Ohlenschlager said the boy was a devout Muslim and wanted to get revenge on 'infidels' who had harmed his Muslim friends. He accepted that his own death was a possibility. Mr Ohlenschlager said the attack was 'definitely politically motivated.' But Bavaria's Interior Minister Joachim Herrmann said there was no indication the teenager had direct contact with IS. The teenager reportedly shouted the Islamic phrase *Allahu akbar (God is great)* during the attack. A

police official said on Tuesday that two of the five people injured were in a 'life threatening' condition. Inside the carriage, a 62 year old man, his 58 year old wife, their daughter, 27, and her boyfriend, 27, were attacked, the *South Morning Post* reports. They were from Hong Kong. The 17 year old son travelling with them was not hurt, it said. A source told the paper the father and boyfriend had tried to protect the other members of the group. Another woman was injured outside the train as the man fled. Fourteen people were treated for shock. A news agency with links to IS said the boy had launched the attack 'in answer to the calls to target the countries of the coalition fighting Islamic State.' " (*German train Attack: Afghan Knifeman 'Wanted Revenge' For Friend's Death, BBC News, July 19, 2016*). Look at Germany's railways today and see layers of dirt flooding in from the sewers of the world, drifting in from the Prophet's Arabian dunes, champion the cause of Islam and Palestine, and kill passengers in cold blood: "A man with a knife killed two people and wounded seven more on a regional train running from Kiel to Hamburg on Wednesday. Speaking to reporters in Brokstedt on Wednesday evening, she said that the suspect was a stateless man from the Palestinian territories. Three of those wounded were seriously hurt, four suffered minor injuries. Federal Interior Minister Nancy Faeser wrote on Twitter: 'All our thoughts are with the victims of this awful crime and their families.' " (*Germany: Two Killed, Several Injured In Train Knife Attack, Deutsche Welle, December 25, 2023*). On May 8, 1842, history was made in France. On this day, the world's deadliest railway disaster at the time occurred, when a train derailed from a broken axle on the railway between Versailles and Paris, killing 200 people, including the world famous explorer, Jules Dumont d'Urville. In the twenty first century, another nation joined France and made history. A train called Germany, speeding down the tracks of cultural disintegration, reeling and careening from the hammer blows inflicted by Marxism and its Islamist proxy, has derailed, crashed and caught fire. It proclaims that a progressive university condemns Israel as a genocidal nation because it seeks to wipe out Palestinian terrorist subhumanity. It proclaims that a progressive university is a Gaza Solidarity movement which seeks to cleanse the Middle East of Israel and Jews. It proclaims that a progressive university is a seminar, classroom and training ground for the promotion of race war against whites, class war against successful people, and a war of extermination against Israel, Jews and the West: "Rutgers University's attempts at educating its students about antisemitism are being resisted by residential assistants (RA) who refuse to accept that Hamas is an antiJewish terrorist

organization, the school's campus newspaper, *The Daily Targum*, reported recently. According to the paper, late last month Rutgers required its RAs, whose job is to supervise students living in on campus housing, to participate in a 'bystander intervention' course aimed at training them to identify antisemitism, xenophobia, and Islamophobia. Several of the RAs, however, abruptly left the virtual session after a Jewish speaker explained that Hamas's antisemitism and desire to destroy the world's only Jewish state precipitated the October 7 massacre, which resulted in the largest loss of Jewish life in a single day since the Holocaust. The paper added that the RAs took issue with the program's citing a definition of antisemitism offered by the AntiDefamation League (ADL). After walking out, they reportedly contacted Students for Justice in Palestine (SJP), which proceeded to author, on the RAs' behalf, a series of *Instagram* posts denouncing the antisemitism trainings as racist and upholding white supremacy. 'The mandated training program organized by the Office of Residence Life requires RAs to learn about DEI, restorative justice, community engagement, and more— all of these are inspired by Indigenous practices meant to unpack systems of white supremacy,' SJP said. 'On the contrary, this specific session worked to perpetuate zionism, racism, and white supremacy.' SJP's post included comments from the RAs who involved them in the controversy. One of them, who claimed to be Jewish, said, 'I am tired of the word *antisemitism* being used to talk over genocide, I am tired of antisemitism being inflated.' The RA added, 'I fear that when the nazis and radicals come once again for the Jews, no one will believe us. It will be your fault.' Another who took issue with the Israeli nationality of one of the course's presenters said, 'One of the facilitators even identified as Israeli and made mention of this multiple times. He justified his authority on the topic by citing his 12 plus years spent in 1948 Palestine, going so far as to call Israel a 'beautiful land.' As *The Algemeiner* has previously reported, Students for Justice in Palestine (SJP) has been a wellspring of antisemitic rhetoric at Rutgers. The group was one of dozens of SJP chapters that cheered Hamas's October 7 massacre across southern Israel, an attack that resulted in hundreds of civilian deaths and numerous rapes of Israeli women. As video footage of the terrorist group's atrocities circled the web, Rutgers SJP shared on its *Instagram* pages memes that said 'Glory to resistance' and 'the clock started running when the majority of the Palestinian population was expelled from their land by zionists during the *Nakba*.' It added, 'You are watching an occupied people rise up against an apartheid nuclear power that has been occupying them and making their life unlivable since 1948.' A milieu of extreme antizionism at the school has resulted in at least one death threat against the life of a Jewish student since October 7. In November, a local news outlet reported freshman Matthew Skorny, 19, called for the murder of a fraternity member he identified as an Israeli, saying on the popular social media forum *YikYak*, 'To all the proPalestinian ralliers, Go kill him.' " (*Rutgers University Residential Assistants Reject Mandatory Antisemitism Training Session* by Dion Pierre). The Charter for Queens College, the first name of Rutgers University, shined forth from the campus when it first opened its gates over a quarter of a century ago: "Our purpose is to educate youth in languages and in the liberal and useful arts and sciences." In the twenty first century, this mission statement, composed during the Age of Enlightenment, has been fed into a shredder manned by the commanders of an unholy alliance. An alliance between Marxism and Islam has assumed control over Rutgers and transformed it into an ideological echo chamber thundering with the politics of gender, race, class and the Community of the Faithful.

For nameless eons, it lived a life apart from the world, sundered from mankind by mountains, deserts and seas. In the twenty first century, China has ascended to heights of material progress and prosperity, yet morally and spiritually wallows in its native barbarism, and is content to luxuriate in the filth and disease of millennia. In the twenty first century, China is the world's largest economy by GDP. It is the second wealthiest nation in the world. It is the world's largest manufacturer and exporter. It is a nuclear weapons nation and has the world's largest army. It is great power, a regional power and a superpower, but in the twenty first, morally and spiritually, it is the same old China, as devoid of human rights, human sanitation and human hygiene as it was at the dawn of history. In December 2019, in Wuhan, the provincial capital of Hubei, China unleashed China, the real China and the true China, the China five thousand years old, upon the world, and created a global pandemic which would claim the lives of six million people, and create the second largest global recession in recent history and the 2020 stock market crash. See people in hospitals stricken by pneumonia transmitted by wild animals. See animal cages rife with maladies blasting out pandemics against mankind. See a nation in intimate, round the clock contact with animals. See a nation whose genetic code reads *animal viruses*. See stands, booths and compartments in which animals and humans eat and sleep together. See people housed in stables and coops. See people and animals share space in the wild. See animals with human genes and humans with animal genes. See the invasion of people and places by animal pathogens. See a ten million square kilometer space teeming with bacteria, viruses, communicable diseases and nothing else. See a dangerous counterworld to the world of reason. See morally uncultivated jungles, steppes and sites of the sinister and the demonic. See plains of apes, primitives, children and madmen. See beings of terror seek to conquer, subjugate and enslave the West. See dark, occult forces place civilization in peril. See societies of fists and knives resist and expel Western influences. See the Red Guards of Mao's Cultural Revolution shout *Kill! Kill! Kill!* at the symbols of freedom and enlightenment. See people wrapped in tattered rags, foul odors, mystical yearnings and bestial regression. See listless, passive, mindless wanderers drift down the meandering River of Tao. See Genghis Khan, Shaman and the Mongol Army terrorize Europe and kill millions of people. See hordes swarm in from the East and engulf Western societies. See mobs declare war on the Western civilizing mission, grounded in empirical methods, scientific inquiry, technological progress and moral advancement. See proof beyond a reasonable doubt that a five thousand year old culture has an animal origin, is a field for wildlife, is a factory of global pandemics, and is a set of instructions for the transmission of a holocaust from beast to man and the destruction of civilization: "A team of scientists say it is 'beyond reasonable doubt' the Covid pandemic started with infected animals sold at a market, rather than a laboratory leak. They were analyzing hundreds of samples collected from Wuhan, China, in

January 2020. The results identify a shortlist of animals—including racoon dogs, civets and bamboo rats—as potential sources of the pandemic. The samples were collected by Chinese officials in the early stages of covid and are one of the most scientifically valuable sources of information on the origins of the pandemic. An early link with the Hunan Wholesale Seafood Market was established when patients appeared in hospitals in Wuhan with a mystery pneumonia. The market was closed and teams swabbed locations including stalls, the inside of animal cages and equipment used to strip fur and feathers from slaughtered animals. Their analysis was published last year and the raw data made available to other scientists. Now a team in the US and France says they have performed even more advanced genetic analyses to peer deeper into covid's early days. It involved analyzing millions of short fragments of genetic code—both DNA and RNA—to establish what animals and viruses were in the market in January 2020. We are seeing the DNA and RNA ghosts of these animals in the environmental samples, and some are in stalls where [the covid virus] was found too,' says Professor Florence Debarre, of the French National Center for Scientific Research. The results, published in the journal *Cell*, highlight a series of findings that come together to make their case. It shows the covid virus and susceptible animals were detected in the same location, with some individual swabs collecting both animal and coronavirus genetic code. This is not evenly distributed across the market and points to very specific hotspots. 'We find a very consistent story in terms of this pointing--even at the level of a single stall--to the market as being the very likely origin of this particular pandemic,' says Professor Kristian Andersen, from the Scripps Institute in the US. However, being in the same place at the same time is not proof any animals were infected. The animal which came up most frequently in the samples was the common raccoon dog. This has been shown to both catch and transmit Covid in experiments. Other animals identified as a potential source of the pandemic were the masked palm civet, which was also associated with the Sars outbreak in 2003, as well as hoary bamboo rats and Malayan porcupines. The depth of the genetic analysis was able to identify the specific types of raccoon dogs being sold. They were those more commonly found in the wild in South China rather than those farmed for their fur. This gives scientists clues about where to look next. The research teams also analyzed the genetic code of the viral samples found in the market, and compared them to samples from patients in the early days of the pandemic. Looking at the variety of different mutations in the viral samples also provides clues. The samples suggest that Covid started more than once in the market with potentially two spillover events from animals to humans. The researchers say this supports the idea of the market as the origin, rather than the pandemic starting elsewhere with the market adding fuel to the fire in a super spreading event. The scientists also used the mutations to build the virus's family tree and peer into its past. 'If we estimate when we believe the pandemic started versus when we believe the outbreak at the market started, these two overlap, they're one and the same,' says Professor Andersen. In their scientific publication, the full genetic diversity of coronavirus seen in the early days of the pandemic was found at the market. See a pandemic begin among animals and spread to humans. Professor Michael Worobey, of the University of Arizona, said: 'Rather than being one small branch on this big bushy evolutionary tree, the market sequences are across all the branches of the tree, in a way that is consistent with the genetic diversity actually beginning at the pandemic.' He said this study, combined with other data—such as early cases and hospitalizations being linked to the market—all point to an animal origin of covid. Professor Worobey said: 'It's far beyond reasonable doubt that that this is how it happened,' and that other explanations for the data required 'really quite fanciful absurd scenarios.' 'I think there's been a lack of appreciation even up until now about how strong the evidence is.' " (*Genetic Ghosts Suggest Covid's Market Origins* by James Gallagher). The evidence is clear and irrefutable. **Fact one.** An analysis of the genetic material from the animals present in the Huanan Seafood Wholesale Market found species which had spread an earlier covid type virus to humans. **Fact two.** The animals' DNA in the market was found next to the covid 19 virus. **Fact three.** All of the 174 people who first contracted covid in December 2019 were connected to the market or lived next to the market within a city of 12 million people. **Fact four.**

Scientists used genetic material from the virus in the market to conduct an evolutionary analysis. Knowing how quickly the virus mutates, knowing that it mutates twice per month, they were able to determine the age of the virus. The virus emerged in December 2019, and the global pandemic virus emerged at the same time. The viruses were thus one and the same. If the global pandemic virus had come from a laboratory, it would have emerged earlier. **Conclusion.** Named after the color of the tents it used when waging war, the Golden Horde was the Mongol Empire established in the thirteenth century by Genghis Khan. It was the largest empire in world history at the time, covering 33 million square kilometers and enslaving 100 million people. Its attack on the West in 1241 was repulsed by the knights of Hungary in a courageous show of force in the hills of Transylvania. In the twenty first century, the Golden Horde is back in business. He is celebrated as one of the greatest poets of all time. His epic poem *Paradise Lost* thrilled and inspired readers with its account of extraordinary deeds, characters, forces and gods. In 1644, he wrote one of the most influential defenses of free speech in history. Entitled *Areopagitica: A Speech of Mr John Milton For The Liberty Of Unlicensed Printing*, he called upon England to be "the mansion house of liberty" and advocated "a free and open encounter" of ideas and opinions. John Milton's words echoed down through the corridors of history, influenced laws, decrees and court decisions across the world, and adorn the Main Reading of the New York Public Library: "A good Booke is the precious life blood of a master spirit, imbalm'd and treasur'd up on purpose to a life beyond life." Four hundred years after Milton exalted free speech as a vital component of human freedom, dignity and progress, a religion has swept through the West and abolished this hallowed institution, this shining jewel of England and the Enlightenment. Four hundred years after Milton demanded the end of state coercion of conscience and belief, and succeeded in his aim when in 1695 the English parliament voted not to renew the *Ordinance For The Regulation Of Printing* which required authors to obtain a license from the government before their works could be published, the censors are back in business and have set up shop in every nation in the free world. Voted into high office by the mob, they conduct their censorship, not in name of the Christian church as Milton's adversaries did, but in the name of the number one religion of the West in the new millennium. They conduct their censorship to enforce the creed of Marxism. The past one hundred years have brought a succession of landslide cultural and political victories for a movement appealing to the denizens of the moral sewers for whom freedom is a threat and burden and absorption into a collective is the path to meaning and liberation. They proclaim that a progressive society has assumed control over every sector of society, from digital services to news sources to the political commentariat to the academic establishment, and leads a global campaign running through every nation on Earth to eradicate the voices of freedom: "In the 1999 cult classic *The Blair Witch Project*, one character tells his friends 'I could help you, but I'd rather stand here and record.' For free speech advocates, we often feel that other citizens have become passive observers as an antifree speech movement grows around us, threatening our 'indispensable right.' One of the most infamous figures in this movement has been former British Prime Minister Tony Blair, who has long been the smiling face of censorship. As the head of the Labour Party, Blair pushed through some of the early crackdowns on free speech in the United Kingdom. He is now calling for global censorship to expand these efforts. In an interview on LBC Radio, Blair declared: 'The world is going to have to come together and agree on some rules around social media platforms. It's not just how people can provoke hostility and hatred but I think the impact on young people particularly when they've got access to mobile phones very young and they are reading a whole lot of stuff and receiving a whole lot of stuff that I think is really messing with their minds in a big way.' We recently discussed how the UK is already using recent rioting to crackdown further on those with opposing or 'toxic' views. For years, I have been writing about the decline of free speech in the United Kingdom and the steady stream of arrests. A man was convicted for sending a tweet while drunk referring to dead soldiers. Another was arrested for an antipolice to shirt. Another was arrested for calling the Irish boyfriend of his exgirlfriend a 'leprechaun.' Yet another was arrested for singing *Kung Fu Fighting*. A teenager was arrested for protesting outside of a Scientology center with a sign calling the religion a 'cult.' Last year, Nicholas Brock, 52, was convicted of a thought crime in Maidenhead, Berkshire. The neo nazi was given a four year sentence for what the court called his 'toxic ideology' based on the contents of the home he shared with his mother in Maidenhead, Berkshire. While most of us find Brock's views repellent and hateful, they were confined to his head and his room. Yet, Judge Peter Lodder QC dismissed free speech or free thought concerns with a truly Orwellian statement: 'I do not sentence you for your political views, but the extremity of those views informs the assessment of dangerousness.' Lodder lambasted Brock for holding nazi and other hateful values: 'it is clear that you are a right wing extremist, your enthusiasm for this repulsive and toxic ideology is demonstrated by the graphic and racist iconography which you have studied and appeared to share with others.' Even though Lodder

agreed that the defendant was older, had limited mobility, and 'there was no evidence of disseminating to others,' he still sent him to prison for holding extremist views. After the sentencing Detective Chief Superintendent Kath Barnes, Head of Counter Terrorism Policing South East (CTPSE), warned others that he was going to prison because he 'showed a clear right wing ideology with the evidence seized from his possessions during the investigation. We are committed to tackling all forms of toxic ideology which has the potential to threaten public safety and security.' Blair's views have been echoed by Speaker of the House Sir Lindsay Hoyle who declared: 'Misinformation is dangerous. Social media is good but its also bad when people are using it in a way that could cause a riot, threat, intimidation, suggesting that we should attack somebody, it's not acceptable. What we've got to do is factually correct what's up there, if not I think the government has to think long and hard about what they are going to do about social media and what are they going to put through parliament as a bill. I believe it should be across, it doesn't matter what country you are in, the fact is that misinformation is dangerous and no misinformation, or threats, or intimidation should be allowed to be carried out on social media platforms.' " (*The Blair Witch Project: Former Prime Minister Calls For Global Censorship* by Jonathan Turley). Highgate Cemetery is a place of burial in north London containing 53,000 graves. On the East Side is the cemetery's most famous and notorious grave. It contains the tomb of Karl Marx. However, its structure and tactics avoid easy detection, which is why so many people claim the group is an apparition. It is true that whenever such spontaneous and concentrated violence erupts, many people tend to believe it is Antifa. Antifa is often the culprit on university campuses. In the film *The Usual Suspects*, the character Virgil described the invisible villain Keyser Soze. He is 'the greatest trick the devil ever pulled was convincing the world he did not exist.' Antifa does exist and the last few weeks demonstrate how skilled it is as the Keyser Soze of social unrest in America. Antifa was founded on a rejection of formal structures and leaders. Many associated groups are part of Anti Racist Action and a loose coordinating organization known as the Torch Network. This lack of structure serves to evade both law enforcement and legal challenges. The threat of Antifa is not its role in civil unrest but its activities attacking free speech. Antifa members have been arrested and involved in violence in the cities. The president of the Portland National Association for the Advancement of Colored People wrote in the *Washington Post* to denounce the 'white spectacle' of the recent violence. He asked, 'What are Antifa and other leftist agitators achieving for the cause of black equality?' Antifa has found allies while the movement has grown. It primarily targets conservatives and the free

speech community, so it has not been a major concern of liberals. Former Democratic National Committee deputy chair Keith Ellison, now the Minnesota attorney general, once said antifa would 'strike fear in the heart' of Trump. This was after Antifa had been involved in numerous acts of violence and its website was banned in Germany. His own son, Minneapolis City Council member Jeremiah Ellison, declared his allegiance to Antifa in the heat of the protests this summer. That fact is that Antifa works to strike fear not in the heart of Trump but in the heart of anyone who will oppose the movement. The Antifa handbook states how the group has rejected the idea of free speech and has spent years organizing protests to prevent opposing views from getting heard. That practice has been adopted by other groups as well. Antifa violence can give colleges or politicians cover for barring conservative speakers. Nancy Pelosi has called for the revocation of a permit for a conservative prayer group viewed as a security matter in San Francisco. George Washington University student Jason Charter has been charged as the alleged ringleader of efforts to take down statues across the capital. Charter has been an active Antifa member on campus for years. Following his arrest, he claimed the 'movement is winning.' It is winning partly since local officials order police to stand down or drop criminal charges to avoid conflict. But it is winning mostly since people remain silent. Silence kills free speech. Antifa knows that. It is the silence of professors who watch as their colleagues are harassed, investigated, or threatened. It is the silence of students who watch as others are attacked for dissenting ideas. It is the silence of reporters who watch as other journalists are fired or forcibly retired for challenging orthodox views. Finally, it is the silence of those politicians who dismiss the destruction of property as a case, in the words of Pelosi, that 'people will do what people will do.' Antifa will do a great deal of damage if allowed. That is why, for academics and writers, Antifa's presence is menacing, not mythological. As Virgil explained, Keyser Soze became the 'spook story that criminals tell their kids at night.' Some politicians want to portray Antifa as a spook story that Republicans tell their kids at night. However, it is no illusion for those who have been the targets of Antifa and related groups. Antifa has achieved the agenda against free speech to a degree that even critics like me never imagined possible. It simply took inaction from our government and silence from our citizens. Threats against free speech are reaching a critical mass in our schools and on our streets. We can either take action or remain passive bystanders to what inevitably comes next." (*Why Antifa Is The Keyser Soze Of Social Unrest* by Jonathan Turley). In Weimar Germany, a group arose calling itself communist and anarchist. It was a group which dispensed with leaders and structures to make a superficial appeal to anarchists, but it lay at the farthest remove from anarchism. Its name was a shortened form of *Antifaschistische Aktion* and it was the epicenter of communist violence and revolution in Weimar Germany. In 1933, Antifa was shut down by a rival Marxist group, Hitler's race Marxist brownshirts, and it migrated across the world. In 1995, it formed an alliance with the Mexican Marxist, Trotskyite group Love and Rage. In 2007, it set up shop in Portland, Oregon and from there fanned out across America. Downplayed by the American establishment as a mere "myth," "fiction" and "idea," in the words of President Joe Biden and Representative Jerry Nadler, Antifa is the deadliest Marxist terror group operating in the West today and has made nations flow with rivers of blood.

BOTANY WILTS UNDER RED SUN

Botany is the science of plant life and one of the most important branches of biology. Botanists study a half a million plant species, life forms which support all animal life, and their investigations have provided staple foods, basic materials such as timber and oil, and maintained world biodiversity. The history of this vital science goes back to ancient Greece. Called the Father of Botany, Theophrastus commenced the science with his *Inquiry Into Plants* and *On The Causes Of Plants*, and his books were standard reference works for over one thousand years. In the twenty first century, this venerable science has fallen under attack by a religious movement. It is the number one religious movement of our time, voted into power by the mob in a century of landslide cultural and

political elections, and it has invaded the arts and sciences and placed them under the iron heel of political correctness. In the twenty first century, the science founded by Aristotle's most illustrious student has been invaded by Marxism and has become a bankrupt shadow of its former self, as unrecognizable as it is strident in its promotion of Marxist race politics. From the master's original proletarian class politics to its derivatives, black power race politics, feminist gender politics, gay politics, lesbian politics and transgender politics, is a short step in the dark logic of tribalism, and in the twentieth century, Marx's nineteenth century hate factory, set forth on the pages of his *Communist Manifesto*, animated a frothing at the mouth monster spewing out statements of gender, race and class politics and mauling innocent people to death. In the twenty first century, this Marxist electricity has smashed through the classrooms, laboratories and greenhouses of botanists and issued a series of proclamations putting an end to the science. The new monstrous currents proclaim that plant taxonomy must be placed under the control of the political correctness police. They proclaim that the botanical system of names must express political opinions. They proclaim that scientific plant species must be renamed to express Marxist political species. They proclaim that botanical names must condemn capitalism as an apartheid regime, and names which do not are offensive. They proclaim that botanical names must shout death to nonMarxist infidels and nonbelievers. They proclaim that botanical names must declare war on capitalists and Afrikaaners. They proclaim that botanical names must tell people to kill South African boers. They proclaim that botanical names must condemn capitalism as a slave trade. They proclaim that botanical names must exalt blacks and indigenous people. They proclaim that botanical names must advocate the lynching of whites. They proclaim that botanical names must be decolonized and transformed into calls to arms to blacks to overthrow the liberal democratic systems established by Western imperialism. They proclaim that botanical names must exalt the life, power and savagery of Africa and serve as flags for the reversion of society to the tribal jungle: "The woke mind virus is a bit like shingles. The virus might go quiescent, but it's still there, waiting to erupt suddenly. The latest eruption is a campaign to purge racist species names from plant taxonomy. Apparently, the botanical nomenclature is rife with a South African version of the 'n word.' The horror! The specific complaint concerns species names that contain some variant on the word *kaffir*, such as *cafra*, *caffra*, *cafrorum*, and *cafrum*, which, we are told, is a very offensive word—the *k word* if you will—tainted by its supposed connection to apartheid. About that word. *Kaffir* is an Arabic word meaning *infidel* or *unbeliever*. It entered the African lexicon as a loanword to Swahili, via the Arab slave trade that long predated the Atlantic slave trade, the colonial 'scramble for Africa,' and apartheid. The Arab slave trade arguably is ongoing, by the way. *Kaffir* became the *k word* via Afrikaans, also as a loanword. The connection to apartheid actually is tenuous: a Google *Ngram* shows its usage actually declining during the apartheid years. I'm also compelled to point out that racially derogatory terms are hardly unique to Afrikaners: the words *boer*—usually in the chant *kill the boer*—or *makwerekwere* serve the same purpose when uttered by black mouths and have been on the rise since the shackles of apartheid were thrown off. Nor is the word definitive evidence of bigotry. My first encounter with the *k word* was through a so-called *van der Merwe* joke, a popular genre of South African jokes in which the butt is a stock Afrikaner character known for his stupidity and clumsiness. The black characters—the *kaffirs*—in a *van der Merwe* joke are usually dragged in as straight men. So, while the term has certainly fallen out from polite discourse, it's hardly the equivalent of a lynching. Still, the *k word* intensely exercises some peoples' emotions, including those of two self appointed commissars of botanical nomenclature: Gideon Smith and Estrela Figueiredo, both affiliated with Nelson Mandela University, in South Africa's Eastern Cape Province. The two have long been doing estimable scientific work to catalogue and describe the world's most biodiverse flora. Somewhere along the way, they became captivated by the white savior project of 'decolonizing' science. Their present passion is ferreting out species names that are vestiges of colonialism. For example, they have compiled a list of two hundred and eighteen species of vascular plants, thirteen algal species, and seventy fungal species that contain some variant of the

k-word. Those names smear botany with the taint of colonialism, they assert, and they are determined that attention must now be paid. They also have a simple solution: remove the *c* from all the variants, which transforms the offending species names from *cafra* to *afra*, *cafrorum* to *afrorum*, and so forth. The trimmed names can now more benignly be construed as 'from Africa', thus healing the wound. Standing in their way, though, are established rules that govern how species are named, one of which states that 'a legitimate species name must not be rejected because it, or its epithet, is inappropriate or disagreeable.' " (*Botanical Backlash: The Controversy Over Woke Taxonomy And Historical Nomenclature* by J. Scott Turner). Look at the Marxist invasion of botany and see the International Botanical Congress change the scientific names of plants on grounds of political incorrectness. See it change the scientific names of plants because the old names were offensive and derogatory to the Marxist creed of race politics. See it change the names of plants, algae and fungi to convey a message of African, tribal, black power supremacy. See it load botanical nomenclature with words messaging black world revolution. See it change the scientific names of plants to condemn capitalism as regime of discrimination and apartheid. See it change the scientific names of plants to indigenous names to promote primitive social organization. See it change the scientific names of plants to condemn capitalism as a regime of black slavery under the blazing heat of the plantation. See it change scientific nomenclature to promote Marxist social movements. See it change scientific nomenclature to condemn capitalism as culturally offensive. See it change scientific nomenclature to disfigure people with the sulphuric acid of red factions. See it assume control over the scientific community and give new names to plants to promote collectivism and enslavement in the name of equality and representation. See it establish new plant names to signal the onset of a Soviet style, Maoist style, Khmer Rouge style age of destruction: "Botanists today voted to change the name of hundreds of plants to remove a racial slur in their scientific names. They also voted to allow a committee to evaluate new species names that could be offensive or derogatory, starting in 2026. Alina Freire-Fierro, a botanist at the Technical University of Cotopaxi who was not involved with proposing the changes, says she's glad that culturally offensive names were discussed at the International Botanical Congress in Madrid, where the vote was held. 'It was about time,' she says. This is the first time that botanists have voted on changing names that could be offensive. Their decision will eliminate a *c* in more than 300 scientific names of plants, algae, and fungi that include *cafer* and *caffer*. The one letter change would mean removing references to *caffra*, an Apartheid era slur used to discriminate against black people in South Africa, in favor of *affra* and related derivatives, implying simply that the species has its origins in Africa. 'We express our gratitude to our colleagues from around the globe who supported our efforts to rid botanical nomenclature of a despicable, racial slur,' says Gideon Smith, a plant taxonomist at Nelson Mandela University who initiated the renaming proposal. In a secret ballot among 556 botanists physically at the Madrid meeting, 63% voted to accept the change. But discussions leading up to the vote have been heated for years. Debates over scientific names have erupted among botanists since at least 2021. Some have pushed to restore indigenous species names and change offensive ones, such as those in the genus *Hibbertia*, which was named in honor of English antiabolitionist and plantation owner George Hibbert." (*In A First, Botanists Vote To Remove Offensive Plant Names From Hundreds Of Species* by Rodrigo Ortega). In a 160 year old mine in Cornwall, England is the world's largest greenhouse complex. Called the Eden Project, it is comprised of vast geodesic biome domes, occupying 150,000 square meters of land, and housing one thousand plant species and one million plants. In the twenty first century, the science of botany is trapped inside the Eden Project. A climate controlled environment fixed by the mob at the temperature of the Sun has incinerated the nonpartisan search for truth. The heat is the blazing energy of political correctness and the wardens are the Marxists in charge of the West today.

DUTCH SPEAK ARABIC

It was a shining center of civilization in Europe. It produced some of the world's greatest artists: Rembrandt and Vermeer in the seventeenth century and van Gogh in the nineteenth century. Its Golden Age in the sixteenth and seventeenth centuries established it as a world leader in trade, science, art and overseas colonization, spreading freedom to distant realms. realities, those realities would disappear.' An incident on the venerable Erasmus Bridge in the Netherlands' old port city of Rotterdam late Thursday night bears that out. The *Associated Press* reported Thursday that 'one person was killed and another seriously wounded in a stabbing incident' in Rotterdam, and that the local cops arrested a man in connection with the stabbings. So far, this is a fairly straightforward account of a type of crime that has become distressingly common all over Western Europe: a man in a busy city center begins stabbing people at random, killing as many as he can. In this case, an eyewitness said that the attacker was 'out to attack as many people as possible.' But here's where this story takes a sharp left turn into one of our most popular modern day fantasylands. A spokesman for the Rotterdam police, Wessel Stolle, 'said there was no immediate word on a motive, but 'we look into all possible scenarios.' Well, not so fast, Wessel. The *AP* report goes on to say that 'Dutch daily *De Telegraaf*, citing witnesses at the scene, reported that a man attacked people at random with two knives while shouting *Allahu Akbar*, the Arabic phrase meaning God is great.' *Allahu akbar* doesn't actually mean *God is great*. It means *Allah is greater*, that is, greater than your god. It's a declaration of the victory and supremacy of Islam that Islamic jihadis often shout while they are in the midst of an attack, as they believe that the phrase strikes terror in the hearts of nonMuslims, which the *Quran* commands them to do (8:60). The jihadis believe that their violent attacks manifest the victory and supremacy of Islam, and so it's the perfect time for them to proclaim that fact. When the attacker at the Erasmus Bridge shouted *Allahu akbar*, he was helpfully providing police with all the information they really need about his motive. And the police most definitely are in possession of this information: Stolle, who is no empty Wessel, 'said police at the scene also had heard that the man shouted the phrase, and that 'it's part of the investigation.' The circumstances of the attack also indicate that this was yet another incidence of jihad. Spotting the attack, a man intervened; he 'said he hit the attacker with two sticks after seeing him attack somebody and managed to take the knives and throw them away.' This heroic bystander 'initially thought it was a fight, but when I started running in that direction I saw that it wasn't a fight. It was a man with two long knives who was stabbing another young guy and when I started shouting he turned around and started approaching everyone who was around him.' Stabbing random people on the street in an effort to kill as many as possible is an all too common practice among jihadis all over Europe. Nevertheless, despite possessing several strong indications that this was a jihad attack, another police talking head, Kristel Arntz, 'said it was too early in the investigation to establish a motive.' Oh, really? Arntz explained: 'We have arrested a suspect, we are going to question him. We will look at all the witness statements and then we will look at what the possible motive was.' Terrific. Maybe the Rotterdam police will also find their way back to their police station if someone guides them there step by step and points out the big building that says *POLICE* on it. But we cannot take that for granted. The Rotterdam cops may be wandering lost for days. It is not that Dutch authorities are searching for the attacker's motive because they think the attacker might have known his victims and had some personal reason for attacking them. They know the stabbings were random. And it's not that they're searching for the attacker's motive because some people say he screamed *Allahu akbar*, but some say he didn't; even the police heard him scream *Allahu akbar*. They're searching for the attacker's motive because, while that motive is blazingly obvious, it cuts against the authorities' most cherished beliefs about Islam and peaceful coexistence, and so they have to struggle mightily to pretend that they don't see it, and try to find something else upon which they can blame the attack. There is no way that this resolute refusal to face reality can end well." (*After Random Stabbings In Rotterdam, A Comic Opera Ensues* by Robert Spencer). Look at the Netherlands today and see Assassination roam the streets dressed as Muslim clerics. See hoodlums called Muslim authorities issue points of hoodlum law called Muslim law and order the killing of infidels. See people who challenge Islam forced to flee for their lives in armored cars, surround themselves with bodyguards toting automatic weapons, surrender their freedom and privacy, and hide away in safe houses and secret locations. In mathematics, the center denotes a midpoint. The center of a circle is the point equidistant from the points on the edge. The notion of a center has an application to politics, where it denotes the middle ground between two fundamental positions. In politics, the center is the middle ground between slavery and freedom. The center denotes a mixture between freedom and slavery and is an incoherent position. A person is either free or is not free, and societies predicated upon political centrism are unstable and on the path to either consistent freedom or to consistent slavery. Listen to them proclaim that a progressive society is a Chinese society, an Iranian society, a Hamas society, a Russian society and a North Korean society which has declared war on one thousand years of freedom in the West. Listen to them proclaim that a progressive society is far left society which spies on free societies, places them in the grip of fear, and disseminates disinformation about them. Listen to them proclaim that a progressive society conducts military and ideological warfare against free societies. Listen to them proclaim that a progressive society sets up fifth columns in free societies to give aid and comfort to a global movement of Marxist enslavement. Listen to them proclaim that a progressive society is a Black Lives Matter society which enforces the tenets of race Marxism and elevates blacks to the status of a master race. Listen to them proclaim that a progressive society is an Antifa society which seeks to kill the supporters of capitalism in the name of fighting fascism. Listen to them proclaim that a progressive society is an antizionist and antisemitic society which seeks to destroy Israel and the

Jews because they represent Western freedom and capitalism. Listen to them proclaim that a progressive society is a communitarian society dedicated to the repeal of constitutional rights. Listen to them proclaim that a progressive society is a radical left society which has abolished the capitalist foundations of modern civilized life. Listen to them proclaim that a progressive society stands for unbridled communist power which has dissolved national borders, outlawed free and fair elections, removed names, signs and monuments which violate the strictures of political correctness, and launched a campaign of genocide against the voices of freedom: "As the presidential election has loomed nearer, the Democrat Party has largely avoided substantive discussions of policy and instead made desperate, unconvincing efforts to brand itself as everything from the Party of Joy to the Party of Twenty First Century Masculinity. Called England's national poet and the Bard of Avon, he wrote 39 plays, 154 sonnets and three narrative poems, and his plays have been translated into every major language and are performed more often than those of any other playwright. In the twenty first century, a tragedy has befallen Shakespeare's name and works. Among

the vanishing circles of civilized people remaining in the world today, what has happened to Shakespeare has brought forth dark visions of collapse, the collapse of human society and the reversion of mankind to the jungles of tribal politics. In the twenty first century, William Shakespeare has been cancelled by a monster and hurled into the dustbin of history. It proclaims that a progressive university condemns Shakespeare because he was an embodiment of white exceptionalism and the capitalist racial hierarchy over which whites preside. It proclaims that a progressive university condemns Shakespeare as a voice of white capitalist insurrection against the people's socialist republics. It proclaims that a progressive university condemns Shakespeare because he stood for white capitalism and was antiblack, antibrown and antiimmigrant. It proclaims that a progressive university paints Shakespeare black, condemns the white Shakespeare as white cultural appropriation, and allows only black actors to perform in his plays and recite his famous lines. It proclaims that a progressive university studies black history and no other history, and black civil rights and no other civil rights, and excludes the study of Shakespeare. It proclaims that a progressive university condemns Shakespeare because he spoke the language and culture of the white man. It proclaims that a progressive university condemns Shakespeare because he was a voice of the white police and their cold blooded killing of blacks. It proclaims that a progressive university is run by black race activists who exclude the study of Shakespeare because he was a voice of white capitalist leadership. It proclaims that a progressive university condemns Shakespeare because he was a voice of white salvation which is the mortal enemy of the black agency, black autonomy and the black struggle for freedom. It proclaims that a progressive university controls what students see, hear, read and think and excludes the study of Shakespeare because, as a voice of liberal capitalist freedom, he was the sworn enemy of black national socialist power: "Two faculty members condemned 'white ownership' of Shakespeare and the state's manipulation of black history during an Appropriation Series at Arizona State University last week. The scholars are pushing for changes in curriculum and leadership that reflect more 'diverse' voices. During the panel, they spoke to eleven ASU students in the audience and other

faculty members via *Zoom*. English Professor Ruben Espinosa argued that Shakespeare's legacy has been manipulated for purposes of exclusion and viewed through a lens of 'white superiority.' He said that for the January 6 'insurrectionists' at the US capitol, Shakespeare represents a symbol of 'white exceptionalism' and 'racial hierarchy.' The organizers sent a letter to the Folger Shakespeare Library, the world's largest Shakespeare collection located one block from the US Capitol, and not to other institutions like the Library of Congress to notify them of the protest beforehand, he said. Espinosa said this act reflects the 'insurrectionists' perception of Shakespeare as an emblem of 'white superiority,' which is why they deemed it important to protect the library during the protest. 'Shakespeare sits atop of that racial hierarchy. He is the epitome of what they consider white exceptionalism and this is why he's valuable,' the English professor said. Espinosa also argued that the Shakespeare Library has a historical legacy tied to antiimmigrant and white exceptionalist sentiments, reflected in its founding leadership and early rhetoric. He said that 'the first director of the library, Joseph Quincy Adams, saw the institution as 'a preservation of the language of the American people at a time when immigrants are coming in like locusts to steal our culture, to steal our language.' 'This is the way he imagined immigration,' Espinosa said. 'It kind of has this origin in antiimmigrant sentiments, right, all the way to January 6th, when we think about that white exceptionalism, and this notion of a kind of white ownership of Shakespeare,' he said. The scholar also said that when leadership roles in the Shakespearean field are taken by individuals who 'do not look the part'—meaning they aren't white—there is often resistance. 'Shakespeare would not have come across as a black person or a nonwhite person in the entirety of his life.' he said. Espinosa argued that a more meaningful appropriation of Shakespeare occurred when the Public Theater in New York had 30 black actors recite the famous *To Be or Not To Be* soliloquy from *Hamlet* following the death of George Floyd. Victoria Day, the event coordinator, declined to answer questions from *The College Fix* via email about the goal of the event and the definition of appropriations. Instead, she directed *The Fix* to a recording of the event. Curtis Austin, a historian and associate director of the Humanities Institute who was also on the panel, argued that the state has historically appropriated black history, claiming it presents itself as a champion of civil rights movements while actively resisting them. 'But the fact of the matter is, the federal government, as well as state and local governments, pushed back very hard against movement activists and the movement itself,' Austin said. 'This is one way the state has been able to appropriate the history, the meaning, and, what I claim, the legacy of the movement,' he said. He cited films including *The Help*, *Mississippi Burning*, and *The Butler* as examples of media that distort the narrative by focusing on 'white saviors' and 'white redemption' rather than 'black agency' and leadership. They 'have appropriated the black freedom struggle,' he said. 'This appropriation is problematic because it reinforces the notion that the fight for civil rights required white intervention and leadership while downplaying the role of black agencies, where in fact it's the state, whether it's the federal government, the state government, or local governments that's actually pushing back against the movement,' Austin said. He argued that by appropriating black history, the state is attempting to 'control what the world sees, what it believes, and how it relates not just to the black freedom struggle but to black people themselves.' The event was the second of two panels on appropriation this semester at ASU. 'What constitutes cultural appropriation, and when is it unethical? Should we adopt voices beyond our own, and if so then what factors must be weighed beforehand?' reads the event description." (*Arizona State U Scholars Condemn 'White Ownership' Of Shakespeare* by Gabrielle Teraat). Two days after his death, Shakespeare was buried in the altar space of the Holy Trinity Church. The epitaph carved into the stone slab covering his grave includes a curse he wrote against moving his bones: *Good friend, for Jesus' sake forbear, /To dig the dust enclosed here. /Blessed be the man that spares these stones, /And cursed be he that moves my bones.* In the twenty first century, black power Marxists have fallen under Shakespeare's curse. Rejecting Shakespeare in the name of anticapitalism, antiracism, "decolonization," "eliminating offensive content," and the exclusion of "dead white men," they have scattered Shakespeare's bones to the winds. Mountains of

bone dust and ash cover the grave of Western civilization.

BLACKS AND BROWNS TAKE OVER ACADEMIC ADMISSIONS

In the game of golf, a handicap is a numerical measure of a player's ability. The numbers are inversely related to level, and players with a high handicap are judged to be poorer players than those with a low handicap. Players with a high handicap are given preferential treatment and are allowed more strokes during the game than those with a low handicap. Players with low ability are rewarded and given more chances to win than players with high ability. The physical playing field of golf is level but not the competing playing field, and players are not treated equally but are subjected to discrimination, either in their favor or against them. In the twentieth century, a monster was born in the West and began terrorizing institutions. It came alive from the surging currents of Marxism and has been on a rampage for one hundred years. It is not proletarian Marxism but an offshoot and development of this, emerging from Marx's original creed by the dark logic of tribalism. Founding a religion of the proletariat, Marx opened the door to a proliferation of tribal entities, each endlessly dividing and subdividing in accordance with the logic and dynamic of secession. The first offshoot to walk through the door of tribalism was race Marxism. Here the tribe seeking power was a race and not a class, and history was viewed as a struggle between races and not classes. The first offshoot to walk through the door of Marxist tribalism was Hitler's creed of Aryan supremacy, founded in the 1920s to compete against the powerful Marxist proletarian movement in Germany. Two brother Marxist derived ideologies, one championing the Aryan race and the other championing the proletarian class, one targeting Jews for extermination and the other targeting the bourgeois for extermination, battled each other in the streets and placed the nation in the grip of fear. Less than a century after Hitler founded national socialism, race Bolshevism and race Marxism, another Marxist tribe appeared on the scene. In the 1960s, race Marxism appeared in a second version in which blacks took the place of Aryans and Jews took the place of the bourgeois. Alongside Hitler's creed of national socialism, race Bolshevism and race Marxism was a creed of black socialism, black Bolshevism and black Marxism, and a program of extermination of whites took the place of the extermination of Jews. A program of group extermination is the telltale sign of Marxism. Hitler's hatred of Jews was mirrored in other creeds, such as nativism and the Ku Klux Klan, but none promoted a program of extermination of Jews. Group extermination is a uniquely Marxist concept, and Hitler's race war was a Marxist war fought under a new name. In the 1960s, the neoHitlerite, neoMarxist black power movement began its rampage through Western institutions, and in the twenty first century, it is everywhere, in every sector of society, spreading its vitriol and demanding discrimination against whites and their extermination. It is present in the world of academia, where it has taken over the admissions process and issued a series of proclamations demanding automatic admissions of black and hispanic applicants. Listen to these proclamations and hear the voices of race Marxism carry on Hitler's crusade with new faces and new flags. They proclaim that a progressive university rejects standardized admissions tests because they are unfair to black and hispanic applicants. They proclaim that a progressive university practices reverse discrimination and makes whites and Asians the targets of race discrimination, and blacks and hispanics the recipients of favoritism. They proclaim that a progressive university discriminates against white and Asian applicants and treats black and hispanic applicants as lords of the realm. They proclaim that a progressive university is a racist university which justifies its racism as the achievement of diversity, and is racist against white and Asian applicants and racist in favor of blacks and hispanics. They proclaim that a progressive university adopts as its motto *diversity is our strength*, which means *racism is our strength*. They proclaim that a progressive university covers its racism against whites and Asians by saying that student applicants are judged "holistically," or by considering nonacademic factors, in order to tilt the scales and admit blacks and hispanics who are not academically qualified. They proclaim that a progressive university enforces

illegal racial discrimination in any secret way, shape or form it can in order to admit black and hispanic applicants. They proclaim that a progressive university dumbs down admissions tests and makes them easy to pass in order to admit black and hispanic applicants. They proclaim that a progressive university holds special entrance examinations enabling as many indolent nonAsians and nonwhites as possible to become students. They proclaim that a progressive university rejects merit based admissions in favor of black based admissions and hispanic based admissions. They proclaim that a progressive university constructs discriminatory filters to screen out the wrong student applicants, or whites and Asians, who are academically more qualified than blacks or hispanics. They proclaim that a progressive university admits politically correct people, blacks and hispanics, and excludes politically incorrect people, such as whites and Asians. They proclaim that a progressive university excludes science questions from its admissions tests because blacks and hispanics cannot answer them correctly. They proclaim that a progressive university is a racist, discriminatory black university and brown university which has excluded whites and Asians from its student body and liberal values from its curriculum: "For decades, aspiring college students have had to submit with their applications scores from standardized tests, such as the SAT or the ACT. Variation of test scores is inevitable—that's the whole point of a standardized exam—and, just as May flowers follow April showers, each round of these exams brings inevitable questions about whether the tests are fair. This is a perennial topic of debate among educators. Recently, the dispute has taken on a litigious edge, with accusations that prestige colleges like Harvard are playing fast and loose with standardized test scores as part of a stealth program of reverse discrimination. Statistically, Asian applicants score higher on the SAT than do white applicants, who themselves score higher than black and hispanic applicants. Yet black and hispanic students are admitted in greater numbers than would be predicted on the basis of those test scores, while Asians' numbers are fewer than would be predicted. When pressed on the matter, colleges have responded with bland platitudes about the 'holistic' admissions process and the presumed benefits of a diverse student body. Ultimately, the US Supreme Court was unpersuaded by such hand waving and told Harvard it had to stop. Since that ruling, colleges have been working out ways to sneak racial discrimination through the back door. Now comes the news that ACT (the firm that governs and administers one of those standardized tests, the ACT exam) will be shortening examination times, reducing the number of questions, and no longer *requiring* students to complete the science portion of the exam. This follows similar action a few weeks previously by the College Board (which administers the SAT, the ACT exam's principal competitor). Could it be that the standardized testing industry is in on the whole reverse discrimination scam? If the tests reveal uncomfortable racial disparities, let's make the tests easier! There's an uncomfortable fact here. Qualifying exams have always been tools of discrimination: That's their purpose. The discrimination has taken various forms over the years, to be sure. In the 19th and early 20th centuries, Harvard and the other Ivies crafted their own entrance examinations that were structured to favor students from a small group of feeder prep schools. In the 1920s, the presidents of the Ivies got progressive religion and organized to have the same entrance exam for all their campuses. This was the origin of the SAT, which was first administered in 1926 and which aimed to facilitate merit based admissions. To the Ivies' dismay, however, this quickly led to a 'Jewish problem,' because Jews tended to overpopulate the upper end of the exam score's bell curve and were admitted in unexpectedly large numbers. This outcome put off wealthy donors and alumni, so Harvard introduced a new discriminatory filter: Not only would merit count but also 'character,' with the latter defined so the scales could be tilted back in favor of the 'right people.' Lately, we have entered a regime where the discriminatory intent is now based on race, as well as shibboleths like 'diversity is our strength' (the opposite is likely more true). All that has really changed is whose oxen are being gored, which are lately white and Asian applicants'. Is this discriminatory? Of course it is. It's meant to be. Is standardized testing based on the twin presumptions of fairness and objectivity? Bollocks. Since its inception early last century, the standardized testing industry has reflected the discriminatory preferences of its principal clients,

colleges and universities. The recent changes, including the ACT's decision to make its science test optional, have to be judged in that cold light. And it must be kept in mind that this is an *industry*. ACT was recently acquired by a private equity firm, which seeks to make the ACT exam a more competitive and profitable alternative to the SAT. Addressing concerns about ACT becoming a for profit enterprise, the CEO of the firm has reassured everyone that ACT will not veer 'one inch' from its mission, which was followed—promptly—by veering to make the science test optional." (*Restore the Science Section* by J. Scott Turner). It was mandatory in Germany from 1933 to 1945. It was performed by extending the right arm from the shoulder into the air with a straightened hand. The person offering the salute proclaimed *Hail Hitler!*, *Hail My Leader!* or *Hail Victory!* This was the Hitler salute and its purpose was to show allegiance to the national socialist state and its fuhrer. Eighty years after the forests of Hitler salutes were cleared from German public life, the Hitlerites are back in business. They hail race preferences, race consciousness, and antiwhite and antiAsian discrimination in university admissions programs. They hail the advent of new black and brown master races. They hail the destruction of destruction.

INDIANS OVERRUN AMERICA

In the early seventeenth century, Andrew White was on a mission. The mission of this Englishman was to found the colony of Maryland in America and tame the savage natives there. He stated his mission to the chief of an Indian tribe, speaking through an interpreter: "My purpose is to extend civilization and instruction to this ignorant race and show it the way to heaven." (*Records Of The English Province Of The Society Of Jesus* by Henry Foley). In 1677, forty years after White landed in the New World, his fellow imperialists founded a school for the Indians. The purpose of the school was to bring forth the human from the subhumanity they confronted and raise backward people to the level of the West: "In 1677, a school for humanities was opened by our Society in the center of Maryland, directed by two of the Fathers; and the native youth, applying themselves assiduously to study, made good progress. Maryland and the recently established school sent two boys to St Omer who yielded in abilities to few Europeans, when competing for the honor of being first in their class. Thus not for gold, nor silver, nor the other products of the Earth did men come here from England, but instead to bring these regions, which foreigners have called ferocious, to a higher state of virtue and cultivation." (*Records Of The English Province Of The Society Of Jesus* by Henry Foley). Three centuries after Europeans journeyed to the New World to establish an outpost of humanity and succeeded in their mission, the savages have fought back and won. They were handed their victory by a fifth column operating in the nation, representing a global movement. Backed by the unanimous votes of the mob, America's enemy within declared war on the Enlightenment and rejected its shining values of human essentialism, human universalism and human rights. It put in place of these values which gave birth to America a primitive, mystical tribal politics of the proletariat. The Marxists who took control of the nation in the twentieth century divided mankind into two warring camps, the collectivist proletariat and the individualist bourgeois, and proclaimed that the iron laws of matter and machines decree that the proletariat will triumph over the bourgeois and exterminate it, and establish a people's collectivist dictatorship in its place. They proclaim that society must give any group which claims it is an Indian tribe, and claims without proof, evidence, certainty or adjudication of any kind, ownership to Indian remains and artefacts. They proclaim that professors and universities which keep Indian remains and artefacts for the purpose of studying the world of savagery, and warning civilized people that it could happen to them, must be shut down and silenced. They proclaim that American society must be placed under the control of Indian tribal leaders who will pray to the Great Spirit, tear down universities, and convert the land into burial grounds for Indian remains and artefacts. They proclaim that American civilization must be destroyed and the land emptied and returned to Indian prehistory in the name of repatriation. They proclaim that a Native American Commission of jackboots must be established to carry out the work of destruction. They proclaim that the scientific study of Indian drug addiction and disease must be prohibited because these can only be stopped by praying, singing, and burying Indian remains and artefacts, and thereby stopping the cries of the unburied spirits. They proclaim that Americans must reject human sanity and social development and achieve absorption in God and Nature on the plains of the Indian year zero: "Last month, California assemblyman James C. Ramos started a state legislative meeting with a prayer; it was appropriate for a meeting that would end with the funeral of anthropology in California. The California legislators met with tribal leaders and California State University (CSU) and University of California (UC) officials to review the progress California's public universities are making in turning over prehistoric skeletal collections to modern Native American tribes who claim that these human remains are their ancestors. This meeting followed audits conducted on both university systems to assess their compliance with the 1990 federal law, the Native American Graves Protection and Repatriation Act (NAGPRA). NAGPRA was enacted to return human remains to culturally affiliated, federally recognized tribes. Cultural affiliation was to be made based on a preponderance of the evidence, which means evidence that provides at least 51 percent certainty. The allowable evidence included historical documents, archaeological data, biological and DNA information, and oral history. The university systems complied with NAGPRA, as it was passed in 1990. Yet, the law has recently changed considerably: 'Native American traditional knowledge' was added as a category of evidence; the category of 'culturally unidentifiable' was deleted; and a lower bar for affiliation is now in place—'reasonable evidence' as opposed to 'preponderance of evidence.' Also, new laws have been enacted. AB275 passed in 2020 and states that traditional Native American knowledge must be deferred to when science and traditional knowledge are at odds. AB389 and AB226 passed in 2023; they target teaching collections that may contain Native American human remains or artefacts. These laws will bury our ability to teach osteology; previous laws applied only to research collections. The auditors' claim that the university systems have been woefully noncompliant did not take into account these moving goalposts. The CSU and the UC had complied with NAGPRA; they had already repatriated collections to federally recognized tribes where a preponderance of evidence established a genuine connection between the human remains and a specific tribe. The collections remaining in universities for research and teaching purposes show no clear affiliation to federally recognized tribes and, thus, were not removed from curation facilities. Now, the guardrails are off repatriation laws, and all collections are slated for repatriation. Throughout the legislative meeting, apologies were issued by CSU and UC officials—including the

new CSU Chancellor, Mildred Garcia. Promises were made to repatriate all collections before 2030, and there was constant discussion about prohibiting research. Statements about targeting retired professors who may hold any materials were repeated, queries were made about shutting down field schools, and concerns about community college collections were raised. University officials and the Native American Heritage Commission (NAHC) discussed the millions of dollars allocated to repatriate collections and the millions more needed to get the job done. Tribal leaders, such as Lynn Valbuena of the San Manuel Band of Mission Indians, who thanked 'the Great Spirit' before arguing that universities should provide land for the burials, repeatedly stated that anthropology departments should be excluded from repatriation decisions. Anthropologists, however, are trained in identifying the remains and identifying links between the past and the present and know these collections better than anyone else. Leo Cisco of the Tachi Yokut tribe who spoke of 'feeling the energy' that comes from skeletal remains of ancestors—an energy only Native people can feel—called scientific research into America's past a crime. Jack Potter of the Redding Rancheria tribe argued that repatriation isn't difficult, and money is unnecessary—just give the ancestors back." (*California Legislative Meeting Starts With Prayer, Ends With Burying Science* by Elizabeth Weiss). George Catlin was a nineteenth century American painter specialized in portraits of Native Americans in the American frontier. His most famous work is *Comanche Indians Chasing Buffalo With Lances And Bows*, depicting the Comanche tribe. In the twentieth century, an age of religion descended on America as the nation abandoned its senses and reason. In the twenty first century, it has resurrected Indian lances, bows, black magic and spirits of the dead, and returned a child of the Enlightenment to the bestial expanses.

CAMPUS REDS SET FIRE TO PROFESSOR

Punishment is not inflicted primarily for the correction or good of the person punished, but for the public good, in order that others may become frightened and weaned away from the evils they would commit. Thus speaks the *Directorium Inquisitorium*, the standard manual of the Catholic Inquisition. Established by the Catholic Church in France in the twelfth century, the Inquisition had a terrifying remit. It was tasked with punishing acts of heresy, and did so by means of imprisonment, torture and death. The Inquisition was abolished in the early nineteenth century, but its spirit lives on and is present throughout the world today. In the nineteenth century, a religion was founded which would soon take the place of Christianity in popular thought. It was not a religion of God in Heaven but of the Collective on Earth. It was founded by Karl Marx and it proclaimed that the primary reality and unit of value in society is a tribe called the proletariat, and the individual exists, not as an end in himself, but in order to advance its power and interests. The proletariat is an unseen mystical being whose existence is known by feeling, faith and a special dialectical logic of contradiction which proves that A equals nonA, and nothing is as it is. In the twentieth century, this religion captured the hearts and minds of the masses and began persecuting nonbelievers. It achieved social and political power and set up inquisitions throughout the world to stamp out the voices of dissent. It constructed a Communist Bloc and an Iron Curtain which enslaved one third of the Earth's population and placed totalitarian power into the hands of the state. In the West, it colored every sector of society and excluded and stigmatized the supporters of freedom. In the twenty first century, it has consolidated and intensified its influence and taken over institutions far and wide. In 1749, Benjamin Franklin convened a board of trustees and founded a university which would become a prestigious Ivy League research institution. On November 14, 1740, the university opened its gates and Franklin became its first president. Under its shining motto, *Laws Without Morals Are Useless*, a galaxy of human talent and achievement would pass through its gates and include eight Founding Fathers of the United States, seven signers of the United States Constitution, three presidents of the United States, 38 Nobel laureates, three United States Supreme Court justices and 19 United States cabinet secretaries. Nicknamed by Franklin as a "Public Academy of

Philadelphia," this institution is the University of Pennsylvania, and in the twenty first century, Marxism went on its payroll, became its administrators and professors, and reduced its motto to seventeen meaningless words. In the twenty first century, the University of Pennsylvania has disgraced three centuries of academic excellence and collapsed. This bankrupt shadow of its former self set up an inquisition and burned one of its professors at the stake. She became a professor at the university's law school in 2001 and was appointed the Robert Mundheim Professor of Law in 2007. She has received the A. Leo Levin Award for Excellence in an Introductory Course, the Harvey Levin Memorial Award for Teaching Excellence, and the Lindback Award for Distinguished Teaching. Her name is Amy Waxman and her crime is that of dissent. She has expressed opinions at variance with a cancerous growth called gender, race and class politics, which developed from Marx's religion of class. The worship of the proletariat opened the gates to a proliferation of tribes, endlessly dividing, subdividing and seceding from the proletariat, in accordance with the dark logic of tribalism, but all united by a condemnation of capitalists as an oppressor class of which they are the innocent victims. The twentieth century saw the growth of a multiheaded monster from Marxist cells, and this monster, whose cells include gender politics, race politics, class politics, gay politics and lesbian politics, stormed into the twenty first century, where it saw another cell develop, called transgender politics, and continued its campaign to exterminate the capitalist enemy. In the twenty first century, it placed itself in the employ of the University of Pennsylvania, set up an inquisition, put Amy Wax on trial, and found her guilty of heresy in a decision whose proclamations are as treasonous to the Enlightenment ideals which founded America as they are ominous clouds foretelling the end of the West. In September 2024, the university administration issued its decision, set fire to Amy Wax and burned down the campus along with her. It suspended Wax for one year at half salary, deprived her of her Robert Mundheim chair, gave her a public reprimand, and at all public appearances she makes, forced her to state the following: "I am not speaking for or as a member of the Penn Carey Law School or Penn." In its decision, the administration proclaimed that a progressive university is a center of anticapitalist, Marxist indoctrination. It proclaimed that a progressive university teaches students the supremacy of black power, feminist power and proletarian power. It proclaimed that a progressive university forbids professors to state the truth that black students are academically indolent, shiftless and below average on the grounds that it is politically incorrect to do so. It proclaimed that a progressive university sacrifices individual rights on the altar of social responsibility and woke ideology. It proclaimed that a progressive university establishes race based admissions procedures in order to admit academically unqualified blacks. It proclaimed that a progressive university forbids professors to state that Western culture is superior to nonWestern cultures because it values reason, science, empiricism and human rights, on the grounds that it is politically incorrect to do so. It proclaims that a progressive university allows violent, antisemitic, proPalestinian student protests on campus in the name of free speech but forbids peaceful, nonviolent student protests against Muslim and Marxist terror because such protests are politically incorrect. It proclaims that a progressive university demands blind adherence to the gender, race and class party line from all students and faculty. It proclaims that a progressive university is an intolerant university which allows students to shout down antiMarxist judges and prevent antiMarxist scholars from speaking. It proclaims that a progressive university is a committed, idealist, miniSoviet Union which enforces an extreme left wing political ideology though it loses donors, student applicants, academic ratings and its international reputation. It proclaims that a progressive university is a dyed in the wool, antiliberal, antiknowledge, antiacademic, anticivil echo chamber thundering on all sides with calls for Marxist world revolution: "An extraordinary scholar and polymath, Amy Wax, has been formally sanctioned by the University of Pennsylvania (Penn), although not fired, as many of her detractors attempted to do. Professor Wax has earned degrees from Harvard, Yale, Oxford, and Columbia, including an MD in neurology, in addition to her law degree. She has argued 15 cases before the Supreme Court. I have been impressed with Wax's extraordinary acuity while serving with her on the board of the National

Association of Scholars (NAS). Penn is stripping her of her title—Robert Mundheim Professor of Law—and cutting her pay, presumably ending a years long battle. I suspected that Penn was deliberately prolonging the ordeal hoping that Wax, a septuagenarian cancer survivor, would simply retire. What is her sin? Did she steal money? Have an improper relationship with a student? Issue heinous attacks on individual colleagues? No, her cardinal sin was that she expressed her opinions on issues of the day that were not in accord with those of Penn's woke supremacy. For example, she once stated in class that her black students, over the years, typically were weak academically and decidedly below average. That may have been an impolitic thing to say, but it was absolutely correct, given Penn's use of racial criteria in admission standards. Wax's other commentary was often irritating to the Penn community. For example, she suggested that she believed that Western civilization was superior to others prevailing in other parts of the world. To Wax, the rest of the world has been trying, with varying degrees of success, to emulate it. It is rich that one of the persons leading the charge against Wax was Elizabeth Magill, herself a lawyer and former Penn president, who resigned under pressure for a seeming unwillingness during congressional testimony to explicitly condemn antisemitic, nonpeaceful demonstrations on her campus by proPalestinian protesters. Magill infuriated a broader public in parroting the campus party line, leading to major donors pulling millions of dollars of support from the university. University presidents have tended to accede to the demands of leftist faculty and students in order to maintain campus peace. But in doing so, they violate behavioral norms expected in American civil society, including a respect for the First Amendment. Groups like the Foundation for Individual Rights and Expression, NAS, and the American Council of Trustees and Alumni protested vehemently and frequently to Penn's persecution of Wax, to no avail. One group that apparently became concerned was Penn's governing board or some members of it. Universities live in two worlds: the woke leftist academic world and the real world, on which they depend for financial sustenance. Typically, the real world largely leaves the Academic World alone, grudgingly providing it with financial support. But that is changing. Acts like shouting down federal judges—think Stanford—and denying distinguished scholars the right to speak at many schools are going too far, and hateful anti-Semitic demonstrations go well beyond the limits of tolerance. It starts to hurt reputationally—Ivy League Penn ranks below nonIvies schools such as Duke, Northwestern, and Cal Tech, as seen in the latest *US News* rankings. I suspect Penn is losing both donors and top student applicants. Trying to enforce a campus leftist political ideology, acceptable in 1970 Soviet Russia, is completely inappropriate in contemporary America." (*Penn's Shameful Sanction Of Amy Wax: A Blow To Free Speech And Academic Freedom* by Richard Vedder). In the fortified city of Birgu in Malta is the Inquisitor's Palace, the seat of the Maltese Inquisition for over a century, from 1574 to 1798. In the tribunal area is a backless low bench on which the heretic sat as he faced the fearsome inquisitor's desk. The palace is now a place of public exhibition and is called the National Museum of Ethnography. It is haunted by the ghosts of the past and the victims of the present day. On the bench sits Amy Wax, placed there by the far left successors of the Catholic Church.

KANT VERSUS THE GOOD LIFE

And the Lord said unto Moses, Come up to me into the mount, and be there, and I will give you tablets of stone, and a law, and commandments which I have written, that you may teach them. And Moses rose up with his minister Joshua, and he went up into the mount of God. Thus speaks Exodus describing a set of commandments which would form the basis of Judeo-Christian morality and earn the allegiance of the gutters of mankind for five thousand years. In the thirteenth century BC, the Lord God of the Jews gave the prophet Moses Ten Commandments on Mount Sinai, and he wrote them down on tablets of stone. These are categorical imperatives, commandments which must be obeyed come what may, obeyed just for the sake of obedience, because they have been set forth by God, obeyed without regard to consequences of any kind, either for oneself or for others.

Received by Moses in the midst of clouds, fire and thunder was a world historical first: a morality of deontology, a morality of duty for duty's sake, which defied the sanity and common sense of ordinary people in its separation, never before made in the history of mankind, of morality from consequences. For the sane person guided by common sense, morality is a set of principles based on reason focusing on the distinction between right and wrong which enable man to flourish in a human manner. Morality is a rational code of values which guides man's actions and determines the purpose of his life. Morality is predicated on the definition of man as a rational animal. Man is a being who survives and succeeds by the use of his reason, and his good and perfection is a life of rational work and production. For the sane person guided by common sense, morality has no categorical imperatives because it is concerned with determining the actions which if undertaken, will lead to a life of rational achievement. Morality devises a series of hypothetical imperatives and says that these should be obeyed in order to produce beneficial consequences. For the sane person guided by common sense, the notion of a categorical imperative spells the death of morality because it commands the performance of actions which are unrelated and opposed to the achievement of rational goals and interests. The morality of rational perfection guided Classical Greco-Roman culture, whose prime symbol was Apollo, god of reason, order, wisdom and healing. Classical culture promoted hypothetical imperatives because it promoted the achievement of rational ends and consequences, and never knew such a thing as a categorical imperative, an imperative to be followed at the expense of the individual and destructive of the individual's life, a monster come alive by the lightning flashes and trumpet blasts of Jewish insanity, exploding after forty days and forty nights on Mount Sinai. Listen to Aristotle, the preeminent philosopher of Classical culture, state that morality is predicated on the special function of man. Morality is rational activity as opposed to blind obedience to a set of commands. Morality is the achievement of rational virtue as opposed to formal virtue. Morality is the development of one's rational talents and abilities and not the carrying out of arbitrary orders. Morality is adherence to rules because they lead to rational excellence and not for the sake of adhering to rules. Morality is the performance of duty for the sake of the rational spirit, soul and psychology of man and not the performance of duty for the sake of duty. Morality guides man as a free, rational actor and not a programmed, rule following robot: "Presumably to say that happiness is the chief good seems a platitude, and a clearer account of what it is still desired. This might perhaps be given, if we could first ascertain the function of man. For just as for a flute player, a sculptor, or an artist, and, in general, for all things that have a function or activity, the good and the well is thought to reside in the function, so would it seem to be for man, if he has a function. Have the carpenter, then, and the tanner certain functions or activities, and has man none? Is he born without a function? Or as eye, hand, foot, and in general each of the parts evidently has a function, may one lay it down that man similarly has a function apart from all these? What then can this be? Life seems to be common even to plants, but we are seeking what is peculiar to man. Let us exclude, therefore, the life of nutrition and growth. Next there would be a life of perception, but it also seems to be common even to the horse, the ox, and every animal. There remains, then, an active life of the element that has a rational principle. Now if the function of man is an activity of soul which follows a rational principle, and if we say *so and so* and *a good so and so* have a function which is the same in kind, for example, a lyre and a good lyre player, and if this is the case, and we state the function of man to be a certain kind of life, and this to be actions implying a rational principle, and the function of a good man to be the good and noble performance of these, and if any action is well performed when it is performed in accordance with the appropriate excellence: if this is the case, the human good turns out to be activity in accordance with rational virtue." (*Nicomachean Ethics*, Chapter 1, Section 7). Five thousand years after Moses transcribed the Ten Commandments from mad voices within, a philosopher in the West proceeded to secularize Jewish deontological morality, and his secular version would tear the world apart. He is the preeminent philosopher of the West, and plays the role in the West which Aristotle played in Classical culture. Born during the Age of Enlightenment, Immanuel Kant was a stranger

and alien amidst this glorious age and sought to subvert its values and ideals, and champion the rule of subjectivity. He gave his philosophy an Enlightenment veneer of universality beneath which he promoted a core and essence of subjectivity. He proclaims that knowledge is universal but subjective, that morality is universal but subjective, and that beauty is universal but subjective. His students and followers discarded the superficial universalism and retained the subjectivist core and essence. Ignore the inessential veneer and listen to the core and essence of Kant's philosophy, and hear a death bell called psychosis ring out during the twilight stages of civilization. Listen to Kant proclaim that the source of morality is not God in Heaven, whose existence cannot be known, nor the world around us, which we can never perceive, nor human reason, which like perception, can know nothing beyond itself, but is just the human will. Listen to him proclaim that morality is obedience to the will's categorical imperatives. Morality is rank unkindness, ruthless zealotry and the rejection of all consequences. Morality is the Mosaic Decalogue authored by man and not by God. Morality is passion, crime and the romanticization of violence. Morality is obedience to the voice of subjective conscience without regard to cautiousness, humanitarianism, rational virtue or the rights of others. Morality is the opposite of reason, goodness and humanity. Morality is obedience to the legislation of the will without regard to common sense, rational self interest, or the counsels of wisdom or experience. Morality is obedience to the inner subjective man, the only thing in existence which can be known. Morality is mindless self assertion, unrestrained action, uncontrolled ambition, the darkest depths of irresponsibility, mass victimization, cold blooded, robotic, killing, and a religion flowing with rivers of blood: "But this is not all. The categorical imperative, not satisfied with proclaiming itself secretly omnipotent, proclaims itself openly ruthless. Kant expressly repudiated as unworthy of a virtuous will any consideration of happiness, or of consequences, either to oneself or to others. He was personally as mild and kindly as the Vicar of Wakefield (whose goodness he denied to be moral because it was natural), but his moral doctrine was in principle a perfect frame for fanaticism. Give back, as time was bound to give back, a little flesh to this skeleton of duty, make it the voice not of a remote Mosaic decalogue, but of a rich temperament and a young life, and you will have sanctified beforehand every stubborn passion and every romantic crime. In the guise of an infallible conscience, before which nothing has a right to stand, egotism is launched upon its irresponsible career. The categorical imperative, as Kant personally conceived it, was that of the conscience of the eighteenth century, which had become humanitarian without ceasing to be Christian, the conscience of the Puritans passing into that of Rousseau. But the categorical principle in morals, like the ego in logic, can easily migrate. If today you are right in obeying your private conscience against all considerations of prudence or kindness (though you are prudent and kind by nature, so that this loyalty to a ruthless Duty is a sacrifice for you), tomorrow you may be right in obeying the categorical imperative of your soul in another phase, and to carry out no matter what irresponsible enterprise, though your heart may bleed at the victims you are making. The principle of fanaticism is present in either case; and Kant provides, in his transcendental agnosticism, a means of cutting off all protests from experience or common sense, or a more enlightened self interest. These protests, he thinks, are not only ignoble, but they come from a deluded mind, since the world they regard is a creature of the imagination, whereas the categorical imperative, revealed to the inner man, is a principle prior to all worlds and, therefore, not to be corrected by any suasion which this particular world, now imagined by us, might try to exercise on our free minds. Thus it is from Kant, directly or indirectly, that the German egotists draw the conviction which is their most tragic error. Their self assertion and ambition are ancient follies of the human race; but they think these vulgar passions the creative spirit of the universe. Kant, or that soul within Kant which was still somewhat cramped in its expression, was the prophet and even the founder of the new German religion." (*Egotism In German Philosophy* by Immanuel Kant). The Classical morality of rational perfection has never been promoted in the West. The prime symbol of the West is Faust and not Apollo, and the Faustian impulses of will and subjectivity have been given systematic form and expression in the philosophy of Kant. The students and followers of

this preeminent voice of the categorical imperative and this preeminent philosopher of Faust, the serial killers, mass shooters, suicide bombers, juvenile delinquents, street hoodlums, gangland brawlers and rebels without a cause who terrorize the world today, have brought civilization to a close.

IMMANUEL KANT: DESTROYER OF WORLDS

It fell ten kilometers in forty three seconds before detonating at an altitude of 500 meters. It exploded with a force of 15000 tons of TNT. The explosion engulfed the city in a blinding flash of heat and light. The temperature soared to 4000 degrees Celsius in one second. Bronze statues melted, roof tiles fused together, and 80,000 people were vaporized in an instant. The time was 9:15 AM, August 6, 1945. The place was Hiroshima, Japan. A mushroom cloud rising above the city signaled the first use of a nuclear weapon in a time of war and thus far the only use. A century and a half before nuclear mass destruction hit Hiroshima, an explosion occurred in the philosophic world which would devastate the intellectual and cultural underpinnings of civilization and bring mass violence upon mankind. It occurred during the Age of Enlightenment, but was detonated by a philosopher who was a stranger and alien in this glorious age, and who dedicated himself to its destruction. The bomber is the preeminent philosopher of the West and has three titles: The Father of Modern Ethics, the Father of Modern Esthetics and the Father of Modern Philosophy. When Immanuel Kant set forth the philosophic system he called transcendental idealism, he did two things. He gave systematic expression to the Western Faustian impulses of will and subjectivity, impulses which distinguish the West from its diametrical opposite, the Apollonian culture of Greece and Rome, and he set into motion philosophic shock waves which would bomb the West out of existence, commencing in the twentieth century. In his theory of knowledge, morality and art, Kant promoted subjectivism beneath an Enlightenment veneer of universalism in order get people at the time to pick it up and handle it, so that it would blow up in their faces. Proclaiming that truth is universal but subjective, morality is universal but subjective, and judgments of beauty are universal but subjective, Kant destroyed these three fundamental branches of philosophy; his students and followers in a few short decades discarded the inessential decoration of universalism and championed the raw, brute subjectivism residing at the core and essence; and this subjectivism vaporized the institutions of reason and science and filled the culture with radiation poisoning. In his magnum opus, *Critique Of Pure Reason*, Kant states the aim of his work, and rings a death bell of psychosis which had never been rung before: "I have found it necessary to deny knowledge in order to make room for faith." *To deny knowledge*: the brazenness of the statement made civilized people blanch with fear. *To deny knowledge*: the shameless insanity of the statement made civilized people grow pale with visions of the imminent end of human advancement and the reversion of mankind to the savage jungle. *To deny knowledge*: look at its application to the theory of truth, morality and art and see the cause of the horrors which afflict the present day. By the term *transcendental*, Kant means that truth is acquired in the manner of a witch doctor without the use of man's senses, acquired by a process of pure internal deduction and mental navel gazing, and by the term *idealism*, Kant means that the perceived world of physical objects is unreal and is created by the process of perception. Look at the philosophy of Kant and its implications and see an act of menticide without precedent in Classical culture. Human consciousness is confined to its own perceptions and cannot grasp reality. Human perception is the perception of nothing. Human perception is an act of creation and not reception and reduces man to a being deaf, dumb and blind. Man is deaf, dumb and blind because he has a functioning sensory system: he is blind when he sees, is deaf when he hears, is ignorant when he thinks, and is aware of nothing when he is aware of something. Man creates the present and can recreate the past. What is called reality is a posit of the mind and senses. Because reality is unknowable and all knowledge is subjective, morality has no basis in reason or nature and is obedience to categorical imperatives set forth by the will. A categorical imperative is an imperative which must be obeyed regardless of consequences, either to

oneself or to others. The will is infallible and omnipotent. The will is true existence. The will is a supernatural reality and is God, freedom and immortality. Morality is the thunder, hurricanes and bedlam of the will. Morality is opposed to rational goodness, ends, justice and benevolence. Morality is living dangerously, recklessly, irresponsibly and without regard for the rights of others. Morality is performing one's duty for duty's sake and not for the sake of any rationally beneficial consequences which may ensue. Morality is a blast of war sounded by the will, followed by terrifying waves of death. Morality is the zealous performance of duty blind to the achievement of rational virtue or happiness. Morality is a neoMosaic Ten Commandments composed by the hand of the will and on its tablets. Morality is legislation from the almighty throne of the will oblivious to human experience, prudence, wisdom, enlightenment, intelligence or common sense. Morality is passion and intensity without reflection or restraint of any kind. Morality is the romanticization of crime and the pornography of violence. Morality is self assertion and self expression unconcerned with considerations of rational self interest. Morality is without goodness, benevolence or conscience of any kind. Morality is satanic ambition which produces mass victimization, mass murder and makes rivers flow with blood: "The fact that each spirit is confined to its own perceptions condemns it to an initial subjectivity and agnosticism. What things might exist besides our ideas he could never know. That such things exist was not doubted; Kant never accepted that amazing principle of dogmatic egotism that nothing is able to exist unless I am able to know it. On the contrary he assumed that human perceptions, with the moral postulates which he added to them, are symbols of a real world of forces or spirits existing beyond. This assumption reduced our initial idiotism to a constitutional taint of our animal minds, not unlike original sin, and excluded that romantic pride and self sufficiency in which a full fledged transcendentalism always abounds. The categorical imperative, or unmistakable voice of conscience, was originally something external—too external, indeed, to impose by itself a moral obligation. The thunders of Sinai and the voice from the whirlwind in Job fetched their authority from the suggestion of power; there spoke an overwhelming physical force of which we are the creatures and the playthings, a voice which far from interpreting our sense of justice, or our deepest hopes, threatens to crush and to flout them. If some of its commandments are moral, others are ritual or even barbarous; the only moral sanction common to them all comes from our natural prudence and love of life; our wisdom imposes on us the fear of the Lord. The prophets and the gospel do much to identify this external divine authority with the human conscience; an identification which requires a very elaborate theory of sin and punishment and of existence in other worlds, since the actual procedure of nature and history can never be squared with any ideal of right. The momentum of Kant's transcendental method, however, led to a very different and quite egotistical conclusion. An adept in transcendentalism can hardly suppose that God, free-will, and heaven, even if he postulates them, need exist at all. Existence, for him, is an altogether inferior category. Even a specific moral law, thundering unalterable maxims, must seem to him a childish notion. What the ego postulates is nothing fixed and already existing, but only such ideal terms as, for the moment, express its attitude. If it is striving to remember, it posits a past; if it is planning, it posits a future; if it is consciously eloquent, it posits an audience. These things do not and cannot exist otherwise than in their capacity of things posited by the ego. All, therefore, that the categorical imperative can mean for the complete transcendentalist is that he should have as if all things are real which are imaginatively requisite for him, if he is to live hard: this intensity of life in him being itself the only reality. At that stage of development at which Kant found himself, God, freedom and immortality may have been necessary postulates of practical reason. But to suppose that these imagined objects, therefore, exist apart from the excellent philosopher whose conscience had not yet transcended them, would be not to have profited by his teaching. It would be merely to repeat it. A later and more advanced transcendentalist, instead of God, freedom and immortality, might just as dutifully posit matter, empire and the beauty of a warrior's death. His conscience might no longer be an echo of Christianity, but the trumpet blast of a new heathenism. It is for the ego who posits to judge what it should posit. The postulates of practical

reason, by which Kant hoped to elude the subjectivity which he attributed to knowledge, are no less subjective than knowledge, and far more private and variable. The senses and the intellect, if they deceive us, seem to deceive us all in much the same way, and the dream they plunge us into in common seems to unite us; but what obscurity, diversity, hostility in the ideals of our hearts! In the categorical imperative we see something native and inward to the private soul, in some of its moods, quietly claiming to rule the invisible world, to set God on his throne and open eternity to the human spirit. The most subjective of feelings, the feeling of what ought to be, legislates for the universe. Egotism could hardly go further. But this is not all. The categorical imperative, not satisfied with proclaiming itself secretly omnipotent, proclaims itself openly ruthless. Kant expressly repudiated as unworthy of a virtuous will any consideration of happiness, or of consequences, either to oneself or to others." (*Egotism In German Philosophy* by George Santayana). Two hundred years ago, a nuclear explosion occurred in the world of philosophy. Detonated by a philosopher nicknamed the Crusher of Everything, its white hot flames and rain of ruin from the air destroyed the study of truth, goodness and beauty. Immanuel Kant's nuclear bomb was subjectivism. Look at the devastation it wrought commencing in the twentieth century. Truth is a social convention and is relative to gender, race, class, culture, nation, community and sexual orientation. Morality is pure license, expression and wild cataracts of rage. Art is not the representation of reality but is the free play of pure forms, and consists of combinations of sounds, colors, lines, shapes and words, as flowing streams of consciousness, without meaning or intelligibility of any kind. Truth as tribalist in character, morality as ruthless, violent formalism, art as the pure formalism of compositional elements, called Modern Art, architecture as pure formalism, called Modern Architecture, without functionality of any kind. These are the aftermaths of the nuclear explosion, the excrescences and cancerous growths which have spread over the worlds of thought, the postEnlightenment, neoKantian insanity which has destroyed the West.

CHRISTIANITY REINVADES SCIENCE

He is called the father of modern astronomy, physics and the scientific method. He championed the doctrine of Copernicus that the Earth revolves around the Sun and met with strong opposition from the Catholic Church, which supported the Ptolemaic doctrine that the Earth is the center of the universe. His rejection of Church doctrine was investigated by the Roman Inquisition in 1615, which found him guilty of heresy in contradicting the Bible. He was forced to recant and spent the rest of his life under house arrest. The fate of Galileo encapsulates the story of Christianity and its 2000 year old war on civilization. Founded by Jesus in the Roman province of Judea in the first century, this global, billion member organization, this peddler of the supernatural, the creation of something out of nothing, the omnipotence of God who can make two and two equal six, the Eucharist which transforms bread and wine into the body and blood of Christ, Jesus as the son of God and Mary as the mother of God, this institution of blind faith and worship, defeated by the Age of Enlightenment, is back in business in the twenty first century. In its mission to destroy reason and science, it is joined by a rival, by a religion which worships at the altar of matter, tribalism and collectivist tyranny. This religion called Marxism, a religion worshipping God Matter as opposed to God Spirit, has made more inroads into civilization than Christianity, but the newly resurgent Christian Church, held at bay for centuries, is celebrating new victories in the twenty first century age of second religiousness, in the age in which history has repeated itself, in the final twilight age of the West. The church has renewed its attack on the doctrine that life emerged from nature and the attack has burgeoned into a mass movement. To new global standing ovations, the church proclaims that since life cannot have emerged by random means, it must have emerged by the action of God. Common sense rejects both alternatives as equally arbitrary. Common sense affirms that nothing in nature occurs by chance. Common sense affirms that to be is to be something; there is no such thing as a something which is nothing; and all actions proceed in accordance with the natures and essence

of the things which act. Common sense affirms that fire burns paper always and necessarily, and that if paper were placed in contact with fire an indefinite number of times, it would always burn. It affirms that nature is not governed by chaos but by laws. Common sense affirms that natural laws are eternal and uncreated, and that natural law that two and two make four never had a beginning and will never have an end. It affirms that life necessarily emerged from nonlife because the notion of a supernatural existence is unintelligible. It is unintelligible because it is the notion of an existence which is on principle unperceivable, and implies the contradiction that man is blind because he has eyes, and perceives nothing when he perceives something. Common sense affirms that life emerged from nonlife through the action of natural, eternal, necessary laws. Common sense affirms that natural laws are necessary because things cannot be other than as they are and thus cannot act in a manner other than how they act. Common sense affirms that life necessarily had a chemical origin. Common sense affirms that because life did not emerge through random processes does not mean and cannot mean that it emerged through the action and guidance of a supernatural being. Common sense affirms that life emerged from nonlife but did not evolve from nonlife, because evolution is an extended process in time and if life had evolved from nonlife, there would have been an intermediate existence, life-nonlife, A-nonA, which is a contradiction in terms and in reality. A thing is either living or it is not living. Common sense affirms that life emerged from nonlife in a single, instantaneous event. Common sense affirms that organisms evolve specific characteristics over time while still remaining the organisms they are, but a change in essentials, a change from one type of organism to another type, or from nonlife to life, necessarily takes place in an instant. Common sense affirms that the emergence of life necessarily had no supernatural intelligence, design, planning or guidance behind it. Common sense affirms that material processes in nature are directed by natural laws and by nothing else. Common sense affirms that matter in nature organizes and orders itself in accordance with natural laws. Common sense affirms that no true scientist, no Newton, Galileo, Kepler or any lesser light, believes in the existence of a nonperceivable, supernatural being. Common sense affirms that there were no Judeo-Christian origins of science because science is diametrically opposed to faith. Common sense affirms that science was born in Greco-Roman culture, whose prime symbol was Apollo, god of reason, order, wisdom and healing. Common sense affirms that the progress in nature from simplicity to complexity, the march from organizational imperfection to perfection, culminating in the development of life and human intelligence, was the product of natural laws. Common sense affirms that the world of molecular machines and biochemical systems is governed by determinate natural laws, and neither by the laws of probability nor by the will of God, both of which can produce results violating the facts of reality. Common sense affirms that the world of matter and its energies is an internally directed system which excludes the actions of extrinsic agents such as random choice or the whim of God, and is a system of eternal natural laws: "This past year, I have seen headlines flash across the *start* page of my Microsoft browser's newsfeed that featured articles about the supposed chemical origin of life. Was it the result of aliens seeding our planet billions of years ago—a theory called Panspermia? Or an asteroid bombardment with trace amino acids and nucleic acids, the building blocks of proteins, DNA and RNA? When I was a college student, one of my colleagues reenacted the 1952 Miller-Urey experiment, originally designed to show how unguided chemical evolution could have occurred on a primordial Earth. After assembling the equipment, he evacuated the air using a vacuum pump and charged the system with water, methane, ammonia, and hydrogen. This was refluxed in the absence of oxygen for a week while a continuous electric spark was passed through the vapor. The idea that oxygen breathing organisms could evolve through random, unguided processes in an oxygen free atmosphere was either poorly considered or outright overlooked by the original researchers. Equally ignored was the debunked theory of spontaneous generation, which shares a close relationship with chemical evolution. This once popular belief held that life could emerge from nonlife—people even thought that leaving rags in a dark closet could spontaneously produce mice. Scientists, most notably Louis Pasteur, had

disproven this notion nearly a century earlier. Several days into the project, when I asked him how it was going. He turned to me, laughed, and said, 'After this, I think I'll write the Ten Commandments.' His results failed to match those of the original researchers, which was the formation of trace quantities of amino acids in the mixture and *voila!* life would shortly emerge thereafter, given a billion years or so. Despite continuing efforts on the part of origin of life researchers to demonstrate a plausible mechanism for unguided chemical evolution leading to greater complexity and ultimately life, none have been successful—not even close. Even the original Miller-Urey experiment was not unguided. It had been designed, utilized designed glassware, and conducted in a designed laboratory. Some intelligent designers collaborated and conducted the experiment. And there was an agreed upon goal—a guided direction—that the researchers hoped to achieve. If it demonstrated anything, it showed that intelligence always precedes and then guides matter and energy. Swiss watches are made by Swiss watchmakers. Computer code doesn't write itself unless coders have initiated the process—even now with the advent of artificial intelligence. The Gordian Knot of all origin of life research is that to make proteins and almost all other biomolecules that comprise cells, you need molecular machines—enzymes—to do the job of assembly. These are themselves unfathomably complex ensembles of proteins or RNA in some cases. If you've ever watched *How It's Made* on the *Science Channel*, you get the idea: things don't assemble themselves. Machines—often robots—are designed by intelligent engineers who carefully manufacture each item. In other words, intelligence and planning always guide matter and energy. When we start discussing protein synthesis, I use a thought experiment with my introductory biochemistry students. I show them a photo of my necktie drawer, which my wife spent an hour organizing by color and folding into neat rows. I then told them the ties spontaneously arranged themselves while I was out. The best response I've received wasn't scientific—one student blurted out, 'I hope you bought her flowers!' No student has ever believed that my ties, given even 'billions of years,' could have organized themselves through random, unguided processes. Common sense leads to common science. The lesson is clear: someone intelligent, with an eye for color and a skill for artfully folding fabric, was behind the organized arrangement. One could say that my wife was acting as an intelligent designer. Belief in God as The Intelligent Designer was the starting point for much of scientific inquiry through the sixteenth and seventeenth centuries. 'The great pioneers in physics—Newton, Galileo, Kepler, Copernicus—devoutly believed themselves called to find evidences of God in the physical world,' writes Stephen C Meyer in the *Return of the God Hypothesis*, his latest book in which he makes a convincing case for the Judeo-Christian origins of modern science." (*The Evolution Of Intelligent Design Theory* by Gregory Rummo). In the twentieth first century, the ghosts of the Dark Ages have returned to haunt the West. The gargoyles and grotesqueries projecting out of the mental wastelands of Christianity pockmark the landscape of the West today. They are the signposts of civilizational collapse.

SOVIET JESUITS TAKE OVER SCHOOLS

On September 27, 1540, a mighty army was founded. Its leader was a Spanish Catholic priest named Ignatius Loyola. This army has secularized Christian doctrine and replaced God in Heaven by the Collective on Earth as the object of worship and sacrifice. According to this, legitimate political theory is critical of Enlightenment values and worships at the altars of mystical, neoHitlerite, black power national socialism. Today's Jesuits proclaim that a progressive educational system condemns capitalism as a regime of white male power and privilege. They proclaim that a progressive educational system promotes institutional racism and sexism expressed in policies of discrimination against white males; promotes preferential treatment for black females in the name of achieving diversity, opportunity and filling the achievement gap; and describes its racist and sexist policies of diversity as the highest forms of fairness and equity. They proclaim that a progressive educational system condemns the liberal arts curriculum emphasizing reason, science and individualism as a course in white supremacy, and mandates black, hispanic and oriental ethnic studies programs which seek to revert mankind to the jungles of tribal politics. They proclaim that a progressive educational system is left leaning, Marxist leaning and politically activist. They proclaim that a progressive educational system forces students to reject liberal democracy and profess allegiance to gender, race, class and ethnic politics as a condition for graduation. Schools there are committed to equity and to 'identifying practices, policies, and institutional barriers, including institutional racism and privilege, which perpetuate opportunity and achievement gaps.' One of the many new trends in education is the teaching of ethnic studies, which means different things in different locales. In the state of Washington, where ethnic studies is a graduation requirement, its main goal is to 'dismantle white supremacy.' In California, many parents in Palo Alto are furious about the school district's plans for an upcoming ethnic studies class, saying they're worried the curriculum is too political and will push left leaning political activism on impressionable high school students. The sciences have also been infected with politics. As described by Wenyuan Wu, Executive Director at the Californians for Equal Rights Foundation, The Next Generation Science Standards, released in 2013 and adopted by 44 states to varying degrees, are the culprit behind our failing K-12 science education. 'By replacing scientific rigor with 'inquiry based learning' and by radicalizing the science education profession with political imperatives of diversity and 'equity', the NGSS has short changed students and degraded science.' " (*Classical Versus Unclassical Education* by Larry Sand). Today's Jesuits proclaim that a progressive educational system indoctrinates students in the neoMarxist, neoproletarian religion of environmental collapse at the hands of big capital. According to this, big capital produces catastrophic global warming through greenhouse gas emissions. The only way to save humanity and protect the planet is through the destruction of big capital. People must lower their standard of living and live like animals in order to turn back the doomsday clock. A progressive educational system expels teachers and students who deny the religion of climate change caused by big capital, a religion unsupported by the record of history, which reveals rising global temperatures uncorrelated with greenhouse gas levels and correlated with sunspot activity. A progressive educational system is run by far left activists who have replaced empirical science by sets of religious beliefs embraced by blacks, women and the poor. In December 2021, *The Lancet* published a study from a team of nine researchers, including psychologists, environmental scientists, and psychiatrists, who surveyed 10,000 people aged 16 to 25 across 10 countries about their climate anxiety and their governments' responses to environmental issues. Seventy five percent reported feeling the future is frightening, and 83 percent said humanity failed to take care of the planet. The study also reported that nearly half said their feelings about climate change negatively affected their daily life and functioning.' It is not clear if counterarguments—often disparaged by Democrats as 'denialist'— will be presented. Students have returned to school in California amid a searing heat wave in the state—which is typical for late August and early September in the state, but such events are routinely cited as evidence of what was once called global warming. Obama administration climate official Steven Koonin has pointed out that it is more likely that winters are becoming milder, rather than summers becoming hotter." (*Report: Mandatory 'Climate Change' Curriculum Begins in California Schools* by Joel Pollak). Johann Christoph Handke was a world famous eighteenth century baroque painter of religious subjects from Moravia. His most acclaimed work is a 1743 fresco entitled *Approving The Society Of Jesus*, depicting Ignatius of Loyola receiving the Papal Bull of approval from Paul III. Five

hundred years after the pope issued his *To The Government Of The Militant Church*, a new militant church has appeared on the scene. It is the Red Army of Marxist militants and the mob has given it the keys to classrooms to fanaticize the minds of youth.

RELIGION: DESTROYER OF CIVILIZATION

A civilization is a complex society founded upon the rule of reason. The complexity, including the state, language, science, technology, agriculture, infrastructure, urbanization and social stratification, would not be possible without the application of reason to human action and experience. Movements opposed to reason are movements opposed to civilization, and a civilization which has abandoned reason is a civilization on its way down. The number one movement opposed to reason is religion. This is a belief system which projects ultimate reality as a supernatural existence and seeks to relate humanity to this existence. On the European continent over the past three thousand years, there have arisen two civilizations, Classical Greco-Roman civilization and Western civilization, and both have been destroyed by religion. Classical civilization, whose prime symbol was Apollo, Greek god of reason, order, wisdom and healing, was destroyed by Christianity, and Western civilization, founded in 1000 AD by Germanic peoples, was destroyed by two religions, acting alone and in concert: Marxism and Islam. The first stage of the West was the Dark Age ruled by Christianity, but this was defeated by the Renaissance and the Enlightenment, and the destroyers of the West would appear in the twentieth and twenty first centuries. The destroyers were an enemy within and an enemy without, but both were enabled to achieve victory by the treason of the Western mobs. The enemy within was Marxism, the religion of the Collective on Earth, and the enemy without was Islam, the Eastern religion of Allah in Heaven, and these enemies of reason dug the grave of the West. Faith, zeal, curiosity, and more earthly passions of malice and ambition, kindled the flame of theological discord; the church, and even the state, were distracted by religious factions, whose conflicts were sometimes bloody and always implacable; the attention of the emperors was diverted from camps to synods; the Roman world was oppressed by a new species of tyranny; and the persecuted sects became the secret enemies of their country. The sacred indolence of the monks was devoutly embraced by a servile and effeminate age." (*The Decline And Fall Of The Roman Empire* by Edward Gibbon, Chapter 71). **Marxism.** Western

civilization was destroyed by a secular version of Christianity called Marxism. It was destroyed by Marxist critical theory which is critical of the Enlightenment values of reason, empiricism, human essentialism, human universalism and human rights. It was destroyed by Marxist gender, race and class politics, in which tribes proliferate like cancerous cells from the original proletariat and are united by opposition to a common enemy: the tribe of the bourgeois and the capitalists. It was destroyed by the Marxist promotion of black power, feminist power and proletarian power. It was destroyed by the Marxist condemnation of capitalism as a regime of social and environmental crisis. It was destroyed by the Marxist condemnation of capitalism as a regime which places a satanic idol called Individual Rights upon the throne of power in place of Collective Rights. It was destroyed by the Marxist condemnation of capitalism as an economy which kills innocent people. It was destroyed by the Marxist exaltation of universal collectivist enslavement as the highest form of economic, political and cultural liberation: "Pope Francis met with a group of Marxists in the Vatican on Wednesday and exhorted them not to let up in their pursuit of dialogue with Christians. On Wednesday, the pontiff received a delegation from the Transversal Dialogue Project (DIALOP), a group devoted to producing a 'differentiated consensus' from Christian social teaching, Marxist critical theory, and feminism. For many years, DIALOP has 'been committed to promoting the common good through dialogue between Socialists/Marxists and Christians,' the pope said in his address, calling its endeavor 'a fine program! Never lose the ability to dream! Don't back off, don't give up, and don't stop dreaming of a better world.' The leaders of DIALOP credit Pope Francis as the inspiration for their project, noting that the pope met with two left wing politicians in 2014, Alexis Tsipras and Walter Baier, and discussed the environmental crisis and the worldwide social crisis. 'At the end of that audience, Pope Francis called the visitors to launch a transversal dialogue, capable of involving the broadest strata of society and above all of the youth,' DIALOP's website states. 'We agreed on the need to continue the dialogue between the European left and the Christian church,' Tsipras said. 'There is a need to create an ecumenical alliance against poverty, inequalities, against the logic that markets and profits are above people.' In its 2022 position paper, DIALOP compared the words of the Virgin Mary in the *Magnificat* to Karl Marx's 'categorical imperative.' 'As careful readers of the Marxian tradition rightly stress, to overthrow the powerful from their throne is similar to the categorical imperative of Karl Marx, which demanded that all conditions should be reversed in which man is degraded, enslaved or abandoned,' the paper states. 'And in the *Magnificat* and in Marx as well, the view of the weakest in society leads to the demand for a fundamental change,' it adds. Little by little, the Catholic Church has moved from its position of early condemnations of socialism to a more welcoming attitude, the paper asserts. 'Probably the best comment on the change in mentality that this represented came from Liberation theologian L. Boff when he stressed that the pope (Francis) has made liberation theology a full part of the official narrative of the Church,' it declares. 'And he commented that for the pope, a poor person is not intrinsically a pauper but an impoverished person: one is not poor, one is made poor,' it contends. 'Pope Francis' message *This economy kills* unites us,' the paper asserts. 'It also unites us in the knowledge that it is the economic, political, cultural, and international relations that generate unholy destructive tendencies.' opponents of slavery will arrest the further spread of it, and place it where the public mind shall rest in the belief that it is in the course of ultimate extinction; or its advocates will push it forward, till it shall become lawful in all the States, old as well as new—North as well as South. Thus spoke Abraham Lincoln on June 16, 1858 at the Illinois State Capital in Springfield, after he accepted the Illinois Republican Party's nomination for state senator. The logic of Lincoln's statement was as terrifying as it was unassailable. A society in a state of philosophic discord cannot endure because it is incoherent. Morally and logically, a society cannot be half slave and half free; a society is either free or it is not free; politically, a society in which one half of the people supports freedom, while the other half supports slavery, is doomed to collapse due to its internal contradiction, and in order to survive, will either have to become all slave or all free. Since the dawn of the twentieth century, the former leader of the free world, whose shining City Upon A Hill lit up the skies for decades with the hope of freedom for the oppressed, has been a living contradiction, half slave and half free.
