

Video Circulates of Georgian MPs Physically Attacking Citizen in Abu Dhabi

eorgian citizen Lasha Gabitashvili U has accused members of the ruling Georgian Dream party of physically assaulting him at a hotel in Abu Dhabi. Gabitashvili, who had publicly criticized the MPs a day earlier, shared a video on social media showing MPs Irakli Zarkua, Viktor Sanikidze, and Gela Samkharauli allegedly attacking him.

Gabitashvili recounted the incident, stating that the MPs confronted him during breakfast with his wife and attacked him in retaliation for his criticism.

"I came for breakfast, and they attacked me, likely because of the videos I shared yesterday. I'm here alone with my wife, and they thought I'd be scared. But I'm not afraid," Gabitashvili said. He added that he believes the assault stemmed from comments he made accus-In a Facebook Live broadcast, ing the MPs of betrayal and criticizing

their stance on political issues.

The altercation follows a confrontation on January 12, during which Gabitashvili approached the MPs in public, accusing them of being "slaves and traitors." He also questioned Zarkua about the arrests of demonstrators during a rally in Batumi on January 11-12. Video footage from the confrontation shows Zarkua avoiding the question and moving the camera away before the argument escalated.

After the physical attack, Zarkua and Sanikidze released a video addressing the incident.

"Some incident happened. It's not something to be proud of, but we are a selfrespecting nation. When they insult my family, there will always be a response,' Zarkua stated.

Sanikidze added, "Everything is fine. There will always be an answer to these stateless people, wherever we are."

Batumelebi Issues Statement Condemning Arrest and Obstruction of Journalist Guram Murvanidze

The editorial team of 166 (petty hooliganism) and 173 **L** *Batumelebi* has released a statement condemning the arrest of their journalist, Guram Murvanidze, and the blatant obstruction of his journalistic duties. They have called on citizens, supporters, and partners to stand against this violation of press freedom. According to the statement, Murvanidze was arrested on January 12 at approximately 9:20 PM while covering a rally near the Constitutional Court in Batumi. He was subsequently transferred to the Poti pre-trial detention center and allowed to meet with his lawyer only at 6 AM the following morning.

The investigation is reportedly being conducted under Articles (disobedience to legal orders) of the Code of Administrative Offenses. However, Batumelebi's statement underscores that Murvanidze's narrative indicates deliberate interference with his journalistic activities. As described in the statement, Murvanidze was filming police arrests at the rally when Batumi Police Chief Irakli Dgebuadze allegedly demanded to know who was recording. After Murvanidze identified himself as a *Batumelebi* employee, Dgebuadze reportedly insulted him and ordered officers to

confiscate his phone.

Murvanidze recounted that police officers tried to take his phone as he attempted to secure it. Despite resisting briefly, the phone was confiscated, and he was arrested without further resistance. Video footage confirms that Murvanidze did not resist arrest.

After his arrest, Murvanidze alleges he was verbally insulted and pressured to reveal his phone's password. The statement by *Batumelebi* highlights that the aggression from the police escalated after Murvanidze identified himself as their journalist.

The editorial team has called for a thorough investigation and urged the Special Investigation Service to hold those responsible accountable. They emphasized that this incident represents a direct attack on journalistic freedom and on *Batumelebi* as a publication.

The coalition of non-governmental organizations My Vote has issued a statement condemning what it describes as systematic repression against civil servants in Georgia. The organization asserts that recent dismissals from state agencies are demonstrative and punitive measures aimed at silencing dissent.

According to Nino Lomjaria, a representative of *My Vote*, employees from 20 state agencies have been dismissed for political reasons. She outlined several factors behind the dismissals:

- Civil servants signed petitions advocating for the protection of Article 78 of the Constitution.

"Since late December, public service employees have begun to speak out about illegal dismissals, deliberately low performance evaluations, and other forms of harassment due to their opinions. The methods, timing, lack of justification, and scale of these actions suggest they are deliberate punitive measures," Lomjaria stated.

She also emphasized threats made by Georgian Dream leaders Irakli Kobakhidze and Kakha Kaladze against officials who criticized the party's deci-

The agency asserts that no civil servant has been fired since its establishment on March 1, 2022, nor has any employee under a short-term
