

Kobakhidze: 'Deep State' using European bureaucracy to prolong war and destabilize Georgia

Prime Minister of Georgia Irakli Kobakhidze has accused the "deep state" of directing European institutions to carry out actions against Georgia's national interests and to prolong the war in Ukraine.

^t'In Georgia, we managed to avoid the opening of a second front, and this is why the 'deep state' is enraged and is using European bureaucracy in corresponding actions," Kobakhidze said during an interview with journalists.

According to the Prime Minister, foreign funding has been used to try to destabilize the country and bring the opposition back to power.

"Foreign funding was used in Georgia to encourage revolutionary processes, to create chaos in the country, and to return the collective United National Movement to power," he stated.

Kobakhidze also said that while American institutions had previously been involved, the responsibility had now shifted to European entities.

"Previously, American structures were also involved in this process. Now, the deep state has entirely and exclusively assigned European structures the task of prolonging the war in Ukraine. The same is happening in terms



of funding organizations. Antistate processes, including in our country and others, are no longer being funded by American foundations, this burden has now been passed on to European structures."

He emphasized the importance of defending Georgia's sovereignty in the face of these developments.

"It's very unfortunate, but as you know, we were under attack from two fronts before, and even then, we managed to defend our national interests. If anti-state activities are funded from European structures by European bureaucracy, we will naturally have a response to that as well. We must protect our national interests to the end."

Kobakhidze concluded by contrasting Georgia's current course with the devastation in Ukraine.

"The 'deep state' has its own interests. It uses European bureaucracy for those, but we have our own national interests, and we will defend them completely. The national interest is not to allow what happened in Ukraine. In Ukraine, there was and still is war, destruction, and enormous loss of life. Of course, as a counterpart, there is good cooperation with European bureaucracy, but believe me, for the Ukrainian people, that is little consolation," he said.

Papuashvili Accuses UK of Attempted Interference Through Election Grant Program

Parliament eorgian Georgian Shalva Papuashvili has accused the United Kingdom of attempting to interfere in Georgia's internal affairs through a newly announced grant competition supporting the upcoming 2025 local elections. Speaking to reporters on April 6, Papuashvili claimed that the initiative from the UK's Foreign, Commonwealth and Development Office (FCDO) "serves exactly the same purpose as previous U.S. financial assistance,' which he alleged had been used to "interfere in other countries, change governments and destabilize them." The comments followed the April 4 announcement by the British Embassy in Tbilisi of a grant competition for Georgian non-profit organizations. The program offers up to £100,000 per project, aiming to support free and fair elections through

voter education, participation among under-represented groups, and election observation.

The Embassy stated the program's goal is to support Georgian elections "that are held to the highest possible standards, in which all sections of the Georgian population are able to

express their opinions."

However, Papuashvili argued that the British program was intended to fill the vacuum left by halted American funding: "The new American administration has exposed this [foreign funding] harmful practice and stopped interference in the internal affairs of other countries," he said. "But when a vacuum is created, other forces always try to fill it and substitute American funding. What they used to do with the right hand of American funds, now they do with the left hand of British or other European funds."

Papuashvili also cast doubt on the transparency of the funding

"The changes contradict the principle of pluralistic democracy and disproportionately restrict the activities of not only existing but also newly established parties in the future. In addition, through vague legislative criteria and unrestricted interpretation by the Constitutional Court, which has political influences, the changes in the current political situation will lead to the weakening of opposition parties, the creation of artificial barriers to the formation of future political forces, and ultimately their abolition," the organization stated in a public

statement.

GYLA also referenced the Venice Commission's stance on party bans, emphasizing that it views such measures as extreme and requiring caution. The organization further noted that high standards must be upheld when banning a party in democratic states, including decisions made by an impartial court, supported by appropriate justification, and free from political influence.

"It is clear that the initiative to abolish parties serves to clear the political field, remove opponents, and strengthen antidemocratic propaganda."


