

Georgian Dream Files Complaint Against Critics Over Alleged Public Insults

The Georgian Dream party has filed a formal complaint with the Interior Ministry against individuals it accuses of insulting party members in public and on social media. MP Irakli Kirtskhalia announced the move during a briefing on June 6.

"Foreign-funded extremists do not shy away from swearing, intimidating, bullying, insulting our family members and relatives," Kirtskhalia said, describing the criticism as part of an "externally funded hate speech campaign." He claimed the remarks targeted officials and their families and called the response "an obligation."

The complaint cites February amendments to administrative law that criminalize insulting public officials. The legislation has been widely criticized, including by the Venice Commission, which warned that its vague language grants excessive discretion to authorities and risks misuse.

Kirtskhalia said the complaint covers "the filthiest phrases and insults" expressed in public settings and online. He accused NGOs, foreign donors, and some embassies of encouraging "organized terror" and undermining state institutions.

The announcement follows a series of recent fines and detentions. Among them, TV Pirveli cameraman Lasha Jioshvili was fined GEL 3000 on May 1 for a Facebook post allegedly insulting a police officer.

Abkhazia's So-Called Foreign Minister Calls for **Binding Non-Use of Force Agreement, Affirms Participation in Geneva Talks**

leg Bartsits, the so-called foreign minister of occupied Abkhazia, recently spoke in an interview with Russian media about a shift in rhetoric coming from Georgia.

"When high-ranking officials, such as ministers, declare their



readiness to apologize, repent, and improve relations with neighboring countries like Abkhazia and South Ossetia, there is nothing wrong with that — in fact, it is positive. However, for these statements not to remain empty, we need to move toward real steps. For example, signing a legally binding agreement on the non-use of military force would be a practical step to help strengthen trust between our countries," Bartsits said.

He also confirmed that occupied Abkhazia will continue to participate in the Geneva talks, though the possibility of transferring the talks to another country is under consideration.

We will continue to participate in the Geneva format with the support of our Russian colleagues. This is the only platform where we can express our point of view and demand certain actions. This format is important, necessary, and currently the only one. However, the Swiss approach is often biased, so it is possible to transfer the talks to a country that will be more objective," Bartsits explained. Looking ahead, Bartsits said he expects new states to "recog-

nize" occupied Abkhazia in the future. "There will be recognitions. We are actively working in this di-

rection with the help of our Russian colleagues. We believe time is on our side. We receive signals from countries in different regions expressing interest in dialogue with us," he added.



The party was part of Strong Georgia alongside Lelo, Citizens, and the Freedom Square movement. The coalition received 8.81% of the vote in the election, according to official results, and won 14 seats in Parliament. These seats were later renounced as part of the opposition's boycott.

Dolidze launched For People in 2021 to promote progressive reforms.

Two Georgian Citizens Illegally Detained by Russian Occupation Forces Released

Tariel and Leonide Tenadze, brothers who had been held unlawfully by Russian occupation forces, have been freed and are now back in territory controlled by Tbilisi, according to a June 6 announcement from the State Security Service of Georgia (SSSG).

The pair was apprehended

near Plavismani, a village in Gori Municipality close to the administrative boundary. On March 11, the SSSG confirmed the detention of three individuals from the same location. One was released soon after, while Mission's hotline system and other available tools used by Georgian authorities.

The SSSG emphasized the government's ongoing commitment to securing the freedom of all citizens detained in regions



the Tenadze brothers remained in custody until the recent development.

Their return was made possible through the involvement of the European Union Monitoring outside its control. The statement also reiterated that responsibility for destabilizing activities near and within the affected areas rests with the occupying side.
